"Bayerischer Rundfunk" (740 kc/s., 100 kw/) Munich, Germany, nice letter; Radio Monte Carlo (959 kc/s., 120 kw/), Monte Cardo, Vonaco (nice letter and beautiful 4-color brochure describing the station); and Koside, Czechoslovakia (1204 kc/s., 100 kw.) (nice card); all three in reply to followups to last saeson's reports, leaving only Tunisia un-verified on reports of last inter. All of above stations are now on different frequencies. Also in from October : eports are nice letter veries from ACA, Fort Clayton, Canal Zone (who received 29 reports on the special) and from Toulouse I (944 kc/s/, 100 kw.), Toulouse, France. Incidentally, lest anyone think I am getting snooty or sumpin in DXing for foreign only, the plain and simple reason is that so many new U.S. stations have come on since I quit donestic BCB DXing back in '41 that I'd go muts sending out reports to all the new ones I can easily hear! Arranging these foreign specials is taking enough time as it is. So far, I've written about 30 stations, with 12 agreeing to come on, and 1, (Radio Jamaica) saying not now, but maybe later on. Toughest country has been Honduras where I've written all 5 stations known to be on BCB without getting a single reply! Was glad to note in November 18 bulletin received today that CB-106 was heard by many. They were heard here from 3:32 to 4:18 a.m., but very poorly through heavy sideband from WMGM that 4:02. 4VGM was prevented from coming on the 18th due to transmitter trouble again, but hope to have everything OK so as to come on 12/24. This morning, 11/20, CB-57 was logged quite easily from 3:04 (when WMCA's carrier went off) till 3:20, when they faded down into the noise level, and were barely audible from then on. There was some QRM from a weak carrier on the frequency. The way these Chileans who are over 5,000 miles away have come through, makes me hopeful that the rest will be widely heard. Toughest one will be the WSTA special I suppose, on 1340 kc/s. TA reception has been spotty, but then it's amazing to me that they're coming through at all so early in the season. Some of the best heard stations that I ve logged in addition to those mentioned in my last report are the American Forces Network station at Landshut, U.S. Zone of Germany on 1106 kc/s., Rettlingen, French Zone of Germany on 1538, Ottringham, England, on 1295, Kosice, Czechoslovakia on 1286, Strasbourg, France on 1376 (loudest European heard here this season), All above leard after Midnight, EST.
