Dec. 11 - KRPL (1400) DX 3:00-4:00, KGPH (1230) f/c 4:12-4:30, WLBZ (620) NNRC DX-4:30-5:00, & WOOF (560) f/c 5:25-5:40, WCRS (1450) s/on 5:30. Dec. 13 - KGIB (1540) T/c 3:15-3:35, KBMX (1470) ET 3:30, WRHC (1400) f/c 3:45-4:00, KYAK (1400) s/off 4:02] WLVA (590) f/c 4:15-4:30, Dec. 16 - WFOX (1280) s/off 3:00, KERO (1230) s/off 3:59, WJEH (990) DX 4:00-4:30, KTXL (1340) f/c 4:30-4:45. WFAA on 570 kc/s. with R-7 at 7:15, and WBAP on 820 at 7:30. Finished up with KYLN at 7:48 and KSTP with QSA-5 R-8 at 8:10 AM. 12/20 - Listened only 54 minutes. Guess I'm about running out of the easy ones because I got only a couple of mid-westerners. At 6:45 heardWMC announce through KTHT, said they had come on at 6:30. At 7:04 on 1210 WCNT was quite strong here, had s/on at 7. WFLA, 970, was still on top on 7:10. Sat. I listened to a few Progressive programs to get mentions of affiliated stations; KVSM & KAFP are the nearest, heard KTUR also on PBS. At noon the network gives a salute to some station, a week ago it was WJEL, 1600, Springfield, O., the 16th, WIL, St. Louis, 1430. Histogy of the station is rather interesting, at times. But so far I have heard no sponsors. They won't last long that way. At 11:30 FM on 930 behind KHJ & KSEI I heard KIUP identify on regular sked. No network affiliation, so irregular station breaks. 12/17 I checked up on some of the f/cs & lack of them. Starting at 3, as listed, did not hear KEYY on 12:0, just KRNO & KSON, usual nuisances. Nor was KOAL heard, on 1230 kc/s. Still need both of them. KGFJ KGON & KERO were on 1230. On 1220, CJOC was not on, had been announced by NNRC. (Came on 1 day late). From 3:35 to 4, copied KWCO on 1560 f/c before I could get them to identify. Then on 1400 4:05-4:23 KOKO Babbled on without identification. Hardly worth verivying such drivel. KWKW was still on, so no WFBR if on. At 3:43 on 1400 KRPL announced a f/c behind KYAK, On 1450 KOBE was using music until f/c at 4, then TT. Didn't get KWMO on 1230, incidentally, KGFJ s/off then. No WKBW between KXRX-WCKY No KRKL, only XEG, no KPRO. KOBE OK, also KYOR same time on 1450. No KWJB on 1240. WPAMt∞ far. No KVNU on 610, & no KTNM on 1400. Didn't get WDSR WGTN nor KRJF, latter not on. Didn't hear WCPO nor KWTX if on. No KSFT (KSTR). At 4:03 KSYC announced during TT on 1490, pestering KWIK (goody!) Envelopes versus staples

During the past several weeks your publisher has received a few letters deploring the use of stapled bulletins and requesting a return to the use of envelopes. At least 2 members have sent in an extra dollar with their dues to pay to have their bulletins sent in envelopes!

So, I thought it would be best to ask for you members to write me and let me know what you think best. Here are the gigures. The use of staples instead of envelopes saves the club approximately \$15 per year and this savings is based on the cost of the last envelopes purchased in September, 1949. They have probably gone up since then. Just what this will mean in the cost of a membership I will not know until I start to purchase our years supplies again next summer.

I would also like to point out that we have had trouble using the addresser on the stapled bulletins and the use of envelopes might be forced on us for that reason alone, however, more on that later. I'm still experimenting on that end.

You might be relieved to learn that bulletins sent to prospective members, DXing stations, etc. are all sent in envelopes.

You might also be interested to know that your publisher felt the Club had saved enough money on the use of stapled bulletins that it could afford to send out the entire 12/16 bulletin via first class mail. He noted that it took 4 days for the stencils to come that week and felt that since the bulletin was being mailed late it might help to send it out first class and so it was done. Did it help?

So would you send your publisher a card of letter and express your feelings in the matter.

- 1. Do you want the bulletins sant in an envelope?
- 2. Are stapled bullctins satisfactory to you?
- 3. In case the majority of members are satisfied with stapled bullotins would you want to pay, saye 25 cents a year more to have your bulletins come in an envelope.

If you have trouble opening stapled bulletins we suggest you grasp the bulletin at the fold and open it up, the staple legs will straighted right out and can then easily be removed. Don't try it just one page at a time or else it will tear, take the entire fold.
