And whereas WIBG and WKDN could be heard every day on 990 and 800, those channels are now occupied by WLCR and WLAD. Other channels ####### weflect a similar change. I hunted for a good DX location & wound up in Elmhurst. Instead of the blank I dres previously, stations fall all over each other in their effort to let me hear them. There are a few recent veries that I'm really proud of. Caught WEMP going off air briefly 1 Sunday AM & managed to get enough of a report off to CJOB to obtain a nice verie letter. I also had a job vith KRUS who answered by letter, & HOL which sent a card Air-mail. Up to the time of the HOL special, my most distant station logged in America had been TGW. Then came the switch to Elmhurst & while I can't boast of the results that Lefty, Steve and others get (mine is not nearly so selective a receiver) still some of the results are nothing short of incredible. Tops in this category (I know nobody will believe me) was logging WKJB easily through local WOR. Naturally I reported them. Sorry for the delay." v/s James B. Tillis, Asst. CE. 2/8- WGAI (560) letter for DX 1/29. 2/8- WLBZ (620) letter for DX 12/11. 2/10-Looks like I hit the jack-got as regards verification for old reports. WVNJ (620) after 5 reports 2/18/49, 10/3/49, 3/3/50, 12/4/50 and 1/29/51. They sent a poor mimeo card to verify report of 10/3/50. v/s Bernard K. Kellow, CE, and WITH (1230) after 3rd report 2/22/49, 9/9/49 and 2/6/51. They sent a letter of verification. v/s Mariles C. Considine, Pro. Mgr. This letterhead looked very familiar so I looked over my veries and found it to be the same set-up as used by WLEE that I received in July 1949. These veries were for reports #9 and #16. My current report number is 868, so they are old. And these are my DX catches for the week: 2/6- WCPO (1230) all-night program heard easily over WNOR after WITH s/off at 3:00. 2/7- WTVB (1590) 2:05-2:17 s/off. I will be on about 3 weeks days breaking in, then nights from 6 PM to 6 AM. 4 days a week. Working different days each week, and every 3rd week working days from 6 AM to 6 PM. Loggings been 43- KMOD 1360 12/25; KAFY 550, KYAK 1400 13/28; KTUR 1390, KECC 990, KGIB 1540, CHUB 1570, KAHU 920 1/3; KENM 1450 1/4; KCIJ 980 1/5; XETK 1390 1/7; KDIA 1490, WGIG 1440, KSPT 1400, WIRA 1400, WRHC 1400, KGCN 1230 1/9; WKNK 1600, WATW 1400 1/11; KRTN 1490 1/12; KYMA 1400 1/14; KMUS 1380 1/15; KVIM 1570, WATM 1580 1/17; KLKC 1540, WELB 1400, WTAL ;270, WBAY 1360, CKXL 1140, WWPB 1450 1/19; KRLN 1400, KYJC 1230, KDZA 1230, WETO 930, CBE 1550, KIFW 1230 1/20; WTTS 1370, KVON 1440, KWRL 1450 1/21; WSMI 1540 1/22; KLMO 1050, WJEL 1600 1/24. As from 2/15 the 1400 channel is to be blocked by a local as well as 1340 which has been completely blocked for years. We've been rather disappointed in the few DXes listed at the height of our DX season- e/g. in 9 days (Jan5-13) only 9 were listed, whilst last year, 29 were listed. Our season is so short that reception of DXes after mid-Feb. is only a fluke. Also every season is becoming more difficult with locals stepping up their power with the consequent additional spread - every station in NZ is now 2000 watts or more, majority 10000. We get the DXes when every NZ & Eastern Australian is on the air with every channel occupied below 1520 whilst it appears to us US DXers have at least 26 channels open when tests are on & double that on Mondays. Veries total 1320, an advance of 50 in year out of 75.

Charlie Conley - 358 Market Street - Lemoyhe, Pennaylvania\_ Guess I played a dirty trick on "Pop" by sending one of my infrequent reports the week he cut the stencils! Since that report I have written to the following: (\* have veried) - CHNO regular \$\$0ff, VOCM\_DX, KAAA\_DX, KELO\_March of Dines, KMOD, regular, KVOO, regular, KXLA regular, WARD\* March of Dimes, WCRW-DX, WHOC-f/c, WHOW f/c, WIAM ET, WOV regular, WSKI\*-DX and WVAM\*-DX. In addition to the 3 veries shown, the following have been received to give me a one-a-day average for the past 2 weeks: HOL YNW CJCS KCBS KCOL KULA KWER KXEO WLBZ WNOK & WPIN. Nice cards from HOL & YNW with letters from the remainder. KULA, my 3rd Haeaiin with an attractive Hula dancer in purple ink and typed with a green ribbon! v/s was Charles D. Calley, Jr., of the Engineerind Depart, ent who said, "Reports of this nature are always appreciated and while some delay often occurs in replying, every attempt is made to handle these matters promptly." (They took approximately a month to ansswer even though I sent the report airmail and enclosed an airmail stamp.) KXEO replied on another attractive letternand which included a sketch of their station. However the letter was mineographed with the following written in - "Exact frequency during the test period cov-ered by your report was 1340.0024 kc/s." That is slicing it fine! Then, "Sorry to be so late. Busy on sonstruction work." was penned in also by Robert B. Bruner, CE, W4KDT WØKDT W8KDT. Indidentally their section of the country must be growing by leaps and bounds. On their envelope they show "Serving 30,000 radio families" while their letterhead has the number at 42,000! Have noted that many of the members report excessive noise the past few months. I at first thought it was all local condition but apparently it is not. However, this morning (2/11) we had a dilly which I am certain was a local product centered in New Cumberland (that is where I live and do my earstraining!) Tried for the 2 Canadians between 3 and 4 withoug success. KAAA came on during a lull in the QRN and I was able to get brief shatches from then to 4:30. Not a sign of 4VGM. However, and this is why I believe it was a local distubbance, was talking with Fred Van Voornees this evening and he mentioned the same trouble with the exception that he could hold KAAA through the racket. While KAAA was putting in a fine signal, the only 2 stations I could get a trace of benind the moise were WCKY and WCFL. In addition to normal power lines, we have a 66KV transmission line (which I helped to build some 20 odd years ago) running about a z-mile from my home. I certainly hope they haven't developed some leaky insulators, or, if that is the case, that they soon replace them! Thanks to WEDC, to whom I sent a thank-you card, both WSKI and WCRW came through fine at this location. WEDC thoroughly blankets 1240 here. Noted Eldon Addy's remarks in the 2/3 bulletin about WPIN.
