However, last Monday night (10/17) I hooked the five-tube Radiola onto the whip and did I DX! It's really a game with that rig, as the only way you can tell what frequency you're on is to wait for an identification. Logged what I thought was WiRL on 1600, but the QHM was so bad I couldn't get a signature. However, I sent 'em a report along with WTOP, for an addition to the log; WTRW, 500 watts, 1590 kc/s., Two Rivers, Wis. on a test, and our DX friend of last winter who still hasn't verified for the report and a follow-up, WKBI, St. Marys, Pa. on a f/c. Came through real well in 1400's usual hash. Also heard KICD's f/c very well on 1240. However, I have him from several years back so didn't report. AND just to see if it were possible, I fished around where I thought 1070 should be on the set and latched onto YSEB again, coming in better than I caught him on the Scott! If sent him a report last week. All that activity wore me out so I haven't tried anything since! Perhaps this weekend I'll work up enough steam to see what gives. It was really stronger than its major-powered competitor CBJ who was then testing too. 10/5, WRYO heard behind XEG at 5:15-5:30 as they conducted their monthly first Friday test with RCA\*Riverhead. 10/8 - HIKM heard with man speaking in Spanish at 7:30 p.m., near CBL on the dial. 10/11 - WSUN, 620, testing at 3:17. 1)/15- WKIN 1320 Kingsport, Tenn., ETing with a poor, intermittant signal at 2:00-2:15 when they s/off. KTYL, 1310, Mesa, Ariz. with its monthly test with a Kansas City monitor at 3:20-3:30, fair signal. KTTR, 1490, at 2:55-3:05 loud and in the clear. Musings of the Members Sid Rosenbaum - 805 Market Street - Wheeling, W. Va. New DX slumped here the past week. On two mornings I rolled out of bed at 4:00 and all I heard was a flock of tone testers that failed to identify. Was up late on 10/ 16 and 10/17 and this enabled me to pull in five new ones. Oct. 16 - KFRU (1400), KBTM (1230) and KSYL (1400) all on f/c. (Time in "D D the D" of 10/20). Oct. 17 -WKRM (1340) with a nice f/c (M) 3:30-3:00 and WXRF (1590) with regular f/c 3:00-3:15. WMON (1340) regular f/c 2:30-2:45, but not needed. The fourth Monday was a flop here due to heavy QRN. Oct. 22 - An mink own Kentuckian on 1490 with musical f/c. (Probably WKAY.) WCMI (1340) regular f/c 2:00-2:15. This one has always failed to verify so I passed him up. Another unknown with musical ET on 1490 back of the new all-nighter WSRS, Cleveland Heights. WLCk (1450) f/c 2:15-2:30 - must f/c bi-monthly as heard at same time on first Monday, 10/1. The third unknown of the morning on 1490 was a "W" on ET (M) at 2:30. Typed on card was 100-250 watts, but failed to mention when 100 watts was used. WAKE and WHM sent nice letters. On 10/18 a Spanish-speaker was heard on about 1305 kc/s. at 4:15. Seemed to be regular program as they used gong at identifications. I have asked KOLS to throw in a little Convention Comedy on their DX and have written XERF regarding a stand-by of at least 30 minutes. That

does it from here. Hal Williams - 50 Third Avenue - Seymour, Conn. Four new reports and a couple of second reports sent out this week. (850) Albany, N.Y. booming in here at 6:15 a.m. with early-a.m. news over WHDH. Unusual for a 10 kw. to overpower a 50 kw. station. 10/16 - WKIN (1320) Kingsport, Tenn., M/ET 1:30-2:00 asking for reports and phone calls. WKBI (1400) St. Marys, Pa. My request for info on WKBI in "DX Yews" brought a tip card from Gus Magnuson, so I picked them up again this AM on f/c and sent a second report addressed to Galen D. Castlebury, CE, rather than to the station. Heard a TT on 910 kc/s. from 2:38 to 2:54 without a break - thought it might be WPFB - Middletown, Ohio who did not verify my 8/14/50 report, but at 2:58 station break, found it to be WGBI, Scranton, Pa. I felt like pushing the NC57 out the window - 20 minutes of TT from a station I did not need. WTRW (1590) Two Rivers, Wis. long M/ET signing off at 3:35, excellent over XEMC. WLOF (950) Orlando, Fla. TT/f/c 4:00-4:15, heard under WWJ. No answer from 12/19/50 report so a second report today. WIPC (1280) Lake Wales, Fla. TT/f/c 4:45-5:00. 10/21 - WBSC (1550) ex-1400, Bennettsville, S.C. S/on 7:00 a.m., 30 minutes of transcribed French operatic music, fine clear signal. Announced as South Carolina's most powerful station. That new station list compiled by Len Kruse was directly responsible for my getting two new stations, WKIN & WTHW. Thanks, Len. With the report to WBSC my reports now number 960. Five veries have been received to make a total of 761. 10/17 - WPAR (1450) nice letter for f/c 10/10, after second report. WTRF (1290) Bellaire, O. Here is the most novel and unusual verie in my collection. In September 1950, Sid Rosenbaum sent me snapshots he had taken of transmitters in the Wheeling area. Having verified WWVA and WMOD, I filed the snapshots with the verifications, and as I needed WTRF and WHLL I wrote WTRF on doublecard in July requesting info on their f/c. The CE returned my card saying no regular f/c, but a daily s/on at 6:50 a.m., prevailing time. So on July 23 I picked them up and sent a report asking for a verie but no reply, so I sent a nice follow-up letter in October enclosing the snapshot Sid sent me. In a few days the snapshot came back with verification of my July 23 report typed on the back of the snapshot! It is signed by the assistant CE. (v/signer given seperately). I wonder if anyone else has such an unusual verie? 10/19 - WXKW (850) by letter, 10/20 WSUN (620) by letter and WMBL (740) Morehead City, N.C., QSL card for 10/14 report.

Pat Reilley - 11 Irvine Place - Jamestown, New York New veries are KOSY WOKE KMOD. 10/16 - WGBI, 910, test at 3:30 - very noisy today. 680 had KNBC WPTF & WPIN all scrapping to stay on top at 3:35. frequency on 695 Kcs., and comes through well evenings.

YSEB on 1075 Kcs. continues to keep EL SALVADOR in the limelight with consistent signals all evening. The neighboring country of COSTA RICA is well represented this week with TIGPH (605), TIPG (625), and TIFC (995) reported by Lefty and Hal Wagner. Hal also adds TIHB (685), and TIW (767). Hal says that TIW announces as "Radio City", San Jose, and was on 763 last spring. Lots of good DX here for anyone needing Costa Rica.

Turning to the islands, Rog Anderson is getting WIPR (940) through most evenings after twilight. This is PUERTO RICO, of course. Lefty reports CMCF (910) on top of the freq. on 10/22 at 7:20 PM. CMCK (980) was also coming in good the same evening. There is a Cuban operating on 1092 according to Hal Wagner, possibly GMKR, however, not identified

yet positively.

This might be a good place to list a few split frequency stations in Spanish which have not yet been identified. Hal Wagner has them on 735, 755, 1042, and 1285. Both Hal and Rog Anderson hear one on 1072.

And from the North American continent, we turn to South America and to COLOMBIA first. Lefty has a verie from HJKM, air mail both ways and back in 8 days. Address: "Radio Cristobal Colon", Carrera 7a, No. 19-70, Bogota, Colombia. He has also logged HJKO (830) under CMBZ at 11 PM.

In VENEZUELA, Lefty has logged YVMF (1119) "Ondas del Lago" in Maracaibo 8:30-10 PM and later with hardly a trace of KMOX showing.

ARGENTINA is represented with Erick Johnson reporting three of k them on 10/20 with what sounded like political speeches with lots of cheering. He had LTI (780), "Radio del Literal", Rosario; LWI (790), "Radio Splendid" in Cordoba; and LR4 (990), "Radio Splendid" in Buenos Aires. The latter is supposed to have moved to 950, but is apparently still on 990. These three would be good ones to watch for the morning of 11/12 after the Argentine election. These three are nice DXing.

JAPANESE stations are reaching the Pacific Coast now with Jim Critchett reporting AFRS Tokyo (770) on 10/13. From Gene Allen via Carroll Weyrich of the NNRG, we learn that he has heard AFRS Sendai (1430) S-8, 4:58AM 10/3; and on the same date an unknown Jap S-7 on 1210 at 5:05 AM. On 10/13 he had JOKP (980) with S-6 signal at 5:03AM.

The final stops on our DX tour of the world this week are the down-under countries of AUSTRALIA and NEW ZEALAND. Our reporter is Bob Sanderson, and he sure makes us all wish we were living in British Columbia too. First in Australia on 10/8 2BL (740) Sydney at 8 AM, S-7-8 signals. Then on 10/17 3AR (620), Melbourne; 2NU (650), Manilla, NSW; 4QS (760), Dalby, Qsld.; 3LO (770), Melbourne; and an unknown on 850, which he believes is 2CY in Camberra. NICE DX.

His list of New Zealanders is equally impressive and reads as follows: On 10/12, 2YA (570), Wollington; 5YA (690), Christchurch; 4YA (780), Dunedin; 3YZ (920), Greymouth; 3YC (960), Christchurch; and 2ZE (980), Wollington. These heard between 5:15 and 6:30 AM.

FOREIGN DX DIGEST continued.
Bob had an excellent morning for Zedders on October 17, and reports the following heard that morning: 2YA (570), Wellington; 2YC (660), Wellington; 3YA (690), Christchurch; 1YA (760), Auckland; 4YA (780), Dunedin; 1YC (880), Auckland; 4YC (900), Dunedin; 3YZ (920), Greymouth; 3YC (960), Christchurch; 2ZB (980), Wellington; and an unknown on 1010. Bob, isn't the one on 1010, 2XG in Gisbourne? He was reported last spring, and verified by Pat Reilley. Sure would like to see some of these stations coming in over this way, but we can't have everything. Incidentally Bob reports that he has a new S-20-R receiver and a 32' antenna, and is expecting big things from it. He has recently reported to 7NT and 2BL.

I would like to report a very pleasant evening spent last Friday with Carroll Weyrich, one of the NTRC BCB editors, at his home in Parkville, Maryland. We appreciate the nice things he had to say concerning our column, and we in turn think he is doing a great job with

both his column in NNRC and his broadcast band log.

From the New Zealand DX Times come the following temporary frequency changes for Australian stations: 2DU and 7BU to 810 Kcs.; 2NA to 820 Kcs.; 4QY to 890 Kcs.; 2LT and 4RO to 1080 Kcs.; 7ZR to 1160 Kcs 2MO to 1370 Kcs.; 2AY to 1480 Kcs.; and 2BE and 4ZR to 1490 Kcs. Also from the "Times" AFRS Secul soon to move from 610 to 1520 or 1600 Kcs. with 50 KW. Pyongyong, North Korea, is on 665 with 250 watts; Peking, China, on 1010 Kcs. with 20 KW. New Philippine at Dugapan on 1040 Kcs. JOSP listed last week on 620 is apparently operating on 610. Peking, China, is operating on 640, 700, 720 as well as 1010. Singapore is on 620. Philippines heard include DZRH (650), DZAS (680), DZFM (710) DZMB (760), DZST (860), Manilla (920), and Dugapan mentioned above. Indians at Hyderabad (730) and VUA3 (780) also reported. Japs heard in New Zealand include JOIK (570), JOSP (610), JOHK (890), and JOKP (980)

Voice of America programs in Korean and Japanese are being broad-cast over JOLK (550), JOAK (590), JOFK (790), JOAB (950), JOBB (830), JOHK (890), JOHG (990), JOQB (1030), JOFB (1050), JOTK (1110), JOTB, (1330), and JOHC (1350). While mentioning Japanese stations, all DX reports of reception for any station can be sent to Mr. Isamu Yamazaki, Chief International Broadcasting Section, Radio Tokyo Bldgs., Tokyo. Please be sure to specify which station you are reporting and underscore that is is a broadcast band station. Reports to AFRS stations in Japan can be sent to Japan Logistical Command, APO 343, C/o Postmaster, San Francisco, California. Most recent signer was a Major Tidwell. You may, of course, write any station direct, but both of

the above sources have verified reports in the past.

Once again, let me thank all of you for the excellent support you have given this column. Please keep it up. Many of you are still including foreign items in your "Musings". We have no objection to that, but won't you please also put the foreign items on a post card and send them to me so that we can really have all of the foreign DX being heard by club members in one place.
