For the benefit of our newer members, and to refresh the memories of the DXers who have been with us for some time, we thought we'd devote this page to some explanations of various features and proceedures in connection with "DX News."

THE DX CILENDAR

Daytime stations, as the general rule, are not permitted to broadcast DX programs, or any scheduled programs between sunset and the following day's sunrise. However, they may conduct frequency checks and tests between midnight and 6:00 a.m. local standard time. Therefore, any programs arranged by our Courtesy Programs Committee from daytime stations are TESTS and are listed that way in the DX Calendar. On such programs, confined generally to g hour's duration, no mention of the NATIONAL RADIO CLUB may be made. However, these tests have been arranged for your DXing by our Courtesy Programs Committee, known as the CPC, and are treated in the NRC DX Special Contest just like DX programs from full-time stations. Now some daytime stations operating on regional frequencies (Example: WACE-1380) may sign on for commercial broadcasting any time after 4:00 a.m., local standard time. So, NRC-arranged DX programs are listed under "Legend" as N*R*C and NRC-arranged tests are listed T*E*S*T. To our intent - logging the station - there is no difference. In fact, all DX programs are actually tests, as the station is testing its ability to get out to distant locations.

With programs arranged by the Newark News Radio Club, DX programs are listed under the "Legend" column a: "NNRC." NNRC-arranged programs from daytime stations are listed "test" in small letters, to distinguish the program from one arranged by our CPC staff, listed in caps.

In giving credit for arranging DX programs, we add "Arranged by D.X.Nutt" but with daytime stations, we cannot list such a program as arranged by anybody, for that would make it a violation, so we give the credit by taying "Information from D.X. Nutt" at the end. This is a technicality, members, but must be adhered to, since the station might otherwise get in trouble with the FCC otherwise. Remember always that every issue of "DX News" goes to the FCC office in Washington as a courtesy to them for the consideration they give to us in supplying us with all the latest changes in station data. So lest anyone think we are slighting any CPCman or station, we thought we'd take the space to give you a full explanation.

MUSINGS OF THE MEMBERS

Every member is invited to send in reception reports for these pages, whether he has been in the club 19 years, or 19 minutes. We especially desire to hear from our new members, whether they are new in the DX game or not.

We generally put the shorter reports towards the bottom of a page, for it is easier to judge whether it will fit in the available space. We try to publish your reports word for word, unless we note grammatical errors, etc. If we find ourselves running out of space as we get toward the bottom, we will then abbreviate a bit so as not to run over to the next page. We try to make every page a complete piece, rather than carry over to the next page, feeling it is neater that way. Once in a while it becomes necessary to carry over, but not very often. So if a word or two is omitted, that is the reason.

Few of us know apything technical about radio broadcasting equipment, so we suggest that such items not be included, unless they refer to receiving equipment or antenna patterns. Great detail in technical matters is for engineers, and such is not the purpose of the NRC.

Please remember that details of the program, verie-signer's name, type of show, any comments by the verie-signer, should be sent to the Editor. Our deadline is Wednesday, don't forget. That means that a program is written up in the last issue to be received before the program is due. A Monday DX is written up in the "DX News" of the previous Monday, so for Tuesday programs also in case you don't get "DX News" on Mondays. So the Editor MUST have DX Program information <u>14</u> days in advance of any DX Program or TEST in order to get that information to the members. If shorter notice than that is received by any of you, it should be sent IM EDIATELY to Harold Wagner who will send out special cards to the entire membership.

Please list everything in E.S.T. - DX programs, and times in your reports. Thank you.
