FRED L VAN VOORHEES-BOX 132-LEMOYNE PENN It has been almost a month since my last report, so it is about time for me to appear in the "MUS-INGS" section, altho most of you are probably tired of me by this time elsewhere in the bulletin. The local paper back on Long Island (Which I still get) says that WALK-1370 kcs in East Patchogue, L.I. does not plan on taking the air until March. This is probably a little early to look for them. WEXL-1340 used to hear this one all the time, now s/off 0200. 1/5 WCVS s/off 0100; 1/6 WHEC-1460 s/off 0100 & WPRS-1440 new station 500w days F/C 0125; CKSM-1220 NRC-DX strong but a little puzzling. WTYS-1340 F/C 1st SUN hrd 0345. KVET-1300 TT at 0420. 1/7 WCLD dedicated "Dixie Jump" to Don Kasky. KWCE-1300 at 0115 with a test, thanked DXers for letters. WOL-1450 test. KSUB-590 test S/on 0800 and off 0115. Two 250's from Calif, KYOR 1450 and Blythe and KICO in Calexico 1490; 1/8 WQAM-560 reg sked 0015-0030. WDYK-1230 prayed 0100 s/off 01.02. KPH0-910; WGCM-1.240 f/c 0325 2nd TUES, What Wisc station was testing on 910 kc with open carrier on 1/8 from 0230-0245 or so Ident at 0245 Loud but I was dozing I guess, sounded like Richlands or something like that. 1/3 Hrd WCSC-1390 TT w/music 0230 6n, WSEA-910-0245 and 870 kcs Radio Jamaica again. WAWZ-1380 testing with carrier lately.
