This DX season is rolling right along, & while I'm not getting some of the exotic stuff I was getting this time last year, I am getting out one or two reports a week to previously unverified stations. Three more veries are back: Algeria-548, by a v/1-FF, Radio London-1133, a v/q; & BBC-1340 Lisnagarvey, v/1. The latter is my first U.S. graveyard channel TA. On MM 10/25, I went into ecstasy - of sorts - on finding WIBG-990 off the air, & went on to log "Radio Peninsular" Madrid, 989 kc/s., at its s/on @ 1:06am, ythrough a very strong signal from CBW. I never did hear much else that AM. On 10/26 I found chronic non-verifier TGW down on 637.5 kc/s., so tried a report, for reception at 9:15pm. On 10/29, & again on 10/30, I got nice copy on Radio Espana-854 Madrid between 6-7pm. Sounds like their power has been increased. MM 11/1: KNWS-1090 in easily, 3-3:30, Dave Schmidt arranged that one, so I would say he's off to a good start as a member of the CPC gang. I didn't dig KBEA-1480, though I heard a couple of stations there, & don't think KXXW was on. WFKN-1220 had a strong signal @ 3:45am. I found YVNZ-1020 in Maracaibo, Venezuela IDing as "Radio Calindario" coming through S-9 plus @ 4am, so copied for a report. Never know who you'll find on 1020! What I would like to know is, who on 1460, between 4-4:30am had a gal DJ, & was playing old standards like "Frenesi" & "Get Happy?" I was all set for an ID when WPON signed on at 4:30' spoiled my fun. The station in question was too weak to be WMBR. On 11/3, at 5:30pm, I had an SS on about 652 kc/s. & I almost flipped, thinking I had Spanish Sahara, only to discover it was "La Voz de San Isidro" in the Dominican Republic. The Dominican Consul in NYC tells me this station is Army operated. On 11/4, I logged CHLO-680 atop frequency during most of the evening, particularly from 10-11pm. 11/5 & 11/6, I noted the West German Sudwestfunk station on 665 atop everything there from about 6-8pm. On 11/6 @ 6:15pm, I heard "Radio Demarara on approximately 761.5 kc/s., hetrodyning WJR, & giving time as "7:30." 73s.

MM 10/18- BBC-1214 @ 1:45 w/Light Programme - mx & announcements w/low bass voice, made ID difficult. QRM from XEB & WCAU's OC. 10/21- GE-527, Greenwood, N.J., radiobeacon. MM 10/24- KOMA-1520 @ 11:07pm. MM 11/1- For some reason, I couldn't pull in KBEA DX, but logged WRDW-1480, also testing. Weak station on 950, not WPEN or WWJ, had programm w/Ray Charles singers & something about University of Colorado. If it's KIMN, it's #1 Colorado. Anybody know for sure? I've been looping out locals (anything to 500 miles, hi!) & I don't even have a loop! I just take a reading in degrees from an aero. chart & turn the Wavemagnet to a 90° angle. Trying for RTF-944 or 836. A friend & I are building a low-power unlicensec XR a la FCC Sec. 15/201, w/100 mw or so. Will mostly be on 640, w/tests & junk on 750 & 1200. Details when finished. 73.

Reception continues to be excellent. One new country this week: Radio Kuwait-1345 logged as country #112. Not a new country but still worth effort is the station on 1394 around midnight that is almost certainly the BFBS station in Tripoli, Libya. Last MM wasn't worth the effort; JBC & WSB killed JOIB-750; CBC LPRT & unID SS killed Japan-1370. To top off a miserable MM, Auroral absorption killed any chance for Asian splits. I would suggest anyone needing Liberia, try 650 on MM after WSM goes off 1:30 & anyone needing New Zealand watch 660 around 4am & 880 around 5am. It's hard to believe but WCBS-880 is the last clear channel station to come back on MM; they're off so late that perhaps a Peking outlet might sneak through around 5:10. When I got KZOO, Honolulu-1210 two weeks ago, I thought that Cuban & HJer had stopped ANing - 'taint the case, unfortunately. Alan Merriman: Your reception of ELBC to 1:38 s/off on 11/1 is exactly the same as mine on that date; in this case at least, Coastal & inland RX sites encountered identical TA fadeouts. ELBC continues to go out about 21 minutes past the E20 time. I have quite a bit of evidence that indicates the "extra" signal heard is the result of magneto-ionic splitting, a phenomenon much too complex to program, much less run on the computer available. Most observed f/out checks w/E20 quite well; occasionally an error of some 20-80 minutes is encountered, however. This seems to be the effect of the Earth's magnetic field on the signal: the signal is decomposed into two "components" w/different properties, the ordinary & extraordinary components. It's beyond present knowledge to predict how much energy will be partitioned to each component & this is significant since the "depth" that each component penetrates the ionosphere is rather different; therefore slightly different "paths" are involved. More data is needed & I hope to conduct an experiment w/the aid of the NRC membership which can help elucidate much mechanisms. Last year at this time I did a series of experiments designed to yield info regarding ionic recombination equations by observing f/in times for TAs. This year I'm repeating them as part of the Asian project. Last year I could detect Portugal-782 one hour & 42 minutes before my sunset; this year I detect carrier two hours before sunset & had readable audio one hour & 41 minutes before sunset. That's real daylight TA DX!

Here is a factor some of the Loop fans fail to realize. Waves arriving at the point of reception via ionosphere have random polarization & wave angles, & this can introduce errors. Loops are ideal for this purpose IF ONLY THE GROUND WAVE IS PRESENT, providing also the location of the loop is such that false bearing are not caused by reflections from nearby conductors. Shielded loops eliminate this latter effect, but only a small amount of signal is received on shielded one. The smallest loop should have a total wavelength of at least one-half wavelength long. (How's Winnie, Perry? Hi -ERC)

A DX NEWS SPECIAL "INFORMATION SURVEY"

Recently the NATIONAL RADIO CLUB officers decided to attempt something new in the way of securing information for its membership, such as the regular hours of operation; information concerning frequency-check transmissions, proof of performance tests, or any other tests stations may conduct. Then, too, if stations would decide to conduct a "test" in the wee hours of the morning, especially for the DXers, we would suggest the best possible date and hour so that the test might be heard by the greatest number of listeners.

200 stations have been contacted, each of which received a letter and return card. It has been proven by this survey, that the number of stations having their FC's conducted during their regular daytime operations is increasing steadily with the many mobile monitor units now in operation in the country. The following is the information secured to date which we hope will aid many of our members. All times listed are EST, unless otherwise noted.

- KMRE Anderson, California (1580) 1000 Days--Letter returned by the Post Office marked "Out of Business".
- WZBN Zion, Illinois (1500) 250 Days--Letter returned by the Post Office marked "Address unknown - insufficient address"; so evidently not on the air yet, although some DXer reported logging this station several months ago.
- KANB Shreveport, Louisiana (1300) 1000 Days--Letter returned by the Post Office marked "Out of Business since March 1965".
- KFAZ Liberty, Texas (1050) 250 Days--Letter returned by the Post Office marked "Station off the air".
- WBOX Bogalusa, Louisiana (920) 1000 Days--Ralph Blumberg, President of the Magic City Bdcsting Corp. wrote "Station forced off the air by the local Klu Klux Klan" across return postal card.
- WMQM Memphis, Tennessee (1480) 5000 Days--has frequency-check measured in daytime; sign-on 7 days at 6 AM CST, and sign-off at local sundown. Harry Simpson, Chief Engineer, has consented to DX TEST on Monday, December 6, 1965, from 3:00-3:30 AM EST.
- WTCA Plymouth, Indiana (1050) 250 Days--has their frequency-check done during their regular hours of operation. Their sign-on & sign-offs varies from month to month. In Nov. 1965 s/on 7:30 AM week-days, and 8 AM Sundays; and sign-off 5:30 PM CST. Mr. Kenneth E. Kunze, Owner, will DX TEST using tone, on early SUNDAY morning, December 5, 1965, from 3-3:30 AM EST

Thank you for the sample bulletins. I find them quite well done. Enclosed please find \$5.00 for membership. I noticed from the sample bulletins that some West Coast listeners were having quite a bit of trouble identifying certain TP stations, especially what might be Burma on 955 kc. I have a test that might be of aid in some of these cases: try to see if known short wave signals which are listed as parallel to BCB signals actually do parallel them. Take good old Burma for example. The WRTVH shows the 955 kc signal operating parallel to two short wave outlets. Since the 6035 kc (50kw) Burma outlet is easily receptable, it would make a good parallel signal. The lack of parallelity between two signals would obviously prove little, although it might acquaint the listener with a familiarity of the broadcasts of a certain country. But if the two signals are parallel, the identity of the BCB signal becomes known. Such a test would most likely work for Burma, since 955 kc and 6035 kc are indeed parallel. I have heard the Burma Broadcasting Service announce the use of these two frequencies as their home service transmissions went into English at 1430 GMT. (Welcome to the club, Bob. I am sure John Callarman will appreciate hearing from you as often as you can.)

- 535A GRENADE. W.I.B.S., St. George's. I've been hearing an English program here, British accent, off and on at 1800-2000. Never really readable and QRM from tone and CW station; seldom stays audible more than 10 minutes at a time. (Drauner, Pa.) This is what's listed, Joe. (Ed.)
- 566 IRELAND. Athlone. good signal 1730 on 11/5; at 1806 another station just below, possibly Berlin. (Dangerfield, Pa.)
- 575 UNID. Oriental. Sounds like Pyongyang. 11/8 possibly parallel 635 at 0632, not parallel 655 or 785, which were, but 725 wasn't either. (Seaver, Calif.)
- 584 SPAIN/UNID. T.A.(2). On 11/8, Madrid was dominant here from 0000 although a second TA, DF'ing correctly for Wein, was visible. By 0210, only faintest traces of presumably Wein were visible; at 0214 another carrier came on. Almost certain this is Faroe Islands. Hard to get audio here due to local on 590. (Nelson, Mass.) R.N.E., Madrid, noted with 12-note IS on guitar 11/2 0005, good. (Wood, Ind.)
- 600 EL SALVADOR. YSNK, R. Exito, San Salvador. Logged past 0100 10/31. Announces slogan frequently. (Schatz, Fla.) UNID. "La Voz del Siglo Veinte" heard past 0100 10/31. Who? (Schatz, Fla.)
- 620 CHINA. R. Peking, possibly in Heilungkiang. 1/7 at 0600 6 pip IS, 6th high, but all with lower pitch than 645, 760, etc. (Seaver, Calif.)
- 625 COSTA RICA. TIRICA, La Voz de la Victor, San Jose. Nice signal 11/8 after 0600 s/on. (Seaver, Calif.)
- 629 AS. RUSSIA. Vladivostok, R. Moscow Far East Service high 11/8 at 0630. This is usually my key to good Far East openings. (Seaver, Calif.)
- 638 CZECHOSLOVAKIA. Prague very high with IS 2225; s/on 2230 w/woman announcer. (Nelson, Mass.) UNID. L.A. here 11/8 at 0605 w/music, het from CMC and Pyongyang makes this rough. TGW? (Seaver, Calif.)
- 640 GUATEMALA. TGW, Guatemala, now back here, looped through CMC etc. Till s/off 0107 on 11/4. (Wood, Ind.)
- 644 ANTIGUA. Antigua & Barbados Br. Service, Ottos. New FBIS log says 5 kw for this one soon. Watch for it. (Schatz, Fla.) Do they still operate on this channel, or are they on 620 kc. as WIDXA indicates? (Ed.)
- 650 COLOMBIA. HJKH(?), Emisora Monserrate, Bogota. Noted AN at good level 0406-0420 11/15. Played many familiar North American instrumentals. I definitely hear THIS slogan on this channel. Call letters HJKH still or HJXX? (Callarman, Texas)
- LIBERIA/UNID. L.A. ELEC continues to come through until about 0138 on MM's when WSM is off. Very weak SS at the time is a mystery; rough DF says SA, which rules out R. Sahara. What's the chance that this is a Deep So. American - say CX-6? (Nelson, Mass.) Until 11/15, Gordon, the Colombians had been abnormally weak on their AN shows here in the Panhandle. No DF for Bogota! (Ed.)
- 654 UNID. Unknown station, presumably UFO of RHM & LEG, noticed 11/8 at 0620, strong het only, no audio. (Seaver, Calif.)
- 660 NEW ZEALAND. ZYC, Wellington. Weak piano concert DF'ed Pacific 0330 on 11/8, but not good enough to warrant wasting time on. (Nelson, Mass.)
- 665 W. GERMANY. Bodenseesender, atop freq. 11/5 at 1800, and on 11/6 1930 to 2000 s/off. Had one and sometimes two stations behind, one being Lisbon. (Dangerfield, Pa.)
- 670 GUATEMALA. TGRT, R. Fabulosa, Guatemala, heard 10/25 at 2253 ID, bullfight (or similar sporting event) in progress. (Seaver, Calif.) They carry many, many sporting events of an evening. (Ed.)
- JAPAN. JOK, Osaka. First Net station only fair 11/8 at 0434-0500. (Seaver, Calif.)
- 675 NICARAGUA. YND, Union Radio, Managua, presumed to be the strong LA 11/7 at 2348; Sunday evening the best time in S.D. as XETRA is off 2300-0000 for La Hora Nacional. (Seaver, Calif.)
- 677 JCRDAN. Getting occasional bits of this one between 2230 and 2300, but so far, no report. (Dangerfield, Pa.)
- 683 SPAIN. C.E.S., Sevilla, not scheduled AN, and do not believe on AN. Usual s/off 1910-1915. (C.E.N.E., Barcelona, 737? is, however, AN.) (Wood, Ind.)
- 690 JAPAN. JOAB, Tokyo. Noted 11/8 at 0656. 690 clear of XETRA from 0500-0730 or so. (Seaver, Calif.)
- 695 UNID. Oriental. LEG says gave Chink pips, only a het 11/8 at 0620. (Seaver, Calif.)
- 700 CHINA. R. Peking, Kingsu(?) presumed weak station 11/8 at 0625 in Mandarin. (Seaver, Calif.) Chiangu Region- al in Nanking shown here by FBIS. (Ed.)
- 701.0 UNID. T.A. Weak 1633 on 11/10; brutal QRM from Morocco. (Nelson, Mass.)
- 701.117 MOROCCO. Rabat is measured here on 11/10; makes audible het with any carrier on 701 proper. (Nelson, Mass.) This significant, methinks, that all B.D.C. stations are shown in E.B.U. as measured precisely on channel. (Ed.)
- 707.68 EGYPT. Cairo measured here on 1710 on 11/10. (Nelson, Mass.) Cairo must be the Arabic speaker heard 11/10 at 2300 on 708, but faded quickly. (Dangerfield, Pa.)
- 725 NORTH KOREA. Pyongyang Outlet weak on 11/8 at 0425, parallel 785 kc. (Scrimgeour, Calif.)
- 730 CHINA. R. Peking 6 pip IS heard 11/8 at 0700, right after JOCK's, right before WPAL s/on, and all through XETRA. Sounds like there might be 2 Chink IS's here, had an echo effect, whereas JOCK's didn't. (Seaver, Calif.)
- JAPAN. JOCK, Nagoya, first net, clear parallel 670 at 0510, nice w/KFOD gone. Pips at 0700 also. (Seaver)

- 746 HOLLAND. Hilversum I almost surely the one with concert music, including one tenor vocal, mostly instrumental though, with female announcer between 0316 and 0331 11/15. (Callarman, Texas)
- 750 ALASKA. KFQD, Anchorage. Only fair 11/8 at 0430. Cuts down JOID a little. (Seaver, Calif.)
- 760 IRAQ. Baghdad's switch from 764 was in response to Swiss complaints about Sottens QRM. Transmitter was made by Brown Boveri, in Switzerland! (Wood, Ind.)
- 761.5 IR. GUIANA. ZFY, R. Demarara, Georgetown, at this spot recently; very clear 11/6 1800-1900. (Dangerfield, Pa)
- 764 SENEGAL. Dakar with good signals daily until 1900 s/off. No QRM and good clear French received. (Calkin, N.B.)
- 773 EGYPT. Cairo heard weakly 11/2 at 1815 with Arabic program and music. Heavy QRM from WADC. (Calkin, N.B.)
- SPAIN, R.N.E. Valencia, very strong at 1907 on 11/8. Seems to be on after 2000. (Dangerfield, Pa.)
- UNID. Something noted here at 0315 11/15, but I was unable to get anything readable. Possibility of Radio 390? (Callarman, Texas)
- 780 CUBA. CMJN, Camaguey, moves here from 960; delete CMHD. (Schatz, Fla.)
- 782 PORTUGAL. CSD-, R. Clube Portugues, Miramar. Very good S-6 to 7 at 0313 11/15. Unneeded. Squeals with Cuban on 780 and the CC on 785 AM, which was there AM of 11/8 as well. Barbados leaving carrier on? (Callarman, Tex)
- PORTUGAL/WEST GERMANY. Miramar detectable 1429 on 11/11. Readable audio at 1450 on 11/10; that is One Hour and 41 minutes before local sunset here. (Nelson, Mass.)
- 795 CHINA(?). U.F.O. here does sound Chinese, no IS 11/8 at 0400, right through hour with classical music. More difficult at 0500 due to PJB. (Seaver, Calif.)
- 799 UNID. Oriental. U.F.O. here sounds like Pyongyang, 11/12 at 0400 was under PJB CC, so no dice. PJB my most-hated station. UFO not parallel 785 at this time. (Seaver, Calif.)
- 808 UNID. L.A. Heard 11/8 at 0535, HJEW or TIGPH-2? No ID when in. (Seaver, Calif.)
- 809 SCOTLAND. D.B.C. Durghead/Westerglen. Right on top at 1730 on 11/9, with Madrid behind. Then I discovered that WGY was probably temporarily off the air due to the power failure. (Dangerfield, Pa.) Madrid back on 809 from 800? (Ed.)
- 810 PUERTO RICO. WKVM, San Juan. Noted 11/7 with Spanish ID "WKVM" at 2303, but none at 2300. Easily separable on loop; otherwise level with WGY. (Wood, Ind.)
- 818 EGYPT. Daira good around 2300 with Arabic music and talk. Particularly good on 10/18 for new country. (Calkin, N.B.)
- 820 VENEZUELA. YVSH, R. Guayana, Upata (despite what WRHB and FBIS say) is noted here 11/15 as early as 0356, and logged well 0422-0431 11/15 with tropical music and announcements between every other record. Very bad audible heterodyne caused either by YVSH or QRM'ing HJED being slightly off frequency. AN now? (Callarman, Tex.)
- 827 BULGARIA. Sofia heard with Arabic programming on 10/18, weakly around 2320. Thanks for previous NRC for this tip. (Calkin, N.B.)
- 828 NICARAGUA. YNOL, Managua, gone here apparently. Heard with religious programme on 10/17 in English at 2235 on. S/off immediately before arrival of Sofia 1 kc. lower. (Calkin, N.B.)
- 833.03 LIBYA. D.F.D.S., Benghazi, still being heard most nights around 2345, but with rather poor signals. Most nights, I don't get any carrier until about 2332, but on 11/8, there was a carrier when I tuned in at 2315. Signal seems to peak nightly around 2345-0000 but I've only heard readable audio after 0000, so not sure when programming begins. Man in English at 0000 sounds like he has mush in his mouth; I suspect that it's a D.B.C. relay at that time. Gone by 0025 at latest. (Nelson, Mass.)
- 834.93 UNID. CHINESE. Politically, it seems highly improbable that No. Korea would relay Peking. Is not firmly on Chinese side in dispute. (Wood, Ind.) Announces as Kiangsi, China. 4 solid ID's now heard. Time pips (longer) differ from 843 kc. outlet. Also earlier fade-in. Is this ex-840? Or Dairen rebroadcasting Kiangsi? Why 2 Kiangsi outlets (different format) within 8 kc? (Obviously different locations??) (Scrimgeour, Cal) Try this for size. Nanchang is the capital of Chiangsi province. Nanching is the capital of Chiangnu province. FBIS shows Nanching on 820-V, meaning the frequency varies. Nanching is located 295 miles S.S.W. of Nanchang, so might want to fade in later! What's chances of Chiangsu from 820 on 843 and Chiangsi from 840 on 835? Does this confuse the issue or issue the confusion????!!1000 (Ed.) Computer, please! (Ed, again.)
- 836 FRANCE/LEDANON/AZORES/SPAIN. The situation here is very clear, and Beirut certainly does stay on late irregularly. Until Nancy RTF s/off around 1800, 4 carriers are visible and DF is dominated by RTF. Nancy's carrier off right away leaving 3 carriers (2,9 cps between Beirut and RNE; 44.5 cps between RNE and Azores). On 10/15, 10/16, 11/4, 11/8, and 11/10, Beirut was good at times between 1800 and 1820 with Arabic vocal music. On all nites, Beirut stops playing Arabic music at about 1820 and instead plays Western music. Beirut's carrier off: 10/15 at 1830; 10/16 at 1830; 10/17 before 1835; 10/18 at 1836; 10/24 at 1858; 11/4 at 1835; 11/5 at 1835; 11/8 1830; 11/10 1834. Except on the indicated dates, no Arabic has been heard past 1830. Perfect DF for Beirut when Arabic up; when Beirut s/off, bearing shifts to Huelva/Azores area. Azores tends to dominate after Beirut off; usually has pop or semiclassical music (e.g. "Song of India," Perez Prado) until about 1854, when man speaks in Portuguese. On 11/10, however, man spoke continuously from 1836. Usually a little bit of music 1857-1900, then a very characteristic clock striking sequence (20 strikes). Man speaks

a bit, mentioning Azores and Ponta Delgado, then instrumental version of "A Portuguesa, followed by carrier s/off about 1904. The weak single carrier then left on channel provides very little audio here but very definitely DF's correctly for Huelva. They go off about 1930 all nites that I've stayed on the channel this late. Then channel is clear. Between tapes, DF, and characteristic SAH's, I can see no other interpretation of the observations. (Nelson, Mass.) RNE Huelva. Dangerfield's IS played by trumpet on RNE Huelva is in fact "The Last Post" ("Gloriosos Caídos por Dios y por España"), as heard on all RNE stations immediately before "Viva Franco, Arriba España." Huelva signs off some 15 minutes after the other non-AN RNE stations. (Wood, Ind.) I believe we have this channel, with all its weaving signals, quite well unravelled. Now, who'll be the first to QSL all four stations? (Ed.)

FRANCE. R.T.F. Nancy good with news 0015 11/2 on RAS-5 and loop; not heard on HQ-180 with 60' LW. (Wood, Ind.)

840 BRAZIL. PRH-9, R. Bandeirantes, Sao Paulo. Quite high 0906 11/15 with usual programming. No sign of LV-4 this week. Check of my tapes from 11/8 indicates definitely LV-4, on special for the Chilean-Argentinian border clashes. Could not determine the context of words "Diariamente de Navidad" from LV-4. Different voice from regular announcer during period had "pronunciamentos" about the border violation in rather austere tones. Music, all instrumental, was quite austere in nature; some with basic Argentinian tone, and could have been described as semi-classic or classic. Note Seaver's UNID. below. (Callarman, Texas)

JAPAN. JOKK, Miigata. Heard as only Oriental on 840 then on 11/6 at 0512 parallel 670 ke. (Scrimgeour, Cal.)

VENEZUELA. YVMY, Barquisimeto. Seems to sign on at 0530 and often clear as a local. (Brauner, Pa.)

UNID. L.A. Running late 11/8 0054-0130 when I left, never real high, mostly classical type music. TGKL? Or HJBI? (Seaver, Calif.) HJBI usually signs off 0030, I think. TGKL s/off varies, within a few minutes of 0100, with Ray Conniff's "Adios." Whenever I've heard HJBI, they've carried typical Colombian tropical music. I've never heard classical music on TGKL either. Methinks you had above LV-4. (Ed.)

854 UNID. L.A. Probably OAX4A here 11/7 at 2350 w/light music, XEMO also off for La Hora Nacional Program. (Seaver, Calif.)

872 ANGOLA/WEST GERMANY/SPAIN. AFN, Munich, goes off nightly at 1907 w/SSB and leaves two carriers on channel. EAJ-101, R. Zaragoza, on 872.004, and R. Angola on 872.084, which results in an audible 80 cps het. Angola usually suffers from EAJ-101 badly, but occasionally dominates the channel some nights. On 11/6, a man speaking in Portuguese was up even with EAJ-101 from 1954 to s/off; Angola off with very characteristic choral version of "A Portuguesa" 2000 each night. On 11/8, Angola provided quite a bit of good copy from 1943 to s/off; Angola had classical music and EAJ-101 had "West Side Story." DF says a little bit south of Louanda. Does anyone know precise transmitter site? (Nelson, Mass.) Following G. Nelson's tip re Angola on to 2000, I have been haunting this freq. So far, found AFN-Frankfurt dominant to 1905 s/off, and EAJ-101 thereafter. Some trace of a third station behind. (Dangerfield, Pa.) One of our international sources, I can't find which, says the 100 kw. transmitter will not be delivered until 1966, so 'tis still 10 kw. (Ed.)

881 WALES. B.B.C., Washford. At good level with English news 0307 11/15. (Callarman, Texas)

885 MONTSERRAT. Plymouth, I suppose. At 0510 11/8, interesting "different" English program, quite clear until WCES-880 carrier knocked him out at 0520. (Brauner, Pa.)

890 JAPAN. JCHK, Sendai. Best I've heard them 11/8 at 0405-0500. (Seaver, Calif.)

935 MOROCCO. R.T.M., Agadir. Very good 11/3. Arabic singing 1130; Azan noted 1855. (Wood, Ind.)

950 JAPAN. JOKR, Tokyo. Great signal, 11/8, 0405-0500. (Seaver, Calif.)

953 CZECHOSLOVAKIA/NIGERIA. (2) stations being noted each night after 2330; would be much easier to log if I could get rid of WPEN-950 11 miles distant. (Dangerfield, Pa.)

955 BURMA. YZK, Rangoon. Probably the station heard 11/8 0426-0612, best 0526-0600 after KJR quit testing. Programming featuring oriental singing to stringed instruments, but also included long talks by man and by lady. Lady announcer. Major program break on half-hour while hour seemed ignored. Language oriental, but rather different from Chinese and Japanese. Only item not fitting is that it was first heard nearly 1/2-hour before start of Burmese transmission as listed in WRH-65. Details sent to Rangoon for checking. About 40% readable at best period. Peaked at S-3, but much fading clear out. Looped correctly from Rangoon. Here's hoping. (Freeman, Calif.) Actually, WRH-65 shows Burmese 0600-0930. Leaves a blank between end of English program 0230 and beginning of Burmese 0600. This silent period would correspond to 1400-1730 Rangoon time. An approximate Great Circle line between Clearlake Highlands and Rangoon passes across the Aleutians, thru or right near the Yalu River, and through the heartland of Red China, right near Chungking ... according to my approximations on the globe. (And the same line passes approximately through Hughson, too!) I hope YZK schedule has changed. And I hope that 1556 Rangoon time 11/8 at approximately 17°N latitude can provide suitable E-20 time. Otherwise, I fear we have another stray Chinese or Korean moving onto a promising split channel. Richard Wood, can you check the language on Clarence's tape? I want to log Rangoon here, too. (ed)

960 VENEZUELA. YVVO, R. Fontera, San Antonio de Tachira (call not "D" but "C", sorry my scrawl) belongs to Colombian Todelar network. Unique in this respect, I think. (Silvera, Jamaica)

970 MEXICO. XEO, Matamoros, Tams. definite ID 2005 11/1 atop channel. Anyone have correct QTH, verie signer. (Hathaway, Ill.) Try Robert N. Pinkerton, Box 1708, Brownsville, Texas. (Ed.)

- 970 SOUTH KOREA. HLCA, Seoul. IS heard 11/8 at 0500, 4 pips, 3 lo, 4th high, almost (is it?) identical to NHK and Pyongyang. (Seaver, Calif.)
- 1000 NICARAGUA. YNY, R. Mil, Managua. Is still here (heard now), but I haven't heard the one on 1040 lately. Maybe it did move. (Silvera, Jamaica)
- 1020 CHINA. Peking(?) "Chungyang Jungming Guangto Dientai (Govt. of China Broadcasting station) is ID. Loud on 11/7 at 0334-0415+. 1040 kc. Not audible then. Announced, in Mandarin, several program changes effective 11/8. Loud!! (Scrimgeour, Calif.) FRIS shows Peking outlet (Chungyang J.K.T.) of 50 kw. in Changchun. (Ed.)
- VENEZUELA. Unid. coming in on KDKA's OC at 0440 11/8, this one really strong as that OC was putting the meter right up to the peg, yet he rode in with high modulation CX. Another SS GRM'd at 0457. just before KDKA hit the deck. (Eraun er, Pa.)
- 1034 PORTUGAL. GSE-2, R. Clube Portugues, Parede, noted 10/17 in Portuguese with musical program at 2200, weak. (Calkin, N.B.)
- 1046A VENEZUELA. An unid. YV noted quite clear at times 0535 onward 11/7. (Drauner, Pa.)
- 1088 ENGLAND. B.B.C. Midland, Droitwich, S-3, 65% readable with English News 0310 11/15. (Callarman, Texas)
- 1100 COLOMBIA. HJAT, R. Reloj, Barranquilla. good clear ID dominant here 0401 11/15. (Callarman, Texas)
- 1110 VENEZUELA. YVNN, R. Punto Fijo, Punto Fijo. No ID heard 11/8 0512-0518, but "Rumbos" news, ahimes, "Royal", etc. clinches it. (Seaver, Calif.)

- 1170 JAPAN. JOJK, Kanazawa, noted parallel to 840 and 670, but weaker, 11/8 from 0408 to 0420. (Scrimgeour, Calif.)
- 1195 COSTA RICA. TICA, R. Columbia, in most evenings at 0000, and after 0600 s/on, e.g. 11/8. (Seaver, Calif.)
- 1196 WEST GERMANY. V.O.A., Munich. Good with news 0000 11/2. (Wood, Ind.) English news and music heard, with one ID, 0001-0100 on 11/12. Hard to copy, but I'm hopeful. (Scrimgeour, Calif.)
- 1200 COSTA RICA. TIQ, Puerto Limon, with ID 11/1 2359 "R. Casino de Limon CR" and probable s/off 2400. (Wood, Ind.)
- 1208 UNID. CC. Loud OC to East in on 11/8 from 0015-0030. Dominican? (Scrimgeour, Calif.)
- 1210 CUBA. R. Reloj Nacional parallel 1200 but slightly weaker 11/8 0140. (Wood, Ind.)
- 1214 ENGLAND. B.B.C. LIGHT PROGRAMME. Quite good 0312 11/15, (Callarman, Texas) Noted with Semi-classical music at 0230 10/25, ID synchronised stations; noted most MM's. (Heinen, N.Y.)
- 1220 UNID. S. on 0600 11/8, then Spanish, but not sure. Only a few words heard, then went into uninterrupted music, smooth stuff, no pop, and not another word spoken up th time he faded out about 0640. (Drauner, Pa.)
- 1235 BERMUDA. ZDM-1, Hamilton. With ads, R&R and good music; signal S-9 for solid 1/2-hour 10/25, and usually S7-8 all night on MM. (Heinen, N.Y.)
- 1268 YUGOSLAVIA/UNID. T.A. Novi Sad strong with CC and then TT 0051; faint traces of other (at least one) TA's at the time, but none DF'ed for Africa. No sign of Mopti, MALI here either at s/on of s/off when 1415 is high. (Nelson, Mass.)
- 1277 FRANCE. R.T.F., Strasbourg. Very good 1745 on 11/9. Still s/on around 2300 with Arabic program. (Dangerfield, Pa.)

Don't know how I'm ever going to get a valid report on this one unless I get a good tape. Kuwait logged as country #112; Asian country #9, and the most Eastward station heard. And only Angola, Mozambique, and S.A.B.C. are farther. (Nelson)

- 1370 MEXICO. KEHF, Nogales, Son. is Unid. previously heard. S/off at 0300, ID as R. Commercial Sonorense, S-3 to 4. (Heinen, N.Y.)
UNID. S.S. Who is weak Spanish-speaker under Nova Scotia LPRT on M's? Believe the SS station is the one slightly off frequency here but not sure yet. (Nelson, Mass.) HJKX, R. Mundial, Bogota, AN. (E^D.)
- 1394 AZORES/LIBYA. CSB-80 barely readable 1920-1940 on 11/8; bad 1000 cps het from Ecuadorian on 1395; CSB-80 usually goes off at 2000. On 11/10 I heard a station from 2335-0020 fadeout which I'm almost positive was BFES, Tripoli. Man up occasionally in what seemed to be English but he too (see 833) had mush (sand?) in his mouth. Again, suspect BBC relay. DF very good for the line which passes through Tripoli from here; fadeout time also checks for Tripoli. Signal not as good as that of Benghazi on 833, (Nelson, Mass.)
