Greetings. It looks like things have picked up again, but not as good as Sept. and early Oct. Here is what has been heard. Will start with a few longwave items from Richard Allen.

- 164 -FRANCE Allouis hrd in FF w/easy listening mx at 0540-0713 on 10/26 w/good sig. Also at 2334-0640 on 10/26-27 and agn at 2343-0537 on 10/27-28. Not hrd during the morning of 10/29.
- 209 -MOROCCO Azilal hrd w/AA talk and mx at 0026-0040 on 10/27, w/fair sig. QRM from Houston Aeradio and unid beacons. Noted again w/chanting and AA talk on 10/27-28 at 2351-0002.
- 218 -MONACO Monte Carlo assumed to be stn hrd w/mx and unid language at 0506-0517 on 10/27. The audio was unreadable due to the intense GHM from unid beacon.
- -GRENADA Radio Grenada finally noted w/audio early eve 10/25 w/accented YL and calypso mx. Used to be just an OC here. (Schatz) * Fair to good sig some nites (weekends, when home) e.g. 0030 10/14 w/discussion/council meeting; 0115 10/18 w/call in show. Much QRM from beacon YAW-534; TV sets. Sig stronger than ever noted before, sometimes as good as ZIZ-555, perhaps has boosted power but modulation still shallow and mushy. (Foxworth) /(Reynolds)
- -RSFSR In at 1055 and Kremlin chimes at 1100, //647 but much weaker. MM 10/20.
- -ST KITTS (?) Believe it was ZIZ leaving its OC on here, apparently AN, looping correctly 10/26 0615. (Helms)
- -IRELAND Athlone. 70 db at tune in 2330, 10/29. YL and male ancrs and slow orchestra mx. Audible only about 6 times during $\frac{1}{2}$ hour period; nx read by YL at 2346. NA at 2356; carrier cut at 2358. Taped. (Bailey) *W/lengthening nites, Athlone has again become audible here at their s/on. Hird 10/23 w/TT at: 0625, into IS at 0628 and has 6 pips on the half hour at 0630. Man and woman, sometimes nice Irish mx. Starts fading around 0650, hrd w/same format the next 2 nites. (Foxworth)
- -COLOMBIA Bogota, R. Nacional de Colombia noted here in mid Oct. but since returned to 570. Varied 574-576 and way o/Oucu (Costa Rica). //680 and SW. Cali-580, by the way, has nover been confirmed as on and probably isn't.(Schatz) -UNID Hrd a couple of nites around 10/13 w/opera, transcribed programs in SS. Gongs at 0456 and s/off w/Colombian NA 0458. Hrd "Radiodiodifusora ..." once but IDs were few and far between. Think was National (govt) stn. Only noted 2 nites and is not being hrd now. Auroral cx that nite helped a lot. Freq was stable and hrd fairly well; did not seem a spur of any sort. (Foxworth)
- 580 -MEXICO XEFI Chihuahua, Chih. hrd at 1240 on 10/27. Probably this one w/mention of Chih. Mucho KIAC slop. Insufficient for good DX report to stn. (lobel) -MEXICO Unid 10/26 at 0555 w/repeated R. Mexicana IDs. XEFI? (Hartlage)
- 544 -RSFSR Svobodny, Kremlin Bells hrd 10/26 1230, then into CC pgm. (Seaver)
- -CUBA CMW R. Rebelde w/tremendous sig from before 1000 on MM 10/27. Man talking SS then march mx and complete ID. (Reynolds)
- >DOMINICA R. Dominica, Roseau hrd w/British accented andr at 0140 MM 10/27 w/ much splash from locals on 590/600. However, good armchair copy at 1000 s/on. (Reynolds) * Was the best sig yet this year 0025 10/13 and continued until 0230 s/off. Format still same as last season. (Foxworth)
- -FRANCE ORTF Lyon was in agn, fair, woman speaking 0632 10/25. (Foxworth)
- -NORTH KOREA Haeju in quite well at 1130 // to 655 who was really booming in on MM 10/27. (Reynolds)
- -NORTH KOREA Pyongyang, has anybody ever hrd another oriental here? All I've ever hrd is the JJ service. (Seaver)
- ENGLAND BBC Deventry; 10/27, World Service nx noted 0600-0615, fair sig thru WSM OC. (Sundstrom)
 - -RSFSR Vladivostok w/vy good s ig MM 10/20 at 1005 when KFI went off. Lots of talk by woman in KK, orch mx at 1013, then man spoke RR. Beautiful Kremlin chimes at 1100. Good agn at 1105 MM 10/27 w/woman in RR. (Reynolds)

- 647 -UNID Strong het hrd here against KFI on 10/27 1228 was probably N. Korea or USSR. No audio hrd, too much KFI slop. (Lobel)
- -ECUADOR R. Vision good at s/on 0902 MM 10/27. (Foxworth)
 -HAWAII KORL Honolulu 10/26 first time this year w/fair but readable sigs 2220
 -2250+ w/"Coral Sixty-Five" IDs and pop mx. (Starr) Hmmm, methinks you've got the times wrong, 0720-0750 maybe? Or, is the new crop in (ED)
- 655 -NORTH KOREA Pyongyang good most AMs, probably best ever 10/26 1200 w/pips and ID, and later at 1234. 2nd stn under then, not SS, not SEA language, probably Verkhoyansk. (Seaver) * Very loud as usual MM 10/20 at 1015. Other NKs on 625/635 but much weaker. (Reynolds)
- ALASKA KFAR Fairbanks in a rare appearance 10/26 1142 w/TC. Alaska tough in SD since it's 2 F skips. (Seaver) * Good briefly w/rock Top 40 format, temp given as 15, full ID 1353 10/19. (Wiseblood)
 -HAITI 4VI R. Lumiere, Fort-au-Frince quite good on 10/27 w/men talking in FF at 0135 w/lots of QRM. Practically in clear at 1000 s/on. (Reynolds)
 -MEXICO XERPM Mexico, DF w/"Radio Uno" ID and lots of strange sounds. Also,a lot of loud boisterous mx. Hrd 10/22 0515. (Lobel)
 -PHONEY ALASKAN! Vy weak sig here most of AM 10/26 but short snatches of EE made me listen for a considerable time, finally hrd a mention of "Chicago" and sure enough this is that WBEM-780 spur Wesley discovered last year. It's back so EBWARE. When I finally hrd it I jumped up and said ----. (Starr)
 665 -PORTUGAL Lisbon, 10/27, vocals, male ancr, noted 0600-0615, best of the lo-
- band TAs (584, 647, etc), fair level and very steady. (Sundstrom) * Noted 10/27 0652 w/pop insts, time pips at 0700, then good Emisora Nacional ID. Is this unusually late, I note few TAs hrd after 0500 listed in IDXD. (Hartlage) Not late for this one, located as far west as it is. (ED)
 RSFSR Komsomolsk hrd 1030 on MM 10/20 w/male group singing in RR then woman s peaking. Kremlin chimes at 1100. Not as loud as 647. (Reynolds)/(Seaver)
- 670 -MEXICO XETOR Torreon, Coah. s/on 10/26 1228, ID as "X E Tor, R. Ranchita".
- 683 -SPAIN/UNID Sharing 5.6 hz het 2323 10/24. RNE msd on 683.0000. (Schatz) 675 -ECUADOR Quayaquil, Radio Reloj IDed at 0600 10/10 following patriotic harangue
- on behalf of the "municipalidad de Guayaquil". Ex sig, Sonora off. (Schatz) 680 -PUERTO RICO WAPA San Juan w/first appearance of season 2330 10/12, alone in auroral cx. (Foxworth)
- 700 -ALASKA KEYR Anchorage presumed the one w/faint US mx mixing w/Japanese synchros 10/28 1335-1340. Much slop, so nothing definite hrd. Also a bad het on about 698.8; no audio hrd there. (Pejza)

-CHINA (?) Fair w/oriental opera mx, briefly o/NHK2 1328 10/19. (Wiseblood) -JAPAN Fair w/NHK2 pgms //830 1325 10/19. (Wiseblood)

- 701 -UNID Het, no audio thru almost local WIW 0512 10/26. (Hartlage)
- -ST VINCENT Kingstown hrd after 1030 s/on w/mx and woman talking on MM 10/27. Local giant KMPC had carrier on testing and messed up a good thing. Caribbean area coming in ve ry well at this time. (Reynolds) Are you sure of this Don? This stn has not been reported in quite a while, and I haven't even been able to find a carrier on this freq when cx are auroral (although they were fairly regular seve ral years ago). Also, if I remember correctly, DXers in Miami and the Caribbean have not hrd them either. (ED)
- 719 -PORTUGAL Norte is daily the earliest TA to appear; in at 2139 10/26 w/man in PP and folk mx. (DeLorenzo)
 - -UNID Weak mushy audio just below WCN 0515 10/26. Not the Cuban. (Hartlage)
- 725 -SURINAM SRS Paramaribo very loud at 0935 on MM 10/27 w/US pop records. Evening reception vy loud at 0215 on 10/28. (Reynolds)
- 730 -MEXICO XEX Mexico, DF 10/27 1222 making a pest of itself agn. Male ancr w/ very fast talk and ID at 1223:55. 10/22 0505 w/soft mx and a few IDs. Hrd at S2, a poor sig. This stn usually in at S7. (Lobel)
- 735 -NORTH KORFA R. Pyongyang fairly good on MM 10/20 at 1105 w/mx and woman in KK. NK on 725 not hrd at this time. (Reynolds)
- 746 -HOLLAND Lopik, 10/27, cl mx noted 0615+ fair sig level but readability poor w/a pounding from 750 WSB splash. Long fades-close to SR. (Sundstrom)
- 750 -AIASKA KFQD Anchorage fading in and out w/JOIB; SID at 1310; pop tunes, mostly oldies; TC at 1320 as 20 after 3. (Pejza)
 - -JAPAN JOIB Sapporo fading in and out 1310-1325 10/28, w/man in JJ. Vy good at 1312, almost armchair quality. (Pejza)
 - -VENEZUEIA YVKS Caracas, R. Caracas atop and clear sig at 0100 10/15.(Foxworth) Hrd 10/6 0755 in clear. YNX/WSB dominant still in eves here. (Seaver)

- 760 -CUEA CMCI Havana 10/27 1218 was in w/S5+ sig and quite steady. Male ancr talking quite slow for a Cuban stn. Did mention Havana and kept saying "Gracious". KFMB carrier back 1220. (Iobel)
- 770 -JAPAN JOUB Akita fair u/KOB w/JJ talk. 10/28 1308. (Pejza) * 10/27 1215 probable faint JJ u/KOB. Could not hear much but male ancr sounding like one on JOBB. (Lobel)
- 773 -SPAIN RNE San Sebastian 10/27, all inst mx, noted 0615+ w/long fades but doing quite well against WABC on peaks. (Sundstrom)
- 785 -NORTH KOREA KCBS hrd w/het on MM 10/20 at 1110. My only NK verie. (Reynolds)
- 810 -PUERTO RICO WKVM San Juan hrd 0415 10/13 w/"Festival Musical de P.R." and IDs as "K-V-M", good sig. Went until s/off 0457 anmt in SS, Ia Borinquena, anmt in EE and SSB at 04592. (Foxworth)
- 816 -NORTH KORFA Kaesong presumed drifting here 10/26 1140. (Seaver)
- ANDORRA Sud Radio fair-good w/YL in FF, FF and EE pop vocals 2209 10/23; strangly, no trace of Maroc. (DeLorenzo)
 -MOROCCO Rabat, 10/27, AA talk to 0625, then chanting, vy good on sig peaks. All alone on freq even in fades, n: SAH noted. (Sundstrom)
 -RSFSH Petropavlovsk, Kamchatsky good at 1316 SM 10/26 w/man giving speech in RR. Much stronger at 1320 when woman began giving news. Switched to Griental language at 1330. Also hrd Mi 10/27 at 1115 but only fair. (Reynolds)
 -UNID Fossible Chinese, seems oriental w/chorus mx 1223 10/12. (Wiseblood)
- COLOMBIA HJED Cali presumed 10/12 0718 w/"la musica colombiana", WEAP off.
 -MEXICO XESB Santa Barbara, numerous "R. Mexicana" slogans and IDs/(Seaver) also Musica Fanchera 1247 10/12. (Wiseblood)
- 827 -UNID 2 TAS W/het of 5 hz. 1/sd 827.002 and 827.007 w/latter dominant at 2344 on 10/24. (Schatz)
- S30 -JAPAN JOBB Osaka fair w/JJ man talking 1305 10/28. (Pejza) * 10/27 1205. Man in JJ u/strong WCCO. Could barely hear JOBB at 1208; reason: WCCO would have to blast my ears w/taps and good morning San Diego. El Cajon is a suburb of San Diego. Just what I needed to wake me up after a long nite of DXing. PLT was 0408. (Lobel) *Usually the 2nd Jap (after JOIB) to appear. Good 10/27 1100 w/pips, NHK ID, then into high school EE program. (Seaver) * In clear at 1245 on MM 10/20 which was not a good time for JJs. Vy strong on SM 10/26 after 1330 w/man and woman giving JJ/EE language lesson. (Neynolds) * The most Consistant TP hrd this year, nearly S9 every morning between 1230-1410. Hrd w/usual flute and harp song 1220 10/12. (Wiseblood)
- 835 -CHINA Nanchang strong w/CC male talk 1303 10/28. (Pejza) * Good level 1347 10/19 w/operatic mx. (Wiseblood) * Kiangsu Province not vy loud but steady sig at 1130 on MM 10/20 w/man talking in Cantonese. Much different from the Nan-chang stn heard in past years. Kiangsu hrd agn on SM 10/26 at 1307 vy loud w/ man/woman dialogue. (Reynolds)
- 836 -FRANCE Nancy ex w/man in FF, FF rock 2225 10/23; SAH noted. (DeLorenzo)
- 840 -JAPAN JOQK Niigata on top w/NHK1 pgm //890 JOHK at 1330 SM 10/26. Both had South Korean QRM underneath. (Reynolds)
- 843 -THAILAND Radio 909, Sakon Nakhon hrd w/weak sig on SM 10/26 at 1353. Orch mc and Thai talk by man. Only hrd once before in 1967. (Reynolds)
- 850 -GUATEMAIA TGX Quatemala City 10/27 0830. May have been the one hrd here. Thought I hrd the ancr say "Otra estacion de Radio Corporacion". (Iobel)
- 860 -MEXICO XEMO Tijuana, BC "The Voice of inspiration for the West", then SS ID by YL 0600 10/27, folo by Rev. Jerry Walker and the Voice of Pentecost, vy fine level. (Helms)
- 870 -CHINA Nanking (?) overriding JOGB w/CC talk by woman at 1310 SM 10/26.(Reynolds) -JAPAN JOGB Kumamoto, not as strong as 830. Hrd w/NHK2 pgms 1228 10/12.(Wise-
- 874 -NORTH KOREA Wonsan "Old Fairhful" in well at 1135 MM 10/20 w/KK talk. /blood) Freq varies from time to time but they are always there somewhere, hi. (Reynolds)
- 875V -NORTH KORFA Wonsan not noted in 870-880 range on 10/26-27. Where did it go? Cx such that it should have been audible. (Seaver)
- 880 -SOUTH KOREA HLKI Taejon poor/good 10/24 1350-1400. Talking by gal, then man. Pips at 1400, followed by ID call letters in EE, fairly good at that point, (Thought that was when they were supposed to fade! (ED)) but faded agn. 2nd vy seak stn under at 1359 w/mx. KBS pips are very similar to NHK, but slightly lower in freq methinks. (Pejza)
- 881 -WALES Hrd w/fair sig MM 10/27 at 0700 when WCES off for unsked SP. Faded about 0720. Was fairly good on peaks, nx and commentary. Cuban was dominant on 880 then. (Foxworth)

890 -ALASKA AFRS Adak Is. presumed the one u/HLKB 10/21 1348-1400. Rock mx, EE DJ, but no ID hrd. (Pejza)

-GUATEMAIA Escuintla, first noted 10/1 w/"Guaremala Musical" pgm 0316. On 10/8, s/off at 0501 w/repeated "buenos Noches Guatemala", but no positive ID in WIS mull. On 10/10 0248-56 a YL giving "la mundial" IDs after each song, also an ID sequence "da da de da da... da da" (like you'd knock on a door) prominent. On 10/17 more "la mundial" and knock-knock, then a good "Radio Escuintla" ID at 0401. Same strength as TGJ so probably 10 kw now. New for me. (Seaver)

If nothing else, they could be an excellent indicator of skip conditions from that area. The frequency can't have much on it to cause interferance.



RESULTS of the WJIC-1510 Salem, NJ, DX test

On Thursday, October 23, Paul Thomas of WJIC showed me the fourteen (1/4) reception reports received as a result of the September 27, 0230-0300 EDT, test.

Reports were received from CT (Frank Dailey, Preston; Ron Musco, Windsor), IL (Jay Florian, Round Lake; Richard Pistek, Chicago), MA (Ray Arruda, New Bedford; Ernie Cooper, Provincetown; Sharon Waterman, Southwick), MO (Bruce Reynolds, Warrensburg), NE (Carl Dabelstein, Lincoln; Ernest Weslowski, Omaha), NJ (Bill Coleman, Rocky Mount; James Hopkins, Pitman; Paul Mount, Teaneck), and ON (Tom Williamson, Guelph).

It seemed to be 50-50 on numbers hearing virtually the entire test, and those logging 10 or less minutes; I had the impression that the interference from WLAC and/or WMEX must have been less toward the end of the test as the bulk of the partial reports were on the end. Code IDs helped all. Amazingly detailed reports from NE despite the distance, as well as from New England as those closer to WMEX (but out of groundwave range) seemed to have more problems with WLAC than WMEX. NJ DXers had problems with both.

Aside from Cooper's "I heard you but don't need a veri, and thank you" card, I was pleased to see good reports from all (surprising amount of NRC/IRCA report forms/ letterheads) with return postage (someone sent a 6¢ stamp!!!), except one; a postcard written in pencil and with incomplete details was received ... requesting a verification! I did not recognize the name...

Verifications shall be sent out shortly.

If you missed this test and would like a second chance, Paul has advised me that the CE, Ben Ferguson, has just responded to a request from the NNRC. Code IDs will also be included. The test will run February 9, 1976, at 0100-0130 EST.

We are in receipt of a letter from Mike Hardester, which we have not yet discussed here in DXN, so we shall now deal with its subject matter:

Mike has enquired of all of the clubs to which he belongs if they could agree on uniform formats and standards for reporting to DX columns. In our case, this would cover the three major columns plus the DX Achievements columns and DXChange. The point is that many DX'ers are members of a number of clubs, although perhaps not as many as Mike is. For those members to comply individually with standards and formats for all clubs is at best difficult in a limited time frame, thus standardization would help these individuals.

The problems, however, arise when one considers that such standardization would eliminate many of the differences between the various clubs. Further, within any ONE club standardization is often impossible simply due to the differing approaches of the various editors. For example, Al Merriman cuts submissions into small individual strips, one to each entry, then puts them in frequency order and than runs them all as one group. Wes Boyd has several different subsections, and so therefore operates differently. When RjE edited DDXD, he did not cut up submissions into strips but rather sequentially numbered each submission on its own sheet and shuffled those for order. By so doing, he found that having each contributor list his name and location after each item was unnecessary, while Merriman favors that approach.

We do not see any quick and easy solution to this dilemma, even within one given club. When one works with even NRC & IRCA, the problems are magnified by different standards and geographical separations of columns. When one expands to include foreign clubs, or other bands or all-band clubs, the problem becomes staggering. RJE is a member of 5 clubs, the most at HQ. Mike Hardester listed no less than TEN clubs, exclusive of ANARC and EDXC which are associations of clubs in two continents. With such a magnitude of clubs, we doubt that a solution is possible.

Another recent piece of correspondence states in part: "I do think that the club should seriously consider reducing the frequency of publication for the bulletin if the postal rates go up any more. If enough volume mailers did this it would put an end to the constant increases in postal rates." As of the present, we do not plan to cut back again on the number of issues per year. Two years ago, we cut back to 30 from 32, and approximately 3 years before that, BPC had cut back from 34 to 32. The fault is not with those mailers who, like the NRC, pay FIRST CLASS postage for mailings, but those who get by at BULK RATE, often as low as 2¢ per unit who are directly responsible for the raises. It is this "junk mail" which doesn't pay its way and which mostly isn't wanted anyway which is clogging up the mails and causing increased costs. We anticipate still another postal increase beyond the 13¢ rate sked to go into effect in late December and we expect it to come within another year of the upcoming increase. This is why we chose to consolidate our new dues at \$15 instead of \$14. We would be losing about 70¢ per member per year at \$14.00, which we were willing to do as we could cover those losses with publications sales. but we felt that another postal increase would result in raising dues again then, and so we chose to consolidate dues at the \$15.00 rate, and, while making about 30¢ per member per year for less than a year, we would build up a sufficient cus so that when combined with publications sales, we could hold the line next time around. One additional benefit from all this is that if the new reduced rate for the second ounce of mail stays with us with the new rate, we will be able to run and thus contributed to our sparse numbers of these of late. We will try to hold out for fewer 32, 36 7 40 page issues, and more 48's which are the most economical way to go. Freely translated, expect 2 or 3 48's b4 Christmas !!

I spoke with the owner of WDJZ-1530 Bridgeport Conn. last week who says they should finally be on the air in early '76. after some 13 years of zoning fights & FCC fights w/WNAB-1450 Bridgeport. He says the XR/studio site on Edgewood Street, Bridgeport, has been cleared of trees & brush & the towers should be up before the real cold SX -(43)sets in. He says they should be testing in January & hopes to start RS in March. WDJZ will have a beautiful mx format similar to that of WPAT/ KABL/KPOL w/heavy emphasis on local NX. It will have a three-tower array & he says its .5 mv/m will take in the city of New Haven. It will eliminate the current reception on 1530 & 1540. On 1530 WJDM Elizabeth N.J. makes it into Brodgeport w/a fair signal, & WOBR Wanchese, N.C. w/only 250w is audible w/WJDM nulled. On 1540, WECP Philadelphia & WADK R.I. dominate, w/WFTR Albany way under. CBS will end its affiliation w/WJR on 1/1 & will switch to WWJ-950 which is dropping NBC. This is the second time in recent years WJR & CBS have split. WJR operated as an independent for a few years back around 1960s following a dispute w/CBS over compensation for carrying the network programs. This time, CBS was unhappy w/WJR's failure toclear certain programs. Rick Shaftan's comments on the stations licensed to smaller communities ignoring those communities and serving the large markets were interesting. In New Britain, a city of perhaps 70,000, the two locals ignore the city & orient themselves to the Hartford market, WRCQ-910 w/oldies & WRYM-840 w/block programming (religious/language). In fact, neither has any facilities in New Britain. WRCQ has its studio/office/XR in Farmington, a Hartford suburb, & WRYM has theirs in Newington, another Hartford suburb. Regarding his comments on limited time stations, I do not believe KPPC-1240 Pasadena operates on that crazy sked (Sun. & Wed. nights) by choice. MOTHBALL MEMORIES. CHAPTER V - Mergers, Moves, and Miracles.

On 1250 (now 1280) were three stations in New Jersey - WAAM in Newark; WODA in Paterson, and WGCP in Newark, which later became WHBI, and which is now still in existance, but on FM. WAAM became WNEW, and their earliest fame came as they were the exclusive station to cover the famous Lindbergh kidnap trial with half-hourly live reports from an anteroom at the Flemington Courthouse. People who had never tuned in anything but WEAF-WOR-WJZ-WABC began dialing for WNEW, and thus they were launched in the public's mind. On 1300 there were three N.Y.C. stations, WEVD, WFAB, & WHAP. The latter was an ethnic station whose slogan was "We Hold America Protestant." A man named Franklin Ford used mostly all WHAP's on-the-air time to rap the Catholic Church and the Pope, and of course, this station eventually was deleted by the FRC. WFAB (Fifth Avenue Broadcasters) became part of WEVD, and then they shared with the old Brooklyn voice of Jehowah's Witnesses, WBBR, which later sold their station to create WPOW. In those days, all these stations were silent Monday evenings, from 6 p.m. on, and during those few hours, that's right. only one night a week. WHAZ in Troy broadcast! They were owned by Rensselaer Polytecnic Institute (now WRPI, on FM). WHAZ today is a daytime station & no longer is effected by the operations of WEVD & WPOW. On 1350, now 1380, those stations eventually became the present WBNX. WMSG which used to broadcast all the sporting events at Madison Square Garden. merged with WBNY, and WKBQ sold out to the Pillar of Fire people who put WAWZ on the air. WCDA was bought out by WBNY, and then the call letters were changed to WENX, The Bronx, "The Station that Speaks YOUR Language." The four Brooklyn stations on 1400 constantly argued and fought with one another, but finally after much adieu, and much trying by the Brooklyn Daily Eagle to buy out all four of them, they merged and became WBYN. I remarked to an engineer at WBYN it was good to see the bickering had come to an end and he said, "Ha - that's what you think! The four of 'em fight more now than they ever did before!" > Service groups, broadcasters split over feasibility of roadside radio

California, Nebraska associations see FCC idea as needless expense, interference to present stations; supporters cite public benefits

supporters cite public benefits There was no middle ground in the reaction to the FCC's proposal for establish-

tion to the FCC's proposal for establishment of Travelers Information Stations for highway users. Broadcaster comments to the FCC last week opposed it; public service groups endorsed it. One citizen group questioned the reason for such a service.

Last June the FCC proposed establishment of a government-operated 10-w radio class that would provide information to motorists. The stations would operate on either of the two frequencies just above the AM band (1606 or 1612 khz) and the frequency just below (530 khz).

In a voluminous filing, the California Broadcasters Association flatty stated the service was not necessary. CBA gave a partial listing of more than 100 California stations that already provide travelers information and said the proposed service would be duplicative and "only add to the taxpayer's burden." The Nebraska Broadcasters Association and others agreed, as did wKr1(AM) Brattleboro, VL, which said the service would be a waste of taxpayer's money. CBA said the price could be "millions, perhaps billions."

NBC asked what will determine the tourist information to be provided and said self-selection through advertising should not be replaced by government determination.

Realization for 10 years

CBA went further than most broadcasters when it charged that the service "would destroy prime-time radio and radio itself." CBA said the service may cause interference to AM stations operating on frequencies adjacent to those proposed for roadside radio. CBA expressed doubts that the broadcast industry could survive government-subsidized competition causing a substantial loss of audience. It also cited the "enormous investment" commercial broadcasting already has made in traffic control information.

And if those reasons were not enough, CBA challenged the commission's statutory power to create such a service, claiming that Congress never authorized the FCC to license a government-subsidized radio system to compete with commercial AM's.

The National Black Media Coalition also has stated its opposition. Although the "road hazards" and "fire emergencies" are emphasized, NBMC said the real reason for the service could be to provide free advertising for local businesses seeking tourists. NBMC suggested that these frequencies would serve a better purpose if they were assigned to minority ownership.

Groups like the International Municipat Signal Association, however, urged implementation of the service. It said that the service comes under the communications Act to promote "safety of life and property through the use of wire and radio communications."

The International Association of Fire Chiefs strongly endorsed the service as a "major step in negating the dangers" of forest fires. The California State Communications Division supported the proposal on behalf of its state. It said that California's Department of Transportation could use it to alert the motoring public and that the Department of Parks and Recreation could give information on various areas. The Habersham County (Georgia) Civil Defense claimed the service could aid the emergency capabilities of local governments.

Antenna for Off-Air AM Monitoring

Amid the forest of high rise structures in San Francisco's financial district, picking out a clean signal for the air monitor can be tricky. While you would suppose that a commercial directional receiving antenna might be available, such is not the case.

The long wire antenna is the type most often used for air monitors. But if re-radiation from nearby structures is a problem, a directional antenna is called for. With our roof antenna farm up some 45 stories above the street, wind is also a problem. All these factors led us to use a compact tuned-loop antenna.

A tuned loop consists of at least 6 turns of #22 wire formed into a weather tight loop and resonated in combination with a tunable inductor at the desired frequency. Broadbanding is accomplished with a shunt resistor which lowers the Q of the circuit. The actual dimensions and geometry of the loop are unimportant. The loop or square should be at least 8 inches across for sufficient signal pickup.


If you have access to an electrician's shop with heat forming equipment for PVC plastic conduit, you can form a circle for your antenna. Otherwise you will have to make the antenna from short pieces of PVC formed into a square with 45° and 90° elbows (see photo). The circle or square is then mounted on an outdoor cast aluminum utility box with ports in the top, bottom, back, and sides. The cover fits on with a rubber gasket. If you make a square out of PVC pieces, it is best to lay out the component pieces and thread the wire through them before cementing them together with PVC cement.

The resonating inductor placed in series with the loop is a Miller 2002 subminiature antenna with the free hanging wire clipped off. Connected to pins 1 to 2 are the many turns which go in series with the loop. Connected to pins 2 to 3 are the few turns that are used to feed the coax. Pin 2 is taken as ground. The function of the shunt resistor is to broadband the resonant circuit by ± 10 kHz at the resonant frequency. The math for the resistor calculation may be found in the Radiotron Designer's Handbook.

The inductor is mounted on a piece of PVC and fixed in place with U bolts. It is directional in the edge plane. That is, the hole is 90° off axis from your transmitter site. The loop does have a front and a back with greater signal pickup in one direction than the other. The resonant point is fairly broad but sharp enough to note on a signal strength meter, associated with your RF amplifier, when tuning the inductor slug.

The reason the inductor is tuned rather than the capacitor is that moisture will effect a variable capacitor more. To reduce moisture effects, it is a good idea to use a heat gun to drive moisture out of the utility box before sealing it. If you have a desiccant to put in the box, so much the better. BM/E
