Note: When a station is granted increased tower height with reduced power, the actual power reduction may be very slight, usually accomplished by the installation of a power-dropping resistor or, in extreme cases, a power-dividing network which drains off the excess power to a dummy antenna. This is done to permit stations to install towers of optimum heights while, at the same time, retaining the present radiation level. Often the tower is heightened to accommodate an FM antenna. It is not uncommon to see a 500 watt station, for example, actually operating at 482.65 watts.

OBITUARIES

Lawrence W. (Larry) Eckenrode, a radio executive and sports announcer in Pocatello, Idaho, who played in the Los Angeles Dodgers and Baltimore Orioles organizations in the 1960s and early 1970s, died unexpectedly in Cedar City, Utah, while en route to his home after a vacation in Los Angeles. He was 37.

Eckenrode, an infielder during his playing days, played with the Albuquerque and Spokane clubs in the Dodgers' organization in the 1960s, and was a player-coach with Los Angeles in the minor league farm clubs in Albuquerque and El Paso in the early 1970s. He was acquired by the Orioles and assigned to Rochester in 1972.

Following his retirement, Eckenrode began working as a sports announcer in Idaho in 1973. He was named Idaho's sports-caster of the year in 1974-75, and became general manager of radio station KSTZ in Pocatello, a position he held at the time of his death.

Bid For Call Letters WSEX Causes Static For The FCC

WASHINGTON (AP) — Darrell Peters is getting some unexpected support in his battle with the Federal Communications Commission for the right to use the radio call letters WSEX-FM.

Peters is the president and majority stockholder of Darrell Peters Productions Inc., which got the license in September for WTCO-FM in Arlington Heights, Ill.

When Peters then asked to change the station's call letters to WSEX-FM, the FCC staff turned him down in two days flat, saying the proposal was not in "good taste."

That decision apparently raised a few eyebrows within the industry. Broadcasters have written letters to the editor of Broadcasting magazine, suggesting the FCC's review of call sign requests has been inconsistent.

Larry O'Neal, the operations manager of WJDQ-AM-FM in Meridian, Miss., wrote in the

current issue: "I personally wouldn't want WSEX as my call letters, but in view of the sum of the others that have been approved by the FCC, I see absolutely nothing wrong with them."

In his petition for reconsideration, Peters' Washington attorney, James Weitzman, notes the agency has granted permission to use such call signs as WGAY, WPOT, KFAT, KKKK, KISS, WLAY, KINK, KOKKE and WLUV.

According to Weitzman, Peters' request to use WSEX has nothing to do with the station's programming plans. "He's planning a quality entertainment format," the attorney said. "The only purpose for asking for those call letters was to give the station an identity and make people sit up and notice."

Larry Eads, the chief of the facilities division in the FCC's broadcast bureau, says that Peters' petition for reconsideration has been received but that action is unlikely before Christmas.

Also heard again in Tulsa was friend KIOA IA after its

Otherwise not much except SS language from Mexico in Tulsa at night and Fayetteville too. DENVER VS. DALLAS

 The most remarkable thing about the Dallas BCB is that you have no locals on the air at night between 570 & 820 kHz - 20 kHz of DXing space across this vital portion of the band. The contrast with the Denver situation is striking. Denver locals at night are found on 560, 630, 710 & 850 on these lower frequencies. The largest span of DXing space in Denver is the 140 kHz between 710 & 850. And I believe there are applications on file for new Denver locals on 670 & 760. Denver is blessed with 37 AM & FM stations, Dallas with 23. Denver has 19 AM stations while Dallas has only nine. In terms of population and economics, the contrast between the two places makes no sense at all. Dallas is the seventh largest city in the U.S.; Denver is #25. And Dallas is a substantially better business town than Denver and you would think that would be reflected in the number of radio stations able to survive in the two places. I spent 12 days in the Dallas suburb of Richardson in late October & early November. On the few occasions when I had time to examine the BCB, I was much impressed by the contrast with Denver reception conditions. Using the GE 35280 AM-FM cassette RX, I could hear the Tahiti hot against 740 stations in the late hours. Another early morning I located the New Zealand 882 hat against the 880 Cuban at 6:55 EST. KRVN was off the air that morning until 7am EST. Both KCMO on 810 & WCOO on 830 separate cleanly from WBAF-820 on the GE. And Dallas local KLIF on 1190, as heard in Richardson, is no stronger than WOAI on 1200. Of course, I realize this Denver-Dallas contrast wouldn't be so striking if the Fort Worth stations were included in the Dallas listing, but even then you would still have that 250 kHz of DXing space on the AM band. When it comes to a wide expanse of useful space, it would be hard to beat the allocation situation in Cleveland, as it was 20 years ago. Cleveland had no locals at all below 850.

DAVE GOES TO FLORIDA - BY RADIO!

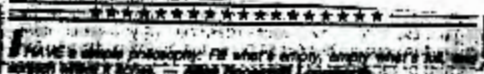

It is about time to invest in a more sensitive receiver - any suggestions? WHEN IS A LOCAL A LOCAL?

NIEL WOLFISH - 15 Donwoods Grove - Toronto, ON - M4N 2X4
A short Musing to comment on a recent Musing by fellow Torontonian TIM KERFOOT. I do count my locals in my totals. The reason for this probably dates back to my beginnings in the hobby when - was an avid SW DXer. Most people I knew tried to hear and verify every station, no matter how easy they were to hear. Thus, I felt it just as important to verify N.C.I. as I did to verify All-India Radio. The same carried over for me when I got into BCN DX. I verified CKEE (now CJCL), & I also went ahead and verified WIRE. I really don't think that 40 or 50 locals really inflate my totals. A little mathematics will show that counting the Toronto - Lake Ontario - Buffalo stations amount to less than 1% of my totals (.056 to be exact). You may also justify counting the totals by considering a NYC DXer who has twice as many locals to contend with - with twice as many locals, you have a much harder time hearing around them to hear non-locals. I hope this makes sense to people out there. In my case, I have two stations heard on 590, CKEY & WRGW. Most likely, moving away from Toronto would allow me to add WOW, WEEI, WWSB, WARM & WKZO to my logbook. Thus, living in Toronto and counting CKEY in my totals makes up for my loss of five other stations that can't be heard with CKEY as a local. The other question that needs to be raised is, what constitutes a local? Using another local example, WHEN-620 Syracuse NY is audible all day 99% of the time. Does that mean that rarely heard Syracuse stations WE2G-1220, WOLF-1490, or WSIV-1540 are locals also? The same can be applied to places like Rochester or Cleveland, where one station is audible all the time, and others are only audible on rarer occasions. 73s.

WHERE ARE WE IN THE SUNSPOT CYCLE?

GENE MARTIN - 3303 East Evans Avenue - Denver, CO - 80210 Dec. 1, 1982
For the final three days of November, I was up in Denver's early morning checking into reception CX around the period of 4-7am EST. Extremely Auroral is the only possible description for what I found those three days in these hours. My most useful test for the extent of A auroral activity at any given time is 760 kHz. I often sit on it a few minutes to find out what is there. On these three mornings, with the loop on an E/W bearing, WJR has been ranging between missing and barely audible most of the time. 760 has belonged to Cuba & KPMB on the E/W bearing to Mexico City and Barranquilla when KPMB is nulled. No trace of WJR could be found on Sunday morning & Tuesday morning and it was "way under" on MN. The A Index these days has been 23 & 26. Now when CX are good, WJR overwhelms KPMB on this frequency along with the Cuban. New Zealand's carrier at 756 is a constant thing in these hours even under these conditions, its audio ranging between missing and barely audible. So you can put it down as a fact of propagation that New Zealand arrives here under the most severe AU CX. But it also is a conspicuous thing that 1XA delivered a better signal on many mornings during the Summer. There were times in the Summer when I found it at almost the same strength as KPMB, 30 to 60 minutes ahead of the Denver sunrise. Both Winter & Summer, it seems the 1XA signal tends to peak near 6am EST. For the most part, reception CX have been poor in Sept-Oct-Nov, Japanese signals were found on only a few mornings, and never with the strength often noted two or three years ago. I wonder just where we are in the sunspot cycle. I had thought we were supposed to be heading into better days by this time, but there is no evidence of that I can detect, nor can I find any in the reports of other international DXers.

A FEW WORDS FROM YOUR OUT-GOING EDITOR

23 Until I read in KERMIT GEARY'S report in this issue, I had not actually known when I started as Musings Editor, so my thanks to KERMIT! So it has been about 36 years and two months. Previous to my takeover, the members' reports were known as "Tips and LPO Reports" - LPO meaning Listening Post Observer. I thought that sounded rather cumbersome, so I came up with the title "Musings of the Members" sort of bending the meaning of the word "Musings" a bit in the process.

My policy was then, and still is, that this section is for the stating by the interested members of their DX accomplishments over recent days and nights, and not for just "gab". More and more we seem to have drifted away from that policy. In those days, the "DX Down the Dial" section, which has evolved into the present "Domestic DX Digest" was used for current, hot tips only, not for a long list of all of one's DX catches over the last little while - like a new station testing, or a new early s/on or late new s/off time, or special one-shot special late broadcasts.

Over these 44 months, it has almost always been my PLEASURE to handle Musings of the Members. Yes, we had some rough spots over those years, but ol' ERC was able to outlast them. I believed in deleting as little as possible from various Musings reports, allowing more or less free speech, so long as it contained no swear or curse words or accusations.

There was a controversy in the 50's about whether any member should be allowed to have more than one Musing in an issue. The powers that were then decided that only the most recent of multi-Musings-senders should be used. I opposed that, for that would mean I could not get an early jump on typing the section, lest one of those on the first couple of pages send in a later Musing which would have to be substituted for the earlier one. I was given five issues to follow these directives. I did NOT, and I continued as Editor!

Then we had a controversy over Club government in the early 60's, and it got into a sticky situation, because, largely, I did not "censor" some of the remarks, a bad mistake on my part. Out of this, the IRCA was born. However, the NRC and Musings continued to survive and grow. Long may it continue!

I was criticized in some quarters for publishing IRCA's DX TESTS in NRC, but I continued to do so, reasoning that the ones being hurt by not so doing would be you, our members, and the folks at the testing radio stations. Now, the interchange between the Clubs is friendly and smooth, forever, I trust, so to continue.

Then there was some fussing over the type size in Musings. - held out for as long as I could to continue with my "Old Faithful" elite-size typewriter, but when HQ (then in Louisville) showed me excerpts from some 74 letters from members complaining about it, I reluctantly agreed to use a larger-type machine; this one. It hurt that so many members would "tattle to the boss" rather than write to me about it. A few did, but the majority didn't.

Our next pot-boiler came with the poetry issue. One member started including limericks with his Musings, and when others followed his lead, it was decided that no poetry would be permitted from then on, by HQ. I did not agree, and when all such was deleted from my section suddenly, I came within an inch of resigning as Editor right then and there. I did boycott my own section for several weeks over it. But I reasoned that handling Musings had been more or less one of my life's highlights, so I swallowed my pride, and continued and did not accept any poetry, good or bad. And I'll admit some of it wasn't good - but then, there are many Musings I don't consider good, either, but I reasoned I am not to judge their content; only to type them, as long as they do not offend anybody.

Then, the subject of whether or not any FK mention could be included reared its ugly head. Realizing that more than 63% of today's radio listeners are tuned to FK stations, I felt a couple of lines on the subject of FK were in order. When it got controversial, and when my work load here at home from being Secretary to both the WQWR Board of Directors and the Provincetown Business Guild Board of Directors got to be very time-consuming, along with the time needed to prepare and present my weekly radio show on WQWR also cut into my spare time, I decided that perhaps my time had come to step down from the Musings post. Believe me, I did so after much thought and lying awake tossing it around in my thoughts until I fell asleep many nights.

It seemed that possibly the best way to find a replacement was to zone the section into West, Central, and East. We had volunteers for West and Central, and I tried to find a suitable Eastern Editor, and I suppose I could have been talked into being Eastern Editor myself. That is, until I received my copy of Volume 50, Number 5, dated November 8, 1982, and read the fourth paragraph on the front page, along with the added footnote at the bottom of Page 8. Then and there I set the deadline of the December 20th issue for my exit. I figured it is time to go. I did not want to see deletions in my work if I put anything in about FK. Lines about rooting for various sports teams, and going for long walks, etc. were apparently O.K. - but FK DX, no.

The need for an FK club is a howling one, in my opinion. That "other club" has not sent out anything since the September '82 issue. NRC could become a real LEADER by entering that field, again, in my opinion. If and when we do, I stand ready to volunteer to be the Editor of that section!
