

From the Editor ... You've pulled it out of your mailbox, you've scanned it and noticed a few changes, and you're wondering just what Swearingen is up to, now that he's DX News editor, and where the NRC is headed.

Let Mike Knitter and me set your minds at ease. Several months ago we decided that after six-plus years, it was time for a change for both of us. Mike's job responsibilities clashed with nis having to meet a deadline 30 times a year as bulletin publisher/editor, and I frankly was getting tired of typing and was getting a little overloaded with hobby-related activities.

And so Mike has delegated the position of bulletin editor to me, thus freeing him for more time to answer correspondence, develop new NRC activities, maintain the NRC Log database, retype mountains of reprint materials, and continue directing the activities of the club. (Sue gets to rest, I guess.) Although his title (as mandated in the club's constitution) will continue as Publisher, a more accurate title might be "Executive Secretary." (Personally, I think he prefers "De Boss".) Club members should be aware that I answer directly to him (and, financially, to club treasurer Dick Truax) and will refer requests for changes in club operation to him.

Mike's strength lies in promotion, and mine in publication, and we feel that the club will benefit greatly from this switch (and if after a few bulletins you feel otherwise, we want to know). I've had over two decades' worth of experience in producing publications, covering news, management, radio, and related fields, and I now feel confident in announcing, publicly, that my goal, as the head of a team, is to make DX News the best radio club bulletin in the world.

Just as Ernie Cooper made it easy for me to continue improving "Musings of the Members" when I took it over in December, 1982, Mike has given me a running start to continue the improvement of DXN. Of course there will be changes ... for example, the address label page was modified to meet postal regulations for automated mailing so that you should receive DXN at a more consistent time, depending upon the printer and unnatural disasters. (The printer's bid is considerably lower than the Wisconsin printer, which should more than offset the increased cost of postage and should put off any dues increase for quite some time, by the way.) Depending upon space availability, we'll run a few photos now and then, as I can make prints utilizing a Kocak contact screen which cuts the cost per photo from several dollars to pennies. (Refer to the quide on the inside back page for photo and other submission requirements.) And by September I will be listing the names, cities, and states of new members who have joined the NRC, along with a current total of dues-paying members. Mike and membership chairman Ron Musco have done a fine job of maintaining the membership level, where other radio clubs having been losing members to the point where their existence is in danger. Now it's my turn to edit DXN so that new readers are more likely to stay with us ... and I'd like to see membership increase by 50 subscribers, or more, per year. Yes, there will be changes, and I think you'll like them.

My most immediate goal, however, is to recruit a replacement for me as Musings editor, either one or more person(s), and if more than one, by some other division than geographical. I can edit, if necessary, Musings for the August issue. And that's it. No volunteer(s) means no more Musings after that. Call me at (913) 266-5707 or write for information, but apply to Mike for the position. I would suggest that you should have some type of word processor (I've been using a simple Commodore 64 and Juki 6100 daisy wheel printer), but even a manual typewriter with a fresh ribbon produces acceptable camera-ready copy.

I plan to edit DXN in as professional a manner as possible, so that it meets the needs of its readers/members, and I expect all column editors as well as other submitters to meet top-quality standards (see p. 23). On the other hand, I plan to have fun and to make readers laugh as well as to consider serious events. As before in Musings, there will be no place in DXN for material unrelated to radio, for personal attacks or slurs, for useless bitching and groaning, or for egotism. It should go without saying that libel, obscenity, blasphemy, or advocation of violence will not be allowed in this publication. I will publish, however, controversial discussions, proposals for change, and timely news, as long as they are related to or affect AM DX'ing, or, as space permits, broadcasting, DX'ing, and the radio hobby in general.

That's enough guidelines for now. Remember that you're a member of a reporting team, too: support the columns, and give us feedback. Thank you for your cooperation during the past six-plus years, and for ... many years in the future. And now ... on with it!

### Regional Conference sets 1 July 1990 for AM Band Extension

On June 9th, the 2nd session of the ITU's Regional Administrative Radio Conference ended in Rio de Janeiro with an agreement to open the 1605 - 1705 kHz band to AM broadcasting starting July 1, 1990. This band is now mainly used for radiolocation. aeronautical navigation, cordless phones, remote broadcast auxilaries, and fixed and mobile services. In the United States, 1605 - 1615 kHz is used for Travelers Information Stations (TIS).

After the re-allocation takes effect, fixed and mobile stations will still be allowed to operate between 1625 and 1705 kHz outside the US, but broadcasters will have priority in the choice of frequencies throughout the Western Hemisphere. Radiolocation beacons can also continue operating in that band on a secondary (noninterference) basis. Manufacture of cordless phones using mediumwave frequencies ended in 1984, so these are already headed toward extinction. The US presented no proposals at the conference for reassigning TIS stations, regarding this as a wholly domestic issue. The Rio meeting set technical criteria for band-sharing among the various authorized services, which we haven't seen yet.

The conference gave individual countries substantial leeway in deciding how these new broadcasting channels are to be used. Anticipating this, even before the conference ended the FCC issued a Notice of Inquiry to solicit comments on whether to treat the new allocation like the existing AM band, or "adopt a system offering substantially less governmental oversight...to offer new and novel services and promote diversity and distribution of radio services in a different way."

Specifically, the FCC is considering offering nationwide licenses on up to 9 of the 10 new channels. These would not be like the old "clear channel" stations, since power would be limited to 10 KW or less (or 1 KW equivalent at borders with other countries). Instead, licensees could decide for themselves how many stations to put on "their" channel and where to locate them. To provide as much flexibility as possible, national licensees would probably be exempt from the Commission's limits on the number of stations a single entity can own, at least initially and within the new band.

The FCC also has some novel ideas about dealing with co-channel interference in the new band - through station-to-station negotiations and the "operation of the marketplace": "there may be public interest advantages in permitting licensees to decide on the level of interference to be accepted." As for TIS stations, the Commission suggests moving the ones now using 1610 kHz up to 1700 kHz.

The deadline for filing public comments in Gen. Docket 84-467 (regulation of broadcasting in the 1605 - 1705 kHz band) was July 11th. Reply comments are due by July 26th. Considering the complexity of the issues raised by the Commission, the comment period may be extended. In any event, an Inquiry is just a first step, a wet finger raised in the breeze. Actual rule-making is further down the road, so if any of you wants to have a say in the use of the new band, you'll have a chance later.

STATION PROFILE: WGSA - 1310, Ephrata, PA.

(Editor's note: John Malicky prepared the following WGSA profile as a result of his pilgrimage accross the Keystone State to the Wilmington Convention.

WGSA Radio is Ephrata's first radio station, having signed on the air on July 26, 1955. Mr. Samuel Youse originally owned the station, and was its operator for some 29 years., from 44 Bethany Road, Ephrata. WGSA - FM began broadcasting in November, 1962. Today, the FM carries the call WIOV, In the fall of 1964, Mr. Youse sold both stations, as he decided to retire from the hectic world of broadcasting. Brill Media, of Evansville, Indiana, purchased WIOV, and Joel Michaels Media, Inc., obtained WGSA. In March, 1986, WGSA moved its entire operation from Bethany Road to the renovated Mentzner Building. The signal is microwavedback to the old site, as the main directional pattern is beamed 16 degrees north of true west to protect WSSJ, in Camden, N.J. The station operates with 5000 watts of power.



WGSA carries an adult contemporary format with emphasis on local, as well as regional and national news, community information, farm news, and sports. Farm news comes through Agrinet programs, and local Ag-updates air eight times daily. Sports coverage includes the play - by - play of the Philadelphia Eagles and Penn State teams. Central Pennsylvanians are informed of driving conditions during both AM and PM drive times from the Traffax Command Center. The news and information, as well as the music stops, on Sunday mornings from 6:AM to Noon, when religion is aired.

WGSA is unique in that its offices and studios are in a most interesting building. Constructed in 1889, the Mentzer Building is an exceptionally sophisticated and nearly intact Queen Ann commercial and office building., standing at the intersection of Ephrata's Main and State Streets, in the heart of downtown Ephrata. Its prominant site represents the significance of the Mentzer family, who had long been instrumental in the economic growth of the area, operating a cigar manufactory as well as being involved in the coming of ageof Ephrata as a small regional market, with its shops bringing the wondors of the late 19th century consumer age to the town. The building is very significant as a "small town skyscraper" that describes the architectural sophistication available in Ephrata at the turn of the century.

The building was recently purchased and completely renovated. The first floor and lower level house commercial businesses, including WGSA, which even includes a shower within the bathroom! The second and third floors contain one and two bedroom luxury appartments. All of the renovation was performed to allow the inside and outside of the building to retain its Victorian style. The Mentzer Building is listed in the National Register of Historic Places.

Six California quakes, and one in extreme northern Mexico, of 4.0 or greater from June 10 to July 1 combined with very large deviation averages over most of that period have supplied a good opportunity to look for correlation patterns. Some of the apparent deviations logged here in Missouri were as high as 8 Khz., wiht many at 5 and 6 Khz. These were verified by a second radio set up to automatically mechanically scan one station's signal on a 24 hour basis and feeding a chart recorder.

Several conclusions have been reached.

First is that the time lag average of 6.36 days between high deviations here and a quake (over 3.0) on the West Coast seems to have changed to 3.5 to 4 days for these seven quakes, and timing must be figured from the high point of deviations rather than the drop-off point. This makes it much more difficult to decide whether a local quake is going to occur or whether deviations are going to drop off here and be followed by a quake westward. And since monitoring of 17 stations is usually done only two or three times daily, with a 12 hour overnight gap, the potential warning time for California would be cut by a critical half day.

Secondly, the lag time for extreme southern California and northern Mexico seems to be about one day longer than for the Los Angeles to San Francisco area. Since no quakes have recently occurred north of the latter, I can only guess that the same might apply there.

Third, the possible accuracy of such predictions, due to insufficient data collected by poor instrumentation (homemade, at that) is about 65%, which puts it in a class similar to the U.S.Weather Bureau, and which, I am told, is not sufficient to be accepted by the scietific community. This is a good thing, that science should only accept very solid evidence. But without better means of investigation, the better evidence will never exist (nor can the relationship between the phenomena and quakes be disproved).

Meanwhile, 18 months have supplied evidence of an amazing correlation of some sort, even if it has not yet been exactly pinned down to certain rules.

As of now, this phenomena seems to be limited to this area, as it exists to the extent found here. The actual extent of the local area may be 100 miles wide and 200 miles long, but the time and means to investigate this have not been available.

There may be, and probably are, other such "sensitive" areas in the country. And it is definite, from some reports received, that areas over some inactive quake faults are either not "sensitive" or are "mildly sensitive". This contradicts my earlier assumptions. Nevertheless, due to persistent reports of supposed inaccuracies of high grade digital readout receivers, it seems safe to assume that many areas are either slightly "sensitive" or sometimes "sensitive".

Mention should be made of an interesting discovery with automatic mechanical monitoring ("fanning" of the dial very slowly across a station's frequency). The chart recorder shows an unusual pattern or disturbance of the signal curve for a short period on the side of the peak toward which the signal is deviating as shown on a second radio. When no deviation is found on the second radio, the pattern is sometimes centered on the peak, but usually is non-existent.

Now, thanks to a suggestion by Mike Medeke, it has been discovered that null directions (when a ferrite core coil radio is rotated) are ridiculously distorted here - some as much as 30 degrees - on deviating signals. What this discovery will mean is anybody's guess. It could be a vital clue - and it is added evidence that something peculiar is going on here. It will be pursued with what means are available.

# **Radio stations plan** return to studios soon

MANHATTAN - Although things are not back to normal, an AM/FM radio station here has managed to overcome most of the problems caused by a fire that left it off the air and without its studios June 24.

community support, according to station manager Lowell Jack. "There have been a lot of long days, but the employees have been super and very enthusiastic about helping out. And the community sup-

University. However, it took three days for the AM station to begin broadcasting again because of a damaged transmitter, Jack said.

The blaze began when a car parked in the station's lot had an engine fire. The long dry spell and the high temperature with hot dry wind that day contributed to the spread of the fire, which ignited bushes and spread into the eaves of the station. Damage figures have not been totaled, but Jack said he estimates the cost at between \$300,000 and \$350,000.

Construction and repairs at the damaged station should be completed within a month, Jack said. In the meantime, the 22 station employees are scattered between the college radio station studio, a temporary downtown office and mobile home and recreational vehicle facilities set up near the station

Kenneth Otis Watson, 29, of Bulverde, was in Bexar County Jail in lieu of bonds totaling \$4,800 on charges of cruelty to animals and criminal trespass, officials said.

The suspect, who told police he

had talked with God and was protestgan Monday night when the suspect ing the language used on the station, claimed the cats were sick anyway and the incident was symbolic be cause of the KITY station's call letters, according to police reports. Terry Rodda, vice president and general manager of the radio station,

which plays contemporary hits, said the matter was in the hands of the police. "It was very upsetting - we've taken added security measures," he told the Express News

Police were told the incident be-

walked into the radio station at 317 Arden Grove and went around the front desk and into an area where only employees are allowed. When was stopped by an employee and was told to leave the building, the in-truder said he didn't like the music KITY was playing and left, according to police reports. The next night, employees found the bodies of five cut-up cats in five boxes at the front door of the station

It is a beautiful piece of music, and I heard it two or three times most every day. The loudest VV is R. Margarita-1020, and they were usually about three minutes late with the anthem so I could hear it on R. Vision-950 first, and then again on 1020! And to those of us who've been hearing an FF station on 1090 mornings when WBAL is silent, take heart - 'tis a new country for us -' it is definitely R. Martinique, which has a fair signal in Frederiksted, and they're mostly talk and sports.

The only Dominican Republic stations I could hear were on 540 and 1040, with a tentative on HIZ-730. PJE3-1120 on St. Eustatius is still going, and is in EE, Caribbean style. The AFCN station on 1200 in Puerto Rico is still on, o/YVOZ, and seemed stronger than when I was down here in '86. PJF1-1410, The Bottom, Saba, is here, and EE Carib style. Anguilla-1505 is on days as well as nights and is EE, with monotonous, hard-sell repetitious preaching. Dominica-595 is in all day also and was heard to refer to a Radio Nevis (Knee'-viss), but he nid not give the frequency - anybody know where he might be on the dial? I did not find him while in St. Croix. WRRA-1290 covers from 1270 thru 1310 on the GE Superadio at the King Frederik Hotel, which is about one mile from their tower. They have mostly island music, as does WSTX-970. The U. S. V. I. stations on 1000 and 1340 are more U. S.-oriented, and you'd not know they were in the Islands by their announcing and music, like Puerto Rico's EE voice, WOSO-1030, which has CBS Nx on the hour, ABC Nx on the half hour, and NBC Sx from time to time. Cable TV brings in WWOR-9, and I saw several Mets games while down there, including the game where Pedro Guerrero flung his bat at David Cone. Just a few brief FM openings since getting back home, nothing sensational, but a few newies. CHSJ is now a daytime local on 700 here; but not heard at all at night. So, good luck, Paul (thanks -pls), and may you always Forward - March! See you-all in Milwaukee.

Greetings, all ... It's official, WFAN is moving from 1050 to 660. WNBC is out, and media types are buzzing. Speculation abounds on the future of Don Imus and his morning crow at WNBC. Latest gossip leans toward Imus, Charles McCord, and Don Criqui moving to WFAN in the morning ... Jack Buck's relationship with CBS radio continues. He has been paired with Bill white to cover the World Series, and with Hank Stram to handle 40 NFL games ... Speaking of pairs, Dave Jennings (ex-punter for the Giants and Jets) is moving to the booth to cover Jets games with Marty Glickman ... KDKA's Roy Fox is packing his bags and moving his talk show to WCKY in Cincinnati ... The summer is certainly the time for stations to tinker with their formats and air personalities to start looking closely at their contracts ... Detroit's WXT's morning controversial talkshow host Al Gardner is moving to the sumny south for a spot on WFLA ... Ted Tevan has been axed again by CRCF in Montreal ... Dow

Pettit and the Milwaukee Admirals hockey team are moving to WISN next season ... The NAB and both houses of Congress are embarking on a rewrite of FOC regulations to simplify on-air lottery reporting and advertising.

It was a sad day in Baltimore broadcasting when on May 27 WCBM went off the air after 65 years of continual broadcasting. Its future has yet to be determined ... Shadoe Stevens will replace Kasey Kasem on American Top 40. Speculators believe that the change may happen before Kasem's contract runs out at the end of the year. Stevens has signed a seven-year (I wonder if Stevens will continue his "Fred Rated" character he created for contract. Federated Electronics TV spots? -pls) ... WABC has been making so many on-air changes that listeners will need a scorecard to keep track ... WWKB has given the ax to most of its on-air staff, switching to fulltime syndicated programming, effective June 10. What a shame to see the once-powerful voice of WWKB (WKBW) winding up in such a state ... WIP has signed a two-year deal to carry the NBA's '76'ers. The '76'ers had previously been on WFIL ... The latest book in Columbus shows AM ers lining up in the following order: WTVN, WMNI, WCOL, WVKO, and WBNS ... Don Wayne has retired from WHIO, after 46 years ... Boston's WBZ is still the number one AM'er followed by WRKO, WHDH ... "Fig" Newton has resigned his mid-day spot on WWWE ... KMOX continues its dominance in the St. Louis market with a 22.1 share.

WINE-940, in Brookfield, CT, is now programming oldies all the time. Its primary rival WLAD-800 has had a mostly oldies format for a while, with Ridgefield's WREF programming misic of the big band era. Not much of a musical AM selection in northern Fairfield County, CT. That is one of the problems living in the shadow of the Big Apple, just 65 miles away. FM ers clearly hold the edge in this, as well as other, parts of the country. My only real programming complaint with area local stations, both AM and FM, is their sparse news departments. They do an outstanding job of informing the public during hazardous weather conditions and local emergencies but fall down drastically covering routine (if there can be such a thing) news. Many listeners have told me that they honestly believe that the local stations pick up a copy of the morning newspaper and react accordingly. While this is a bit harsh, the time value factor is certainly a difficult one for local stations with understaffed news departments and small budgets to combat.

In this part of Connecticut many small towns utilize the town meeting form of government. Local issues, such as taxes and other voting issues, are important but rarely reported in time-valued manner. Many stations go with syndicated or network programs during the "off" periods and don't even staff the newsrooms or provide inserts during these times. The bigger, regional stations totally ignore local happenings, unless it's negative, a murder or major accident. What a shame. The results of elections or community votes are unknown to area residents until the morning, despite the fact that the polls closed the previous evening. Some area residents have even formed telephone trees to get the word out to interested parties. (!!!! -pls) What a sad commentary. The local FM sisters of these stations have little news time allocated. The local hardrocker probably figures that kids don't want it, as it breaks up their continuity, and the beautiful music probably rationalizes the same way. (The same problems exist all over the country, too. News coverage is expensive in radio -pls)

As Mike and Sue's tenure as editors of DX News comes to an end, I would like to thank them for all of their hard work on behalf of the NRC. I would also like to thank Paul for his editorship of the Musings of the Members column these past years. I feel that the fine line he has walked providing the members with a vehicle to share thoughts and information, without the personal attacks and non-related garbage of years ago, has done a lot to enhance the quality of the column. While I am passing out kudos, all the column editors should be commended for their time and effort on behalf of our organization. While I'm on a roll, maybe the club should consider waiving the annual dues for club officers and column editors, if we don't already do so (We don't -pls). Many organizations have enacted similar procedures to reflect, albeit in a small way, our support for their fine work. Hope I haven't stirred up a hornet's nest with this last comment, hi ... So much for now.

Hi all! Thanks to an incredibly noisy NYC apartment building I've been away from the BCB DX circles for some time. But by the time you read this, I'll be at the above address which should be a little more RF quiet.

As a reintro, I'm a 26-year-old systems analyst with a very small software and communications firm serving Wall Street. I joined the NRC back in 1978 when living in Cincinnati. From Cincy 1 heard and taped 1100 stations in 30+ countries and 40+ states. Best mail veries were KRDS-1190 in AZ, Anguilla-1505, Dominica-595, and the western biggies KEX, KOMO, and KMJJ. Back then I had a working HQ-180, but the power supply seems to be shot. At the moment I'm using a Sony 2010, an SM-2  $l\infty p$ , and an Eavesdropper dipole for shortwave. The 2010 and SM-2 are no match for the noise and the NYC locals on MW, so I've wandered up onto shortwave a bit.

Since I'm going to be at the NJ address for a couple of years, and since my girlfriend will be in law school for the next two years, I figure it's a good time to get back to BCB DX ing. This summer I ve vowed to build an NRC loop and get the HQ-180 fixed (and possibly modified with a mechanical filter or two).

I have some quesions for you folks out there, if you don't mind. First, is anyone building FET amplifiers for NRC loops these days? (I don't think so, Rick -pls) Or does anyone have and amplifier designs with instructions that even an electronic moron can handle? The actual loop should be fun to build, but I'm no whiz with a soldering iron. The only plans I have for an FET amp are the ones in the NRC antenna manual. Are the suppliers listed there still around? Second, what happened to the proposal to expand the BCB above 1600? Is it dead, or will we some day have some new high-end DX possibilities? The 1987-88 DX season dig not turn out to be what I had anticipated, with only a total of 13 new loggings of which 5 were merely call letter changes. 8 reports were sent but only 3 veries received - WNNZ-640, KSKY-650, and WESC-660. The 5 holdouts - WXPX, WCBC, WYRV, WJTZ, and semi-local WXRL-1300 for report on their recent power increase to 2400 watts. They prefer to read your letter to the audience than send a verification. (Can you record that? That'd be a new wrinkle in paper vs. taped veries! -pls)

This season I concentrated my efforts into bumper sticker collecting - writing to over 700 stations from October to April. The rate of return was rather discouraging, 46% overall with the best states being New Jersey and Massachusetts at 80%, Maryland at 66%. The poorest were Connecticut and Pennsylvania, 0% and 4% respectively. I wrote all 21 stations in NW PA and had only reply - WWCH Clarion who had no stickers of their own but kindly sent me what they had recently received as samples. On Tuesday, June 7, WWCS AM Stereo 540 "Your Clasical Stn" had its day at Pittsburgh's Three Rivers Arts Festival (June 3-19). With some time off, this DX'er took the year-old "T" (subway) into town for the first time and found several of the staff just setting up their operation adjacent to the main stage in Point State Park. Very soon I had the opportunity to meet three of the DJ's (one dressed like a Fred Astaire dancer and known as the "WWCS" Phantom!) and CM Joe DiDonato. WASHINGTON — Miami radio listeners who want some extra confidence can tune in these days to AM 980 — "Your Motivation Station."

Since August, it has been pumping out positive thinking 24 hours a day, 5,000 watts strong, in a fast-moving format that sounds like Top 40 without music.

It gives tips on courtesy, caring and achieving excellence, and pep talks from motivation specialista. It airs health advice, news edited to stress the upbeat, and tales of products and people that weren't supposed to succeed but did. Features like "Energizer of the Day" and "the WNN Supercharger" round out the broadcast day.

In New York another commercial AM station is on a new specialized track: round-the-clock sports. WFAN updates scores from games big and small every 15 minutes. It fills the airwaves with stadiumhero interviews, trivia quizzes and 3-minute features on subjects like sports surgery and workout routines.

In Los Angeles, meanwhile, AM station KMNY is trying something similar for the financially minded. This "Money Radio" is a 24-hour report on stocks, commodities, corporate strategies and the business world in general.

These are tough times for AM, the venerable pioneer of commercial broadcasting, and it is fighting back. With experimental formatis like these and technical innovation to bauish tinny sound and interference, it is working to stop a seemingly endless alide that has taken it to a 30 percent share of the listener market. As recently as 15 years ago, it had 70 percent of the market.

"What are we going to do to salvage the AM spectrum?" asked David E. Parnigoni, senior vice president-radio of the National Association of Broadcasters. "That's a real serious question."

What especially troubles AM radio is a generation gap among audiences. AM draws in older people, who tend to like news, information and "nostalgia" formats. FM has the younger audience, which likes music, music and more music.

Now AM operators are wondering whether their listeners will be replaced when they die out. Will baby boomers gravitate toward AM as their hair goes gray?

"That generation has been raised on FM and FM music," said Wayne Vriesman, vice president of Tribune Broadcasting Co.'s radio group. "Many of them today hardly know that AM exists." He said he thinks that technical improvements will help, but that they alone don't hold the key to a revival.

"AM," he said, "has to produce programming that is going to attract — programming besides news and information and talk that's going to attract these younger people as they mature."

To be sure, AM is nowhere near extinction. About 4,900 of the close to 8,940 commercial radio stations in the United States are AM, doing a business estimated by Duncan's Radio Market Guide at

\$1.7 billion to \$1.9 billion last year. FM is a far bigger business in dollar terms, though the station numbers are lower. In 1987, the 4.040 or so stations rang up at between \$4.8 billion and \$5 billion in sales, Duncar's estimates.

As earlier as the 1940s, some in dustry sages predicted FM's dominance. Its range might be shorter than AM's, but its tone was deeper, picher, making music more true to life

The changeover gained speed in the late 1960s and early 70s as lowbudget, underdog FM tried new formats in "beautiful music" and rock. "There was new programming that attracted people as well as superior sound quality," said James Duncan Jr., editor and publisher of Duncan's Market Guide.

FM's sparser advertising helped, too. At first, that was because harddy anyone wanted to buy time on FM stations. Today there is plenty of interest, but FM still airs fewer ads because the industry believes that listeners of all-music formats won't accept the volume of ads that air on AM. Eighteen minutes per hour of advertising is common ou big time AM; FM typically bas about helf that

AM's decline may have been speeded by the failing quality of its jown sound. Despite the mass defection of listeners. AM stations have continued to proliferate, crowding the spectrum and causing static on stations adjacent on the dial.

At night when the upper atmosphere bounces AM signals back to

earth, the stations' range increases, making the noise even worse. Today AM has retreated to a large degree into talk and information, in part on the logic that the

made in formats like that of the Washington area's lead AM station, WMAL — news, traffic reports, community service, personality disc jockeys, even a bit of music. In many big cities the biggest revenue station is still AM — WMAL, WGN in Chicago, WINS in New York.

And in rural America, generalinterest AM continues to thrive. Technical capabilities explain much of that: FM rarely carries more than 65 miles, making it commercially impractical in areas of low population density. A strong AM station (50,000 watts is the maximum allowed) will extend 750 miles or more at night and not be blocked by hills and valleys the way FM is. (AM continues to do unusually well in the hilly San Francisco area, partly for this reason.)

But for most smaller AM operators the squeeze continues, and a feverish hunt is under way for specialty formats. If listeners want something and your station alone has it, they'll tune to you whether you are AM or FM, the logic goes. "They don't really have to have -via Tony Fitzherbert

that mass appeal in order to stay in business," suggested Jim Gallant, director of broadcast operations at WMAL-AM.

Thus it is that in a suburb of Little Rock, Ark., a children's station has been on the air for the past 2/3 years. KPAL (K-Pal) is on the air from 6 a.m. to 10 p.m.

"The only reason we don't go longer is our age group goes to bed." said the station's general manager, Bill Henslee. Advertising is often aimed at parents who listen in-both by choice and necessity.

Other specialty formats don't make the cut, however. Station WHRS in Winchester, Ky, the heart of racing country, adopted an all-horse format recently. But it dropped it for "beautiful music" after the local station filling that more lucrative niche got out of the business.

About the only music category in which AM remains king in urban areas is 'nostalgia' Big-band music, introduced to America in the 1930s by way of vacuum-tube AM, sounds more authentic to many older listeners on that medium. So do many rock 'n roll hits of the '50s. Station KRVN of Lexington,

Solution RVV/V of Lexingloit, Neb, has found success through both rural service and one of the country's older specialty formats. It opened in 1951 as an all-agriculture station and today, at 50,000 watts, brings news and views on that subject to farm kitchens and tractor cabs across a large swath of the Midwest. It will go 24 hours in March.

AM hoped to brush off the cobwebs a bit with the unveiling of AM stereo in 1982, years after FM had adopted stereo. The trouble was that not one but five systems, all incompatible, went on the market that year.

The Reagan administration had just come into office, and deregulation was its theme. The Federal Communications Commission declined to set a single standard for stereo, saying market forces would do the job better.

"It was a disaster," said Tribune Broadcasting's Vriesman. "We lost years through that process." Radio manufacturers, consumers and stations postponed big-ticket equipment investments until it became clear which system would win out. Their dithering, of course, slowed the weeding-out process.

Today only two systems remain, made by Motorola Inc. and Kahn Communications Inc. Nonetheless, only about 10 percent of the country's AM stations broadcast in stereo, although that number may increase.

The number of stereo receivers is slowly proving. Acto-makers are starting to install them in new models, radios capable of tuning in either system have appeared, and industry officials are potting their heads together to work for a single, voluntary standard. **General** - Original pages are reduced about 63%, so that your original types or drawn page width mist be no wider than 7.7% inches to fit. Use pica (12 point) type; if you can, make each page 75 lines long. 8  $1/2 \times 11^{\circ\circ}$  paper is the best, but shorter lengths are perfectly acceptable. Balf-size columns (3.3/4° wide, for two-column pages) are time. Any other widths will result in wasted space, time, and effort. **Proofread** your typing. If you correct, type the correction; don't write it in.

Propiread your typing. If you control, type the correction, don't write it in. Prepare your submission EXACTLY as you wish it to appear. Use a black ribbon, not grey. Never tape over an original, type on colored paper, or make any mark over your original, except in a light blue non-repro pendil.

**Drawings and other graphics** should be in black ink, although you may want to do the original in soft .05 nm rencil and then photostat it. Submit photos in the form of black-and-white NEGATIVES ONLY, in 110, 120, 126, 127, 185, or 620 size. Indicate whether or not you wish the negatives returned, and by what time. Prints cannot be accepted. (If they are, the NEC can afford to have only a few PMF'ed.)

The contents of DX News is intended to aid the AM broadcast band DX for (500-1800 kHz) in pursuing his hobby, and submissions will be chosen according to this standard on a priority basis, normally to fill a 24-page issue, which can be writed for 24.1 cents per copy. If we can stay within these guidelines, we won't have to raise dues, and everyone will be happy. I think.

Articles may rang from several lines (radio news) to several pages. Avoid abbreviations, and use only obvious ones related to radio. Write so that an average 12-year-old can understand you. If your topic is technical, include summaries in layman's terms, not in mathematics, and explain just why your ideas are important to the hobbyist. (If you cannot produce layman's cory, consider instead writing a monograph for reproduction as an NRC reprint.) Attribute sources in the text, and include a bibliography, if necessary. (Obtain WR197EN permission when quoting copywrited sources.)

In other words, write clearly and simply, so we can understand what you're trying to say.

DXN needs ... short news items, such as the ones in this issue prepared by Pete Kemp ... evaluations of receivers, antennas, and other DX haroware ... technical articles in layman's language ... propagation information ... news about the hobby ... historical articles about radio and the hobby, especially from older members, in the form of anecdotes or articles ... Arbitrons for major cities, including both AM and FM ... clippings, of current important BCB events ... cartoons, both editorial and humorous ... fixit how-to's and construction articles for beginners ... more submissions by all members to all columns ... more readers. Keep in mind that the shorter a submission, the better chance it has to get in somewhere. Next deadline: Saturday, August 6.

Finally, don't despair if your submission is not printed immediately, eventually, or ever at all. I have brough clippings and station logos to use as filler for another 25 issues, for example. If you take the trouble to submit an original article, you can expect the editor to consider it carefully, but don't be offended if you're asked to rewrite it. If you can't type, send the article in anyway, and we'll get it typed ... I'll have students who may need the credit desperately for class. I'd prefer queries before you prepare articles longer than one page, so we can plan accordingly. Thanks for your help in making DXN better than ever.
