MORE SILENT AM STATIONS: FCC UPDATE

Late last year we ran what was billed as the "official" FCC listing of silent AM stations. As is typical of "official" FCC documents it was outdated and filled with obvious errors. Member David Lewis obtained an updated list dated 12-17-91 and forwarded it to me. As usual it was alphabetical by call so it's taken us some time to look up all the calls and attach frequencies to them. As before there were quite a few errors. A local station that I know returned to the air in September of last year was still on the list. Another that returned back in 1990 (!) is still listed amongst the silent. In all we found about a dozen really glaring errors and have corrected them in the list offered below. No effort has been made to add silent stations noted in DX News since the date of this list (approximately DXN #11) since it is assumed most of the membership has updated their Logs already. If you don't show these stations as SILENT you may assume that they are and thus update accordingly.

As before, if you have FIRST HAND knowledge of any of these stations no longer being silent please send that information to me. It will be included in subsequent AM Switch columns. And PLEASE, before you write to add stations to this list, check the AM Switch columns between Issue #11 and now to see if they have already have been reported.

White DJ of soul helped America go funky in '40s with black show

At the end of World War II, much of rural America remained without local radio. Even communities with their own stations often were left silent at day's end, when many broadcasters signed off.

But after sundown, when the ionosphere got good and slippery and radio waves started pogo-sticking, bouncing like bad checks across the starlit hinterlands, there were the clear channels — the 50,000-watt powerhouses that reached for those distant, mostly rural audiences unserved by daytime radio. They were Nashville's WSM with its Barn Dance; and New Orleans's WWL,

"with studios high atop the Roosevelt Hotel."

And above all there was John R., "comin' at you from WLAC, Nashville, Tenn., 50,000 watts strong, 24 hours long, way down South in Dixie."

His real name was John Richbourg. He was white but played only black music. In fact, he was the first major disc jockey in America, white or black, to regularly program rhythm and blues, blues and gospel — a milestone frequently and erroneously accorded Cleveland's Alan Freed, who began his show in 1951.

It was 50 years ago that John R. joined WLAC. For three decades, until 1973, he was a cultural staple of rural and black Southern life. He had his brew of down-home rhythms and sales pitches for Dixie Hummingbird records, Rose Petroleum Jelly and Red Top baby chicks ("50 percent guaranteed alive at the time of delivery").

"He had so much soul that people in the black community thought he was black," says James Brown, who credits John R. with bringing his music to national attention. "I loved the man."

Artists nationally "broken" by John R. include Mr. Brown, Otis Redding, Ray Charles, B.B. King, Jackie Wilson, Gladys Knight, the Coasters, Joe Simon, Jimmy Reed, the Dixie Hummingbirds, the Orioles, Johnny Nash, Pigmeat Markum and Moms Mabley. Two years before Mr. Richbourg died of cancer in 1986, many of those artists — including Mr. Brown and Mr. King — returned the favor, appearing gratis with their bands at a testimonial dinner.

"Otis always listened to John R. when he was on the road," says the late Mr. Redding's manager, record executive Phil Walden. "He also called him pretty often. Sometimes they'd talk on the air. You see, in addition to everything else, John was a good soundboard to find out if a single had been done properly."

Wolfman Jack says, "He lives with me. I do his style, even today. He used to raise goose bumps on me, and nobody else has done that — except possibly me sometimes."

Love for black music

Born in 1910, Mr. Richbourg came to WLAC after a short stab at acting in New York and a brief radio job in Charlotte, N.C. Except for a World War II stint in the Navy, he remained at the station until retiring in 1973.

Mr. Richbourg's affection for black music was shaped during his boyhood as the son of a cotton broker in rural Davis Station, S.C. "I used to listen to the farmhands as they would come in at the end of the day singing," he once said.

"I know people say this all the time, but they really did sing. And this particular plantation worked about 200 people. And to hear that many people singing — spirituals, songs of faith, that sort of thing — was something that was always exciting."

Although a self-described "independent conservative," Mr. Richbourg quietly opposed racial segregation throughout much of his life. During the 1940s, while teaching at a Nashville broadcasting school, he cir-

cumvented Jim Crow laws barring black students by inviting them to come around WLAC after his show for informal lessons on a station console. Later he opened a school for black broadcasters.

Until the end of World War II, American radio remained a largely white medium. Black people didn't own and only rarely worked at stations. Except for a few low-powered urban outlets, broadcasters didn't seek them as audiences and rarely played their records.

Funky format an instant hit

Even WLAC began programming black music as a fluke. One night in 1946, local black college students talked their way past a security guard and into the station to ask disc jockey Gene Nobles if he'd be willing to put aside his Tommy Dorsey and Jo Stafford records long enough to spin a few of theirs.

Other jocks — William "Hoss" Allen, Gene Nobles, Bob "Wolfman Jack" Smith and Hugh Jarrett — worked WLAC's night shift, and it was Mr. Nobles who first experimented with black music on the station in 1946. But John R. was the one who listeners waited up for. "And that's right," he would boom with his river-deep resonance, "you can get that record at Ernie's Record Mart, Nashville, Tenn. My, my, there's records galore in that store. . . . And don't forget Royal Crown hairdressing, friends, because just a touch adds so much!"

John R.'s nightly broadcast ran in segments between 8 p.m. and 3 a.m. The 1 a.m.-to-3 a.m. segment, devoted to advance copies and other new material, was a phenomenon. "All the jocks around the country would stay up and listen to him just to hear what the hell he was goin' to play," recalls colleague "Hoss" Allen.

"Why not?" Mr. Nobles replied.

He played, and liked, the students' boogie and blues records.

So did WLAC's listeners — though not the ones the station had assumed made up its main audience. As approving mail flooded in — much of it from out of state — the station realized it had a larger, more widespread and blacker audience. WLAC decided to devote all its evening programming to black music.

"WLAC was the only black music on the radio when I was growing up," says the Rev. Robert L. "Jackie" Beavers, who listened to John R. as an adolescent in Cartersville, Ga.

Later, as an R&B performer and nightclub owner, the Rev. Beavers became a friend and business associate of Mr. Richbourg and even delivered his funeral oration. He still laughs about their first meeting in the 1960s: "I was in heaven 'cause I was gonna finally see this black man I'd listened to since childhood. Then I saw he was a white man — I almost fainted."

At its peak, John R.'s program was said to reach 14 million listeners across 38 states. He also enjoyed a wide following among young whites, such as country songwriter Bob McDill, whose 1979 hit "Good Ole Boys Like Me," recorded by Don Williams, included a paean to boyhood nights in Beaumont, Texas, listening to WLAC ("when John R. and the Wolfman kept me company/By the light of the radio by my bed").

"There was something very romantic about John R.'s show," Mr. McDill says, "about that voice way down at the end of the dial coming over all those miles, selling all those baby chicks and Royal Crown hairdressing."

Mail-order sales were important in more ways than one. Not only did Mr. Richbourg become the king of "per inquiry radio," a form of mail-order selling by which stations are paid a specified amount per inquiry the company receives. Mail-order sales also gave him his air name: John

R. was easier for customers to write.

WLAC's monopoly on black music didn't last long. By the late '40s, other stations were programming it. In 1947, white-owned WDIA in Memphis became the South's first radio station to try full-time black programming, and, unlike WLAC, it hired black on-air talent. In 1949, Atlanta's WERD became the nation's first black-owned radio station.

As gospel, R&B and blues widened their broadcast niches, WLAC's hold on its listeners faded. By the early '70s, the station decided to ditch most of its black programming. Although "Hoss" Allen continues his nightly gospel show, 1510 AM otherwise devotes itself to a news and talk format. As segregation had made the WLAC phenomenon possible, so the fading of racial barriers ended it.

John R.'s professional and personal demise came just as precipitously. After he left

WLAC in 1973, Mr. Richbourg — a small man with dark, slicked-back hair — exhausted his money in unsuccessful efforts to launch a record company. Toward the end of his life, ravaged by cancer, he sold his prized record collection — four decades in the making — for \$700.

He also tried, without success, to get back into radio. By then, of course, work for white R&B disc jockeys was scarce. Sadly, the man who had filled the American night with Orioles, Dixie Hummingbirds and Red Top baby chicks had crafted his own obsolescence.

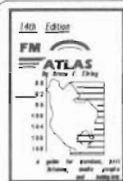

MedFERs, which operate under Part 15 of the FCC Rules and Regulations, are unlicensed and may operate anywhere in the MW band with a maximum power of 100 mw. Most, if not all, use CW transmission; therefore, a BFO is required to hear them. There are probably many other active MedFERs that are not listed and some that are

listed may be inactive. If you have any additions, corrections, or deletions, please submit them to either the DDXD-East or DDXD-West columns.

Even though MedFERs run at only a tenth of a watt they do get out and they do verify. So why not give 'em a try? Have fun and good DXing! DX'ing 'smart', with shared tips and requests by NRC members

You're listening to talk on 1290, coming through the electrical noise and interference from other stations. You aren't sure, but you believe that it's Larry King. So you turn on another radio and tune in to the local station that carries LK, and sure enough, it's the same as what you're hearing on 1290. So now you check the NRC AM Radio Log or frantically search back issues of DX News to find out who carries LK on 1290. You've just utilized one of the most popular techniques for IDing difficult DX - parallel DX.

PARALLELS

A parallel can be loosely defined as a simulcast, relay, network, or any situation where two or more stations are broadcasting the same programs. Some parallels are more useful than others. Domestic nationwide networks can be helpful in narrowing a field of candidates, but should not be used alone for definite verification.

Local sports networks can be useful parallel targets. For example, if you're in Boston, and you think you're hearing the Red Sox on 610, then tune in to WRKO and compare the audio. If they're the same, you could be hearing either WGIR or Florida's WIOD! Now just concentrate on catching a local commercial or weather forecast during a break, and you've got a newie! Check out the Sports Networks column for possible targets.

Networks in Canada are better parallel targets because there are fewer stations. In many cases, the CBC or the regional Radio Mutuel for example, will be on only one station per frequency. So if you're hearing opera music or French talk on a weak signal, consult the log and make the comparison with a stronger regular.

Parallel targets are most useful when trying to ID foreign language international DX. Cuba's Radio Rebelde is one of the most well known parallel targets, with several mediumwave and two shortwave frequencies. And if you're not too good with foreign languages, the shortwave parallels can be a big help in IDing a station.

YOUR HOMEWORK ASSIGNMENT

To get started with using parallels as a targeting technique, generate a list of stations that are parallel to one of your regulars. For example, if Radio Mutuel's CJMS-1280 is one of your regulars, scan the NRC AM Radio Log and jot down all the other stations listed on the net. Now tune in to CJMS on your secondary receiver, and start DXing on the primary receiver. You may be surprised at what you can hear! Some of your homework has been done as TDX provides the following list of stations and their parallels, compiled from the pages of DX News and this editor's logbook.

By the end of January, the Latin American & Caribbean DX that was all over the dial during the previous weeks had literally disappeared. Even 825 was quiet w/ no sign of St. Kitts. So I enjoyed some domestic listening and DXing during the quiet spell. 1/24 I was listening to Radio Mundo Hispano on WUNR-1600 when they signed off early at 5:30 PM without explanation, with full data & SSB, leaving WRAL in the clear with Shadow Traffic, 'Spirit of NY' ID & inspirational music. 1/31 WMZQ-1390 came in strong at 6:40 PM w/CW music, a QC traffic report, simulcasting their FM. 2/1 WICC-600 noted better than usual w/Super Gold satellite oldies at 7:45 PM, no Cuban interference. Newie WGGM-820 was in good w/an ID for Chester-Richmond-Petersburg at 8:01 PM & VA basketball. Another newie WWMO-830 was alone on the frequency but weak w/CW gospel music at 8:24 PM. WHCU-870 noted w/Syracuse basketball on the NY State Radio Network at 8:45 PM u/WLAM. A lot of growling interference was burying WLS but no Spanish heard.
