

WQEW Changes Format

NEW YORK It was a signature sound of New York City-the place where, in 1936, the city's first disc lockey, Martin Block, created "The Make Believe" Ballroom." Now it is history.

After 58 years of broadcasting, WNEW(AM) on 1130 kHz in New York, is no more. The historic station: was synonymous with American musical legends like Frank Sinatra, Tony Bennett, Count Basie and Ella Fitzgerald. The format that made it. great is affectionately called the "American Popular Songbook."

WNEW ceased to exist after its frequency was sold to former investment banker Michael Bloomberg, who renamed it WBBR (for Bloomberg Business Radio).

However, with every ending comes the promise of a new beginning, and so it is with radio. Passing the torch with all the glamour and fanfare of a gala New York opening night, the New York Times Co. christened WQEW(AM) the successor to WNEW.

WQEW-on 1560 kHz, operating with 50 kW-replaces WQXR, a classical format station for the past 56 years. WQXR-FM, on 96.3 MHz, also owned by the New York Times, will continue to air classical music

Singer Tony Bennett was at the microphone with program director Stan Martin and air personality Jonathan Schwartz, both former WNEW staffers, to kick off the new radio station at a sign-on ceremony on Dec. 2, "WOEW will play the great writers, the great players and the great vocalists, and present them tastefully to an audience that appreciates the very best of the American Popular Songbook," said Martin.

Bennett introduced the first record, Frank Sinatra's "New York, New York." The set followed with "Stardust," by Nat King Cole and Bennett's own "The Best is Yet to Come." Later, at a party to celebrate the sign-on, singer Liza Minnelli and Bennett made personal appearances.

WQEW transmits from Maspeth, N.Y. and covers the greater New York metropolitan area, from Long Branch, N.J. to Newburgh, N.Y. to New Haven, Conn. to Patchogue on Long Island

As for the demise of WNEW, there was an air of nostalgia that comes when a great institution is lost forever. "It is sad," said former WNEW disc jockey Mark Simone in an interview with New York Magazine, "but it's happened to every great radio station that ever was. I mean, that's what radio is, isn't it...echoes?"

An early deadline this week due to my vacation plans, but there are a few things to report. The big news was the end of my 660 iinx ... sort of. Read on!

PAN-AMERICAN DX

660 ST. LUCIA SLBS 1/3 0645-0735 - With nothing else worth pursuing, I was listening to WFAN football talk while typing, when the call-in host suddenly announced a sign-off "for an hour and a half'. Presumed SLBS on late with Australia vs. West Indies cricket match (sounded like an Australian announcer, but no SW parallels found), AST TC at 0704 ("3:04") after coverage concluded, then music "You Are the Only One", other announcements (including mention of St. Lucia) about sports events, and soca music. Correct southeast bearing, weak. At first happy to hear anything on 660, then bummed out that previously IDed SLBS was blocking long-sought Mexico. I was tempted to call up WFAN when it came back on the air and compliment them for their fine cricket coverage, since all the other callers were complaining about the dead air! [JR-NY]

660 MEXICO R. Seis Sesenta 1/3 0710-0758 -At first poor under SLBS, UTC-6 TC for "Ciudad de México" at 0713, then blasting away SLBS for good with popular music (salsa, lambada) by 0735, leading up to sign-off announcement mention of R. Seis Sesenta, and abruptly into Mexican National Anthem, power cut at 0758. It could be Mexico City's XERIN, which is scheduled for 0800 sign-off on IRCA List and 1992 WRTH, but the "6-60" slogan is not mentioned in either listing in conjunction with XERIN. Can anyone help me on this one? [JR-NY] (You bet - the Mexico City station uses only "R. Seissesenta" as their slogan, and they play a variety of Spanish-language music. I did not hear them use any call letters while I was down there, however -pls)

660t MEXICO La Mexicana, Tampico, 1/3 0800-0817 - A much weaker Mexican station on the same bearing was left after R. Seis Sesenta signed off, playing a more traditional blend of music. In fact, the first song I noted was an accordion piece "El Chubasco" my wife Melissa had been practicing (over and over) on her accordion on our ride back from Washington just a few days ago! Other accordion pieces followed. Two partial IDs heard "... Sesenta, La Mexicana". Possibly XEAR Tampico "La Mexicana", but 500 watts shown in WRTH makes me skeptical about it (although Paul Swearingen says this is heard in Kansas) (Tim Hall's list shows 1000 watts, and the musical format also fits -pls.) Final song before WFAN came back on at 0817 was an orchestral piece I identify with the soundtrack of old silent movies where the damsel is in distress. I'll need to review the tape on the above three loggings to see if other details and clues can be found. [IR-NY]

NETHERLANDS ANTILLES PJB Bonaire, 12/23 0345 - Poor with religious program in English in splatter from local CKJS. [SA-MB]

STATION NEWS

ANGUILLA: On a recent edition of "World of Radio" (12/26) Glenn Hauser solved the reported logging of the Caribbean Beacon on 700 kHz by a PLAY-DX reporter on vacation in the Caribbean (DXN 60-12). It is a mixing product from 1610 kHz minus 910 kHz. Thank you, Glenn. [JR-NY]

CUBA: To all publications which have reprinted Alain Pepin's CUBAN AM AND FM LIST: the numbers added to some call-sign's are NOT legal call letters, they are Alain's own invention to distinguish between different relay transmitters. [JR-NY]

CZECHOSLOVAKIA: As of midnight, January 1, 1993, this country is no more, having peacefully separated into two new countries: The CZECH REPUBLIC (capital Prague) and the SLOVAK REPUBLIC (capital Bratislava). I happened to tune in the English shortwave broadcast at midnight (apparently recorded earlier), and they were still IDing as Radio Czechoslovakia, but the announcer said that while he didn't know what they would be called in days to come, they would still be broadcasting. Two of the three RC SW transmitters are located in what is now Slovakia. [JR-NY]

NETHERLANDS ANTILLES: Transworld Radio is to cease all short wave broadcasting from Bonaire July 1, 1993. The service will go to satellite. [DX Australia 12/92] (No mention of 800 kHz medium wave in this item - Jim)

UNITED KINGDOM: Virgin Radio frequency allocations are likely to change subtly from previously published information. Previous reports indicated use of 1197 and 1215 as main channels, supported by ex-BBC local radio channels such as 729, 1485 and 1521 kHz. In an attempt to rationalize the distribution of frequencies nationally, Virgin Radio is hoping to use only channels between 1197 and 1242 kHz. Specific allocations are not yet public and if the Radio Authroity doesn't give the go-ahead, Virgin will fall back on previously published frequency schedules. It seems that frequency uncertainty will not put back start of test transmissions due for next spring, and tests with new frequencies may be brief [Direct from Virgin Radio via Steve Whitt in Medium Wave News 12/92] This could mean new UK activity on three channels 1206, 1224, and 1233 kHz, except the already allocated channels 1197, 1215 and 1242 kHz. Any activity on channels other than 1215 kHz is intended to fill in holes in the main coverage area so transmitters are likely to be low power, probably 0.5-2 kW. [Distance 12/15/92]

Target DX

DX'ing 'smart', with shared tips and requests by NRC members

In this edition of **Target DX**, we'll zero in on hets, per the suggestion of Tom Beaton, who inquired at Ray Arruda's GTG about het loggings that have appeared in IDXD.

WHAT'S A HET?

Het is short for heterodyne, a steady tone heard when stations broadcasting on nearly the same frequency "beat" together. Usually one station will be a stronger regular, let's say it's WLS-890, with a tone heard under the WLS signal. If the interfering signal causing the tone is strong enough, then you should be able to tune slightly off of 890 until the tone disappears and hear audio from the other station. In this case, knowing that there is a strong signal from Algeria on 891, you would tune to 891 and null out WLS as much as possible. The result should be some audio from Algeria. Sound simple? Not! This does require a little finesse and patience, along with the right conditions.

The "beat" frequency in this case refers to the audible pitch of the tone, which is determined by the difference in the frequency of the two stations. The difference between 890 and 891 is 1 kHz, so the tone produced by this particular het will be

1 kHz. Other examples:

1) Two stations on exactly the same frequency will not produce a tone.

2) If Cuba's Radio Reloj is slightly off frequency at 760.2, then a 200 Hz low frequency growling might be heard under WJR-760.

 When St.Pierre et Miquelon is in strong on 1375, a 5 kHz tone might be heard under your local station at 1370 or 1380. TARGET HET LIST

With this basic understanding in mind, here's a target list of trans-Atlantic hets. These should be fairly easy game for east coast DXers.

- 91 ALGERIA Listen for French or Arabic language programs and upbeat local music.
- 981 ALGERIA A little more challenging than 891 because of regional domestics on 980.
- 1089 ENGLAND English/Euro-pop music, sometimes Spain is also heard here.
- 1359 SPAIN Try for stations from Arganda (new 100 kW) or Melilla on this frequency.
- 467 FRANCE Heard in English, German, and French, a challenging catch for beginners.
- 521 SAUDI ARABIA Arabic chants and talk, many times dominant over WWKB-1520.
- 1593 GERMANY German and US pop/rock music, try after 0300 UTC (sunrise enhancement & power).

Don't get discouraged if you can't hear all of these hets. I haven't logged them all yet either. By keeping track of loggings in IDXD, noting the time, location, and equipment used, you could make up your own target list of hets based upon your own experience and capabilities. Given the right location and conditions, hets can be logged using a barefoot portable's directional capability to null domestics. 73s and good luck!



The Superadio III - A brief review ... by Gerry Thomas

Being a long-time fan of the General Electric Superadio, I was eagerly anticipating the arrival of the new Superadio III. This was especially true because the "III" was touted has having dual selectivities and I had tried several years ago to install a narrow ceramic filter in my old "A" model without success (that is, without excessive insertion loss or leakage). Because I couldn't find a "III" in Pensacola and because my wife was planning a visit to Tucson, AZ, I asked her to look out for a Superadio III and buy a couple (one for me and one for my local DXing buddy, Charlie Barfield) if she came across any. She called to say she had found them priced at \$39.95 at a discount store. This was well below list price and I was ecstatic---"How lucky could I get? The upgraded "III" model with dual selectivity and at a lower cost than my old Superadio II! Hot Dang!"

Well, to make a long story (i.e., "review") short, the Superadio III is a bummer (in my

humble opinion, and based on an examination of only two samples).

Packaging Impressions

The first tip-off to my impending gloom was the description of the dual selectivity feature printed on the outside of the box. Instead of saying the usual "Wide" and "Narrow" for the two selectivity positions, the description talked about WIDE and NORMAL; (What? That's a strange way of labeling selectivities, I thought). And this dual selectivity feature was called "AM Accent"---not a radio electronics engineering term I had ever heard of before. Oh well, all the other heart-string-strumming words were there---Tuned RF on AM, Large 7-7/8" Ferrite Rod, Long Range Reception, and so on. So, I opened the box and found a very handsome, black with chrome trim radio about the same size as the older Supers.

Turning It On

The first thing I noticed upon applying power to the "III" was what seemed to be an uncharacteristically high level of "hiss" to all but the strongest of local signals. As I tuned down the dial, I noticed that the dial read-out seemed to be pretty consistently 30-40 kHz off from the actual frequency but my real shock came as I started to notice "birdies" at several places across the band, apparently the result of my strongest local WRNE-980 (a moderate strength 10 kWer). The old Superadio II never had trouble with any of my locals. Hmm. What's going on here? There was no apparent answer so I decided to try the dual selectivity feature and, as it turns out, the label on the controls is accurate---the selectivity is WIDE and NORMAL (not NORMAL and NARROW as I would have preferred). The only difference between the WIDE and NORMAL positions is an increase in the hiss level in the WIDE position; any improvement in fidelity was minimal (I guess because the NORMAL position pretty well passes most of the AM audio band already). I had to find out what in the world was going on here so ...

Off With The Back

I noticed as I was removing the screws on the back of the radio that, whereas earlier models of the Superadio were made in Japan, Taiwan, or Malaysia, this fellow was made in China! Removing the back revealed even more surprises. The first was that there was only one circuit board (earlier Supers had isolated the RF/Oscillator sections on a board separate from the IF/AF sections). The second BIG surprise was THERE WAS NO VARIABLE CAPACITOR!!! THEY WERE USING VARACTOR DIODES TO TUNE THE THING! Now, it is definitely possible to design a perfectly adequate radio using varactor diodes but the engineers who put the Superadio III together obviously flunked the course. Things were becoming clearer---this radio was not designed for performance, it was designed for profit margin. A tear almost came to my eye as I recalled the beautiful metal, multi-ganged, relatively expensive, airgap variable capacitor that tuned the old Superadios; here I was looking at a single, cheap potentiometer controlling at least five varactor diodes. As far as the dual selectivity feature goes, there's no sign of an AM ceramic filter; I think (though I'm not sure; I don't have a schematic) in the WIDE position a Qspoilling resistor is simply switched in. It is really a shame that such a venerable nameplate as the Superadio has been reduced

Attempts At Improvement

I spent a couple of hours the next day trying to align the various sections of the beast with only minimal success---it's just a poor

Performance---HA!

In the daytime, I get nine stations; none farther than 50 kW WWL-870 in New Orleans. At night, things pick up so that almost every channel has a station detectable (but my \$9.95 clock radio does too).

FM? Audio was great, AFC worked fine, DXability? I don't do much FM DXing so I don't feel qualified to comment.

At this point, my disgust was just too overwhelming to continue. Charlie Barfield reports similar non-results so my findings apparently aren't a fluke. And given the engineering/manufacturing short-cuts I saw inside the radio, it's unlikely, in my opinion, that dramatically different findings would occur with different samples.

Conclusions

The Superadio III is a major disappointment. If you want to experience a really super radio, run to your electronics stores and try to find some remaining Superadio IIs. Pay extra, if you have to, but think twice about purchasing the Superadio III; that would only encourage General Electric's Consumer Electronics Division to continue offering low-performance/high profit margin products.

Expanded Band Delayed

WASHINGTON Problems that have delayed the opening of the expanded AM band (1605-1705 kHz) for several months are expected to be resolved "shortly," according to the FCC.

William Hassinger, the FCC Mass Media Bureau's assistant chief of engineering, declined to elaborate on the nature of the delay, but said once the problems are worked out, the FCC will begin processing applications for the new frequencies.

Hassinger said he had hoped the problems would have been resolved before the end of the year.

The expanded band allocation was part of the FCC's AM improvements program (Docket 87-267), approved in early 1992. Receiver manufacturers have been adding the frequencies to tuners and radios for two years.

Although the FCC declined to comment on what caused the delay, it is reportedly a disagreement with the National Telecommunications and Information Administration (NTIA) over Travelers Information Services (TIS).

Travelers Information Services are low power AM transmitters used to relay information to motorists, such as traffic, weather, and airport directions. Disney World, for example, uses TIS to relay information about the theme park as motorists approach it. Most TIS facilities are located on 530 kHz.

The FCC wants to allow the TIS providers to operate anywhere in the existing and expanded band on a secondary, non-interfering basis. The NTIA and other groups, including NAB, said the service should be given set frequencies-530 kHz on the existing band and 1710 kHz on the expanded band.

Another issue had to be resolved before the expanded band could be open to applications: a treaty with Mexico over frequency coordination of expanded band frequencies in the borders areas. It has been settled, according to the FCC.

MOGADISHU, Somalia — At a sidewalk table outside Jasiira Mini-Market, eight men gathered to peruse the sensational news in the city's new morning paper.

"Ninety-five percent of it is untruth. It is making exaggera-tion," said Abdukadir Esse, his Kalashniko vrifle across his lap and a bundle of stimulant khat leaves in

a bundle of stimulant khat leaves in his pocket. "I think it's propaganda, yah?"

Esse was right. The newspaper, called Raja (or Hope), is published by the U.S. Army's 4th Psychological Operations Group, known as "psyops," and it is intended to make Somalis more compliant with the allied humanitarian cam-

with the allied humanitarian campaign.
Col. Layton Dunbar, the psyops commander, presides over Raja—circulation 8,000, the capacity of his digital printers. He is also responsible for Radio Raja, which broadcasts twice a day on the AM band for half an hour, and for the leaflets dropped before the first troops arrive in each new city. troops arrive in each new city.

"It's not easy to find a Somali native speaker with a security clearance," Dunbar said. "We printed up several million of that

All that changed with the arrival of Abdullahi Omar Mohamed, 35,

a naturalized U.S. citizen who was born in Mogadishu and is a Wash-ington-based financial consultant and linguist. A contract interpreter for the State Department and interfor the state Department and inter-preter-translator for the Justice Department, Mohamed got a call from Dunbar the day before the Marines bit the beach.

At Mohamed's insistence, the broadcasts also begin with a pas-sage from the Koran. One Somali song accompanies the news and then, in uncertain concordance with Islamic values, Bonnie Raitt sings, "Let's Give 'Em Something to Talk About,"

"The Somali people like West ern music, as long as it's kind of up-tempo," said Sgt. Robert Gwin, the radio-station manager and

technical guru.

Secretary-General of the Organisation of East Caribbean States, Irene Bramble of the Antilles Radio Corporation and Karney Osborne of Radio Antilles will welcome representatives of the international broadcasters involved at a ceremony to be held in Plymouth, Monterrat. The BBC will be represented at the ceremony by Barry Whitehall, BBC World Service's Controller of Resources and Administration

Commenting on the BBC's role of

Mr. Whitehall said: "The restoration of this important transmitting station is a remarkable joint effort by the international broadcasters. It allows Radto Antilles to provide once again, its much appreciated Caribbean Programming, but also outlet for the BBC and other international broadcasters to relay their

"BBC Transmission has been involved in planning and supervising stroyed 'Hurricane Hugo' in September 1989. We are delighted that the close links we have established with Radio Antilles will be continued through the management and World Service.

Radio Antilles 100KW medium wave transmitter operates on 930 kHz. Its coverage serves the Caribbean region during daytime but extends as far as eastern Cuba and Columbia after dusk.

BOB HARRISON - 166 RENNER AVENUE - UNION, NJ 07083-8839 ----- First of all, thanks to AL QUAGLIERI for his special assistance in obtaining a verie from reluctant WMVI-1160. And thanks also go out to VIC MELIS in helping me locate the new GE Superadio III. Again and again, the NRC crew comes through! The new Superadio has proven to be a super disappointment. Maybe they took some engineering shortcuts with this one, or perhaps my receiver was defective but the entire band from about 1030 khz up beyond 1600 khz was filled with an annoying background noise, preventing any hope of DXing with this thing. The problems persisted day & night with electric or with batteries, even local WQEQ-1560 was almost unlistenable. And a spur of WCBS-880 was constantly heard on 850. Anyone else have any comments on the new Superadio? I'd really like to know whether I just happened to get a lemon. Quite by accident, I found another inexpensive portable that is rather good for AM DXing, the RCA Audio-Trak RP7750. Any other recommendations? The major wind & rain storm which struck the NE on 12/11 affected a few stations here. WMCA-570 was knocked out the entire weekend, and WNYC-820 was off for more than a day. WNJR-1430 was severly crippled for a few hours in the afternoon and early evening and the only DX I got out of the whole thing was WDIC-1430 with a full-data sign-off at 5:15PM. Nothing new on 570 or 820 but it was great to hear WBAP once again. Another DX opportunity came with the WNEW/WBBR switchover. On Monday 12/21, WBBR honored the silent period of WQEW which it was simulcasting and in skipped WWWW ('Our call letters are easy to remember, they're all W's!'). By the way, never did squeeze a verie out of WQXR, hope WQEW is a little friendlier. Finally, at long last, I've finally logged the station which had been my closest unheard since I began DXing over 10 years ago, WTTM-920. I had heard & verified 11 other stations on 920 from Melbourne (FL) to Milwaukee, but not a peep from Trenton, just 42 miles away. And now, suddenly, WTTM is a daytime regular! Not an 'easy' regular but definitely in there all day long under WPAT-930 splash. No doubt they've made some transmitter changes there (no, a new directional system was installed, they're likely setting up the pattern by this time-DWS). Taking WTTM's place as my closest unheard is the new WIFI-1460 down in Burlington County. Best wishes for good DXing to all in 1993!

GERRY THOMAS - 3635 CHASTAIN WAY - PENSACOLA, FL 32504 ----- Time is becoming incredibly precious around here of late, I'm down to less than 5 hours sleep a night now and, unfortunately, it isn't because I'm DXing all night-hi! I did manage to try a couple of tests a few weeks back but fell asleep at the dials so I missed them. By the way, a tip of the hat to J D STEPHENS for setting up all the tests the past few years, thanks for a thankless job well done. I just finished a quickie review of the new G E Superadio III and sent it to HQ. The bottom line? It's a loser due to GE's engineering and manufacturing shortcuts (lousy sensitivity, birdies, good FM audio, though). The Superadio A, B & II models were excellent in most all respects, the III changes in the circuitry and excellent engineering of those models to save a few bucks and ruins performance in the process. If you want a Superadio, try to locate a leftover model II, forget the III and its \$10 clock radio performance. I've received a few questions about the Quantum Loop. According to my calculations, its 'effective height' is about 19 inches, that is, its signal gathering ability is about the same as a 13' box loop with a 40+db amplifier. Its sensitivity falls somewhere between my 3ft. inductively coupled box loop with 18db amplifier (which I used for years) and a 4ft. directly coupled box loop with single stage amp. Also, like all loops, teh deepest nulls of locals are produced when the coil is tilted so that the coils smallest dimension is perpendicular to the signal. On air core loops, this is the open end of the windings, on the Quantum (because the coil diameter is smaller than its length), the deepest null is when the strong signal tobe-nulled is perpendicular to the body of the coil. Incidentally, I've printed up some descriptive brochures (with photo and user comments) of the Quantum Loop. If you'd like one, a large SASE will get it to you. Backlogged orders for the loop still are resulting in waits of 3-4 weeks. 73

Only a jingle "Oldies 92.9, KFSO", no mention of location or 2 AM outlets on 980 & 1400. KEYX-1400 has a local morning drive show but otherwise seems to relay this. KLLB-1510 sneaked an ID ('The new KLLB') thru KTID at 4:10PM. KHPY-1530 (Spanish with 'Radio Felicidad' slogan) was giving KFBK a good battle to 4:47PM s/off. 12/19 KORC-850 w/ID and local spots at 6:34AM in KOA null. Does this one have PSRA now or were they on by mistake? 12/23 KUFA-1470 was a surprise visitor at 5:04PM w/local spots & ID during Jazz basketball. 12/24 brought 3 new ones onl 400, KWNA w/spots for Winnemucca businesses 5:06PM, KART w/CW & ID (giving location as 'Jerome-Wendall-Twin FAlls') at 5:30PM (ID GY #2) and KUNA with ID at midnight. DAVE NORMENT (N3NGM) - 20300 FREDERICK ROAD #65 - GERMANTOWN, MD 20876 ------ Hello fellow NRCers! Being my 1st MUSE, I'll tell you a little bit about myself. I'm 34 years old, single, a ham since '85 and a member of the NRC for about 1 year. I've worked in TV and radio in various capacities, from bench tech to assistant CE. But foremost is my love for radio and AM broadcasting. While on the subject of commercial broadcasting, it is with great sadness that I recently ended my position as assistant CE with WINX Rockville, MD. In radio, we all start at a small market station and eventually move up to bigger and better things. This move in my career may be for bigger but I don't know how much better. I grew up listening to WINX and only dreamed of working there one day. WINX was part of United Broadcasting, a large chain of stations spanning the country founded by the late Richard Eaton in the early 50's. In fact, WINX first went on the air on 1600 khz in 1952 with 1000 watts day and 500 watts directional night, maintaining the same format (Top 40) under the same ownership until this past week when they were sold to a former employee. In these days of extreme competition within the industry, 40 eyars of doing the same thing is unheard of. This ends an era in broadcasting as all United Broadcasting Co. (UBC) stations are now being sold off, one by one. Mr. Eaton passed away in 1982 and his will stipulated that no UBC station could be sold for a period of 10 years following his death. Well, the demise of a once mighty empire consisting of no less than 20 stations has come to pass. Cleveland was the first to go a few weeks ago, followed by Rockville. The WINX studios are in a 100 year old registered landmark that sits on prime commercial property, so it's safe to say the studio/transmitter operation will be combined at a new, future sight. In other radio doings, WTEM-570 apparently is unhappy with its 1000 watt night signal originating from a 4 tower array in Bethesda, MD. WTEM recently out-bid long time mainstay WMAL for the rights to carry the Redskins. It seems the investment in the Redskins won't amount to much if the station can't be heard to the N of the city where major growth and development have occured. The immediate fix was the decision to simulcast games on sister station WGMS-FM but the long term fix is their brand new AM facility located in Germantown, MD, a good 13 miles n of the old site. Upon visiting the site, still very much under construction, I noticed 4 500 ft towers in a box configuration spanning aout 100 acres. The towers are unpainted and lit day/night by white strobes, irritating the neighbors. I'm trying to find out if the new sight will be 5000 watts day and night, I suspect directional SE fulltime. Looks to me they're about 4 months away from on air testing. I've been hearing WWJZ-640 testing on a regular basis during daylight only, local WMAL-630 makes life miserable for me and I will likely not hear them at night. Long silent WPRW-1460 has been sold to a group called Capital Kidds Radio Co. WPRW will join forces with recently acquired WNTR-1050 and WITH-1230 with a triplecast format designed for kids 12 & under. Expect all 3 stations to be up and operating as 'Kidds Radio' by spring. Lastly, it was very interesting to hear WQEW on 1130 the other night with WBBR ID's from time to time. I guess the rumor that the WNEW call would be retained was nothing more than a rumor. I'm disappointed! More news when I get it and find time to write. Happy DXing and 73 to all! (Thanks very much for checking in, Dave, and welcome to the NRC! And nice talking with you that early morning from WINX, sorry to learn your no longer with them. Please keep in touch!-DWS)

stations transmitters were flooded, leaving no local signals on 570 & 820 from Friday 12/11 through Monday 12/14. That meant, during the day, WEAZ-560 came. blasting into the NY area like a ton of bricks. And WGY-810 could be heard clearly as well. At night, 570 was filled with a strong UNID French Canadian signal (CJEM-DWS) but there was no trace of WSYR, which was a mild surprise. As for 820 at night, WBAP ruled and WCCO-830 was another easy catch, both rare in NYC these days. On Monday morning 12/14 WOR-710 left the air for maintenance and/or storm repairs. That meant WGN-720 could actually be listened to for simple pleasure, which allowed me to tage a great interview with R&B singer Jerry Butler. CHTN was also clearly hourd with a simple turn of the GE Superadio II. They were running the syndicated 'Oldles Coast to Coast' program heard across Canada. The storm also provided a great opportunity for radio to shine in an emergency situation. Both WCBS-880 & WINS-1010 provided non-stop wall-to-wall coverage for 4 days with scores of reporters calling in from the NY-NJ-CT. It was exciting and well done and made me wonder why I left radio for TV! At least I'm still in news. And finally, WNEW ([nally retired its Big Band/MoR format at 8PM Friday 12/11(if anybody has a tape of this, I'd like to hear from them). After that, the station began to broadcast Its sister station WYNY, CW music on 103.5. This went on til Tuesday, when WNEW's new owner took over. That's when 1130 began to simulcast another AM statton in the same market, WOEW-1560. On 1/4, WNEW will adopt its all business news formal. On Tuesday 12/15, I heard a commercial for WQEW on WINS! This is the first time I have personally heard a promotional announcement for a seperately-owned station on another station in the same market on the same band! On the other hand, the move makes perfect sense, many MoR Listeners are also all news listeners so cross-promotion can help both outlets. I'm sure I've used up more than my attoted space so I'll s/of for now. Happy Holidays everyone & 73

It looks like I will once again be involved with the ANARC gathering in February, manning an NRC table and having another forum on AM DX. If any other NRCers are planning on attending, please let me know as I would like to set up a group for the AM forum. This is a good gathering as all DXing spectrums are represented and well worth attending. The DX TESTS from KGWA-960, WRIX-1020 & WNTK-1020 all were received and reported during December, a call to KCWA confirmed the tones being heard as theirs as the times noted matched up. WAYNE HEINEN'S recent write-up on power line noise is just about the same thing Tive gone through and am again getting hit with pretty hard, sunset is just about uscless anymore. It appears the FCC is finally going to set a standard for C-OUAM as the AM Stereo standard which I'm glad to see. But don't watch for your stereo lights to be coming on at a greatly increased number, conversion to stereo for an AM station is still very costly. I don't think that DAB is going to be a big contributing factor in not letting AM Stereo grow but the bottom line, bucks! During the WNEW/WQEW simulcasting, 1130 also honored the 1560 Monday AM silent period. With the way the Canadians were being heard from reports in DDXD, I thought there just may be a chance for it to make it to the E, no luck, just WWWW with a slight trace of KWKH on 12/28. This was the only time I've heard 1130 off in many years. And I will miss the great AM Stereo sound on 1130, it was one of the best, 1560 is still running the Kahn system! WWJZ-640 is now on 0530-0000 daily. WIFI-1460 has been noted running oldies on the weekends and religion weekdays, saying 24 hours at that, partially readable here daytime with WCEI/WIMX/WILM splash.
