The FCC continues its housecleaning this month with another list of stations that it has begun license revocation proceedings against since they have been off the air over a year. The new Communications Act has a provision we'll detail next month which calls for license revocations for stations silent more than a year. Thise stations are indicated +++ below. Several more licenses have already been cancelled as you will see.

WGTL NC Kannapolis: license CANCELLED and call DELETED along with App for Rock Hill, SC synchro

930 WLLL VA Lynchburg: silent station is ON THE AIR

WRNJ NJ Hackettstown: as already noted here, this station has been bought by WINS-1000 1010 with the intention of taking it off the air to improve their coverage in NJ. A letter from Lawrence Tighe, CE, confirms that they will be off soon BUT they "are moving to 1510 on the AM dial, please let us know how you receive our new non-directional signal" There is an existing App for 900/230 U2 for Hackettstown so evidently WRNJ plans to move here but we have no official word that this has been granted.

HERE WE GO AGAIN: EXPANDED BAND, PART TWO

The FCC has released the new reconfigured Expanded Band Plan. As expected, the new modeling of the band has resulted in the addition of only a few more stations than the original allocations. This time around there are 87 stations that will be afforded the opportunity to apply for a Construction Permit to operate in the Expanded Band. While this is only eight more stations than the original list, many are new additions. There are THIRTY ONE stations that have been dropped from the first list! As with the first plan, this one will be official barring any petitions for reconsideration. You may recall that such petitions resulted in the scrapping of the original bandplan. This list was released just a day after the copy deadline for Issue 25, and it has since been circulated by Internet and several trade magazines so you may have already seen the list. However, for your convenience in making entries in your Log we have sorted the stations by their PRESENT operating frequency. I don't believe the list in this format has appeared anywhere else. (Note: Jerry's list is followed by two lists, arranged by state and then by frequency, as I was able to download them from the FCC's Internet web site, juggle them in a database, and corrected them with data supplied by Wayne Heinen -pls.)

Several interesting things: There is only ONE station on 1610 kHz. KXBT, formerly operating on 1640, has been moved to 1630. You have probably noticed this change has already taken place. The FCC, in its unending quest for accuracy, listed well over a dozen stations with outdated calls, showing instead the call of the station when the original list was generated in late 1994. We have attempted to make the appropriate changes. The Internet posting and most trade magazines have simply passed along the wrong calls. All stations will be 10000/1000 U1.

*Notes WJRZ-1550 is the only station on the list that is a CP for a new station that was never built on its primary frequency.

KSHY-1530 reflects a CP to move to this frequency and city from the station's present 1370 Cheyenne operation that never took place. We don't know what effect WKZQ-1520's application to move to 1450 kHz will have on their allocation here. The FCC listed the city of license for WGOD-1090 as St Thomas which we believe is wrong. In late 1994 Fred Weinberg, the owner of KTRT-1270 Claremore, OK, a long time advocate of the expanded band, announced that he would drop 1270 and begin broadcasting immediately on 1640 kHz as soon as his license was issued. Before the FCC established the expanded band he wrote many letters to trade publications urging its approval. Once the legislation passed he was equally vocal in urging stations to begin using the band as soon as possible and announced his hope that KTRT would be the first station to operate on the band. He was, in short, one of the major cheerleaders for band expansion. Well, guess what? When the computing was all over for the reconfigured allocations KTRT was no longer among the those stations with an expanded band frequency. We imagine Mr. Weinberg is unhappy to say the least.

☐ Apologies to those whose loggings were sent in time for the last edition but didn't see print. I guess I over estimated the power of the internet, and under estimated my ability to get thing all tied together on time. (No apology necessary, Bill; how you coped with the move and still got the column out on time is a mystery to usl -pls) I believe I've caught all the "left-over" loggings. If not . . . I'm sure you'll let me know.

- Results of a very productive DXPedition to Lemmonjoki, Finland have been received via the 'Net from Mika Makelainen of Vantaa, Finland. Also participating in the excursion was Jorma Mantyla from Kangasala, Finland. Mika had 3 NRD-535's, Jorma an Icom IC-R71E and a spare NRD. Antenna installations in the beginning of the expedition consisted of about ten beverage antennae each 1000 meters in length, directed to South America, Central America, North America, direct North and the Far East. During the week some of the antennae were taken down as ours was the last DXpedition to the location during this season. In the end only half a dozen beverage antennae were in use. Their DX Site was an isolated lakeside cottage on the edge of a place called Lemmenjoki, which can be translated as "Love River", location: N68.783 E26.333, 40 miles from the community of lnari, far above the Arctic circle in Northern Finland. This Love River is a national park but is also known for placer mining. In a vast area there are only a few houses but thousands of reindeer and unspoiled arctic nature. DXPEDITIONS in the same small cottage have been held regularly since the 70's, ours was DXpedition number 96 - thus the abbreviation and signature "LEM96", which follows each logging, and does not refer to the calendar year. Not to be outdone, Michael Rolph wasn't satisfied with his recently-garnered GY records, so he ventured a few kilometers further into the Outback . . . and logged 'em again! All new Graveyard records appear at the end of this column. See . . . we not only get DX loggings here, but a touch of geography, too! Kent was touring western Wisconsin and passes along several updates. And The Boys from Manitoba ventured to "The Beach" again for an end-ofseason DX session which garnered a few new ones. Shawn says the temperatures weren't too bad. Even the seat in the outhouse wasn't too cold!!!
- ☐ The FCC has decided to go ahead with their previous expanded-band plan. At least as near as I can figure out. One interesting note is they have KXRT-1190/1640 allocated to 1630. (See Tim Hall's logging in Special). Am sure AM Switch will sort things out for us. Kent Winrich sez: "Got an e-mail from the guy that runs the transmitter at CIAO...'1... posted that the station runs 1kw into a single tower which has sloper wires and performs as a three tower arry oriented north east. No deep nulls anywhere in the pattern, just some forward gain and a flattening towards Windsor (CBC 540). The transmitter is a Gates solid state. There is a stanby (sic) omni tower on site. Most of the old 790 towers are gone. I operate the TX site, so any questions just ask. Rob'." I haven't a clue who this "Rob" is, but the CIAO-530 tidbit may be a good trivia question sometime.
- ☐ Attention CPC Test Reporters - effective immediately, include ALL station data in the report. Meaning: CLs, state, city, date, time, and what you heard (or that the test was not heard). Also, report the city-of-license, NOT the mailing address. If you can't look this data up and include it in the reports, I can't either. Save your postage, or effort if e-mailing.
- The Graveyard record for WDSG Dyersburg, Tennessee has been vacated. So, it's up for grabs!
- ☐ Once again, I am "on the move". I'll be here in Alamogordo, NM for a few months, but ask that you send snail mail to the address shown at the top of the column. Letters are being forwarded via Priority Mail twice a week. The "30-day old" rule is being relaxed a bit during this period, but don't wait 'til the last minute when sending in your reports. See you next month.



The MW band during daylight is dominated, of course, by many Cubans, but at night only the big network Cubans were clearly audible on their most local frequencies. Most channels yielded U.S. stations at night. Surprisingly, no Jamaicans were audible at night or during the day."

Ray speaks: "Anyone interested in TP reception should try 774 kHz, 1098 (Marshall Islands), and 1548 (4QD) during the half hour before local sunrise. The TPs came through all summer last year with some of the best audio in June and July. I have noted as many as 43 TP carriers in a single morning (APR 1) this spring. The amazing thing about the TPS is their consistency. They are there day after day regardless of the A index, but are never very strong.

GUAM 801 (tentative MAR 22 from Dale Park in Hawaii): This could well be the 1kW station in Nelson, New Zealand, part of the "Radio Rhema" religious network. Correct reports for these tests are verified with a beautiful special 690 kHz QSL card depicting Quito at night. In order that QSLs retain their value, I am being very stringent about report details. Specific audio items heard should be reported to the second if possible. Tape recordings are welcome but tapes can not be returned.

Over the past few months, I've received a number of great reports from as far as Scotland and New Zealand. I've also been sent some amazing fabrications, one that went as far as to include paragraphs of English language identifications and HCJB historical material, none of which was aired! There has also been the possibility of one or more pirate HCJB DX tests originating in the U.S., making accurate reporting all the more important. The pirate operators could never guess what is aired, however, making the bogus transmissions easy to spot. What I do have on the tests includes unlikely code words and sound effects and songs that one probably wouldn't expect to hear on an HCJB DX test. You have the fun trying for the tests but I have a lot of fun producing them! Changes in programming status; reported by listeners

Mark Burns, of Terre Haute, IN, writes to note that KLBG - 580, Alexandria, LA., now runs a religion format. While DX'ing, he heard "Thanks for listening to KLBG, where God's word is first priority". Mark, I hope that they verified for you! And, here, my favorite radio station, WYNY -103.5, New York City, dropped its country format, disc jockeys, and listeners at 6:04am, on Monday, March 10. At least Evergreen Media allowed the air personalities to broadcast their final shows over the weekend with many listeners calling in to say goodbye and express their sadness that this personable station, with its friendly announcing staff would be gone. Among advertisers on the final weekend was WGSM - 740, in Huntington, Long Island, hoping to get some of the dedicated WYNY listeners. At 6:04 AM. Evergreen introduced their new format with some foul mouthed individiual named Mancow, who came on the air talking about male appendages and likening competing local morning radio hosts to rectums. I have not listened to the station since. The Daily News radio column listed eight or nine little thousand watt AM stations in the metropolitan New York suburbs which carry country music. WGSM is making an effort to replace WYNY, with PD Randy Turner in morning drive, with a show which is actually a more enjoyable show than the former Kat and Dave Morning Show on WYNY, and a few live assist hours in the afternoon. However most of the music is satellite - fed with generic hosts saving nothing of substance. I prefer my country music played by someone in the station's studio, with a local accent, WGSM cannot hope to replace WYNY...its 25,000 watt daytime signal, from a four tower array near the LIRR Huntington Station, protects Toronto, WVCH, Chester, PA, and Bob Bittner's WJIB in Cambridge, MA., and goes away from most of the New York City area. Additionally, WGSM probably could not afford to pay the ex-WYNY personalities. New York now has no FM country music station. By contrast, Portland, ME, has two FM country outlets - WPOR-101.9 and WTHT-106.5 - plus WPOR - 1490, which simulcasts its FM!

The first part of the annual railfan trip will be to Chicago, in June, where, along with enjoying METRA and the CTA, I hope to put together sone Station Profiles of some more of the unique little AM radio station in the Chicago suburbs. Now, for the second part of the trip, in July or August, I hope to get to either Los Angeles and San Diego or Portland, Seattle, and Vancouver. And a request....does any NRC member know where the radio studio and transmitter location are, around San Diego and Los Angeles, or around Seattle and Portland. If so, please write!? I would love to do a Station Profile on XETRA - 690, San Diego - Tijuana.

Carrier Current Stations

This is a list of carrier current stations edited down from a list of college radio stations posted as public domain on the World Wide Web, primarily for the use of independent record labels seeking to send their releases to college and other noncommercial stations. Only AM stations from that list and a few others reported in ID X News, but not listed on that list, are listed here. The complete list is available at "http://www.jett.com/collegeradio/clgradio.html" and includes frequencies, complete addresses, andtelephone and FAX numbers.

Carrier current stations radiate a signal, usually on the lower end of the AM band, into some sort of wiring, often the power wires, and can be received on any radio placed near the wires. They are most popular on college campuses and dorms, particularly at smaller schools and in large metro areas where the FM band is crowded. Some operate as an alternative to a school's licensed FM station. See John D. Bowker's recent series of articles on legal alternatives to pirate radio for more details on carrier current stations.

Keep in mind that none of these stations are licensed by the FCC or CRTC, their "callsigns" and frequencies are unassigned and can change at any time for any reason. Likewise, these stations come on the air and go silent with no public notice. Gathering information about these stations is obviously a challenge. 

I found AL GERMOND's comments about night conditions in the 3/18 DX News to be very interesting. In travels around the country over the past few years, it seems that most frequencies are nothing but noise and hash except the remaining clear channels. To hear a regional station at night, you practically have to have the lights of the city in sight (or the stations tower lights!) Here at my home, many of the regional frequencies, especially in the 1300-1500 range, sound just like local channels. By any measure, this has been a good DX season. I've let a couple of months go by without reporting due to a heavy work schedule, so I'll cover the highlights. 2/4 1 tried for all the AK tests (the is the only state that hasn't been heard here) and didn't hear anything, except what I thought was a code ID from KYAK-650 at 3:34AM CST. This was during a comedy routine on WSM. I sent KYAK a tape, which they verified with a form letter. Later, ROB KRAMER and I tried to copy what sounded like the code using his audio filters, but we were unable to decipher anything. I've sent another report to KYAK to get a more definite verification. In the meantime, I have AK verified, but I'm not sure I heard it. Anyone else hear anything at this time? On 2/5, the KTRK-1670 test broadcast was heard here at 6:57PM with good signals. The WIRC-630, KCSR-610 and WTLA-1200 DX TESTS were all heard here. More recently. the following tests were tried and NOT heard here: KBSU-730, WTCH-960 (heard previously on reg. sked), KBTC-1250, WOPP-1290. WEAG-1490, WTMC-1290, WKXY-930 and WTMY-1280. Here's a target for any sports fan, I read that the new United Center had installed some kind of antenna above the upper levels to rebroadcast the AM signals of the Blackhawks and Bulls. I was there for a Blackhawks game on 3/11 and the signal of WMVP-1000 was much stronger than when l had taken the radio to other games, when I turned the Walkman on at 7:21PM. A week later, on 3/19, I was at a Bulls game and turned on WMAQ-670, which had a much stronger signal, but was subject to what sounded like pulsing, almost like a helicopter was overhead. 73 (The frequency was set too close for the synchro type transmitter system; the repeater should have been set a little further off from WMAQ-DWS)

Greetings from the Great Smokies. It's been far too many moons since I've appeared in these pages. I've been DXing since 1970 and a NRC member since 1982. For the last several years I've been inactive, partially because my work took away some of the best DXing time, but my schedule has now changed to allow chasing CPC tests on Monday AM. Speaking of CPC tests, I spent a couple of interesting nights at the dial after seeing LEE FRESHWATER'S efforts in #23, Tried for 8 of the 10 tests he arranged and bagged 4 of them. I logged WMOP-900, WOCA-1370, WRUF-850 and WLUS-980. Of the bunch, WOCA



was the easiest with a strong signal and no interference. WLUS was the toughest of the bunch, WYFN was putting in a monster signal that night. A hearty TIIANK YOU is in order to Lee for his fine work. Also looked for some of the other tests scheduled during this period with poorer results. WSBA-910 and WZZB-1390 were not heard, while WLIK-1270 and KNIR-1360 could be considered only tentative as I was able to copy only parts of the code IDs. Was really surprised by WLIK; for 5kw they have a really lousy signal. A couple of items of radio news from around here: WUTK-850 has been sold to Dick Broadcasting, which donated the station to the Univ. of TN 8 years ago when they moved WIVK to 990. Plans call for the station to replace CNN Headline News with the AP News feed. The move should take place in early May when new studios are finished. Report also has it that they purchased WXVO-98.7. WIMZ-1240 went all sports on 4/1. One error I noticed in the log is WECO-940; for the past couple of years this station has been fulltime gospel, and it runs live during AM drive and Sunday 8A-2:30P and carries the Reach satellite network the remainder of the day. The station still operates daytime only; engineer decided nighttime authorization of 16 watts wasn't worth the effort. I'm still working at WECO-FM 101.3, now on the air 11A-5P Saturday and Sunday. Equipment here is a Superadio II, now assisted with a Quantum Loop. Also have a Hallicrafters SX99 but it could use some work and definitely needs an alignment. Also have a Bose AWR1 Wave radio. I wanted to write to tell members of the telephone call I got from Bill of WMIM-1590 (I think he was the CE). He said the station runs 1000 watts daytime and 17 watts at night, and I got them at 17 watts! He said he has gotten reports (2) from Cape Cod before. He said he was applying for the frequency of 830 and said it required 3 towers, I guess he doesn't have 3 towers. He asked me if the Cherry Valley station was on the air yet, WCRN, saying that construction permit has been around since 1987. I forgot to tell him it is now in Worcester, MA, but did mention that it simulcasts with WROL-950 during the day. He said he didn't have any bumper stickers but was filling out a prepared card. Very interesting talk. I guess he was surprised I got WMIM at 17 watts. I mentioned that the club might be interested in arranging a DX TEST and he seemed to like the idea. I wanted to comment on some of my best DX in years past. I got into the hobby in the mid 50's with a cheap, 5 tube RCA table radio that I got for Christmas one year. I was only 7 or 8 years old living in Adrian, MI at the time and was always amazed at the signals that would come in at night. I was especially amazed to hear KSL-1160 boom in an hour or two after sunset when WJJD signed off. Of course, that was in the days of the "real" class



1-A Clear Channel stations. In 1959, my family moved to Riverside, CA and I got a bit more sophisticated in my DXing. Lacquired an old RCA ACR-111 16 tube (aka: boat anchor) general coverage receiver (1937 vintage) that was originally owned by W6AA, the first licensed ham in CA. I hooked this monster up to a series of longwires strung all over the place and was amazed at what I could hear. I joined the IRCA when it first started in '64 as a charter member. 1 started sending reception reports, and the veries rolled in! Some of my best domestic verified catches included WCIN-1480, WSAI-1360, WING-1410, WFLA-970 and WYZE-1480. () course, all the clear channels (WBZ, KDKA, WLS, etc.) were easy, almost nightly, catches in the early 60's. I used to listen to Clark Weber on WLS-890 with his Silver Dollar Survey on the East of Midnight program nearly every night out there in S CA. I also verified several HI stations and KFAR 660. Monday mornings were always great for DXing as most stations signed off at midnight on Sundays (including the 'KFI Monster' on 640). It was a great time to look for frequency checks and stations on the air for test purposes. Once every month, every station would sign off at midnight Sunday for an hour, so the old EBS (Conelrad) system could be tested on 640 and 1240 khz. 1 also remember the old KGBS-1020, a daytimer then (now KTNQ), would sign ON at 9PM Sunday night with jazz music and stay on until 2AM Monday which coincided with KDKA's silent period (midnight til 5AM Eastern time) (and the only way I heard and verified KGBSI-DWS). In the mid 60's I moved to Warren, OH and went off to college and had little time for DXing. The interest was always there, however, and was rekindled several years ago when I joined the NRC. I am sure the real old timers in the club have even more interesting stories to tell, buit I really enjoy thinking about what the 'old days' were like for me in the hobby. One last item: I want to thank everyone who caught my DX TEST on WCGW-770 in December. I received about 26 valid reports with about 20 of them coming from NRC and IRCA members. All but one included return postage. All reports have been answered. I hope to do another WCGW test next winter. By the way, WCGW is licensed to Nicholasville, KY with studios in Versailles, KY and offices in Lexington. Several listings show Versailles or Lexington as the city of license. It's a LONG and CONFUSING story, trust me on this one! Hope everyone has a greta summer!

Many thanks to MARTY BASSIN for the detailed comments on the Ramsey Electronics loop antenna. After reading his experiences, I decided to spend the extra money and buy a Quantum Loop instead! I'm looking forward to getting it in the near future. A while ago, 1)AVE asked for a "strangest station" MUSING so here goes. On 4/4/68, I was listening to 730khz during the evening and found a very strong station on top of the frequency. As I recall, its programming didn't fit the mold of the stations usually heard there. I was really thrown when it gave an ID of WEJP. Now I was REALLY curious as there was no such listing in the log and assumed it was a call letter change that I had missed. I don't remember how I found out, but this station was a pirate operated by Vinnie Cavaseno (an NRC member in Queens)!

In response to my report, Vinnie sent a nice letter verification on very professional stationary in which he mentioned that regular programming began 11/67 and was terminated by the FCC 4/6/68 at 8:45PM. In addition, he mentioned that my reception report was the farthest that he knew of at the time. Regrettably, I don't have any notes about the power that was used or the type of antenna system. Not much to report DX wise since my last MUSE, weather has been quite unpredictable, either Springlike 70-80's (with S9+10DB static crashes) or mid-winter like (nice and quiet). I received a verie from KXBT-1640, a nice card giving the frequencies as 1190/1640 khz, 10kw days/1kw nights. They are quite regular here almost every evening, with audio first noted around San Francisco sunset, but best from midnight til 6AM ELT. Another hohum CA regular. Apparently, they believe they are authorized to be on 1640, no FCC info has been seen to acknowledge this however, get 'em while you can! They DO VERIFY at least until the novelty wears off or the FCC shuts them down. This should be an easy CA catch for the E Coast. I can even hear them on the car radio after midnight! Verie states that they are the 1st expanded band station W of NJ. We'll see how long it lasts, the RI station

on 1110khz made it 10+ years without night authorization, so who knows! Recent veries in from WYAM, KLIF-570, WDAK, WTNN, WNAK, KBRT, WSBA and KXBT. Stayed up for DX TEST marathon of 3/23 and 3/25, all of the IRCA tests were heard except for WKXY-930 and WRZN-720, WRZN is somewhat regular at sunset, so I don't believe they were on. All the others were heard fairly well. The WZZB and WBLA NRC tests were not heard. Last weekend, KNIR and WTBQ were barely heard. If I didn't know code or knew when to look for them, I would have missed them! 26 out of 49 reports back, 16 (all tests) still out.
