

**1530 WYNE PA North East** – Call change to WMCE (effective 1/24).



## ON THE AIR

**740 KBRT CA Avalon** – Applies for license to cover CP for U4 50000/190, CoL to Costa Mesa CA; this indicates they are ready to start testing.

**1430 KZQZ MO St. Louis** – CP for U4 50000/5000 is on the air.

## **APPLICATIONS FOR CONSTRUCTION PERMITS**

**1660 WWRU NJ Jersey City** – Applies to modify day pattern, remaining U4 10000/10000.

## SPECIAL TEMPORARY AUTHORITY (STA)

**900 KALI CA West Covina** – Granted STA for U1 430/38 at the CP site; lease on licensed site expires on 2/1 and the CP isn't ready for full operation yet due to copper theft.

**1200** KFNW ND West Fargo – Granted STA for U4 45000/13000; having transmitter issues.

**1300** WKSC SC Kershaw – Applies for STA for U1 45/45 at temporary site (licensed site gone).

**1380** KTKZ CA Sacramento – Granted STA to operate night pattern at variance.

Applications to extend STAs were <u>received</u> from WEEI-850 Boston MA (pattern at variance) and WMNT-1500 Manati PR (unstated, having zoning issues at licensed site, STA in effect since 2002).

An application to extend an STA was granted for WNIX-1330 Greenville MS (U1 1000/55).

The FCC grants STAs for up to six months. In an emergency, a station can operate with reduced power or, if normally licensed with a directional pattern, to operate non-directionally at one-fourth licensed power (unless someone complains of interference). But the station needs to notify the FCC right away and obtain an STA if the situation will last for any length of time. The FCC doesn't keep track of whether STAs actually get used – for example, KALI-900 above sought its STA in advance of expecting to lose its lease soon, but if anything changes with the lease and KALI doesn't start using the STA right away, you'll never be able to tell from the FCC web site. If a station needs to extend an STA beyond six months, it can get six-month extensions, which are supposed to be progressively harder to get, if it can justify the actions it's been taking to get back to licensed operation. Usually the FCC grants original STAs within one or two business days; STA extension requests are usually filed a few days before the 6-month expiration, and the FCC grants them within 6-8 weeks. If the extension request gets dismissed, it's usually because the station is back to regular operations already and doesn't need it any more. If no extension is filed after 6 months, it can generally be assumed that the station is back to regular operations – but more often that you'd think it means that the station is so accustomed to STA operations that it forgot to file the extension request.

Antenna height will be 182 metres (EHAAT) and the radiation pattern will be non-directional. Not only will CBLS 1240 go off the air, but CBQW 1340 in the nearby town of Hudson will also go dark. **(SMA-MB)**

SK Regina – 1/20 0709 – News ending with "And that's the world report for this hour. A reminder, our website cbc.ca has more on the opening weekend of the NHL. If you tune in late, you can get our whole newscast whenever you want to go to cbc news...I'm John Wilcox CBC News." Into: "John McDermott, good morning it's Sunday January 20th. Here's Saskatchewan Weekend...Well yes good morning and welcome to the coldest morning of the year. Just about everywhere in Saskatchewan has a wind chill warning in effect with temps this morning feeling like minus 40 and beyond. It feels like minus 40 in Saskatoon, and Regina..." (JDS-MN)

**MS Tupelo** – 1/2 2130 – Fair to good with R&B oldies from the Brothers Johnson, Diana Ross & the Supremes, War, and Tina Turner, then an ID of "...heart and soul, 104.3 The Pulse". Heard again after 2200 with songs from Sister Sledge and Michael Jackson. Was tipped off to this by Earl Higgins and confirmed it by looking up www.pulseoftupelo.com, which mentioned WELO 580 AM on the homepage. MS #7 at this QTH, and first time I've heard WELO since 4/21/1991. **(RD-NE)** 

580 CKWW ON Windsor – 1/2 2056 – Weak in WIBW null with "Sundown" by Gordon Lightfoot and "Let's Hang On" by Frankie Valli & the Four Seasons, then jingle ID of "580 CKWW, more music". First time heard since 3/9/1995. (RD-NE)

**600 WSJS** NC Winston-Salem – 1/14 2317 – Fair under WMT with tape-delayed NASCAR discussion program "Fast Talk". Stuck with it, and finally got CLs in a promo at 2334 for the Clark Howard Show. NC #3 here. (**RD-NE**)

**600 CJWW SK Saskatoon** – 1/21 0816 – Out of C&W music, with man saying "Randy Travis...on CJWW," followed by temperatures in various Sask. towns; wind chills running in the -40 degree range and lower. Fair signal but way under nearby KCOL. **(JW-CO)** 

**640 KTIB LA Thibodaux** – 1/21 0800 – Out of music with LID by man: "640 AM KTIB Thibodaux [pronounced "Tibbadoe"], a ?? broadcasting station," followed by a vocal rendition of "God Bless America;" sounded like news after this but not sure. KFI partially nulled but still a very noisy frequency. **(JW-CO)** 

- 650 WSM TN Nashville 1/12 0721 Out of song "Garden Party" Ricky Nelson. Into jingle "Six-Fifty WSM." Followed by song: "After All This Time" Rodney Crowell. (JDS-MN)
- **660 KTNN AZ Window Rock** 1/17 0952 KSKY Dallas is hard to null, but with KKOB in on 770 more than an hour after sunrise, time to look for KTNN yes, there it is with Burger King ad mentioning half a dozen towns where that exists in Navajoland. KSKY makes SAH of 52/minute = 0.87 Hz with KTNN. Then news in English of AZ such as marijuana bust in Bagdad, and then of NM. At 0957 has switched to Navajo language, and 1008 still audible with Navajo chanting. KTNN official sunrise in January is 0930; February, 1000. **(GH-OK)**
- 680 CJOB MB Winnipeg 1/22 1811 NEW Out of traffic report, into commercial for Prairie Chevrolet. Followed by "That's traffic for the Manitoba Lotteries air Six-Eighty chopper." Into weather forecast with extreme wind chill warning in effect, ending with "Right now minus 23 wind chill minus 32 Six-Eighty CJOB." (JDS-MN)
- **680 CFTR ON Toronto** 1/12 0728 Bloomberg market news, Into commercials for Pizza, Pizza, and United Way Toronto. Followed by national weather report. Into "Six-Eighty on the AM dial, and (inaudible) @ 680news.com, this is Six-Eighty news." Followed by news with references to Toronto. (**JDS-MN**)
- 700 WLW OH Cincinnati 1/12 0749 Local weather report ending with "I'm Fox Nineteen meteorologist Katy Morgan for news radio Seven-Hundred WLW where it is Fifty-Eight." (JDS-MN)
- **720 KDWN NV Las Vegas** 1/17 0956 Talk in EE; 0958 call-in re guns, to 257-KDWN and then full ID as "Newstalk 720, KDWN;" meanwhile mixing with UNID "Jewsharp" music, 1000 the 7 o'clock news. Nice to hear KDWN Las Vegas NV again, now on legal 50 kW day pattern starting at 0945 in January; 0930 in February. **(GH-OK)**
- 730 KKDA TX Grand Prairie 1/16 0910 M&W talk in Korean, dominant from N/S, fortunately in null of adjacent KRMG 740 Tulsa, 0913 losing out to Spanish Ke Buena = XEHB Chihuahua, 0914 regaining a bit to mix with it. Just flipped from "Soul 73" format, much to the chagrin of the Black community in The Metroplex. Call change might be expected, but maybe not, since to the DXer, KK = Korean and DA = directional antenna (at night anyway). FCC still has it as KKDA. I wonder how many other full-time Korean-language stations there are in the US? The Metroplex now also has Vietnamese, Chinese, South Asian AM stations, at least, plus lots of Spanish (GH-OK)
- 730 CKDM MB Dauphin 1/22 1828 Out of classic rock song: "It's the Parklands best, Seven-Thirty CKDM. And you're listening to the classic five at five. And it's not a complete classic five without one of the greatest bands of all time. It's Queen, Crazy Little Thing Called Love." (JDS-MN)

The only PSSA its authorized is a 15-minute extension in December from sunset 1715 to 1730 with 10 watts **(GHOK)**
- **750 CKJH SK Melfort** 1/22 1836 Out of classic rock: "CK Seven-Fifty classic hits from the 60' and 70's with Ian Thomas, It's Five-Thirty-Six. If you can eat a large pizza in ten minutes (inaudible) you can pick up your entry form from TJ's pizza in Melfort. All the proceeds going toward TeleMiracle. Weather forecast is next on CK 750." (**JDS-MN**)
- 760 WJR MI Detroit 1/12 0811 Break in talk show: Female voice with song "Color My World" in background "You're listening to *The Warren Pierce Show* on news talk Seven-Sixty WJR." Back to show. (JDS-MN)
- 770 WABC NY New York 1/14 0147 *Red Eye Radio* program ID. Is the only 770 on their affiliate list I was at first suspecting this weak talk signal in English would be KKOB or KKOB, but not with that show. Been ages since I've heard WABC out here more than 2 megameters away (GH-OK)
- 780 KSPI OK Stillwater 1/15 0141 250-watt daytimer has again left its carrier on all-night, groundwave-steady dead air clearly from here in null of WBBM (GH-OK)
- **850 KFUO MO Clayton** 1/6 1836 Fair with instrumental piano hymns and sacred music. Took the webstream, which was only about 3 sec. behind, to nail it. **(RD-NE)**

**880** KLRG AR Sheridan – 1/16 0858 – Open carrier from E/W dominant in KRVN null from the north. Surely one of the poorest examples of managing a 50 kW AM



station, as frequently happens, still dead air past 0901, instead of Canada Calling from the WTAN Florida network as once heard at this time; then begins to fade vs. KRVN signal. 1/17 0935 – \*still\* open carrier/dead air E/W with SAH in null of N/S KRVN NE, no doubt KLRG Arkansas, more 50+ kWh wasted. Do they know about this in

- 920 KLMR CO Lamar 1/17 0933 Announcer refers to http://slapstupidpeople.com That URL doesn't work, so maybe meant http://slapstupid.com/ Then promo/ad for upcoming comedy night at Eagles in Lamar. Apparently Eagles Lodge is a hotel rather than a fraternal organization. (GH-OK)
- 930 KSDN SD Aberdeen 1/14 0142 Coast to Coast recognized, same speaker and subject as on 860, 850, 840, etc., etc., in WKY OKC null. 1 kW night pattern is mainly toward the northeast, with very little southward, from close to due north from here; new one, anyway, presumed. (GH-OK)
- **960 KMA IA Shenandoah** 1/12 0103 ABC News and commercial breaks; local KGWA is again providing a 5-minute Fox-hole with no modulation, except for some hum. **(GH-OK)**
- 960 KGWA OK Enid 1/11 0141 Fox-hole of dead air again; only ABC news detected, presumably KMA Shenandoah IA. (GH-OK)
- 980 KSGM IL Chester 1/5 1758 Fair, //their FM sister with "KBDZ, Perryville" ID, then C&W songs "Born To Fly" by Sara Evans and "Meet In The Middle" by Diamond Rio. Not heard anywhere since 2/6/1991. (RD-NE)
- 980 WYFN TN Nashville 1/5 1759 Fair with brief legal ID: "This is WYFN, Nashville." (RD-NE)
- 990 KRKS CO Denver 1/1 1859 Fair in CBW null with "KRKS" jingle, mentions of "the Mighty 990" and "Denver" in legal ID. (RD-NE)
- **1010 KXXT AZ Tolleson** 1/1 1944 Good with "KXXT Ten-Ten AM" ID between REL programs. AZ #5 here. **(RD-NE)**
- 1020 KMMQ NE Plattsmouth 1/13 0835 "La Nueva 10-20" by SHVA, Mexican music but not // 930 WKY which has happened before; in null of breaking-up semi-local KOKP Perry OK. 1/14 0858, sunrise surge clear with semi-local KOKP Perry OK carefully nulled. Spanish restaurán ad, slogan as "La Nueva 10-20 AM, La estación de La Raza." So still have not heard the alleged "Ke Padre" slogan as in NRC AM Log 2012-2013. Then live DJ with TC, "un minuto para las ocho de la mañana," and phoning Celina (sp?) in El Salvador, playing a bit of Mañanitas for her, telling her it's "Radio K en Omaha, Nebraska" llamando, but no sign of a legal ID even as announcing in passing "8 en punto." - 1070 WDIA TN Memphis 1/17 0909 Usual fast SAH in almost-null of off-frequency KLIO Wichita, but this time it's not KNX: "Hello, you're on DIA," Bobby taking quick phone calls, also mentioning full call WDIA. He and they all sound like they are black. Topics all over the place. Bobby is defeatist about ever stemming violence, so why try? This is the 50/5 kW station I don't often hear. Day pattern has major lobe to the south, but a minor lobe to the west: (GHOK)

- **1130 KQNA AZ Prescott Valley** 1/19 0959 Legal ID for KQNA-AM and K260BL 99.9 FM Prescott; Fox News was next, followed by local news at 1002. Poor signal. (**JW-CO**)
- **1140 KLTK AR Centerton** 1/15 0929 Faint with CLs in EE heard during SS ID. Noted a "La Mas Mexicana" ID a half hour before. **(RD-NE)**
- **1140 KCXL MO Liberty** 1/15 0932 Fair with ad for event at local raceway, mention of I-70, then CLs. Had been one of my closest unheards. **(RD-NE)**
- 1160 WYLL IL Chicago 1/12 0933 Easily separated from KSL by nulling is something from the NE/SW, religious referring us twice to wyll.com in order to patronize local advertisers. FCC AM Query shows WYLL is licensed daytime for BOTH 50 kW, 2 towers, and 15 kW, 6 towers. The 2-tower pattern is broad favoring the southeast, but enough to the SW for us: While the 6-tower pattern is an auxiliary/backup from a considerably different set of coordinates, with major lobe to north, hardly any to the SW: (GH-OK)
- **1200 KFNW ND West Fargo** 1/14 0924 Gospel in English looping N/S, but not something WOAI San Antonio would be carrying. No sign of anything else except weak Spanish, i.e. WRTO Chicago. - **1200 WAMB TN** Nashville 1/1 1757 Good with "Raindrops Keep Fallin' On My Head" by B.J. Thomas, then ID: "Happy New Year from WAMB, Nashville." Had been looking for KYOO, which is still unlogged here. **(RD-NE)**
- **1250 KZDC TX San Antonio** 1/14 0928 Capital One ad in English, associated with sports, 1430 "Sports Leader, ESPN," no Spanish at first, which usually dominates from La Equis, KYYS Kansas City. 5 kW non-durational days, and seems N/S, though KBTC in Houston (how do they pronounce it?), south-central Missouri is also ESPN. **(GH-OK)**
- **1260 KDLF IA Boone** 1/17 0904 Ads in Spanish, quickly confirmed as KDFC by area code 515 mentions for Maestro Sebastián and others **(GH-OK)**
- **1270 KSCB KS Liberal** 1/19 1722 Good with Liberal at Colby girls high school basketball game, ads for Al Shank Insurance and Keating Tractor & Equipment in Liberal. Not new, but not often heard here. **(RD-NE)**
- **1400 KVSF NM Santa Fe** 1/17 2122 Play-by-play basketball action, Santa Fe High vs. Sandia Prep; occasional "ESPN 1400 KVSF" ID. About 25% copy in the Graveyard jumble. **(JW-CO)**
- **1480 KLVL TX Pasadena** 1/15 0819 Fair with ad in EE read by slightly-accented male: "... the #1 best-selling .... in Houston," along with a mention of a phone number in the 713 area code during the spot. Confirmed via webstream. **(RD-NE)**
- **1510 KCTE MO Independence** 1/16 0844 "ESPN 1510," from Kansas City mentions "teaming up with WHB." No longer an audible het, I realize, as probably for some time this 10 kW daytimer has been back on frequency, confirmed by BFO comparing to adjacent channels. **(GH-OK)**
- Tucson 1/12 0936 Scott Simon's voice so it has to be Weekend Edition Saturday which in turn has to be from this 50 kW daytimer. Soon fades out, but back at 0943 during usual sports segment. Has PSRA of 39.0 watts, October thru March starting at 6 am local, the limiting station being XEBG Tijuana, not any of all the other US stations on 1550. PSSA also of 39.0 watts every month on a complicated schedule from sunset to as late as 7:45 pm MT (2145) in January. Must have just gone up to 50 kW day power a few minutes before I heard it. (GH-OK)
- **1670 WOZN WI Madison** 1/12 0939 Financial talk show, poor signal from the new CBS Sports network, but must not be 100% SBG (Silly Ball Games). **(GH-OK)**

720 UNID -- 1/17 0941 – Continuous "Jew's harp" twanging, goes on and on past 1447 as I am DXing XEJCC and again at 0956 mixing with KDWN. Can't imagine WGN doing this. Surely not some local device, sounds just like intentional amplitude modulation from some station. Only other 720 around here is KSAH Universal City TX. Possibly they were out of order? (GH-OK)

- 900 UNID -- 1/14 0144 'Coast to Coast' audible among the QRM, but no affiliates found on 900 at C2C website, either by Google search or by looking at individual likely mid-continent state listings. A new one? Ideas? Should check C2C later in case it's updated (GH-OK) CHML has Coast to Coast 0100-0500, per its web site DY.
- 930 UNID -- 1/17 0929 As KWOC MO is giving way to KLUP TX I hear what sounds like "KRDZ." Except that's 1440 in Wray CO. I know of no relationship between that and KRKY Granby CO, the nearest 930 in the state, which I have heard before, different ownerships. On 930 itself, no similar/fuzzy calls to KRDZ (CH-OK)
- 960 UNID -- 1/15 0104 During another KGWA Fox-hole of dead air, I make out some harmonica/blues music at 0604 UT which based on unusual format I suspect is from WABG in Greenwood, Mississippi, but have never been able to catch any ID from. (GH-OK)

WRWD (107.3 and 99.3) was formerly the call of WJIP-1370; the WRWD home page doesn't show WHUC as one of its sister stations, though it does list WKIP-1450. (BH-MA)
- **ON Oakville** 1/18 2034 Woman talking about how she likes working at the station with Christian programming "24/7," inviting listeners to call her at 905-338-1250, or email her at buzzjoy1250@gmail.com, she then started to sing about Jesus, lost to a black gospel station. **(TF-NH)**
- 1270 WXYT MI Detroit 1/23 0000 Fair; "WXYT AM, WXYT HD Detroit, CBS Sportsradio 1270," ex-talk. (BC-NH)
  - **WDLA NY Walton** 1/10 1656 Poor until fade-out with ad for GNC Gold Card, ID as "AM 1270 WDLA Walton." **(MC-NJ)**
  - WLBR PA Lebanon 1/21 0813 Battling usual WXYT and WHLD groundwave with local weather, run-down of Pennsylvania lottery numbers, ad for Home Improvement Outlet in Lebanon. (MKB-ON)
- 1300 WAVZ CT New Haven 1/14 1832 Briefly atop with ESPN feed, "ESPN 1300" slogan, before lost again under WJMO, no sign of WGDJ, which comes in here during the day when WPNH is off the air because of a power failure, an occasional event here in the country! (TF-NH)
  - WJMO OH Cleveland 1/14 1820 Way atop frequency in my truck ten miles outside Plymouth with Black Gospel music, ID for "Inspirational 1300, WJMO," more gospel music. (TF-NH)
- **1350 WOYK PA York** 1/15 1627 Great signal with local news, "I'm Cathy Clark, you're up to date from Radio PA," "Number One Sports Minute" from Yahoo Sports Radio, ID as "Home of the real sports fan, Sports Radio 1350 WOYK," signal then faded. **(TF-NH)**
- 1440 WJJL Niagara Falls 1/15 2100 Out of moldy oldie with "It's 9 o'clock. Radio 1440 WJJL Niagara Falls-Buffalo" and promptly sank into a muddle. Audible again at 2103 with Elvis's "Teddy Bear." (BH-MA)
- **1460 WDDY NY Albany** 1/16 1635 Ads for Temporal Scanner and Wendy's, contest promo to win a winter vacation with Disney, usual annoyingly shrill prepubescent announcers, into music. **(TF-NH)**
- 1490 WICY NY Malone 12/18 1629 "... 102.7 WICY, happy holidays," then young kid's voice said "Merry Christmas." Rose up briefly, then disappeared into mess. (MC-NJ)
  - WNTJ PA Johnstown 1/22 1900 Surfaced briefly with promo/ID, "... Monday thru Saturday from noon to three, on News/Talk 1490 WNTJ." (BC-NH)
- **1510** WLAC TN Nashville 1/24 0400 In WUFC null; "Newsradio 1510 WLAC, Nashville's news, traffic and weather station, Fox news now." (BC-NH)
- **MA Greenfield** 1/15 1625 Easy listening music, AP Update at 1630 with Rita Foley, musical sounder for "Memory Lane 1520, WIZZ," into more music and Geico ad. No sign of WWKB. **(TF-NH)**
- **1660 WWRU NJ Jersey City** 1/18 2055 Good signal with Korean programming, EE ID as "AM 1660 WWRU, Jersey City and New York City" at 2100 into more Korean programming. **(TF-NH)**
- **1680 WTTM NJ Lindenwold** 1/18 2110 In SS with announcer who laughed a lot (at his own jokes?), Spanish music, lots of references to Mexico. Good signal for 1000 watts. **(TF-NH)**

## **Trans-Atlantic DX**

- FRANCE *RMC* Roumoules JAN 5 0633 Poor in noise. First heard with two men and a woman in a French discussion. Dramatized ad string at 0644 followed again by the same three speakers to 0659 when there was another ad string to 0700, then a presumed ID on the hour as a brief, punctuated announcement by a male, followed by a woman reading news complete with actuality reports. Heard also the next night, though poorly, and not since then. [Funkenhauser-FL]
- 945 **FRANCE** *France Info*, Toulouse JAN 5 0526 Good in peaks with long fades. First heard with male/female talking heads in French morning prattle with brief music bridges. This may have been some kind of newsmagazine. No discernible ID at 0600 UTC. [Funkenhauser-FL]
- 1089 **UNITED KINGDOM** *TalkSport* synchros DEC 28 0145 and DEC 29 0550 Fair, although never clear enough to get good idea of context much less a decent ID with slop from 1090 kHz. In fact despite a somewhat improved signal DEC 29 0600, the Mexican anthem played by someone on 1090 completely obliterated any ID. First heard in early Dec with two men discussing the suicide of the unfortunate English nurse who had been duped into speaking about some royal pregnancy by two Australian radio morons. Frequent weak snatches of English talk here but under very rough conditions. [Funkenhauser-FL]
- **SAUDI ARABIA** *BSKSA* Duba DEC 28 0120 An ending sequence of a radio drama by male and female actors complete with music bridges, and a talk sounding like credits with plenty of mentions of 'Arabyiah' at 0123 UTC. [Funkenhauser-FL]
- 1575 **UNITED ARAB EMIRATES** *R.Farda*, Al Dhabiya DEC 28 0016 Nicely in the clear with Middle Eastern and cabaret music hosted by a male speaking very briefly between music selections. I checked SW 5850 kHz and found the program in parallel with 1575 better at times than on SW. I used the Excalibur's audio mix feature to continuously monitor upper and lower sidebands independently and the G313e on SW while recording with Total Recorder. Heard a male announcer at 0030 reading news, then into more music, and interestingly at 0038 The Monkeys singing "I'm a Believer" with a nice clear *R.Farda* ID at 0042 UTC. [Funkenhauser-FL]

## Pan-American DX

- MEXICO XETX Nuevo Casas Grandes, Chih. JAN 18 0632 Hora Nacional promo, 0633 PSA for Instituto Estatal Electoral, but didn't hear which state; "Sí, se puede" federal PSA. Then ID as "90.5, La Ranchera de Paquime, y 540 AM," also mentions group BM Radio, and on to romantic music. Still no sign of XEWA. Sounds like they stress it Paquíme, rather than Paquimé. [Hauser-OK]
- 750 **VENEZUELA** YVKS *RCR* Caracas JAN 24 0100 Good; Venezuela beisbol coverage. [Conti-NH]
- MEXICO XEROK Cd. Juárez, Chih. JAN 24 1307 "XEROK, la estación más potente del norte de México, 50 mil watts," then hyped news ID numerous times as "Calibre 800" must be contraxion for canal libre, outro? Then a prayer rendering gracias to some señor, choral music bit; 1311 over to live announcer, woman emitting her own "cucú" laughing, silly chatter with others; she has poor dixion, also mentions sibling station 1240 XEWG, so simulcast? XEROK is really peaking now, way over KQCV still on night facilities; other guy promotes that later this morning he is going to give away tickets to an Indios game on Sunday; 6:14 time check, talk about the 'clima', current temp 6C. Now the distorted modulation station is starting to interfere, presumably XEDD or XEZR, still not positively IDed. As for the power, XEROK was once 150 kW, and IRCA Mexican Log still shows that day and night, while Cantú and WRTH 2013 both show 50 kW now. [Hauser-OK]
- 820 **CUBA** *R.Reloj*, Ciego Avila JAN 23 0056 RR Morse code through WNYC and others. [Conti-NH]
- MEXICO XEIK Piedras Negras, Coah. JAN 24 1317 Spanish news from between southwest and south/southwest, vs. WCCO opposite, jarring mispronunciation of François Hollande as "frankois," each letter pronounced, 7:18 time check, 1321 ID as *R.Zócalo*, ad mentions Colonia Lomas del Norte, then Piedras Negras, FM frequency jingle ending in .9,

[Hauser-OK]

- i.e. 100.9 as XHIK is listed, on to music. As previously researched, this is XEIK, *R.Zócalo* being the group or news name connected with Saltillo, while all references continue to name this 830 outlet *La Norteñita*. [Hauser-OK]
- 900 **MEXICO** XEW México, DF JAN 24 0643 Program promos for *W Radio*, atop co-channel interference with SAH, 0645 traditional XEW descending chimes. [Hauser-OK]
- 900 **MEXICO** XEOK Monterrey, NL JAN 18 0649 Screaming gospel huxter in Spanish, loops north/south with SAH. JAN 24 0655 Preacher with howling audience including kidsounds, 0659 concluding with assertion that música rock es satánica, ID as Radio ACIR and refers to 'La Biblia Dice' as program name, lunes a jueves 11 p.m. a 1 a.m. which has just been reached in CST. 0700 "Radio ACIR en 900 de amplitud modulada," website ending in .mx; 0701 mentions Monterrey, but more 'La Biblia Dice', 0702 mentions Nuevo León and 900 AM again. This must be what is listed as XEOK *La OK Noticias*, 10/0.25 kW in Monterrey per IRCA Mexican Log 2012; WRTH same except has *R.Tráfico* as additional slogan. Cantú as *OK Noticias* only and nite power as 2.5 kW, which is more like it. 900 in Monty was once a co-channel XEW relay as XEWM, long gone. Monty and DF are close to same direxion from here, Monty somewhat further west.
- 960 **MEXICO** XEFAMA Cd. Camargo, Chih. JAN 22 0600-0605 During local KGWA Fox-hole with remaining strong open carrier nulled: dominated by Mexican music, 0602 ID mentions "Chihuahua, México," so XEFAMA again, which is becoming famous around here for penetrating KGWA. Romantic music until KGWA modulation
- blasts back on at 0605 UTC. [Hauser-OK]
  970 **MEXICO** XEJ Cd. Juárez, Chih. JAN 20 1240 Just as I tune in, "La Jota Mexicana, 970." [Hauser-OK]
- MEXICO XEAU Monterrey, NL JAN 23 0636 "En tu radio, Milenio 103.7 FM" and back to rock music in English. I think not, but something on 1090 AM, i.e. XEAU in Monterrey NL, listed 250 or 500 watts at night, but not so unusual here, and in fact often dominant. Now it's a bit easier as KAAY Little Rock is reported off the air, maybe forever. JAN 24 0600 Mexican national anthem no doubt XEAU too, and 0640 with music in English. Also at 1251 ID as *Milenio Radio*, 6:51 time check, SAH from something. [Hauser-OK]
- 1100 **MEXICO** XETGO Tlaltenango, Zac. JAN 23 1252 Frenetic banda music looping northeast/southwest, quick announcement unreadable, then a slow song. 1253 plays fanfares several times, 1254 woman introduces newscast with phone number, www. site mentioning Zacatecas. Possibly separate stations, as rechecking the bearing now it's closer to north/south appropriate for Zac, i.e. per Cantú: XETGO *R.Cañón* + FM 90.1 5,000 400, and IRCA agrees; WRTH shows power as 5/0.5 kW. 1257 fading, as 1110 KFAB splatter overtakes. [Hauser-OK]
- MEXICO XEJPV Cd. Juárez, Chih. JAN 19 0645 "En Radio Viva, proclamamos lo altísimo [the most high], Radio Viva 1560" on to gospel rock in Spanish. Soon lost in interference and did not get a bearing on it. *R.Viva* in the IRCA Mexican Log: XEJPV Cd. Juárez, 10/-1 kW the minus really means presumed / suspected / estimated night power. WRTH 2013 says 1 kW fulltime, and Cantú says 1 kW daytime only: hardly. [Hauser-OK]
- MEXICO XERF Cd. Acuña, Coah. JAN 19 1529 Spanish, can it be XERF, or Tulsa? By golly, promo for La Hora Nacional, and it loops correctly for XERF, almost two hours after sunrise and about a megameter away. Sure helps to be *La Poderosa*. [Hauser-OK]
- ANGUILLA Caribbean Beacon, The Valley DEC 29 0625 A recorded program of The Rev. Gene Scott dominating the frequency and of course parallel 6090 kHz. Really a regular/local around here. [Funkenhauser-FL]
- MEXICO XEVT Villahermosa, Tab. JAN 24 1223 Very poor in Spanish, s9+10 with fading but not enough vs. noise level, so XEVT, as previously identified, is still third-harmonicizing from 970 kHz. Surprisingly, by now I have yet to see anyone else reporting it. [Hauser-OK]

## **Trans-Pacific DX**

- 693 unID JAN 23 0900 Apparent transmitter site sunset enhanced transpacific carrier, not strong enough to produce audio. JOAB most likely, although a residual post-sunrise signal from *BBC5* UK is also possible. [Conti-NH]
- vinID JAN 24 1325 JBA TP carrier detected here on a quick check, soon gone, no time for a complete MW 9 kHz scan; typically *NHK* Japan. [Hauser-OK]

Funkenhauser's Snowbird Report: I brought my NRD 545, Winradio G313e and Wellbrook ALA 1530 to Sebring, Florida, where if anything the noise and RF hash is even higher than in Cheektowaga, New York. In early December, I purchased a G31DDC Excalibur and a second ALA 1530 as an early Christmas present to myself, and spent a little time doing some DXing. The Excalibur is an interesting receiver. I use it and the G313e on two different laptops, both being i7 Quad Core Toshibas. One sports a first generation i7 chip, while the other is a recently acquired third generation variant. Compared to the audio on my NRD-545, the sound, especially from the newer Toshiba, is simply poor! Both units employ RealTek audio systems/drivers and cause me audio fatigue even when good stereo headphones are used. I find that I need to limit audio response between 200 Hz and 1000 Hz because of the high frequency hiss. I guess there is a learning/adjustment curve here. The evening that I heard the Saudi and R.Farda, there were signals of varying strength on many TA splits from 1557 down to 567, easily seen on the DDC display. Unfortunately, I didn't have the opportunity to pursue them, and I'm not yet at the point of recording the entire MW spectrum and going back to see what I've caught, not yet anyway (Hi!). The real-time display is a bonus, and it's nice not only to record a catch, but also to see and to photograph the signal on the DDC display. After a couple of pictures, I realized that the best resolution, most easily photographed with my equipment, resulted when I used the white skin option. Long wave reception has been unspectacular, though with some regulars. Radio Medi Un on 171 is almost always there nightly in one form or other and 162, 183, 234 and others appear from time to time. I did have a nice surprise to hear RMC on 216 kHz. It's been a long time since hearing it, so I submitted it as my lone long wave report.
