

A relatively slow week at the FCC over the New Year holiday.

CALL CHANGES

1270 KRVT OK Claremore – Call change to KTUZ (1/3).

1550 KZRK TX Canyon – Call change to KNSH (12/31).



New Station Watch

CP on the air:

1200 KPSF CA Cathedral City – This new station (U4 5000/1300) has been on the air for at least a year and a half with program test authority; final license granted 12/31.

CPs expired:

1400 KBEV UT Vernal – CP for new station (U1 1000/670) returned at licensee's request; station had been granted program test authority in December 2012 but never seems to have gone on the air.

Applications/appeals dismissed:

1490 APP MT Orchard Homes – Application for new station (U1 1000/670) dismissed; applicant failed to respond to 2010 FCC request for tower information.

1570 APP VA Ettrick – Application for new station (U2 9000/700) dismissed; applicant failed to respond to 2010 FCC request to amend application to avoid excess QRM.

The FCC will record a total of 4,727 AM stations licensed at the end of 2013, down 9 from the total at the end of 2012. This total includes 87 stations in US territories (American Samoa, Guam, Marianas Islands, Puerto Rico, and U.S. Virgin Islands), and is derived from a database that erroneously omits one licensed station (WRCR-1300) and that inconsistently treats some synchronous operations as independent stations and others not. I believe the accurate total for total *licensed* stations in the 50 states and the District of Columbia as of December 31, 2013 is 4,648 if synchronous stations are counted and 4,640 if they are not.

New station CPs outstanding at the end of 2013 numbered 54, including 7 that have been built and are awaiting final licensing (KCIK-740 Kihei HI, KXTW-1120 Manor TX, KRJW-1240 Altamont OR, KUSG-1350 Agana, Guam, KVSM-1380 Santa Maria CA, KHTC-1490 Malmstrom AFB MT, and WIGT-1690 Charlotte Amalie, USVI), 7 that have expired but are still kept in the database (presumably under appeal), and 40 within their original 3-year construction window.

And two of those new station CPs are coming up against January 2014 expiration dates: KEGC-1030 Elk Grove CA on 1/21 and 1460 Shawano WI on 1/28.

1600 WFIS SC Fountain Inn – Station went silent 12/31 and license cancelled 1/3; this was part of the deal for the power increase at WTZQ-1600 Hendersonville NC.





WVAL MN Saulk Rapids - 1/2 1854 - Old or classic C&W, CBS news on the hour, ID at 800

1908, then back to old C&W. (FO-OK) 850 KOA CO Denver – 12/28 0137 – Surprised to hear a female hosting 'Coast to Coast AM,'

most unusual, via KOA (and countless other non-synchronized frequencies); admonishes callers not to use 4-letter words as her guest is discussing swearing, both casual and causal. Casual swearing serves no purpose other than to show the person is too lazy to think of and utter the proper word, and doesn't care how it damage her reputation. Causal swearing is exclamatory and forgivable especially if from injury. Before next break, hostess IDs as Dr. Kathryn (?) Alpert (?) Bingo! Pats/Festival foods ad, Happy New Year in LID, Fox News at TOH and Yahoo Sports again at 1903. Only the 2nd time heard! Rare! (JJR-WI)

- 920 CFRY MB Portage la Prairie 12/14 0833 Pizza ad; results from Manitoba Junior Hockey League; soon faded. Sounded like they went into C&W shortly afterward but could not tell for sure. No ID heard, unfortunately; would be a new one here. Local KPOF-910's IBOC was off at the time; it's back on now, unfortunately. (JW-CO)
- 960 CFAC AB Calgary 12/30 0103 During 5-minute 'Fox hole' on local KGWA Enid, dead air which still occurs more often than not at local midnight, besides a mishmash of stations when I null the KGWA carrier, if I aim thru it toward the NW, I hear sports news, and ID as CBS Sports. This is the position previously capturing CFAC Calgary AB, which once was ESPN, but it's now CBS Sports. CFAC normally fails to restrict its 50 kW signal to northward as required by international treaty. (GH-OK)
- 980 WPFP WI Park Falls 12/28 0805 Poor;-IRN/USA news; "Heartland weather" jingle, ... Northlands ... Weatherology ... Freedom Talk 980." I cannot remember hearing this in years! Just never makes the trip! Logged in 1978 as WNBI. Rare! (JJR-WI)
- 990 KWAM TN Memphis 12/25 1730 Business ad with phone 901-683-4900 "here in Memphis," then back to Earl Farrell for Memphis Show talk show. Stayed in well for several minutes. (FO-OK)
- **1010 WMOX MS Meridian** 12/8 2313 Atop channel with New Orleans Saints football, announcement of the "New Orleans Saints Radio Network" going into commercial break. When I was in Iowa City back in mid-September, I was getting this around Midnight local time, which made me wonder if something is amiss with their pattern. According to radio-locator.com, WMOX should be shooting the bulk of its nighttime signal to the SW of Meridian. **(RD-NE1)**
- **1050 WDZ**IL Decatur 12/27 1400 ID at TOH: "You are listening to WDZ Decatur ESPN 1050 The Fan, Serving Central Illinois for over 92 Years" Good signal on Nissan car radio while driving on I-55 south of Bloomington, IL. Previously unreported station. (TMJ-IL)

Manor – 12/30 0155 – Ranchera music mixing with KMOX. At first I am not

- hearing it when I null KMOX toward the SE for KEOR Catoosa, the daytimer which has been caught running all-night, and would be praise music. By 0700 this is audible with KMOX nulled for ID mentioning Austin, Bustos? Media, "líder de radio en español," right back to romantic music in Spanish. So this is the new station KTXW, city of license Manor TX, which we already reported in DXLD 13-23 last June and followed up in 13-28: "'Now we must beware of another new Spanish station on 1120, KTXW in Manor (Austin) TX which has just started testing, "nostalgic wall-to-wall Spanish language ballads format" as 'Exitos 11-20" with 5000/155 watts.  1220 WSLM IN Salem 12/30 0204 WSLM ID in passing atop the jumble, and with off-frequency het from TX nulled. 82-watt classic-country station in Salem IN continues to dominate the frequency, surely running day facility of 5 kW. Day & night figure-8 pattern is slightly clockwise from east-west. (GH-OK)

 Weatherford 1/2 0836 South Asian language stands out here, news? from N/S, no doubt The Metroplex TX outlet heard before, KZEE Weatherford but street address in North Richland Hills, P O Box in Hurst, "South Asian Radio," "Hot Pepper 1220," 1600/200 watts U4, all per NRC AM Log 2013. That means different directional patterns day and night, despite NRC Pattern Book 2013 showing it ND day and night. FCC AM Query shows day pattern has main blob from NNE to ESE, a notch but not a deep one at 335 degrees, and not much further north toward Enid. Despite lower power, night pattern is better for us, a broad cardioid with null to its southwest. But it should now be on day pattern, official January sunrise at 0830. (GH-OK)
- **1230** KVOC WY Casper 12/2 2158 Good with clear ID: "Casper's ... talk, AM 1230 KVOC, Casper, Wyoming." (RD-NE1)
- **1250 KNEU UT Roosevelt** 12/16 1938 Ad for furniture store in Roosevelt. ID at 1939, "KNEU, Real Country." **(FO-OK)**
- **1290 WIRL** IL **Peoria** 12/20 1835 Bradley Braves coaches show talking to one of their coaches. **(FO-OK)**

- **1300 KLER ID Orofino** 12/30 0905 Local ads; canned ID by male voice at 0906: "News, weather, sports in the morning, and the best Country music all day long, AM 13 KLER" and into music. Fair. (JW-CO)
- **ND** Minot 12/9 1002 From the Perseverance Pays Off file: After about a week of hearing (albeit faintly) the theme music to the REL program "Insight For Living" around this time nearly every day, I was finally able on THIS day to get enough signal to hear a mention of "North Dakota" and CLs during a weather forecast before they went into the program. ND #10 at this QTH. **(RD-NE2)**
- 1380 KLIZ MN Brainerd 12/22 1659 Popped in briefly with "KLIZ the fan." (FO-OK)
- **1380 KXFN MO Saint Louis** 12/22 1700 ID as "1380, the woman", phone given 314-361-9610, all women talk show. **(FO-OK)**
- **1380** KKRX OK Lawton 12/21 1932 "All new KKRX" with call change, soul music, then "All new heart and soul, 1380." (FO-OK)
- **1400** KSRR UT Provo 12/30 0854 Beatles song; "1400 K-Star" slogan followed by more music at 0857. Fair, but soon lost to QRM. (JW-CO)
- **1410** KNTX TX Bowie 12/31 2059 Man with legal ID: "... on KNTX 1410 Bowie-Nocona(?)," followed by CBS news at 2100. Fair/poor. (JW-CO)

- 1190 **MEXICO** unID DEC 27 0043 A Mexican is dominating the channel on non-directional car radio antenna, with news, 6:42 time check, federal PSAs, rumbling het from something off-frequency. Two best bets are XECT Monterrey and XEWK Guadalajara. [Hauser-OK]
- MEXICO XEHI Cd. Miguel Alemán, Tamps. DEC 27 0104 On car radio, Mexican music and ID as "La Consentida," for which XEHI is only match in the 2012 IRCA Log; that's right across the Rio Bravo from Roma, Texas. WRTH 2013, however, names XEHI "Mi Radio 1470, Puro Cañonazo," but has no other 1470 as Consentida. What about Cantú? No Consentidas on 1470, tho I am positive that's the slogan I heard, and yet another identity for XEHI: La Caponera. What does Caponera mean? Random House says: "coop for fattening capons; gaol; place where one lives well free of charge." Well, I'm sticking with XEHI = Consentida, as that's the very active identity currently on Facebook. Dictionary definition of which is over-indulged or spoilt, hardly something positive. In DXLD 13-36, Henrik Klemetz said words like consentida imply mistress. [Hauser-OK]

Cuba Observations by Krueger

All day December 25, *R.Reloj* was running the four descending chimes usually reserved for Sundays instead of the Morse RR sounders after each minute time marker, but oddly except for the first five minutes top of hour and bottom of hour when the RR's were used. A subtle albeit odd nod to it being Christmas?

While I've not heard 1140 *R.Ciudad Bandera* in a long time, the opening 1700 news item on *R.Reloj* mentioned some upcoming program on Bandera, so presumably they are still on the air.

Like the above, *R.Sandino* is apparently still around (presumably FM only; years ago they were on highly variable 646-652 kHz as often observed from here). This per a mention on the *R.Guamá* news December 26 around 1150 on 990 kHz.

David Crawford's (Titusville, FL) synopsis of the Cuba logjam on 1140 kHz. Reception conditions on his east coast vs. my west coast of Florida to Cuba are always quite different. So far we have confirmed active on 1140: *R.Rebelde* (2x), *R.Bayamo*, *R.Musical Nacional*, *R.Mayabeque*, and *R.Surco*. "Ecos de Mexico" is a program on *R.Surco*. If you hear ranchera on 1140 outside of the scheduled program, after 0130 UTC (not sure when it starts and their website is down just now), it could be something else.

So far unconfirmed: *R.Ciudad Bandera* web scrub shows nominal sked is 0600-0100 local, i.e. 1100-0600 UTC. It begins Mo-Sa with a program "Mañanitas Mexicanas", i.e. yet another XE music program, that might stand out in the pileup, but an 0600 signoff might stand out also. Matanzas would be an easier shot from the west coast in general, of course.

R.Camagüey web scrub shows nominal sked is 0659-1300 local, i.e. 1159-1800 UTC. Sign-on would be the only way to catch this probably. This is probably a better shot from the east coast here. The 0700 local start along with me hearing an unID anthem at the odd time of 0000 UTC, i.e. 7 p.m., has me wondering if the programming block might be repeated 12 hours later.

R.Cadena Habana presumably replaced by Mayabeque.

R.Rebelde no. 3 conjectural based on varying relative audio delays, haven't heard 3 at same time thus far though.

One of the reasons why our Ultralightdx Yahoo group has had booming growth for over six years is because we have accepted many diverse challenges... from the basic challenge of DXing with a simple pocket radio (which all of us share) all the way up to the challenge of developing 21st Century antennas (and discovering innovative DXing sites) to make pocket radios surprisingly effective in Transoceanic DXing results.

Not all of us have the ability or desire to develop breakthrough antennas (or perform loopstick transplant operations), but the entire history of the Ultralight Radio DXing community has been one of amazing accomplishments – from Rob Ross' reception of 300 stations in one month on his SRF-59, Richard Allen's reception of multiple Longwave TA's from Europe and Africa on his 7.5" loopstick PL-360 in Oklahoma, and Allen Willie's reception of hundreds of TA's on his SRF-M37V in Newfoundland. When our late Co-Founder John Bryant was still with us he would constantly challenge each one of the Ultralightdx leaders (including me) to try something new – either in antenna work, DXing accomplishments or volunteer service.

John was an ex-Professor of Architecture at Oklahoma State University in Stillwater, and he had a natural teaching style familiar to all those who knew him. John was the one who introduced me to DU-DXing in 2008, teaching me all the basics of how to track down exotic South Pacific DX right in the middle of the worst possible season – the dog days of summer. At the time it sounded like

science fiction to me, and I thought that John might be "pulling my leg" – but he was absolutely right!

I don't have anywhere near the accomplishments or leadership that John had, but he and I did share a fascination with antennas – especially monster antennas that could make Ultralight radios highly competitive in Transoceanic DXing. So, in the spirit of John Bryant, I would like to offer some links to articles that have inspired many Ultralight Radio DXers to really push the limits in antenna construction – including one article that John and I wrote together. As I have shared with anyone willing to listen, I'm convinced that the future of our Ultralight Radio community is very bright – and optimism and innovation will win out over pessimism and boredom every time. Sometime this winter, why not try something new to increase your Ultralight Radio DXing fun – maybe a new antenna, a new band (FM, SW or Longwave) or Transoceanic DX reception? The future belongs to those who are excited about it – one of the reasons why our Ultralight Radio Community has been one of the most vibrant segments of the AM-DXing community for many years!

NOAA Space Weather Outlook

Issued December 30, 2013 – For the period December 30, 2013-January 25, 2014 (From http://www.swpc.noaa.gov/ftpdir/weekly/WKHF.txt)

Solar activity is expected to be low with a chance for moderate activity through 25 January. Region 1936 is expected to rotate around the west limb on 04 January but the anticipated return of old Region 1928 keeps chances for M-class activity intact until 17 January when Region 1936 is scheduled to return and finish out the period.

A chance for a greater than 10 MeV proton event exists through 04 January. Flux levels at geosynchronous orbit are still slightly elevated and Regions 1934 and 1936 are in good position to produce further enhancement should they erupt in the next few days. Probabilities will drop significantly once these regions rotate around the west limb.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at normal to moderate levels throughout the period.

Geomagnetic field activity is expected to be mostly quiet through 31 December. Quiet to unsettled conditions with isolated active periods are expected from 01 - 04 January due to a combination of a positive polarity coronal hole high speed stream (CH HSS) and a possible weak impact from the coronal mass ejections (CMEs) associated with two filament eruptions observed early on 29 December. Mostly quiet conditions are expected throughout the period with possible unsettled conditions on 10-11 January, 14-17 January and 23-24 January when recurrent CH HSS features are expected to be geoeffective.
