#### THE DX TIME MACHINE

75 Years Ago - From the June 15, 1939 *DX News*: A new editorial lineup was announced for the BCB section, with Dick Cooper (assisted by Stephen Mann) to be BCB editor, Pat Reilly as BCB contest manager, and Joe Becker as FCC editor; the SW section comprised most of this issue of *DX News*.

**50 Years Ago** – From the June 13, 1964 *DX News*: James Tonne, chief engineer of KBIM-910 Roswell, N.M., sent a long letter to the NRC detailing what should, and should not, be in a reception report from a broadcaster's perspective.

**25 Years Ago** – From the June 26, 1989 *DX News*: WNZK-690 was granted a CP for night operations on 680, the first grant of a US split-frequency operation in decades.

**10 Years Ago** – From the June 14, 2004 *DX News*: KYPA-1230 ceased broadcasting from the Odd Fellows Lodge Building on Oak Street in Los Angeles, after 80 years of broadcasting (starting as KGFJ); Mark Connelly reported the new Radio Farda-1170 from Abu Dhabi.

In May, the FCC auctioned off the rights to apply for 22 CPs where two or more mutually exclusive applications were received in 2004, and where the FCC had not found a preference for any of the applicants. Ten auctions resulted in winners, while twelve auctions ultimately didn't receive any bids.

Ft. Wayne format moves could occur soon after June 2, when Adams Radio Group closes on two different purchases that put seven local stations into its hands. Adams CEO Ron Stone tells the News-Sentinel "Get ready to go along on the ride with us...it's going to be a lot of fun." The paper's Kevin Kilbane says "any programming changes will take place quickly at some stations, and later at others." So he's not taking the "no-changes" pledge. Minnesota-based Adams Radio Group is paying \$2.9 million for the Summit City Radio stations and \$3.5 million for the assets owned by Russ Oasis. We knew that Adams would be trading away classic hits "Rewind 106.3" WHPP Columbia City to Redeemer Radio's WLYV/1450. And that it's swapping WGL-FM Huntington at 102.9 to Calvary Radio Network in exchange for a Ft. Wayne translator at 103.3. The News-Sentinel says the lay-Catholic Redeemer Radio programming will stay on 1450 until July 1. Combining two clusters into one means some layoffs, as Adams transfers the Summit City stations to the Oasis facility – and will sell the Summit City studio space. The first score for the revived Adams Radio Group was a quartet of stations in Las Cruces, New Mexico, and it's waiting to close on four stations in Valparaiso, Indiana for \$8.5 million. Here's a tease - the Ft. Wayne paper says Adams is "looking into buying six more stations on the East coast."

#### From Radio Insight (via Shawn Axelrod)

With the number of Progressive Talk stations dwindling, yet another syndicated Liberal Talker is ending their terrestrial radio shows. Ed Schultz will cease production of his daily 12-3pm eastern show on Friday in order to focus more attention on his MSNBC TV show. In its place Schultz will host a one hour streaming program and podcast on his <a href="WeGotEd.com">WeGotEd.com</a>. The podcast will debut on Tuesday, May 27. Schultz stated on MSNBC, "This change will give me more flexibility to be on the road, to do the kind of shows I want to do here for The Ed Show here on MSNBC. This is on me, you know. I just don't want to do a three-hour talk show anymore."

580 WKTY WI La Crosse – 5/17 1359 – Fair in null of WILL with "WKTY" heard in station ID during 10-second break on the Milwaukee Brewers Radio Network. (RD-IA1)

**590 WJMS MI Ironwood** – 5/17 0144 – Good in KXSP null with C&W mx, ID as "Real Country," so running that network. An instant Google search using "Real Country 590 AM" pointed directly to this. I'm inclined to think, by the loop bearing, that it was, indeed, WJMS. **(RD-IA2)** 

**640 WMFN MI Zeeland** – 5/17 1408 – Weak in tight WOI null with music in Spanish. Only Michigan station audible here in the daytime, as KCCV-760 covers WJR. **(RD-IA1)** 

**640 KWPN OK Moore** – 5/17 0202 – Fair in WOI null with mention of Oklahoma City Thunder BKB in local promo. UnID noted at the same time with REL program *Through The Bible*; most likely WCRV. **(RD-IA2)** 

**690 KFXN MN Minneapolis** – 5/17 0224 – Strong with woman singing in Hmong language. **(RD-IA2)** 

**720 WGN** IL Chicago – 4/16 1356 – Weak but audible with Chicago Cubs BB // KCIM-1380. Announcer Pat Hughes was talking about the Cubs' World Series appearances in the 1930s vs. the New York Yankees. (**RD-NE2**)

**750 WNDZ IN Portage** – 5/13 1914 – Very good with Christian talk program by male in Spanish. 50 miles west of here, in Iowa City, 250 watt KBOE-740 comes in with a stronger daytime signal than WNDZ. Here, it's just the opposite. **(RD-IA1)** 

750 KMMJ NE Grand Island – 5/6 2136 – Preacher in English from N/S, surely KMMJ. Not in Spanish at the moment, a minute before my streetlight ignites for the night. I

also overlooked reporting this a few days ago: 5/3 2133, country gospel music in English from N/S, but off by 2158 with WSB. KMMJ is that rare "Unlimited" station with a Limited schedule, 10.7 kW, apparently in deference to WSB. Per 1977 FCC info, in May the hours are 0715-2145; June, 0700-2200. **(GH-OK)** 

**790 WRMS IL Beardstown** – 5/17 1450 – Fair with recitation of rosary. "WRMS" heard in a long string ID of Covenant Network stations at 1459. Only got this by pointing the loop straight south (and 90 degrees from Chicago) to eliminate as much of WBBM's IBOC as I could. **(RD-IA1)** 

**790 WKRD KY Louisville** – 5/16 2228 – Good with scoreboard show following Louisville Bats BB. **(RD-IA2)** 

**810 KBHB SD Sturgis** – 5/17 0259 – Very good signal, giving WHB fits with classic C&W tunes and a "KBHB, Sturgis" ID. Has since been noted apparently running day power all night long by many DXers in the Midwest and Pacific Northwest. **(RD-IA2)** 

KFUO MO Clayton – 5/5 2144 – Organ music from NE/SW, vs Rockies BB from the NW = KOA. Surely it's KFUO, although May official FCC sunset there is 2100. If I recall correctly, KFUO gets to stay on until LSS in Denver, which is 2200 ELT now. At 2145 organ music fades or cuts off? Meanwhile at 2146, KOA pauses to promote "Talkradio 6-30, K-How" which was once a competitor, but now both are owned by Citicasters Licenses, Inc. When nulling KFUO to get KOA, I am also hearing a weaker station in English underneath; it's too early for Tacoma, so presumably one of several stations after dark in the South. My streetlight ignites at \*2137 with a clear sky, 14 minutes after Enid sunset at 2123\*, cooling a 102-degree day. (GH-OK)

**880 CKLQ MB Brandon** – 5/17 0231 – Fair in WCBS null with C&W music and western Manitoba weather. **(RD-IA2)** 

**910 KBIM NM Roswell** – 5/9 0159 – Amid the jumble, instead of Miamuh OK, I am hearing a promo/PSA for a university in Roswell (an ENMU campus?), KBIM radio

mentioned, then full ID as KBIM 910 and FM xx.7, into ABC News. The original KBIM-FM was 94.9 and it got out well by tropo to the east, but I suppose they were divorced long ago. Now NRC AM Log shows the FM translator of 910 is on 93.7, K229BV, and 910 is only 500 watts at night with pattern a circle tangent south, no good for us; yet KVIS'

pattern is a tight figure-8 toward Enid. Something seems amiss here with one or both, or just a propagational fluke. **(GH-OK)** 

**920 WBAA IN West Lafayette** – 5/16 1447 – Fair in null of polka music (had to have been KDHL) with NPR program "Here and Now" //WSUI-910. Pointing the loop in a NE direction brought in a weak third station, most likely WOKY in Milwaukee. **(RD-IA1)** 

930 KOGA NE Ogallala – 5/18 0800 – Man with legal ID at 0800:18: "Celebrating 60 years serving western Nebraska and northeast Colorado, AM 9-3-0 KOGA Ogallala," followed by Fox news; local weather followed at 0802, then 70's nostalgia music. Fair/good. (JW-CO)

940 WFAW WI Fort Atkinson – 5/16 1450 – Fair in KPSZ null with Milwaukee Brewers BB. (RD-IA1)

960 KGKL TX San Angelo – 4/2 2112 – Good under KMA with local ad mentioning a phone # in the 325 area code, a "960 KGKL" ID, then back to Texas Rangers BB. 7th station from Texas added to the logbook here this season. (RD-NE1)

**1020 KJJK MN Fergus Falls** – 5/16 2256 – Fair in KDKA null with Minnesota Twins BB. **(RD-IA2)** 

**1030 WQSE TN White Bluff** – 5/17 0119 – Fair under WBZ with Southern Gospel music, ID: "…on WQSE…White Bluff, Tennessee…" **(RD-IA2)** 

**1050 WNES KY Central City** – 5/17 0117 – Good with "WNES 1050" heard in liner after Reba McIntire C&W oldie "Little Rock." **(RD-IA2)** 

1100 KNZZ CO Grand Junction – 5/2 2215 – Talk host from NW discussing "gamma waves" (not rays) in his brain, totally separable from baseball on WTAM Cleveland from the NE and roughly equal strength until the former cuts off abruptly, how rude! 2215 is indeed official FCC sunset in May for KNZZ Grand Junction, after ND 50 kW daytime. It's 10 kW directional at night, or 36 kW during Critical Hours, tight figure-8 slightly counterclockwise from N/S, approx. 349/174 degree peaks, 80/260 degree deep nulls, each almost as nullable, plus/minus 20 degrees. (GH-OK)

- 1110 KVTT TX Mineral Wells 5/14 2128 KFAB is sufficiently nullable to hear something in English, but South Asian accent, inviting requests to be called in for next show; says he will be back tomorrow morning, and then Tuesday night, bit of South Asian music. Deep fades; 2130 UT canned ID in English as "---- Radio, KVTT, 11-10 AM, Mineral Wells-Dallas-Fort Worth," and more South Asian vocal music. Radio-locator.com shows slogan as "FunAsia Radio." Wikipedia link to program schedule shows different hosts at those times. And includes, Hindu, Moslem, Christian shows; for Indians, Pakistanis, Bangladeshis and Nepalis (at least). Official KVTT sunset in May is 2130 (June & July: 2145), but unaware of this, I did not note any abrupt disappearance. 50 kW day pattern. FCC web site shows major lobe to the SE, secondary to the SSW and tertiary to the NW. However now it would be on 39 kW for Critical Hours. (GH-OK)
- **1180 WSQR** IL Sycamore 5/13 1752 Fair with "WSQR" in liner between oldies by the Charlie Daniels Band and Kansas. Situated about 12 miles from the transmitter of KJOC-1170 at the time of reception, splatter on 1180 was minimal when turning the loop 90 degrees from KJOC. (**RD-IA1**)
- 1190 KKOJ MN Jackson – 5/1 2127 – Loops north/south, sign-off refers to FM 105.7, "all oldies all the time," and KKOJ; nice version of Star Spangled Banner by a cappella men's choir (or maybe a smaller group, hard to tell in QRM) until 2129. This is 5 kW directional daytimer in Jackson MN, on I-90 next to the IA border with Spirit Lake per website program co-town with schedule http://kkoj.com/kkoj\_schedule.htm where we see that "Your One and Oldies Music" is the format on KRAQ FM, which of course is not signing off, while the AM is country. (GH-OK)
- 1190 WNWC WI Sun Prairie 5/13 1753 Good with "Faith Radio" heard in promo. Turned the loop ESE (and away from Sun Prairie/Madison) in hopes of getting a daytime reception of WOWO, but it didn't show. (RD-IA1)
- **1220 KOFO KS Ottawa** 5/16 0801 Local news of a fatality on "K-68 near Ottawa," so it's KOFO Ottawa KS, 250/40/47 watts U1. Remnant of skywave remains on the upper band; today's Enid sunrise 0724 ELT, with about 10 minutes to go for earliest in about 3 weeks. **(GH-OK)**
- **1230 WCLO WI Janesville** 4/9 2116 Atop briefly with Milwaukee Brewers BB // WIBA-1310. Only 1230 shown on the 2014 Brewers affiliate list. First Wisconsin GYer heard here since nabbing KFIZ-1450 back in December. **(RD-NE1)**
- **1290 KOUU ID Pocatello** 5/7 0829 "Country Classics on one station, K-O-Double U, Country Classics 1290 AM, 102.9 FM" and into music; heard a bit later announcing a new FM frequency (100.3). Not sure if this will replace 102.9 or simulcast. At 0840 weather and legal ID: "...KOUU Pocatello-American Falls-Blackfoot-Idaho Falls." Generally fair signal, with ups and downs. **(JW-CO)**
- **NE** Omaha 5/23 0745 Imus with guest sounding like Dolly Parton, but does she \*look\* like Dolly? Can't tell. First possibility: KWFS Wichita Falls TX, which is a talker. NRC AM Log shows Imus is on the CM = Cumulus Media network, and KWFS is too, but not on the Imus station finder. He is however on KOIL Omaha NE at 5-8 am CT. so very likely thence. But that listing can't be trusted as current: Imus' only OK affiliate is shown as KRVT 1270 Tulsa, which is a neat trick since it's been KTUZ in Spanish since January. **(GH-OK)**
- **NE** McCook 5/23 2137 Rockies Radio Network, also mentions High Plains Radio, plugs a rodeo, during pause in silly ballgame; NW/SE, good peaks but total fadeouts. It must be KBRL, which is in that group. and the only 1300 on the Colorado Rockies network. KBRL is 5000/136 watts U3. Has three major lobes, the one at 170 degrees close enough for us. Official May sunset is 2145; June & July, 2215. (GH-OK)
- **1470 KYYW TX Abilene** 5/16 0806 Promo for Newstalk 14-70, KYYW; for weather see kyyw.com and then hour three of Bill Bennett's Morning in America with guest host Mark Davis. [Heard] before skywave fades out. **(GH-OK)**
- 1490 WDBQ IA Dubuque 5/16 1501 Fair in daytime pileup with "WDBQ" heard during ID time on the Chicago Cubs Radio Network. WZOE was topping the channel with Dave Ramsey at the time, and KBUR was airing the same, only able to separate the two at legal ID time. A fourth station was also audible when pointing

the loop north, this one with satellite oldies -- WGEZ

in Beloit is the most likely possibility. (RD-IA1)

- 1510 WQQW IL Highland 0151 Dominant signal is something new, Mexican music, long corrido, loops somewhat CCW from E/W. 0155 partial ID as "La Ke Buena" with no WLAC to be heard, but that must be in a fade, regaining shortly making 4 Hz SAH, during C2CAM; just after 0200 ID in accented English as "WQQW, La Ke Buena" and right back to music. This is a 1 kW \*daytimer\* directional toward me! (GH-OK)
- **1510 WWHN IL Joliet** 5/16 1536 Decent daytime signal in WLRB null with black gospel music. **(RD-IA1)**
- 1510 KNNS KS Larned 5/23 2134 Ad in English mentioning area code 785, which is northern KS, and loops NNW; there is no het so KCTE Independence MO must really be off the air, and this is the Larned KS station KNNS, no longer Spanish, as in NRC AM Switch for March 14. Larned, southwest of Great Bend, and KNNS's address is there, is actually in the 620 area code, but not far from the 785 boundary, no doubt within its coverage area and/or that of its FM. (GH-OK)
- **MO Independence** 5/9 0132 ESPN Radio is dominant, looping NE/SW, and about 5 seconds ahead of ESPN on 1500 KSTP. This is obviously KCTE Independence MO (circa Kansas City), 15 kW \*daytimer\* cheating yet \*again\*, \*and\*, \*always\* off-frequency far enough to cause an audible heterodyne. Poor WLAC doesn't have a chance, only as a carrier to het. (And then there was another 1510 daytimer logged a few nights ago around midnight, WQQW circa St Louis, but not tonight). - **1520 WLUV IL** Loves Park 5/16 1559 Fair with "WLUV, Loves Park" ID during Alex Jones program. (**RD-IA1**)
- 1530 KCMN CO Colorado Springs 5/28 0204 One more check for KLBW cheating daytimer heard three previous nights around now: instead frequency dominated by music, "Baby-Love," about same NW/SE bearing as for New Boston TX, but is opposite, "Good Time Oldies on the I-25 Radio Network," which means Colorado: KCMN Colorado Springs, but it's got to be cheating too, as NRC AM Log shows it with 15000 watts day/15 watts night! (GH-OK)
- 1530 KLBW TX New Boston 5/24 0205 "KLBW, 1530, The Light and KLBW1530.com," loud female ID, preceded and followed by soft modulation if any. But not soft enough: this is a 2.5 kW ND daytimer ONLY, in New Boston TX, which is in the extreme NE corner, so far out, that if you head due north you'll be in AR instead of OK; just west of Texarkana TX & AR. It is of course a religious station, which nullo modo keeps it from breaking the law (just ask Tony Alámo). Or was it an unpublicized DX test? - 1550 KUAZ AZ Tucson 5/8 0859 PSA for Pima County Clean Air Program; weather; legal ID at 0859:53: "This is NPR 89.1 KUAZ-FM Tucson and 1550 KUAZ Tucson, a broadcast service of the University of Arizona. It's 6:00" and into NPR news. Good signal, as usual, but this may be the last time logged here, due to local KDCO taking to the air. (JW-CO)
- 1560 KKAA SD Aberdeen 5/6 2141 Harold Camping lives! Not on SW WYFR anymore, but on KKAA, 10/10 kW U4 from Aberdeen SD. And he is getting younger, judging from his voice compared to the last days on SW. Also had him at 2133 on more common Family Radio station, KYFR-920, Shenandoah IA. Now at 2141 and 2151 I can tell that 920 and 1560 are // and synchronized. How fortunate we are, since the FR translator in Enid remains defunct from 88.3. KKAA dominant on 1560, no KGOW to be heard. (GH-OK)
- 1570 KBCV MO Hollister 5/4 0145 In XERF null, Christian Resource Center in Beckley WV mentioned, unclear if start, stop or mid-program, but per www.christianradiojournal.com, hovering over MO, they have a 1570 in "Branson," as I expected, my closest in the XERF null, actually KBCV. Furthermore it's the only 1570 affiliate. (GH-OK)
- 1580 KKTS WY Evansville 4/10 2311 Very good with modern pop hit "Glad You Came" by The Wanted, then ID as "Hit Radio KKTS." Tried for this after other DXers in the Midwest and Pacific Northwest reported hearing it. This and KVOC-1230 are the only Wyoming stations added here this season. (RD-NE1) 5/8 0836 Out of AC music and into one minute of NBC news at this odd time; local ads and call letter ID followed. Fair at best. (JW-CO)

- **1600 KMDO KS Fort Scott** 4/4 0753 Atop after late switch to day power with "...a proud KMDO/KOMB Sports Booster..." heard in a local ad (was sure I also heard a mention of "Hy-Vee," but I can find none anywhere close to Fort Scott). A rare visitor to this QTH. **(RD-NE1)**
- 1610 CHHA ON Toronto 5/20 0158 Again no IBOC from 1600 KATZ St. Louis to block "CHHA, Radio Voces Latinas, 1610-AM" ID; 0159 plug for "su noticiero Panorama, de lunes a viernes," promo some 21 de mayo event in Toronto. And no IBOC either from KEPN Lakewood CO at a right angle to block Anguilla. Holding breath/crossing fingers that both be gone for good, but one is often ultimately disappointed in such cases. **GH-OK**)
- 1660 KQWB ND West Fargo 5/6 2138 C&W music from N/S must be KQWB, West Fargo ND, ex-True Oldies. That Channel is being abolished as of June 30 and affiliates are already bailing out. Three items about this are in DXLD 14-18. Soon overtaken by Rockies vs Rangers on the "Texas Rangers ESPN Radio Network," i.e. KRZI Waco TX. (GH-OK)

Searching directly on that, the best I can find is last year's. If DXM and DXN were on paper, I could have found baseball networks quickly instead of wasting a lot of time hunting & searching the pdfs. (GH-OK) Well, DXN is on paper for those who want it ... but no 1500 Cardinals station on this year's list DY.

- MEXICO XEMR *R.Esperanza*, Monterrey, NL MAY 10 1101 Super truncated version of anthem beginning at tune-in, ending 1102, excited male, mention of Monterrey so tentatively the one. Barely there in the multiple Cuban and probable WNWF co-channel. [Krueger-FL]
- 1150 **CUBA** *R.Bayamo*, Bueycito MAY 24 0214 Good under/over WJBO with Cuban oldie vocals, parallel weaker 1160 and fair-poor 1140, so these three are still active. [Krueger-Mana FL]
- 1220 **CUBA** *R.Caribe,* La Fe, Isla de la Juventud MAY 6 0040 Nice Cuban pop/rock. [Krueger-FL]
- 1310 **CUBA** *R.Enciclopedia*, Nueva Gerona, Isla de la Juventud MAY 25 0355 Easy listening music, female time check, ID into highly truncated Cuban anthem at 0400. Parallel 530 kHz. Fair, nice to hear them here again. [Krueger-FL]
- MEXICO XEBS *La Más Perrona*, México DF MAY 19 1027 Mexi-tune, male XEBS calls, more vocals and chatter, never an anthem in the 1100 range on this one (logged the previous three days in the 1045-1110 range as well). Calls and *¡La Más Perrona!* slogan at 1101 and 1103. Very good level but eventually giving way to WMYR Ft. Myers classic country. Perrona doesn't mean "cheap" in this instance; it's a Mexican-ized phrase used by youth for great or excellent. [Krueger-FL]
- 1550 **CUBA** *R.Rebelde*, Santa Clara MAY 24 2115 Excellent with weak WRHC under, apparently soccer coverage as lots of "goooooooal" mentions. What, no baseball? Presumed site though many listed. [Krueger-Boca FL]
- ANGUILLA Caribbean Beacon, The Valley MAY 17 0555 Can barely make out from the southeast PMS parallel 6090, as well as harp music from the northeast, surely CHHA Toronto. Usually these very weak signals are both blocked by IBOC from 1600 in St. Louis and Denver; can both of those be off IBOC now, or forever? MAY 18 0155 Again no IBOC from either angle. [Hauser-OK]
- CUBA *R.Rebelde*, La Habana//Guantánamo MAY 9 0137 As my streetlite ignites after LSS, dominant signal at tune-in is R.Rebelde FM ID and production credits; 0139 mentioning Día de las Madres, which is apparently coordinated with the Yanqui calendar! Unlike various other Latin countries. Convenient to be in step with the gusanos in Miami. Indeed not parallel 1180 and 5025 *R.Rebelde*. How much of the time, or is it all the time that this 1620 carries the "FM" service? MAY 27 0614 "A esta hora, al ritmo de la vida en Rebelde," and parallel 5025 so the AM, not the FM service now. [Hauser-OK] If there's a pattern as to when they feed the FM I've yet to figure that out. I'd guess about 25-40% of the time it's FM. There are also times I hear the FM service on 1180, but not on the one or two strongest transmitters at my proximity, rather on occasion one or two of the weaker ones underneath. [Krueger-FL] Rebelde FM also occasionally heard on 600 kHz. *Conti*

#### DX Season Wrap-Up

By Werner Funkenhauser

#### **SDR Setup**

I've used my WiNRADiO Excalibur with a third-gen P7 Toshiba laptop running Windows 7 Pro for long burn-in now, and respect it more than when I first got it. However, my earliest criticism of Excalibur's poor audio remains. I'm not too happy with AMS either. It is noisy and to varying degrees inadequate in weak signals with QRM and adjacent channel slop. There, it delivers audio masked in its own noise. Perhaps this is a problem only with my Excalibur.

I never begin a DX session without the demodulator recorder being at the ready. I didn't like Excalibur's default directory path for recordings, so I use 2 Terabyte dedicated external USB Drive for all my recordings. The USB drive root directory has parent subdirectories for each of the years 2012, 2013, and 2014. Under each year, I have subdirectories for the months January through December, inclusive. Each month has subdirectories for each its days.

Say it's May 18, 2014 and I'm about to begin a new day's DX session, I immediately start the demodulator recorder. The File Path will show the last subdirectory into which Excalibur wrote files - as an example, F:\2014\May\May17\Rec-0.531MHz.WAV, yesterday's last recording. I use 'Browse' and in the next window, I open May (at the top of the screen) revealing all the previous days subdirectories. By right clicking the mouse, I create a new subdirectory for today, namely May18, and immediately click on [Open] twice. This returns to the Excalibur display, and makes the new, empty, May18 subdirectory the Excalibur default 'Save'' location. The File Path now shows F:\2014\May\May18\Rec-0.531MHz. This new directory is where Excalibur will save all of this session's audio, bitmap and spectrum files. The File Name Rec-0.531MHz, still appended to the File Path from yesterday, will automatically be replaced once a new recording starts because as I always use the 'Insert frequency' option. If I record a station on 720 kHz, the full new File Path with File Name becomes F:\2014\May\May18\Rec-0.720MHz. I do not usually change the default File Name except in unusual cases say I record two stations sharing the same frequency, but at different times on the same day.

To accompany my Excalibur recordings I use the [FN], [PRTSC] function to create a screen capture of Excalibur's display and sometimes also a Grey Line display. Those are pasted into Windows Paint and saved in Paint as BMP files with appropriate names, something like Screen720.BMP and 720GreyLine.BMP, along with those that Excalibur's saves. Browsing with Paint to Excalibur's default directory, namely F:\2014\May\May18\, before saving with Paint puts all the files for this session into the same location. The Excalibur screen capture provides lots of information, showing my settings, time, etc. It provides far greater detail than Excalibur DDC Spectrum Saves. Later when I need it, finding a recording is a snap with Windows search, and all related files are easily found in the common subdirectory.

While recording on the Excalibur, I also use a second computer, running a WiNRADiO G313e for on-air parallels. It is also used to capture Web parallels. This is where its real value lies - the ability to go to parallels on another system, without cluttering up Excalibur, or the need to keep open numerous windows on the main computer and draining resources. I use Audacity or Total Recorder, and parallel recordings are also saved in this DX session's directory, because the Dedicated USB Drive is accessible from the second computer through my home network.

This may all seem like a lot of work, but getting information for the log book or a report is a lot easier this way, the more details, the more accurate the reports/logs.

The Excalibur's visual display is really valuable for seeing the splits, off-frequency wanderers and TAs. But the DDC Bandwidth has to be narrow (I use 20 KHz) with DDC and Demodulator RBW at 12 Hz and AVG (average) both windows display rate set high (1 sec), so that it is possible to see a signal easily, without it being surrounded by fast changing spikes. Also the DDC window has to be large. I don't use the full spectrum display field, and instead drag the DDC window far to the right, and then drag the DDC or Demodulator windows' lower edge right to the bottom. Splits, even weak ones are readily visible unless overpowered by strong adjacent signals. It is quite easy to see off-frequency operators this way and with the Mediumwave Offset List as a resource, it presents a whole new type of DX target.

I have two Wellbrook ALAs antennas - a 1530 S and a 1530 S+. I will often use those together with a Quantum Phaser, which works pretty well. The ALA 1530 S+ travels with me to Florida during winter. I also have an RF Systems EMF antenna. Though short, it is excellent for long wave reception. Since I don't have a whole lot of real estate in either location, I've been envious of guys who are able to erect larger directional antennas and phased arrays. Because of limited space here in Cheektowaga, I decided to go back to a classic K9AY system - the 30 foot deltas at right angles supported on a single post. Andy Ikin kindly put one together for me, even though Wellbrook no

longer sells that particular product. It's an excellent antenna - every bit as good as the K9AY system that Al Merriman built for me back in the mid-1990s.

- 189 **ICELAND** *RUV Ras* 2, Gufuskalar MAR 20 0438 Icelandic female playing folksy ballads. Very poor. MAR 24 0307 female introduced Bobby Dylan's 'Just Like a Woman'. Poor. MAR 27 0249 Three-way talk by a woman and two men. Weak in noise. APR 23 0252 Poor with rock music.
- ENGLAND *BBC Radio 4* synchros, MAR 17 0240 fair with English talk. MAR 20 0525 English man interviewing another. Poor. MAR 25 2335 Very poor/QRN with a male speaker. Quranic prayer ending at TOH, brief Arabic announcements by a man and woman then English rap (complete with obscenities), more thumping pop in various languages, also rap (perhaps the same artist?) and salsa piece. 'Jil FM' slogan by female singers between songs at 0415, 0422 and 0425. APR 07 0340 Poorer, ending of a song with two men speakers, brief announcement by a woman then Quranic prayer before TOH in difficult conditions as it faded. 0407 resurfaced with a lively ME/Arabic pop vocal, paralleled via web.
- 693 **ENGLAND** *BBC Radio* 5 *Live* synchros MAR 24 0452 In 690 slop; two Brit-accented men also heard via BBC 5 web stream. TOH spots obliterated by 690 fanfare, into BBC news by a female. MAR 27 0258 Poor, in parallel with a better 909, English male announcer then BBC news followed by Rhod Sharp program according to web feed. APR 5 2328 Snatches of a Brit-accented female in parallel with a better 909 though both very poor. APR 6 0348 Men discussing the missing jetliner then Ebola Outbreak in Africa. Poor-fair and in parallel with 909 kHz.
- FRANCE *Info* Rennes MAR 17 0318 Heard an animated discussion by a woman and man followed by a female singing in French to a Middle Eastern style melody. Music was from the French station, but also here, someone on 711.109, presumably *SNRT* Morocco, which I couldn't decipher.
- GERMANY Deutschlandfunk, Ravensburg/Sheppau APR 1 0450 Fair, a German female interviewed about Crimea ('Internationale Gemeinschaft', 'in der Krim (Crimea) and 'Sie zusammen arbeiten müssen' in context). Difficult in TOH fanfare, however a female read news at 0401, confirmed by a few seconds delayed web stream in this time-frame.

- HOLLAND Nostalgia Radio 5, Lopik MAR 23 0223 Easily paralleled via web, Dutch man playing pop music including Bobby Dylan's 'Like a Rolling Stone', 0230 a Dutch male preacher gave a sermon ending at 0257 with a brief gospel piece, then surprisingly, The Boxtops' hit, 'The Letter' to the TOH. At 0301 a female read news, fading, but with mellow instrumentals heard at 0307and 0310. On-air signal seemed delayed compared to the web by some 4 to 5 seconds. APR 6 0258 Rock song then a female at 0300 with presumed ID and news bits followed by music in a fade, resurfacing at 0312 with Al Green's 'Let's Stay Together', 0326 Nat King Cole 'Autumn Leaves', Sam Cooke 'Chain Gang', Tom Jones, 'She's a Lady' all heard well and in parallel on their web stream.
- MAURITANIA *R.Mauritanie*, Nouakchott APR 4 0234 Lengthy Quranic chanting amid periods of fading. Tenuous! Not claiming it as definite <u>then</u>. Last Fall, I heard similar stuff here Quranic prayers <u>but from two distinctly different stations</u>. Other possibilities exist in this time frame. APR 14 0545 Quranic prayers, weak in WBBM slop but this time slot makes it more a definite for Mauritania.
- 882 ENGLAND BBC Wales synchros Likely Washford MAR 23 0217 Through adjacent WCBS QRM, English talk also heard in parallel web stream. 0320 with BBC program items about a Belfast woman whose body had been missing 30 years, Statins and heart patients. MAR 26 0137 Only bits of Brit-talk too poor to follow then, but later at 0207 in hard WCBS splatter with BBC news, a financial program with an American being interviewed on tax shelters, mentioning 'sodas and beverages industries'. MAR 31 2324 English talk briefly and very poor. APR 1 0424 Two men discussing Afghan politics and elections mentioning 'The Taliban' and 'The opposition' in context. APR 5 2335 Parallel with web stream slightly delayed, music clobbered by slop.
- 909 **ENGLAND** BBC Radio 5 Live synchros MAR 17 0226 - English-accented men and Birmingham woman in tele-talk about Wisteria plant care, also via web stream. MAR 17 0310 - Very poor, two men in English also heard in parallel on 693 and the web in a discussion on conservation issues and renewable sources of energy. MAR 20 0523 - English talk. MAR 26 0043 - Two men and a woman in a three-way conversation in hard-to-hear through slop, but able to confirm content was the same as web stream. Better later at 0218 BBC programming with the narrator interviewing an American about the mud slides in Washington State, the rescue equipment being used, such as helicopters, and efforts by the U.S. navy and Sheriffs' offices, there followed a feature discussing the NCAA Basketball Tournaments, all also heard in a web stream with a significant delay. See also 693. APR 25 0331 - Poor with a man and woman in interview about sports as I thought 'schedules' and 'team' were mentioned, another interview of a man retiring from some team, '...to spend more time with the family.' APR 4 0244 - Weak, female/male actuality report with web parallel.
- 945 **FRANCE** *France Info,* Toulouse MAR 26 0200 Poor with bits of French talk.
- 1053 **ENGLAND** *TalkSport* APR 04 0315 Bits of Brit talk seemingly with parallel 1089 by 0319. Poor, slop from 1050/1060. APR 5 2324 Very poor, though audible in slop.
- ENGLAND *TalkSport* synchros MAR 26 0052 Heard clearly and fairly strong, a male in sports talk phone conversation/ interview with another one talking about Manchester and Manchester United. Ended the segment with a music theme but no real ID heard at the TOH where all I could determine were a couple of program notes and news bits. Later at 0205 parallel with web stream which was delayed some, theme music with sports talk mentioning, 'Coming up in a minute... winning cup...' APR 1 0157 Fair with sports palaver about Manchester United. APR 4 0322 Good. Glad I was recording! At 0324 light classical music faded up intermittently over sport talk, then at 0330 I heard a sultry-sounding female speaker but couldn't make out the language. More snatches of music followed by a man/woman talking at 0345, now sounding Slavic, still mixing with a *TalkSport* promo 'Let It Rain'. Pretty well gone by 0350 but *TalkSport* remained, though weak time pips 4 and another longer tone at TOH (could be wrong but didn't think it was TS). Day/night map leaves few possibilities. Others on-frequency are in daylight or off, as far as I could determine from web sources. APR 29 0248 Fair in slop with two men talking about, what else? sports.
- 1215 **ENGLAND** *Absolute Radio* synchros APR 1 0113 Bits of English talk and later with a rock vocal. APR 5 2320 Maybe them again with bits of hard to hear talk, though more likely the next one here.
- unID APR 29 0438 Two men conversing in an unfamiliar language difficult to hear, mentioning music (moozika) then into a song, music bridges and talk, fanfare at 0445 and woman at 0448 being interviewed by a man, sounded Slavic but signal was fading quickly, gone by 0450.

- GERMANY *Deutschlandfunk* Heusweiler APR 25 0340 Two German males and a female in a three-way conversation almost strong in very short peaks dropping to inaudible level for the most part. Just had some halogen track lights installed at the Burnt River DX site. They're billed as "LED compatible, for what that's worth, and it's also labeled as a 2-wire track system. System is on a dimmer that never previously caused problems when it was either off or set to full brightness. But this new system is creating a terrible buzz on AM that only goes away when I turn them off. The noise carries a fair ways - beyond where my coax goes to the external antenna. Any thoughts, recommendations or such?

From: Mark Durenberger Subject: 3 Phools in the Phield

This evening, 3 Phools in the Phield set up a reversible 140-ft. Double-Delta antenna at a quiet place in Burnsville MN. The goal was to see what sort of nulling we could do off the "backside" of the antenna (whether the "backside" was the North end or the South end). Think of it as a superhot loop antenna, but unidirectional in pickup rather than bi-directional. It works. On a number of frequencies we were doing armchair copy of one station; flip the antenna and the first disappeared while another came up just as well...from the opposite direction. We were oriented North-South since most of our local pests were North of us. Antenna reversal is as simple as flipping a switch. Interestingly...the null held up across the band; little or no re-nulling was needed. Surprisingly, we could do no better than about 27 db nulls of local stations. Our conclusion was that the Double-Delta seems to like low- and medium-angle skywave and doesn't discriminate as well with strong ground-wave signals. We will also investigate whether the extension of the null pot and RF takeoff VIA UNEQUAL LENGTHS OF CAT-5 degrades the null. (I've seen better than 40 db null on these guys when the null pot is right at the leg of the antenna; in this case we had run 150 ft. of Cat-5 to get to the receiver.) Mike Bates and Jim Dale may chime in with their own observations. It was an evening well-spent. By the bye: 690 Minneapolis, 25 miles away with 4 watts authorized postsunset came in at -36 dbm (its day level) and never changed through the evening, well past sunset. #### Radio station for dogs launches

Auckland dogs alone at home and feeling lonely will from today be able to tune into a radio station designed for them. A new initiative has brought together researchers and canine behaviour consultants to put together 24-hour programming that will be both fun and relaxing for doggy listeners.

Broadcasting on 87.7FM to central Auckland, K9FM plays dog-centric content ranging from relaxing classical music to chat shows that include Talkies, Fetch in the Park, and Meditation with Vet Joanna - all programmed and made with dogs in mind.

Canine behaviour consultant Jess Allsop who helped consult on the station's programming said dogs would be able to focus on words they recognised and be calmed by the station's music. "My job is to make sure it is as dog-friendly as possible," Allsop said. "At the moment when dogs listen to a radio, they have to listen to programmes targeted at humans."

K9FM featured words like stick, fetch and walkies, which dogs could pick up on and understand, Allsop said. "Also musically it was about finding tempos and beats that are known to be calming for dogs." Owners might enjoy the station too, she said.

K9FM is the result of collaboration between the New Zealand Radio Training School, Colenso BBDO, Pedigree and Mars. The radio station will run 24 hours a day. (<u>stuff.co.nz</u>)
