NEW STATION WATCH

First, some news on the 640 kHz CP, formerly at Terre Haute IN, which (as *DX News* readers know) was recently granted a move to Peotone IL (south of Chicago). The Peotone CP expired on July 29, and would have required the licensee to take its co-owned WMFN-640 Zeeland MI off the air. With the July 29 deadline approaching, the licensee has filed a CP application for WMFN to move it to Peotone, with the same U4 4500/1200 facilities as in the new station CP, which it would surrender. The final result, if granted, would be no different from what is contained in the CP – a station operating at Peotone, and no more station in Zeeland.

So why the application? It's a clever move to try to get around the hard 3-year deadline for building a new station CP, as you can't apply for a replacement new station CP until the next auction window (whenever that will be), while CPs to modify existing stations can be requested at any time. We'll see if the FCC buys the approach.

SRN stands for Salem Radio Network, informally "slanted radio news" with its far-right religious agenda. Wasn't it originally "Satellite Radio News"? 7/6 - Once again I have missed the ToH ID for KLEY, running 250 instead of one watt at night, already in SRN News. Then the hour is filled by Restaurant Radio with guest someone who has a show on cable TV's Food Network; 0157 UT finishing with ad/plug for a taranto.com (?) restaurant in Chicago. 0159 ad for CardGuard, and this time I stay tuned and awake for the next ToH ID at 0200 which is: "The new Radio 11-30, KLEY-AM, Wellington" plus singing ID of call letters, into more slanted radio news. (GH-OK)

1220 WSLM IN Salem - 6/27 0116 - "WSLM, 97.9 FM with Kentuckiana weather" from

Accuweather, back to C&W music. This station has been cheating for months, obviously with 5 kW day power instead of 82 watts night. This gives it a great advantage over numerous other 1220 stations from Ohio to Kansas to Texas to Georgia, or beyond, which are allowed only low power at night to protect Cleveland, which itself has a tight null westward. In case

WSLM is still observing its legal pattern, it's a figure-8 slightly clockwise from east/west. (GH-OK)

1230 WBBZ OK Ponca City – 7/4 0829 – Reporting a large power outage on the east side of PC, unknown cause but can't be weather; threatening people on oxygen. Utility no doubt working on restoring, but may be slower due to holiday. **(GH-OK)**

1250 KYYS KS Kansas City – 7/4 0856 – Spanish skywave still in from ex-WREN Topeka, i.e. "La Equis 12-50, La Súper-Estación," 25 kW day power. Hi local noise level on SW bands encourages me to MW DX more. **(GH-OK)**

1330 KCKM TX Monahans – 7/24 2148 – Sunset skip is hopping, as I tune across, "You'll hear it all on the oil field station, KCKM," of the recent DX test, but volatile propagation immediately replaces it with KNSS in Wichita. **(GH-OK)**

1370 KXTL MT Butte – 7/5 0410 – Local weather. **(RS-UT)**

1440 KTNO TX University Park – 7/4 0836, 0844, 0857 – Open carrier/dead air from NNW/SSE, doubtless 50 kW KTNO University Park TX (The Metroplex), supposed to be Spanish religion. Not the first time heard doing this, failing to save how many souls as a result? **(GH-OK)**

1520 KYND TX Cypress – 7/13 0803 – Distinctive voice of CRI newscaster in English can be heard mixing with KOKC, making slow SAH; KYND is the ChiCom (Editor: Chinese Communists) state access to Houstonians with ordinary radios, bleeding over past Oklahoma City. **(GH-OK)**

1600 KRVA TX Cockrell Hill – 7/6 0816 – Tune-by ID in English for KRVA Cockrell Hill-Dallas, and right back to Vietnamese. Thank you very much. I don't think I've ever heard the English slogan "Radio Saigon" as listed in NRC Log. **(GH-OK)**

1640 WTNI MS Biloxi – 7/31 0059 – KZLS is still in dead air as for the last few hours, as noted at 0128 and 0310 (is no one paying attention at the station? May require a trip out to the remote Hennessey transmitter site). With its open carrier nulled, I

hear ESPN Radio, and an ID for WTNI Biloxi MS, following IDs for two or three FM stations. (GH-OK)

1640 KZLS OK Enid – 7/15 2245 – KZLS is again playing country music, no doubt sibling simulcast from KNAH 99.7 Mustang, instead of talk, its major format; recheck July 6 at 0817, its third format is dead air with hum. **(GH-OK)**

1680 KGED CA Fresno – 7/29 0203 – Very weak signal from WNW/ESE with SRN news, fast SAH with another weakie from another angle; 0205 ID sounds like KGEZ, hymn? and into talk show. Must be KGED Fresno CA. Since the demise of KRJO Monroe LA, have been seeking DX on this frequency more or less open here. NRC AM Log shows only KGED is with SRN, conservative talk format, 10/1 kW ND. **(GH-OK)**

UNID

530 UNID -- 7/4 2254 – Even when I am much closer to Vance AFB for the fireworks, "K530AM" is quite weak on the portable. Must be running much less than the nominal 10 watts now, and probably no longer reaching the outskirts of OKC. Still with inane loops of PSAs about car seats for kids, what to do when a hurricane hits here (?! Not likely until sea level is 1200 feet higher). (GH-OK)

890 UNID -- 7/5 0420 – Spanish speaker under local KDXU. (RS-UT)

1680 UNID -- 7/6 0145 – With KRJO Monroe LA off the air for financial reasons, I ought to hear some of the five other US X-banders; there are two very weak signals, one with talk from NE/SW, making a fast SAH, perhaps WPRR, Public Reality Radio in Ada MI, if not the closer but weaker TIS stations in IA that KAZ has been hearing from IL. (**GH-OK**) See KGED logging above. (**JDT-WA**)

One more issue, then volume 81 will be complete. Hope you can spend some time during the rest of the summer fixing antennas, reviewing your DX records and recordings, and generally getting ready for the upcoming DX season.

For the umpteenth time I dug out my data concerning PSRAs, Sunrise DX, etc., and attempted to reconcile the "old days" with the new. To wit: instead of the old days with a tape recorder (or two) running so band scans could be constantly captured, we now have the capability of running multiple recorders – or at least the equivalent.

A couple of years ago I invested in a software design radio (designed?) and discovered disappointment that it would only cover 192 kHz in a single "pass." Ultimately, I ended up owning one (Excalibur) that will capture the entire broadcast band. I'm still learning how to utilize it to the best advantage. Memory and storage have gotten so inexpensive it's become seemingly ridiculous. The other day I purchased a 1 TB drive for well under \$100. It's supported by USB 3.0 so the data transfer is quite fast. Even allowing approximately 1 GB per minute when recording the entire band, things like a "snippet" of three or four minutes at the top of the hour – one can capture a huge chunk of data for later perusal – like after I've had my power nap!

Obviously, once the data is collected, one still has to listen. Fortunately, one can listen in a manner unheard of years ago with only tape recordings. I would love to start some kind of discussion (or exchange of emails) to learn more about how to efficiently utilize an SDR for AM DXing.

- 1134 **KUWAIT** *R.Kuwait*, Kabd NOV 8 0258 Quran, ID by woman and fanfare into newscast. Same theme that is on the Interval Signals Online webpage. Good over Spain.
- 1170 **WALES** *Swansea Sound,* Swansea NOV 5 2059 Faded up over Slovenia with a spot and ID mentioning website address and being from "the heart of southwest Wales."

- 1323 **ROMANIA** *R.Târgu Mires*, Târgu Mires NOV 5 1958 Over Gold with pop music. Sign off by man mentioning frequencies. Test tone afterward, just like the 1053 *R.Iasi* station does.
- 1530 **ROMANIA** *R.Constanţa*, Mihaileni & Mahmudia NOV 6 1959 Faded up over *R.România Actualitati* with folk music and a quick ID at 2000, then it appeared to go off.

Issued July 28, 2014 – For the period July 28-August 23, 2014


Solar activity is expected to be at predominately low levels through the outlook period with a chance for moderate level activity (R1 radio blackouts) from 28 July - 09 August due to the presence of several complex regions on the disk.

No proton events are expected at geosynchronous orbit.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be normal to isolated moderate levels.

Geomagnetic field activity is expected to be at mostly quiet levels for the majority of the outlook period in the abserce of transient features. Unsettled to active conditions are possible associated with high speed solar wind streams on 28 - 29 July, 05 - 06 August, 10 August and 22 August.

More AM radio stations taking their signals to FM dial 3 Milwaukee broadcasters have made the jump this summer By Duane Dudek

Is AM dead?

"Absolutely not," said Bill Hurwitz, vice president of Milwaukee Radio Alliance, who added that 15% of all Milwaukee radio listening is of AM stations.

This means 85% of it isn't. And news, sports, information and talk on WTMJ-AM (620) and WISN-AM (1130) account for most of that 15%.

So some AM stations are taking their act on the road and moving to the FM dial. Three stations here did so this summer alone.

Two of the recent translators belong to stations with music formats: WZTI-FM (100.3) and WJTI-FM (97.9). WZTI-FM, owned by Milwaukee Radio Alliance and called Martini Radio like WZTI-AM (1290), went on the air Monday.

"There hasn't been an adult standards station in Milwaukee since WOKY," said Hurwitz. "Now, there is."

Actually, WZTI-AM went on the air with the format in March 2013, and the poor sound quality on the AM dial likely has contributed to its meager ratings. In a recent ratings trend survey, it was ranked 29th among total listeners.

It has since "evolved into an upscale adult format station," said Hurwitz who, spent Monday driving around the area testing the signal range of the translator located on the American Towers cluster in the Estabrook Park area.

WJTI-FM repeats the Spanish-language music format of WJTI-AM (1460).

Both are called Radio Caliente and are owned and operated by John Torres, principal officer of El Sol Broadcasting.


"I do everything from sales to engineering," said Torres, a veteran local broadcaster, who bought the former WBJX-AM in 2007 and moved the license from Racine to West Allis.

He said the approval process for an FM translator took two years.

The third local station to add a translator to simulcast its signal is WSSP-AM (1250), the sportstalk station owned by Entercom Communications Corp., which can now be heard on 240-watt WSSP-FM (105.7).
