From the FCC: The FCC is looking for written comments on its proposal to allow AM stations to move to all-digital operations on a voluntary basis. One station, WWFD-820 in Frederick MD, has been doing this on an experimental basis since 2018. It's thought that, if the proposal is accepted, stations with FM translators would probably be the first to adopt digital-only broadcasting, as the FM signal would still be available to listeners who don't have digital-capable AM receivers. According to the FCC, adjacent-channel interference would probably improve, as all-

digital AM broadcasting uses less spectrum than hybrid analog/IBOC broadcasting – but co-channel QRM is an issue. Comments can be submitted through March 9 at the FCC's comment portal at <https://www.fcc.gov/ecfs/>; refer to proceeding number 19-311. For more info see the FCC notice available at [this](#) link.

“Curiouser and curiouser, said Alice”

Bruce Conti emailed me this week “New translator for 780 WCKB per sign-off announcement, no longer using 97.7 W249DE, confirmed with a search of the FCC FM Query for 102.7 translators in North Carolina and found W274CA:” So I diligently looked up the Facility ID for W274CA and it’s 93127. I went to add W247CA to the logbooks data table for translators and received an error “Facility ID already in the translator table” So I went to my handy look up crossed reference what AM station had a translator using Facility ID 93127, The answer? WCKB-780! Come to find out FCC is now licensing the same facility on two channels!

My master table shows that the CP for W249DE is now licensed as W274Ca but W249DE both licensed and CO were left in the FM Query table! I sent a copy of this to Dale Bickel who oversees “The “Q’s” (AM & FM Queries) and his response “I made a similar complaint about another translator recently, essentially the same scenario. Logic and LMS don’t go hand in hand; I often wonder what the contractors are thinking. (Not sure I really want to know.)” Dale. We hope that as they continue to implement the new Licensing and Management System (as Dale pointed out a government contractor) that drive the FM Query that they straighten this kind of situation out.

From *Radio Insight*

Four St. Louis area stations are on the verge of deletion or forced sale as the FCC’s Administrative Law Judge dismissed the 2012 license renewals for Entertainment Media Trust’s 1190 KQQZ Fairview Heights IL, 1430 KZQZ St. Louis, 1490 KFTK East St. Louis IL, and 1510 WQQW Highland IL for failure to prosecute. The stations were acquired by the trust between 2006 and 2012. A petition to deny was filed for their 2012 license renewals in which local resident Mark Kern stated that the trust was being run by Bob Romanik, despite he being ineligible to hold an FCC license as a convicted felon (obstruction of justice and bank fraud). The FCC concluded in a previous investigation that Romanik provided all of the funds for the acquisition of the stations, but while not listed as a party in any FCC filing they supported Kern’s claim that Romanik held de facto control over the stations including negotiating an LMA agreement for 1490 KFTK with Emmis Communications (and now Entercom). The FCC stated that Entertainment Media Trust, which also operates as Insane Broadcasting Company, failed or was unable to provide responsive information to the agency and is setting up the hearing to establish whether there has been an undisclosed de facto transfer of control of the Stations to Romanik, EMT engaged in misrepresentation and/or lack of candor in its applications and other communications with the Commission, or if the Trust shields Romanik or the Trust’s beneficiaries from holding attributable interests in the Stations under the Commission’s ownership attribution policies. Today’s ruling comes after trustee Dennis Watkins failed to make an appearance before the court on multiple occasions after first attempting to take the trust into Chapter 7 bankruptcy proceedings. Watkins finally submitted a pleading in January that the judge considered to be procedurally and substantively deficient. The judge then ordered Entertainment Media Trust to show cause by February 10 why the applications should not be dismissed for failure to prosecute, which he did not respond to. While today’s decision also dismisses the previous grant of a CP for 102.9 W275CS Highland IL to rebroadcast 1510 WQQW it does not yet delete the licenses. The FCC must still rule on whether they will be deleted or a sale will be forced. In 2005, convicted child molester Doug Lane was forced to sell his three Scranton/Wilkes-Barre PA licenses with all proceeds going to local charities establishing precedent.

The signal seems to be fading on the radio days of vitriolic Metro East shock-jock Bob Romanik. The Federal Communications Commission on Wednesday (*February 19 wwh*) issued an order terminating license renewal efforts by stations connected to the broadcaster. Romanik was suspected of deceiving federal regulators into hiding his ownership of four radio stations. Billing himself as the

“Grim Reaper of Radio,” Romanik is the host of “Kool Killer Kountry Radio” on KQQZ (1190 AM) in Fairview Heights. KQQZ and the three other stations all are involved in the FCC dispute. Romanik has been regularly criticized for making racist, homophobic and misogynistic slurs on his shows. He has claimed his monologues fall under constitutional free-speech protections. The FCC action, however, did not focus on what Romanik has said, but rather on paperwork. The FCC probe into Romanik’s licensing issues began in 2012 when St. Clair County Chairman Mark Kern filed a

complaint. Kern renewed his complaint in 2016. The complaint alleged that although the licenses for the four stations were issued to Entertainment Media Trust, headed by lawyer Dennis J. Watkins, Bob Romanik was the de facto owner. The FCC noted that Romanik has filed campaign records with Illinois and Missouri election officials in which he identified himself as a radio station owner. As a convicted felon, Romanik effectively is prohibited from being the licensed owner of a radio station.

A former Washington Park police chief, Romanik admitted obstructing justice in a federal investigation into organized crime in the 1990s and later was convicted of bank fraud. Jane H. Halprin, the administrative law judge in the FCC case, chastised the trust and Watkins for defying and ignoring several court orders since the proceeding began in July. Neither Romanik nor Watkins could be reached for comment about the ruling or a possible appeal.

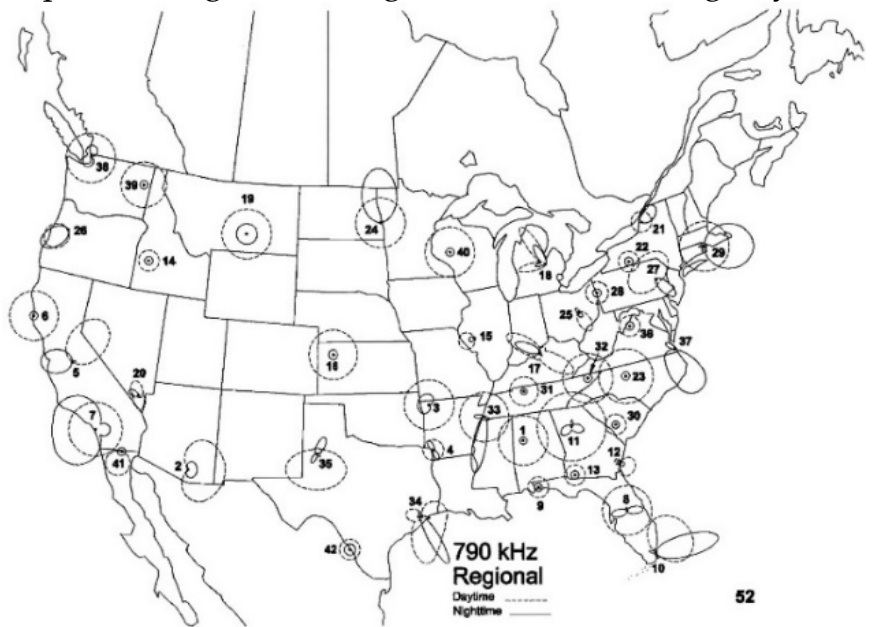

- 790 WAYY WI Eau Claire – 2/11 0819 – Poor, with ‘Ho-Chunk Gaming in Black River Falls, Chippewa Falls’ in ad. (JJR-MI)
- 820 WBKK MN Wilton – 2/11 0801 – Poor, with phone number “218-444-XXXX . . . ??? . . . Cakes”, LID, “Real Presence Radio”. With others. (JJR-MI)
- 940 KVSH NE Valentine – 2/14 0840 – Extended weather forecast for the region. Poor, spotty reception. An appropriate Valentine's Day logging. (JW-CO)
- 940 KMER WY Kemmerer – 1/24 1000 – Still audible after sunrise despite only 240 Watts. Sports program “First Base Sports Friday” talking about Star Valley High School wrestling, ID, news. (SB-UT)
- 950 CFAM MB Altona – 2/8 0841 – Poor, with many Manitoba mentions including hockey, etc. No WWJ. KOEL way in back. (JJR-MI)
- 960 KKNT AZ Phoenix – 1/24 1100 – “The Patriot KKNT” ID and slogan after ‘Harry’s Razor’ commercial and promo for station website, then into independent news. (SB-UT)
- 980 KNTR AZ Lake Havasu City – 1/24 1100 – Well after sunrise for this 1000 Watt station, “All Sports All The Time” KNTR, 94.3 FM, barely audible above others but clearly heard slogan. (SB-UT)
- 980 CJME SK Regina – 2/9 0807 – Poor, with temperatures for Regina and Saskatoon. “980 CJME is on Facebook”. Alone! (JJR-MI)
- 990 WNML TN Knoxville – 2/19 0813 – Poor, with “Toyota Knoxville -- I-40 at the ??? exit” into sports. No CBW. (JJR-WI)
- 1010 WHIN TN Gallatin – 2/19 0816 – Poor -- “. . . the new 100.7 WHIN & AM 1010”, then ‘Eye of the Tiger’ by Survivor. Morning chatter. Alone. (JJR-WI)
- 1010 CBR AB Calgary – 2/11 0800 – Poor, with “I’m David Gray. In Calgary, minus three degrees”. Some WPCN, but no CFFR or CKMX. (JJR-MI)
- 1100 WISS WI Berlin – 2/21 0807 – Poor -- ‘Edge of 17’ by Stevie Nicks, “. . . the bug (slogan) with Wayne & Lexi . . .” into ‘Sky High’ by Jigsaw. (Both songs from 1970s). Alone. No WTAM. (JJR-WI)
- 1140 CHRB AB High River – 2/8 0833 – Poor, though atop and alone. “Southern Alberta's Radio Station – AM 1140”. (JJR-MI)
- 1150 WGGH IL Marion – 2/18 0819 – Poor, in/out trading with an unID giving obits. Two times during songs, local host gave no calls! (Hello!) Finally, weather, time check and news with ‘Marion’ and ‘Southern Illinois’ mentions! Still no calls (though at 08:31!) twelve minutes and never used call letters. Unreal! That is “Radio 101”! No WHBY, though in earlier. (JJR-WI)

- 1270 WCMR IL Elkhart – 2/10 0929 – Poor, with end of ‘Back to the Bible”, then “. . . Gospel 1270 & 105-3 FM”. Rare! (JJR-MI)
- 1280 WBIG IL Aurora – 2/19 0847 – Very poor, in fade up, over WNAM. Talk of Bolingbrook and Eola Road. Shopping show. Logged as WMRO in 1971. Not heard in years. Rare. (JJR-WI)

- 1310 CIWW ON Ottawa – 2/10 0805 – Male and Female anchors. “1310 News”, promo for “Ottawa Today at 9 AM”. Poor, but alone. (JJR-MI)
- 1320 KOZY MN Grand Rapids – 2/13 0837 – Poor, with “. . . contest line 999-KOZY to win”. With others . . . no WILS. Lousy conditions. (JJR-MI)
- 1320 KHRT ND Minot – 2/10 0925 – Poor in nice fade up. Loud with Southern GOS music. Calls, and lost to WILS fade up. [in again the next day!]
- 1320 KHRT ND Minot – 2/11 0919 – Poor, but alone, with “. . . as heard on K-Heart last night”. Little WILS today. (JJR-MI)
- 1390 KRRZ ND Minot – 2/11 0943 – Poor, though alone and steady. “All day, all night . . . Minot's Classic Hits, 1390 KRRZ”. (JJR-MI)
- 1410 WING OH Dayton – 2/11 0929 – Poor, but alone, with “1410 ESPN Radio” into ‘Golic & Wingo’. No usually-dominant WIZM. (JJR-MI)
- 1420 WHK OH Cleveland – 2/20 0833 – Poor, with various promos for shows, etc., for ‘AM 1420 The Answer’. No KTOE today. (JJR-WI)
- 1450 KGRE CO Greeley – 1/24 0903 – Ranchera music ending, “Tigre FM es KGRE, Greeley”, then a listing of translators before continuing with promotional audio. (SB-UT)
- 1460 CJOY ON Guelph – 2/11 0850 – Poor, but steady, with little/no KXNO. ‘Bad to the Bone’ by George Thorogood and calls. (JJR-MI)
- 1470 KXSL AZ Show Low – 2/6 0902 – Quick legal ID just as I tuned in at 0902, followed by two minutes of ‘Town Hall News’. The rest of the hour consisted of C&W music, “K-Bear 100” slogans and occasional ads. Fair signal, occasionally on top. Have not heard since. Ex-KVSL. (JW-CO)
- 1470 KYYW TX Abilene – 2/12 0807 – Weather; ID as “News Talk 1470 KYYW” and into ‘Hugh Hewitt’. Fair in QRM, mainly from KSMM and KKTY. (JW-CO)
- 1490 KIBM NE Omaha – 2/10 1028 – Poor -- “Boomer Radio” and OLDies cutting through (usually in) KRIB. (JJR-MI)
- 1550 KESJ MO St. Joseph – 2/9 0933 – Poor, with no WHIT. “Joe 107.5” said twice into Pat Benetar song. (JJR-MI)
- 1570 KAKK MN Walker – 2/8 0851 – Poor, with “. . . here on the KK Radio Network” (owner of KAKK) – no usual WLKD. (JJR-MI)
- 1590 WTVB MI Coldwater – 2/19 0800 – Very poor, though clear “Coldwater” cut through. Lost to WPVL. (JJR-WI)

- 680 KKGR MT East Helena – 1/26 1801 – Song ending, then “Helena's Home for the 70s, 80s, and More” slogan and ID, then right into Queen's ‘Bohemian Rhapsody’ and more music. Rare catch of anything at all over KNBR day or night from here. (SB-UT)
- 690 KGGF KS Coffeyville – 1/27 2000 – Several competing stations, but “Mighty 690” slogan and city clearly audible, into Fox News. (SB-UT)
- 730 WSTT GA Thomasville – 2/9 1828 – Black Southern gospel across the hour until 1828 classic, beautiful, canned sign-off announcement by man, with calls, city, power, station street address, PO Box, phone number;; powered off at 2329. (TK-FL)
- 730 WLTQ SC Charleston – 2/9 1840 – EWTN feed, local hard break and end-tagged “. . . a proud sponsor of Catholic Radio South Carolina . . .” and man “You're listening to WCKI, Greer 1300 AM and WLTQ 730 AM, Charleston . . .”. (TK-FL)

- 840 KMAX WA Colfax – 1/26 1800 – Commercial for ‘GAB Radio Network’, ID, “Inland Northwest's News Leader”, “The Max” slogan, then news about the Kobe Bryant helicopter crash. (SB-UT)
- 850 KHHO WA Tacoma – 1/26 1900 – “South Sound Talk 850 AM” in the clear with KOA Denver nowhere to be heard. ID, then Fox News about Kobe Bryant. (SB-UT)
- 860 KNAI AZ Phoenix – 1/26 2000 – Mexican music. Weak over other stations, then ID, 101.9 translator info, “La Campesina” slogan, an more music. (SB-UT)
- 880 KKMC CA Gonzalez – 2/13 2200 – Weak at first, but faded up giving web address of program, ID and local advertiser offering discounts to KKMC listeners, promo for “Insight for Living” program. KRVN usually dominates 880 here. (SB-UT)
- 930 KMPT MT East Missoula – 1/26 1800 – “Your Conservative Beacon”, translator info, ID, city, “The Patriot” and into CBS News. (SB-UT)
- 980 KMIN NM Grants – 1/26 1900 – Well heard with 104.3 FM translator, “Broadcasting to Five Counties from the Radio Center on Roosevelt Ave”, ID, city, and “You are in K-Mine Country”, SRN News. (SB-UT)
- 1230 KSBN WA Spokane – 2/13 2105 – Ending of USA Radio News with local anchor giving Spokane area weather, followed by ID and commercials. (SB-UT)
- 1230 KVOC WY Casper – 2/13 1958 – Just barely above the din, but clear ID and calls, “This is Casper's new FM talk station, 95.9”. (SB-UT)
- 1240 KLYQ MT Hamilton – 1/26 1800 – Very muddy audio, competing with KWIK, so hard to tell which audio went with which station, but KLYQ call letters heard and town name. (SB-UT)
- 1250 KHIL AZ Willcox – 1/26 2003 – Country music fading in strongly over local KNEU until booming in with ID so clear it could be just down the road. Briefly as strong as any local station! (SB-UT)
- 1320 KOFA AZ Yuma – 1/23 2300 – “Border Radio FM 94.7” from Arizona Western College picked up cleanly for the first time over local KNIT. Previously logged as KAWC. (SB-UT)
- 1320 KXRO WA Aberdeen – 1/27 2100 – Under CHMB Vancouver, BC, but multiple calls heard although no frequency given. Goes into CBS News at the top of the hour then fades a few minutes later. (SB-UT)
- 1340 KTMM CO Grand Junction – 1/27 1900 – Full ID, “Covering the Western Slopes”, long translator list, “The Team” slogan, and CBS Sports. Faded, and gone a few minutes later. The strongest reception of a Colorado GYer for me thus far. (SB-UT)
- 1360 KLSA CA San Diego – 1/26 2000 – Promo for the ‘Darren Smith Show’ on “Xtra 1360”, ID, and Fox Sports news about Kobe. Usual station KPXQ Glendale had powered down. (SB-UT)
- 1370 KAST OR Astoria – 2/13 2100 – Lots of competition with local KSOP nulled, numerous calls and weather with ABC News and “Celebrating 30 Years” on the air with news, sports, etc. (SB-UT)
- 1400 KEYL MN Long Prairie – 2/15 2116 – Atop with Johnny Lee's 1980 country classic “Lookin' For Love”, then liner: “. . . 103.1, KEYL”. I've always wondered . . . does looking for love in all the wrong places equate to DXing on all the wrong frequencies? :) (RD-IA)
- 1400 KMNV MN St. Paul – 2/15 1948 – Good signal, but fading, with regional Mexican music, then bits and pieces of liner: “. . . mas musica . . . La Raza!” Webstream was about 15 seconds behind. (RD-IA)
- 1400 KBRB NE Ainsworth – 2/15 2024 – Fair with liner between country songs: “You're tuned to the best . . . KBRB, Ainsworth”. DXers TRIVIA: this was the last station in America to run monthly frequency checks, and was still doing so as late as 2002. (RD-IA)
- 1400 WBIZ WI Eau Claire – 2/9 2205 – Atop briefly, with Minnesota Wild hockey play-by-play. Only 1400 shown on this year's Wild affiliate list. No sign of nearby WGIL at all. (RD-IL)
- 1450 KCLX WA Colfax – 2/13 2104 – Fading up with the ending of an unknown country song, cut off with “1450 KCLX, Colfax, Palouse Country” and into ABC News. (SB-UT)

Unreported Domestic Stations

One station (KAST-1370) was reported to DDXD this issue for the first time since at least Volume 67 (1999-2000). So we are down to 312 full-service (100 watts and up) AM stations in the United States and Canada that have not been reported to DDXD during this time. - 640 **MEXICO** XETAM Cd. Victoria, Tamps. JAN 30 0222-0232 – Poor well under KFI with a steady mix of romantic ballads in keeping with the romántica theme. Mexican Log lists 1 kW nights at 1,252 miles. [Battagliano-CA]
- 780 **VENEZUELA** YVMN *R. Coro*, Coro JAN 28 0245 – Spanish language tropical style music, "Radio Coro" jingle at 0256, more music, possible top of the hour ID with Coro mention, more music, clear Radio Coro ID at 0309 UTC. Fair almost over WBBM (nulled) to very poor. [Snider-ON] FEB 16 0400 – Under/over WBBM; choral national anthem. [Conti-NH] FEB 16 0840 – A nice surprise after the DX test from KKOH. Fair to good signal, at times giving WBBM a run for its money, although never overtaking it. Caught one "Radio Coro" ID at this time in a liner read by a male in the middle of a long stretch of salsa/tropical music. No question this one would've been heard in the Quad Cities, and perhaps a bit further north from there. Venezuela #1 and country #5 in the Davenport, Iowa logbook. Tried for it on the



- nearby Muscatine, Iowa KiwiSDR, but the amount of buzz there made DX'ing 780 impossible. [Dau-IL]
- 840 **HAITI** *Radio-Télé 4VEH*, Cap Haitien-Petite Anse FEB 17 0355 – With WHAS off from 0330 to 0408 (and again for intermittent periods after 0414), I got fair receptions of instrumental versions of old-time church hymns like "He Leadeth Me", "How Great Thou Art", and "Be Thou My Vision" until 0426, when WHAS finished their transmitter maintenance and came back on for good. Thanks to Chris Dunne in Pembroke Pines, Florida on dxworld.com's BCB Logger for ID'ing this as 4VEH. Both Les Rayburn in Alabama and IRCA's Tom Laskowski in South Bend, Indiana got Cuba's CMKC R.Revolucion while WHAS was off, but that one eluded me. Still, I'll gladly take this. And, as was the case with 780 *R.Coro*, this one was getting into central Illinois well enough that it also would've been heard in the Quad Cities at the time, albeit slightly less well than in Peoria. Haiti #1 and country #6 in the Davenport, Iowa logbook. [Dau-IL]
- 900 **MEXICO** XEW México, DF FEB 1 0317-0322 – Generally poor with a fair peak. Rose up out of the noise floor with "I Saw the Sign" by Ace of Base then into a dance/club tune. Parallel stream. [Battaglino-CA]
- 940.8 **COLOMBIA** HJGB *R.Calima*, Cali FEB 17 0500 – Offset frequency varies between 940.8 to 940.9 kHz, tonight measured at 940.824 kHz. Confirmed by John Fisher with Don Moore in Colombia, frequency switches from 940.05 to 940.83 sometime between 0300-0357 UTC, and then switches back sometime between 0906-0957 UTC. Mauno Ritola observed similar, the carrier jumping from 940.05 to 940.83 between 0400 and 0500 UTC. Apparently alternating between two transmitters. [Conti-NH]
- 940 **MEXICO** XEQ *Ke Buena*, México, DF FEB 17 0801 – Fair, het from HJGB; promo, "¡La Ke Buena!" [Conti-NH]
- 950 **MEXICO** XEKAM Tijuana, BC FEB 2 0225-0230 – Good with "Save Tonight" tune and several "Radio Fórmula" mentions. Essentially a local for me at 102 miles. [Battaglino-CA]
- 1050 **MEXICO** XEG Monterrey, NL JAN 30 0528 – Long talk by male in Spanish. Sounded like he was in a small studio. "La Ranchera" ID at 0533, into possible ads. Poor at first, but audible under CHUM and others. Eventually lost. Parallel to Tune In stream. [Snider-ON]
- 1300 **MEXICO** XEP Cd. Juárez, Chih. FEB 12 0233-0241 – Good with mix of regional Mexican music. "Radio Mexicana Nuestras Noticias" ID's between songs by male announcer. At 0241, what sounded like a news report began. Parallel stream. [Battaglino-CA]

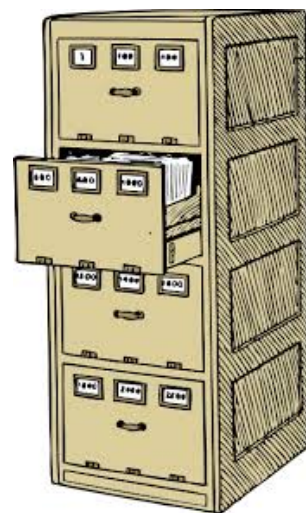

From the *DX News* archives

75 Years Ago – From the March 2, 1945 issue of *DX News*: According to Bill Gabriel, the new call letters for WEAJ-660 New York will be WNBC; a \$75,000 campaign is planned to boost the new calls. A DX test from new station KONP-1450 Port Angeles WA, using a Douglas Fir tree as a tower, was widely heard on February 26, with reports from Al Bartholomew (Corning NY, “sure packs a wallop for 250 watts at that distance[;] they are louder than most 1 kW west coasters”), Joe Brauner (Williamsville NY. “h[ea]rd very well, not bad thru WGNC [Gastonia NC]), Ernie Cooper (Brooklyn NY, “nice S-6 sig[na]l and completely in [the] clear”), Pop Edge (Buffalo NY), Bill Gabriel (Lakewood OH), Ralph Johanns (Buffalo NY), Doc Kirk (Point Pleasant WV), Cpl. Len Kruse (Fort Monmouth NJ), S/Sgt. Al Maley (Highland Falls NY), Stan Morss (Bradford MA, “my first 250 watt station on the Pacific coast”), Pat Reilly (Jamestown NY), and Dave Thomas (Proctorville OH)



50 Years Ago – From the February 28, 1970 issue of *DX News*: While all reports in *DX News* are in Eastern Standard Time, it was proposed that domestic columns switch to Eastern Daylight Time during the summer months and the international columns to GMT year-round, since most domestic stations adjust their schedule when DST kicks in. Gordon Nelson’s article on seasonal patterns in Trans-Atlantic signals continued: in the summer, more free electrons are produced in the ionosphere due to the longer days and higher sun angles, so it takes longer for them to recombine after sunset. Later in the evening this is less of a problem, but the early sunrise at most TA stations precludes much TA reception during the summer. In upcoming issues, Nelson goes on to discuss the Mid-Winter Anomaly, auroras, and other types of ionospheric absorption that affect TA reception. Richard Wood noted excellent reception of Eastern North American stations in Hawaii in early February, including graveyard stations in Illinois and Louisiana.

25 Years Ago – From the March 6, 1995 issue of *DX News*: Ray Moore discussed the relative merits and drawbacks of large and small, amplified and unamplified loop antennas. Don Moore noted that the second harmonic from San Andres Island, a Colombian island off the coast of Central America, was again audible on 2200 kHz. CFQC-600 Saskatoon SK had its final broadcast on Feb. 6, and CJWW-750 moved its format and calls to 600. On the same day, CJCL-1430 Toronto ON moved its calls and sports format to the former CKYC-590.

10 Years Ago – From the February 22, 2010 issue of *DX News*: The passing of three longtime club members were noted, including John Bryant, who died on February 9 from injuries sustained in a fall from a ladder, and Kermit Geary, an almost-charter member of the NRC, who died on February 10. John edited *Proceedings*, a publication with many technical articles on DXing, and was a pioneer of, among other things, the Delta (or Kaz) antenna and the Ultralight movement. Kermit was an active NRC member almost from the very beginning (most of the early issues of *DX News* that have been scanned and posted to the NRC web site are from Kermit’s collection). Both John and Kermit were well-known to many in the NRC and in the DX community.
