### From Radio Insight

**Talk 770 WABC Sold.** Red Apple Media has announced it has closed on its \$12.5 million purchase of Conservative Talk 770 WABC New York from Cumulus Media. In an on-air interview with midday hosts Curtis Sliwa and Juliet Huddy, Catsimatidis stated that there would be no imminent programming changes. 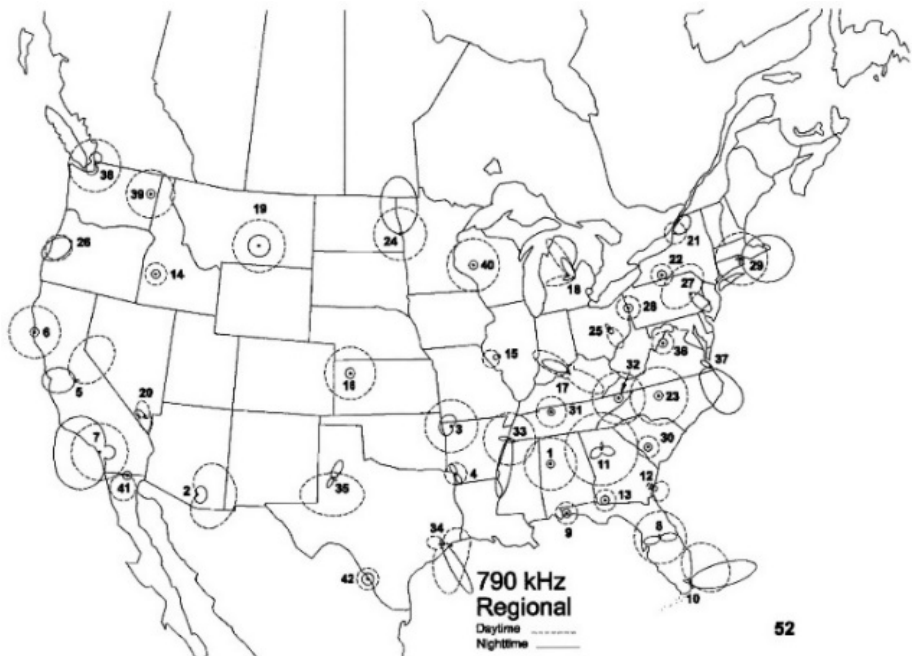

- 700 WLW OH Cincinnati – 2/15 1050 – Mike Allen Jr. discussing campaign finance legal case in Hamilton County. “News Radio 700 94.5 FM” ID, ad for Ohio Lottery and other local ads. Good signal, clear. (HPR-NY) *I wonder how far WLW's daytime signal would have traveled back in the day when they fired up the half-million watt transmitter. Mike.*
- 710 WAQI FL Miami – 2/28 2214 – Noted female announcer under very strong Radio Rebelde, "Radio Mambi la Grande" slogan at 2218. Poor to very poor with WOR nulled. First time heard at this location. (PS-ON)

- 720 WGN IL **Chicago** – 2/15 1105 – Local news, “720 WGN” ID. Weak midday signal, some splatter from WOR-710 and WDOS-730. **(HPR-NY)**
- 760 WJR MI **Detroit** – 2/15 1405 – “WJR traffic and weather together”, Zip Recruiter ad. Weak signal, last gasp of daytime groundwave. **(HPR-NY)**
- 780 WWOL NC **Forest City** – 2/10 1605 – “WWOL780.com” ID/website promo, old-time southern gospel music. Call stands for “Wonderful Words of Life”. **(HPR-NY)**
- 900 KJSK NE **Columbus** – 2/21 1905 – Presumed in multi-station mix (WCLM, CHML, UNID preaching and oldies) with several mentions of “CBS Sports Radio”. Only CBS sports I find on 900 kHz is KJSK. **(KK-VA)**

- 940 WINE CT **Brookfield** – 3/9 2101 – Way atop with sports scores, “940 Sports Radio, WINE” ID into more CBS Sports feed, outstanding for the FOUR watt night signal, or somebody forgot to drop the power upon leaving the station for the night. **(TF-NH)**
- +++ – 2/28 2246 – Sports talk, CBS Sports Radio mentions. Pretty much faded out by 2254 with a brief pop up at 2259 with another CBS Sports Radio mention. No ToH ID heard. - CFNV QC **Montreal** – 3/12 1959 – Station promo that uses snippets of Elton John’s “Tiny Dancer” and Peter Gabriel’s “Digging In The Dirt”. Then ID in French followed by a song sung by a woman in FF. **(NjW-ON)**
- CJGX SK **Yorkton** – 2/27 2211 – Saskatchewan junior hockey game, // webstream. In mix with Mexican station. **(NjW-ON)**
- 950 WXGI VA **Richmond** – 3/6 1742 – In multi-station mix (WCTN, WBES, WORD, WKDN, Cuban R. Reloj.) with female “...5 and 102 7 ESPN” slogan. **(KK-VA)**
- WBES WV **Charleston** – 3/7 2336 – Sports talk, Fox Sports Radio mentions, “...The Sports Fox” slogan at 2344, various ads, “950 WBES, The Sports Fox” ToH ID at 0000. Poor to very poor with WWJ. First time heard at this location. **(PS-ON)**
- 960 WELI CT **New Haven** – 3/6 1757 – In WFIR/WRNS mix with promo for “... high school hockey on news radio 9-60 and 96.9 FM WELI”. **(KK-VA)**
- WFIR VA **Roanoke** – 2/10 2220 – Virginia Department of Health PSA, ad for Zip Recruiter, Mark Levin show with prayers for Rush Limbaugh’s lung cancer and talk on the secret war on cash. Strongest I’ve ever heard WFIR, like a near-local. Disappeared suddenly at 2228, then re-appeared much weaker in a station jumble. **(HPR-NY)**
- 970 WCHN NY **Norwich** – 3/12 2300 – Caught “WCHN, Norwich...” at tune in, Fox Sports Radio mentions, into sports talk. Poor to very poor in station mix. **(PS-ON)**
- 980 WULR SC **York** – 3/6 2000 – Mixing with WTEM, WAAV and other Spanish, female in SS with “Radio nueva vida” slogan, male with bilingual “WULR...cadena vida” ID. New station for me. **(KK-VA)**
- 990 WTLN FL **Orlando** – 3/6 1927 – In multi-station mix with station promo mentioning “...everyday at ‘The Word Orlando’”. First time heard since call change from WDYZ. **(KK-VA)**

- 1200 WRKK PA **Hughesville** – 3/4 1818 – Classic rock, "Williamsport's rock station, Rock 94.9" slogan noted in dogfight with usual pest WMUZ. **(MKB-ON)**
- 1230 WCMC NJ **Wildwood** – 2/17 0103 – "Diana" by Paul Anka, "Classic oldies 93.9 WMID FM" ID. // WMID-1340 Atlantic City. Often dominant here on 1230. **(HPR-NY)**
- WCBT NC **Roanoke Rapids** – 2/28 2007 – Mixing with numerous graveyard stations, "Today's best...Gospel and today's best southern soul. WCBT AM 12-30" station promo. **(KK-VA)**
- WPCO SC **Columbia** – 2/28/ 2029 – Mixing with numerous graveyard stations, male with promo for University of South Carolina, local ads mentioning "...3 showrooms in Columbia" and "Founders Federal Credit Union". First time hearing since call sign change from WOIC. **(KK-VA)**
- 1240 WATT MI **Cadillac** – 3/14 1900 – ToH ID: "conservative talk and scintillating conversation. What you need to know 24/7. 1240 WATT AM and the all-new 106.1 WATT Cadillac. It's 7 o'clock" into Fox news. **(NjW-ON)**
- WWWC NC **Wilkesboro** – 2/28 2131 – Mixing with numerous graveyard stations, "...life changing local radio. The way it should be. Hometown Christian radio 3WC" station promo. **(KK-VA)**
- 1250 WPGP PA **Pittsburgh** – 3/9 2110 – Atop with talk about gun control by several Pennsylvania. No sign of often heard WARE, WMTR, WGAM, or CJYE, not heard here before although night signal is directional toward NH. **(TF-NH)**
- 1260 WQOF DC **Washington** – 3/1 2129 – Relevant radio religious programming in mix with other talkers, ID as "WQOF Washington. Relevant radio 12-60 AM.". First time hearing since call sign change from WSPZ. **(KK-VA)**

- 1320 WJAS PA **Pittsburgh** – 2/15 1848 – "Talk Radio 1320 AM 99.1 FM" slogan, PSAs for Smokey Bear (prevent forest fires), hungry children in America and American Heart Association, "iHeart Radio WJAS" ID. **(HPR-NY)**
- 1330 WKTA IL **Evanston** – 2/26 1800 – "WKTA Evanston-Northbrook-Chicago" ToH ID cutting through usual Erie, PA sports talk pest. **(MKB-ON)**
- WESR VA **Onley-Onancock** – 3/15 0549 – Coming in well at this time with Blake Shelton's "God's Country". "Coastal Country" slogan ID at 0611. **(JW-PA)**
- WETZ WV **New Martinsville** – 3/15 0550 – Presumed, clearly heard ad for PJ's Pizza with a 304 (West Virginia) area code. **(JW-PA)**
- 1340 WNCO OH **Ashland** – 3/12 2000 – ToH ID: "Fox Sports 1340 WNCO Ashland Mansfield, an I-Heart radio station". **(NjW-ON)**
- 1350 WINY CT **Putnam** – 2/9 0959 – "Fly Like an Eagle" by Steve Miller Band into short newscast at 1000 and local weather, great 1950s style jingle into "Shout" by Ernie Maresca. Good signal even with slop from local WENT-1340. **(HPR-NY)**
- 1360 WDRC CT **Hartford** – 3/15 0503 – IDing as "WMMW, the talk of Connecticut" for // WMMW-1470 Meriden. **(JW-PA)** Per NRC Log, their slogan is "Trump 103.3", i.e. "all Trump all the time"! Mike.
- WTOC NJ **Newton** – 3/5 2235 – Radio Vision Cristiana programming with preacher in SS. Unable to get ID, but definitely // to Simple Radio stream. Poor to very poor in station mix including WSAI. **(PS-ON)**

- 1420 WBEC MA Pittsfield – 2/24 0618 – "America's first news with Gordon Deal", then "1420 WBEC" by man. Very poor in slop. (GL-NH)
- WEMB TN Erwin – 3/10 0558 – Clear ID from "1420 Sports Radio WEMB" at this time and a minute later. Clears up the source of the "Sports Radio 1420" slogan IDs from a couple nights ago. (JW-PA)
- 1450 WENI NY Corning – 3/7 0700 – Caught "WENY Elmira" ID for // WENY-1230 into Finger Lakes Network local news before fading into graveyard mush. (MKB-ON)
- WKIP NY Poughkeepsie – 3/3 1635 – Sean Hannity Show atop frequency for five minutes. (TF-NH)
- WLEC OH Sandusky – 3/12 2000 – ToH ID that also mentions FM 93.5 and says they are locally owned and operated by Bas Broadcasting. (NjW-ON)
- CHOU QC Montreal – 3/9 2130 – Atop frequency with ethnic stuff sounding like Arabic, definitely not French or Spanish. (TF-NH)
- 1480 WDJO OH Cincinnati – 2/11 0126 – "Mr. Tambourine Man" by the Byrds, promo for "the sixties at six on Cincinnati's Oldies Network WDJO" into "Walk Like a Man" by the Four Seasons. (HPR-NY)
- 1490 WOLF NY Syracuse – 3/4 0700 – ToH ID mentioning Fox Sports and also 1300-WOSW in Fulton NY. (NjW-ON)
- WRCE NY Watkins Glen – 2/24 1804 – Popped out of jumble with "Classic Country...1490 WRCE" ID into C&W song. (MKB-ON)
- 1550 WAZX GA Smyrna – 2/25 2115 – Playing various oldies with a signal that would often fade into the mush. At 2139 the signal jumped right up to +40 with "Papa Was A Rolling Stone" by the Temptations, occasional automated time checks, more oldies by Rod Stewart, The Troggs and even some country, ID at 2201 "WAZX...". Poor at first to excellent. (PS-ON)

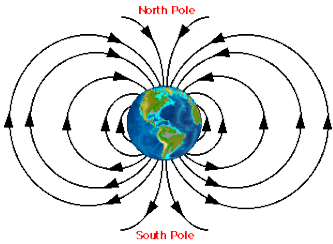

## Wayne Heinen – Aurora CO

Taping DX and listening took a hiatus through half of January and most of February. I was the chairman of “The Swapfest,” the Denver Metro area’s largest ham fest, which took up quite a bit of my time. I saw quite a few boat anchors change hands, there are still collectors out there acquiring R-390A’s Hammarlunds and old Nationals. We had some warmer weather which allowed me to inspect and do some repairs to the flags. The East/West antenna just needed a little TLC with a good cleaning of the connections at the baluns. The North/South flag was extended to 38’ X 10’ with the replacement of the wire. The thinner 18-gauge wire had broken on the bottom, probably from the dog’s running back and forth harassing the neighbor’s dogs! I replaced it with some 14-gauge wire, cleaned up the connections and also had to resolder the connecting wires on the toroid transformer inside the south side balun.
