

From Radio Insight: New FCC Chairman Nominated

President Biden has nominated acting FCC Chair Jessica Rosenworcel to a new term, where she will continue to serve as Chair of the Commission. Rosenworcel has served as an FCC Commissioner since 2012 and as acting Chair since the start of 2021. Prior to joining the agency, she served as Senior Communications Counsel for the United States Senate Committee on Commerce, Science, and Transportation, under the leadership of Senator John D. Rockefeller IV and Senator Daniel Inouye.

Biden has also nominated Gigi Sohn to fill the vacant fifth seat on the commission. From 2013-2016, Gigi served as Counselor to Former FCC Chairman Tom Wheeler, and from 2001-2013 was Co-Founder and CEO of communications and technology policy advocacy organization Public Knowledge and Project Specialist in the Ford Foundation's Media, Arts and Culture unit and Executive Director of the Media Access Project. If she is confirmed, Gigi would be the first openly LGBTIQ+ Commissioner in the history of the FCC.

Pesky STAs with Longwires

"I dug into KNTB a bit more today. I was about 20 miles from Lakewood this afternoon and couldn't hear the station. Two other stations with the same power and distance (KSUH-1450 and KUOW1340) came in well on the car radio. 1480 was vacant. I checked KNTBs FCC database entry and found a whole series of extensions to a STA issued in 2018. Basically, their old transmitter site was vandalized, copper stolen etc, so they had to use a makeshift wire antenna. Since then, they've been trying to find a suitable new site, have found a candidate, are making progress etc. as documented in the extensions. The most recent one is dated last June. So, I guess they could be using low power into a piece of wire with very limited coverage. Or they could be silent most of the time. It's hard to say without driving to the transmitter site. Interestingly, the engineer named on the STA and the extensions is the owner of KGAA-1460, which has also been operating with a few hundred watts and a long wire." (Bruce Portzer-WA)

See also John Wilkins logging in issue 3 (p. 13) of KKCL-1550 in Golden CO. It's so weak we can't hear it at our home QTH's. The reason for KKCL is to keep their "2 relays" K245CM-96.9 & K245AD-96.9 legally relaying their signal.


NRC Antenna Pattern Book 8th Edition

THEY'RE B-A-A-A-CK!!!

- **1560 WFME NY New York** 10/28 0800 Usual Family Radio programs, apparently as a test broadcast. In mix with other gospel stations; at only 1000 watts, not the blockbuster signal of yore. **(MKB-ON)**
 - +++ 10/30 0454 DX News 88-18 in July notes that WFME was approved to broadcast at 12,500 watts. Wikipedia indicates power is 1000 watts. Even with the likely limitations of WFME's antenna, signal was pretty weak; at the top of the hour, gone completely. Test signal programming at this time consisted of a repeating loop indicating Family Radio is returning to the airwaves on 1560 AM and requesting reception reports. (JW-PA)
 - +++ 10/29 2158 Fair-poor; tail end of "Weekend Hymns Sing" music program, station ID near ToH: "Family Radio, WFME New York," deteriorated after ID. (JI-PA)
 - +++ 11/6 2200 Testing and asking for email or phone 1-800-543-1495 reception reports. They mentioned using a site in NJ for transmitting, but did not say the power level. (RH-CT)
 - +++ 10/30 1749 Running test loop announcing the "Family Radio's flagship station" was back on the air from facilities in West Orange NJ and suggesting that people could phone in or e-mail "coverage" reports. (NjW-ON)
 - +++ 10/30 1815 Fading in/out with WGLB; "What you're hearing is a test signal of Family Radio, New York, broadcasting from West Orange, New Jersey..." with phone number 1-800-543-1495 and email requests@familyradio.org for signal reports. (BC-NH)

Voters rejected year-round Daylight Saving Time (DST) in Alberta by the slimmest of margins on October 18. Both British Columbia and Ontario have already taken legal steps to move to permanent DST once specified neighbours do so. Ontario is waiting for both Quebec and New York. BC is waiting

for Washington, Oregon and California, which require federal approval since current US law does not allow DST in the Winter months. Saskatchewan adopted CST year-round, but allows exceptions in certain areas.

Listed below are the Rogers-owned All News stations now using the slogan "CityNews Everywhere", by itself during simulcast segments in the Evening and Overnight periods, or with

frequency and/or location during local segments. A few local reports end with just a "CityNews" tag. Rogers is currently in the midst of two lengthy legal battles. One is for corporate control between the son of founder Ted Rogers Jr. and the late



founder's wife and two daughters. The other is a \$850 million lawsuit by cableco Videotron over a 2013 agreement to create a shared wireless network that never was built. No one is suggesting bankruptcy, but this could threaten Rogers' purchase of Shaw, which is still awaiting federal government approval. The proposed takeover does not include Corus, which holds the stations, and was split from Shaw in the late 1990s.

570 CKGL ON Kitchener – Web site logos are "CityNews Everywhere" and "CityNews 570".

660 CFFR AB Calgary – "CityNews Everywhere 660 Calgary" heard at the top of the hour and "CityNews 660 Everywhere" at the bottom of the hour during local programming. Local ID as "CityNews Everywhere on CityNews 660 Calgary" at top of hour during network simulcasting Evenings and Overnights, with network segments just "CityNews Everywhere".

680 CFTR ON Toronto – Web site logos are "CityNews Everywhere" and "CityNews 680".

1130 CKWX BC Vancouver – Local ID as "CityNews 1130 Everywhere" heard during network simulcasting Evenings and Overnights, with network segments just "CityNews Everywhere".

1310 CJWW ON Ottawa – Web site logos are "CityNews Everywhere" and "CityNews 101.1", indicating sparse on-air mentions of 1310.

The CBC's former shortwave repeaters, CKZU (CBU) and CFGB (CKZN) both on 6160 KHz, are listed in a current CRTC license renewal application, despite the fact that they are not currently licensed, and stopped broadcasting several years ago. The application is a complete reversal of the Summer 2013 situation when the CBC asked the CRTC to delete the license for CKZU, claiming they were already off the air, then having to rescind the request. At the time CKZU was still on the air.

CHCM 740 Marystown, Newfound and Labrador's FM replacement, CHCM-FM 88.3 is now on the air, simulcasting CHCM-AM, which simulcasts VOCM-590. Given that the three month simulcast period usually begins after the Test phase is complete, CHCM-740 will likely go off the air in February 2022.

Well, back to reality; I still have to do my 1190 KEZY report. Until next musing, 73, Rene.

Forgive me, Linda, but the tymtayshun (as Red Ingle spelled it) was too strong after reading Ken MacHarg's Radio History Revisited essays in the Nov. 2 DXN, referring to "Monitor" and the "Grand Ole Opry," but the urge to Muse hit this octogenarian hard.

My first radio job, in 1955, was the night shift at KCOV-1240 in my home town, Corvallis, Oregon, and I had complete charge of what was aired in the night shift. I loved "Monitor," and the satirical bug in this ex-class clown's head prompted me to name the night shift DJ show "Rotinom." That, of course, is "Monitor" spelled backwards. I was a fan of a zany DJ named Hawthorn, who recorded Red Ingle's "Serutan Yob," so I succumbed to the temptation to take Monitor's slogan, "Going Places, Doing Things" and make Rotinom's slogan "Going Places, Doing Things, To People (followed by an evil laugh.) I used as theme song for the show a 45 instrumental played at 78 RPM, and had all kinds of satirical fun. One of the regulars on "Monitor' that Ken didn't mention was an actress whose history was almost as weird as her name – Tallulah Bankhead. I don't remember if it was I, when I hosted Rotinom, or a radio comedian like Bob Hope who coined the name Tura Lura Lunkhead in her honor. Later, KCOV switched me to daytime, including one hour of country music, but Rotinom continued to flourish, in the hands of Bud Deller, "The Big, Round Feller." I had inherited the afternoon pop music shift, labeled "The Rose Room," so I changed the name of the country hour to "The San Antonio Rose Room."

Many years later, a song I wrote, sadly, derided what was happening to radio, opening it by identifying two of my favorite country DJ's from the early '50s, the first the chief engineer at KUGN, Eugene, Oregon, and the second the DJ-songwriter who was a one-hit wonder with "Detour, There's a Muddy Road Ahead," and had the night shift on a small station in northern California.

My song:

"Skipalong Hathaway in the afternoon, Okie Paul Westmoreland late at night. From the pier at Santa Monica a Spade Cooley tune, Louisiana Hayride when reception was right On Radio, The Way That It Was. Talkin' 'bout radio, the way that it was.

"Walk in off the street, get to be a deejay. Minimum wage, 60 hours a week. The manager is offering psychic pay. You can pick your own music and you get to speak, on Radio, The Way That It Was.

"Commercials going for half a dollar a spot. Time, temperature and some corny patter. You'd play eight or ten songs in an hour-long slot. You had so much fun it really didn't matter, on Radio The Way That It Was.

(Later in the song, I dreamed of being a country-music star:) "Little bitty town I was just passing through. Thought I'd give the DJ his favorite wish, A star off the road for an interview, but all I could find was a satellite dish. That's not radio, the way that it was.

"Now every station plays the same short list. Hall-of-Famers, newcomers, equally moan. Listeners don't know what it is they've missed, And the station owners wonder where the listeners have gone. Oh, Radio, The Way That It Was. Bring back Radio, The Way That It Was."

Back to "Monitor" for a minute. When NRC'er Pete Taylor hired me to help put 250-watt daytimer WCAS, Cambridge, Mass., on the air in 1967, we were news-oriented, covering five Boston suburbs, Watertown, Cambridge, Arlington, Somerville and (sorry 'bout that) Belmont, my goal, with talented part-timers attending Boston Area university kids, to establish a Monitor-like format, mixing pop music with news and feature stories. But what happened with WCAS, the most fun I had in radio,

even if it was satire-free, is a whole 'nother story. Three of my part-timers, by the way, had outstanding broadcast careers.

Hello to all in the NRC. It's been quite a while since I last visited this column. First order of business: let me be the latest to welcome Linda Brodsky to the fold of DX News editors. I trust you'll do a great job with this column, Linda, carrying on the tradition established by Ernie Cooper and Paul Swearingen. I've been a member of this outstanding club for about 30 years. Reception reports were submitted sporadically back then, I found just a couple late in 1993. I'm not even sure what I was listening on; I think the ICF2010 showed up later and the Field Radio 350 arrived in the early 2000's, while the AR-88, R390, and HQ145 slumbered in the basement. I also use the Tecsun PL380 which works pretty well with headphones. Short wave was a bigger part of the hobby at that time as I sought out international music and perspectives. Internet radio and other media have supplanted SW for that purpose so now it's just chasing MW DX in the early mornings. My most diverse frequencies are 1470, 1420, 1370, 1330, 1240, and 940, and I'm up to 246 North American stations heard. My best power divided by distance pickup is probably WKDP 1330 at 16 watts and 464 miles. I hope everybody is doing well and enjoying the season!



Radio History Revisited:

From "Hi-Yo, Silver" to "Well, King, This Case Is Closed" Kenneth D. MacHarg

For those who grew up in the later years of radio's golden age, there were three programs that bring back fond memories. They are *The Lone Ranger*, *The Green Hornet* and *Challenge of the Yukon / Sergeant Preston of the Yukon*.

Their common characteristics were that they were highly successful and were originally produced at WXYZ in Detroit by the station owner <u>George W. Trendle</u>.

The Lone Ranger

"Hi-Yo, Silver! A fiery horse with the speed of light, a cloud of dust and a hearty 'Hi-Yo Silver'... The Lone Ranger! With his faithful Indian companion, Tonto, the daring and resourceful masked rider of the plains led the fight for law and order in the early Western <u>United States</u>. Nowhere in the pages of history can one find a greater champion of justice. Return with us now to those thrilling days of yesteryear. From out of the past come the thundering hoof-beats of the great horse Silver. The Lone Ranger rides again!"

How could anyone who was a child in the late golden years of radio forget those words? They opened one of the most popular children's western programs ever broadcast on the radio and later on television.

The roots of this famous production go back to Detroit in 1933 when the writer, Fran Striker, and Trendle created the "daring and resourceful masked rider of the plains" as a weekly cowboy program. WXYZ contracted with Chicago's WGN to receive the show via telephone. Shortly thereafter, New York's WOR joined them. These three stations formed the Mutual Radio Network in 1934.

The series ran on radio for 21or 22 years (depending on what historical source you choose to believe) and the title character was portrayed by actors George Seaton, Earle Graser, and Brace Beemer.

That show turned out to be one of radio's longest-running programs resulting in 2,596 radio shows as well as 18 novels, 221 television episodes and several feature movies. (I can't claim to have heard all of those, but I will confess to having been an addicted listener from the late 1940s through its radio and

television history.) At its peak the radio program was carried by more than 400 American stations.

The episodes told the story of six Texas Rangers, two of them brothers, who were ambushed by the

fictional Butch Cavendish Gang. Five died, but the sixth was critically wounded and rescued by a passing Indian who nursed him back to health. Now known as the "lone ranger," the lawman wore a black mask made from his dead brother's vest so the Cavendish gang wouldn't recognize him. He set out to seek justice and right wrongs wherever he went.

One of the characteristics of the program was the strict moral code that the Lone Ranger modeled. He never took off his mask, never smoked, swore or drank alcohol, and never shot to kill except when he brought down his brother's murderer. His wild, white stallion, Silver carried him faithfully through countless scrapes with thieves and cutthroats. On each episode of The Lone Ranger, the masked man miraculously appeared and righted injustices, leaving behind a silver bullet as his mark.

In contrast, it presented a stereotyped characterization of Tonto, his "Indian companion" who spoke in a rustic dialect and used such phrases as "get-um up, Scout" and "you betchum." Those kinds of expressions were common in the days of the long-running program but would not be as acceptable in today's more culturally sensitive climate.

It was radio that made the Lone Ranger's theme song, <u>Gioachino Rossini</u>'s William Tell overture, a familiar tune. In fact, during its heyday there was a joke that an intellectual is someone who can listen to the William Tell overture and not think of The Lone Ranger!

The Lone Ranger's first movie serial appeared in 1938. In 1949, he made a transition to ABC television starring Clayton Moore in the title role and Jay Silverheels as Tonto. Although the radio program ended in 1954 and the television show in 1957, the Lone Ranger's adventures continued in movies such as The Legend of the Lone Ranger (1981) and The Lone Ranger (2013).

Fans of the Lone Ranger can relive those glorious "days of yesteryear" at the <u>Texas Ranger Hall of Fame and Museum</u> in Waco. In addition, almost one-thousand episodes of The Lone Ranger radio series can be downloaded at: <u>www.otr.net/?p=lone</u>.

On a personal note, I attended a church camp for several years that was located on a lake north of Detroit where Brace Beemer lived. From time to time he came to the camp to tell stories around the campfire. Can you imagine a bigger thrill for a kid who was a devoted Lone Ranger fan?

The Green Hornet

The Green Hornet was a fictional masked crime-fighting <u>superhero</u> created in 1936 by <u>Trendle</u> and <u>Fran Striker</u>. After his radio debut, the character appeared in numerous dramas in a wide variety of media including <u>film serials</u> in the 1940s, <u>The Green Hornet</u> television series in the 1960s, multiple comic book series and <u>a feature film in 2011</u>.


Though various incarnations sometimes changed details, in most versions the Green Hornet was the alter ego of Britt Reid, wealthy young publisher of the *Daily Sentinel* newspaper by day. But by night, clad in a long green overcoat, gloves, green fedora hat and green mask, Reid fought crime as the mysterious vigilante known as "The Green Hornet," and was accompanied by his loyal, similarly masked partner and confidant, <u>Kato</u>. Though both the police and the general public believed the Hornet to be a wanted criminal, Reid used that perception to help him infiltrate the underworld, leaving behind for the police and the criminals any incriminating evidence he found.

The Green Hornet debuted on <u>WXYZ</u>, the same <u>Detroit</u> station that originated its companion shows <u>The Lone Ranger</u> and <u>Challenge of the Yukon</u>. Beginning on April 12, 1938, the station supplied the series to the <u>Mutual Broadcasting System</u> radio network, and then to <u>NBC Blue</u> and its successors, the <u>Blue Network</u> and <u>ABC</u>, from November 16, 1939 until December 5, 1952.

Challenge of the Yukon / Sergeant Preston of the Yukon.

Following the success of *The Lone Ranger* and *The Green Hornet* on Detroit's WXYZ (Now WXYT), Trendle asked for a similar adventure show with a dog as the hero. Trendle insisted that it not be a dog like the heart-warming Lassie series because he wanted it to be "an action story."

Thus, Challenge of the Yukon began as a 15-minute serial, airing locally from 1938 until 1947. Shortly thereafter, the program acquired a sponsor, Quaker Oats, and the series, (in a half-hour format), moved to the networks. The program aired on ABC from 1947 to 1949. It was then heard on The Mutual Broadcasting System from 1950 through the final broadcast on June 9, 1955. In September 1950, when the show moved to three broadcasts a week, the title was changed to Sergeant Preston of the Yukon.



The program was a series about Sergeant Frank Preston of the North-West Mounted Police and his lead sled dog, Yukon King, as they fought evildoers in the Northern wilderness during the Gold Rush of the 1890s. Preston first joined the Royal Canadian Mounted Police to capture his father's killer. Each episode had him battling a new crisis, whether it was tracking down a murderer, a gang of thieves, or claim jumping miners.


Yukon King had a keen instinct for sensing criminals, and was equally valuable dealing with wild animals. Typical plots involved the pair helping injured trappers, tracking down smugglers, or saving cabin dwellers from <u>wolverines</u>.

Generally Yukon King and his dog team were the key mode of transportation--as signaled by Preston's cry of "On, King! On, you huskies." In the early radio shows, the cry of "On, you huskies!" would alternate with "On, you malamutes" from show to show.

As with "Hi-Yo, Silver Away" in *The Lone Ranger* program, the Sargent Preston program also coined a well-known closing: "Well, King, this case is closed."

A personal note--In 1955, the <u>Quaker Oats</u> company gave away land in the <u>Klondike</u> as part of the <u>Klondike Big Inch Land Promotion</u> which was tied in with the television show. The deeds were evidently genuine and involved one square inch of a lot in Yukon Territory issued by Klondike Big Inch Land Co. Inc. They were inserted into Quaker's <u>Puffed Wheat</u> and <u>Puffed Rice</u> cereal boxes. If I would look around the house I think that I might find mine. If I do, I could lay claim to the property. But then, I'm not sure that I would want to be responsible for the property taxes which have accrued over the past 66 years! I did read, however, that to this day Yukon officials receive letters and phone calls about the deeds.



But a sour note was sounded as the NRC asked not to be included in the dedication of a number of Canadian tests, due to an ongoing issue with an all-DX club "Club Cooperation Plan" that had not yet been approved by the various boards of directors of all the DX clubs.



50 Years Ago – From the November 13, 1971 issue of *DX News*: Bruce Portzer of Seattle, Washington was among the new members being welcomed to the NRC. From the November 20, 1971 issue of *DX* News: The DX test from the VOA station on 1178 kHz in Okinawa was heard on November 14 by several Boston-area members, with Ray Moore's tape of the VOA interval signal around 0600 Eastern being the most definitive audio. George Kelley and Gordon Nelson also heard traces of the program.
