Lucky Dog Broadcasting has moved Oldies "Utah's Goat" 1580 KWLO Springville 99.9 K260DS Provo UT to a new set of frequencies. The Oldies format has moved to 96.7 KQMB Levan, 96.7 K244DH Saratoga Springs and KKUT-HD3 Mount Pleasant UT replacing Soft AC "KOSY 96.7". Lucky Dog, which owns KQMB and K244DH, had agreed to purchase KWLO/K260DS in July 2019 for \$300,000, but has failed to close on the acquisition with a 2020 status report indicating at the time it was waiting to secure an SBA bank loan to complete the deal. 1580 KWLO/99.9 K260DS are currently redirecting listeners to the new locations.


NRC Antenna Pattern Book 8th Edition

NRC Member George Csahanin of Crowley, Texas writes:

"There is a station licensed to Cleburne that has its transmitter about 5 miles east of me and it generates a bunch of noise on my websdr and Kiwi SDR receivers. Well about a month ago I noticed they were dead carrier. Checked a day later and still just carrier, no modulation, no IDs. Well, I retired after 48 years in the broadcast biz I got curious and looked their info up on the FCC web site, which showed them having a silent STA "due to Covid" which is nonsense since it is satellite fed Chinese programming. Well silent means off the air. I contacted their attorney in DC and advised them to contact the station and get them to turn it off. I estimated that at 11 kW they were burning through about \$1000-\$2000/month in power cost.

They turned it off.

The FM had been approved for 236 Watts on 98.5 MHz. CBON-6 is a repeater of CBON-FM Sudbury Ontario, part of what used to be the CBC's French AM network, now known as Ici Premiere.

CJNB 1050 North Battleford, Saskatchewan: A lot of confusion around their current "official" Slogan, coupled with Auroral conditions that make them inaudible most nights in Edmonton, but here is what is currently known . . . Overnight on November 15, "Your Home Town Radio..." was heard, but top of the hour ID and 3-4 splitters heard on November 18 were all "Saskatchewan Country CJNB", all voiced by the same female announcer, with only the ID mentioning simulcast CJNS-FM Meadow Lake. 

NEWFOUNDLAND MARINE LOG REPORT

Don Moore

I had great fun attending the Cappahayden DXpedition with Jean Burnell, John Fisher, and Jim Renfrew this year. It was my first trip here. And while the medium wave broadcast logs will be a while in coming, here are the logs I made of marine weather broadcasts in and just above the X-band. All logs were made with an Elad FDM-S2 on a 300 meter beverage running along the shore to the porth

The big highlight for me was hearing all fifteen Norwegian MF marine stations. Telenor currently operates eleven transmitter sites on mainland Norway and two more on Svalbard (1731) and Jan Mayen (1743) islands. All of these were heard at least twice. (I had previously heard three of these – 1728, 1782, and 1785 – in Pennsylvania.) Two more marine weather stations are operated by the Norwegian Meteorological Institute – Bjornoya Meteo from Bear Island on 1757 and Hopen Meteo on 1750 from Hopen Island. These were also heard on several nights and both have already responded with e-QSLs. The four Artic island stations are exceedingly rare DX. Svalbard was heard at Long Beach Island a few years ago. The logs at the Utility DX Forum go back to 2006 and have one entry for Jan Mayen in 2010 and none for the other three stations.

For those of us who do the majority of our DXing from home or while mobile in the car, it can be easy to forget just how high our noise floor really is on the AM band. A few days ago, I needed to dispose of a dishwasher after we installed a new This meant loading the old one up and hauling it to our county landfill.

They close at 4:30 PM Central Time, which currently is rapidly approaching sunset. I arrived at about 4 PM. During my drive, I had been listening to 550 kHz on the car radio, hoping to catch the "550 Stereo" station that Lloyd has been hearing in Louisiana. I had been hearing only WDUN in Gainesville, Georgia—and even that wasn't coming in well.

As I entered the gate of the facility, I was instructed to drive about two miles to the current dumping location. It's all dirt road, and the power lines end at the entrance gate. The site itself is approximately 200 acres of cleared forest in a rural part of my county. The view is beautiful as you approach the dumping area for household waste. You can see for miles in nearly every direction.

About 100 feet in, I noticed a big drop in the ambient noise level on the radio. WDUN went from marginal to easy copy. But at about 1/2 mile into the site, I noticed an even larger drop in the noise floor...remarkably so. WDUN was clearer than a local station at this point, and I could also hear two other stations in the background. One playing country and western music (suspect WAME in Statesville, NC), the other was also a news talk format.

With more time, both could have easily been identified.

After dumping the dishwasher, I parked briefly at the site and marveled at the low noise. I checked a few other frequencies, and the band was remarkably clear throughout. Couldn't help but think about the possibilities of a beverage at a site like this or even just a remote SDR with an ALA1530 loop or similar.

Locations like this with low noise floors are increasingly hard to find, especially in developed areas. This same noise floor would apply to my FM DX'ing as well. Noise on all bands has become not just the enemy, but a constant companion.

Sadly, building a remote receiver location isn't trivial. It requires a broadband Internet connection, power, ability to remotely control a rotor, etc...etc...

What a memory that brings back, Karl. The place you speak of was Look Rock in the Great Smoky Mountains National Park.

You, me, Frank Merrill, Jeff Kadet, David Reitz, and the late Ernie Cooper made the Saturday night excursion (Oct. 6, 1990) into the mountains for a fun bit of DXing. My favorite moment was getting a crystal-clear reception of WHO-1040 in Des Moines with their late Saturday night replay of that afternoon's 12-7 Iowa win at Michigan State. Two other great memories of that weekend were the tours of WUOT-FM (where Glenn Hauser once worked) and WIVK 990/107.7, where then-PD Mickey Dearstone told our group that WIVK's morning show pulled an astonishing 34 share in the ratings book, highest in the nation (at that time) for any locally-produced morning radio show. The Monitoring Times convention was also fun, getting to meet Radio Canada International's Ian McFarland and Universal Radio's Fred Osterman for the first time.

And Karl, since you're talking about inquisitive people wanting to know what the heck you're doing, my story relates to a trip I made 5 years ago to Davenport, Iowa to do a few days of FM DXing. Got checked into my hotel room in mid-afternoon, grabbed the Sangean ATS-909X and headphones, and headed outside (well away from one side of the hotel, or so I thought) to begin. No sooner than 10 minutes had gone by when the desk clerk AND the hotel manager both came outside to ask! I politely and diplomatically explained exactly what I was doing, and they both sort of said, "Oh, ok...we just had some guests look out their window and one of them was wondering what you were up to. Thanks." And they walked away. I got a chuckle out of it, but just to be on the safe side, I now do my FM DX'ing on road trips INSIDE the room, preferably one that's on the hotel's top floor.

(Ed. Note: Rick is responding to a post on another list from Karl Zuk: "At the Monitoring Times convention in 1990, 20 of us gathered in the parking lot of a mountainside park outside of Knoxville, Tennessee after dark to see what we could pick up. We strung out a long wire antenna and hoped for the best. Some time later, a park ranger drove up and said 'Hey! What are you guys doing?' We told him we were listening to the radio. He laughed and said 'In all my time hearing that excuse, this is the first time it is actually true!'")

This month marks the first anniversary of my return to AM DX after a 20-year hiatus. My most productive period of DX was by far my teenaged years in the Chicago area between 1978 and 1982, where I logged over 1100 stations before going away to college. I subsequently built reasonable AM logbooks of several hundred stations during stays in Detroit (1987-1992) and St. Augustine (1993-1999), but this past year represents my most focused listening since my youth. The combination of extensive past experience in AM DX and almost complete naivete about the current state of the hobby has led to a year of sudden discoveries and slow realizations.

The first is the state of AM radio. In Mexico, the migration of most AM stations to FM has profoundly changed the band. An automated scan of the AM dial on my car radio during the day detects no local signals, only a few from the adjoining state of Guanajuato and the low-band powerhouses from Mexico City 120 miles away. Queretaro city has no AM service to speak of, with XEQRMD-1310 usually silent or running an open carrier, and many stations in the region are similarly at risk of disappearing at any time, as semi-local XEAK-890 has done in the past week or so. This situation affords me great opportunities for long-distance DX; on some frequencies my nearest station is more than 500 miles away. As a result, my first-year tally is low in number but high in variety: 377 stations logged from 31 Mexican estados (only Yucatán remains), 27 US states, 4 Canadian provinces, and 10 countries. Over 20% of my catches have come from Texas, whose closest border is 400 miles north.

A second difference is that I find AM stations much less interesting to listen to than in my youth. Most of the local programming that gave a sense of place and drew me into the hobby is gone, replaced by dull content or angry discourse. A handful of stations in Mexico and the US offer programming for the local community, like the Mexican stations that serve indigenous populations or the occasional high school football game in a small Texas town.

The last dramatic change for me was learning about software-defined receivers and acquiring a Perseus SDR. For my first five months back at the dials, I used the old-school approach with my 25-year-old ICF-2010, listening live to weak signals for hours on end. If I had continued in that manner, I likely would have drifted away from the hobby again because late nights and early mornings are a lot less forgiving at 58 than they were at 18. Considering that my wife didn't previously know about this particular weird interest of mine, she has been understanding and supportive, but a partner tethered to a receiver is not what she signed on for. Fortunately, SDR DX allows me to record the band at optimal moments and replay at leisure, and with Bluetooth headphones I get most of my listening done while cooking, cleaning, or gardening.

Finally, it's been great to reconnect to the NRC and IRCA, both the traditional clubs and the various new forums on the interwebs, and witness the generosity of other hobbyists. Shoutouts to old DX buddies Earl Higgins and Karl Forth, who like me have never aged; column editors Bill Hale, Bruce Conti, Linda Brodsky, Nancy Johnson, John Johnson, and Peter Laws; the moderators of the Facebook groups; Neil Kazaross and the DXers who have used his antenna designs to pull in amazing catches; and Tim Hall for curating a ton of info to enhance my own DXing experience.

DX'ing has been limited due to being pressed into service helping out in at my son's home in Demarest for most of the month. I brought my Skywave SSB and SONY digital recorder with me and try to check the AM band before I go to sleep. Only new logging was WIBX, Utica NY 950kHz at 0100 ELT with news and ID. I figured out how to use SSB and fine tuning function on AM and it does sometimes help in separating audio from two stations. I will be returning home for a week or so and I'm looking forward to using the RSPDx and the various antennas I put up during the summer.

Radio History Revisited: Historic National Radio Networks—Part One

Introduction and the development of the traditional networks

As radio stations started popping up all over the country there became an almost immediate challenge of how to share programming that was becoming popular and of interest to listeners outside of one station's coverage area.

Initially, some stations shared via regular telephone lines and several alliances were established for the exchange of programs. But, those early services were, at best, ad hoc arrangements for isolated productions and with little planning and coordination. It was inevitable that eventually stations would band together.

Much of the early network and local programming was musical. Concerts featured live and recorded classical compositions, popular dance music, jazz, and country. Radio drama developed as the complement to the musical programming. Network programming ranged from fortunetellers to gory thrillers. Commercials became more numerous and insistent in their pitch to listeners. Advertisers saw radio as an inexpensive and effective way to reach a national audience.

On November 1, 1921, AT&T set up a transcontinental telephone line to carry speeches from Virginia to auditoriums in New York City and San Francisco. By the next year the company started station WEAF in New York as part of a national "toll" broadcasting service. It recognized the potential for advertising sales and aired its first such commercial announcement--for an apartment complex in New York City. The ad cost \$100 for ten minutes of air time. (In contrast, it is reported that a 30 second spot on New York City radio station WCBS today costs around \$1,405.)

NBC

It wasn't until September 25, 1926 that the first actual network was established. On that date, RCA (Radio Corporation of America) formed the National Broadcasting Company (NBC) to take over its network broadcasting business.

The premiere broadcast of the network took place on November 15, 1926, when NBC aired a four-hour program from the Waldorf-Astoria Hotel in New York. The broadcast featured singers, orchestras, and comedy teams. It also included remote broadcasts from Chicago and Kansas City. As many as twelve million people were estimated to have heard the broadcast. In less than two months, NBC was operating two networks, the Red Network and the Blue Network.

In 1942, NBC was required to divest one of its national networks, so it sold NBC Blue, which was soon renamed the <u>American Broadcasting Company</u> (ABC). After this separation the Red Network continued as the NBC Radio Network. In 1987 NBC sold its remaining radio network operations to <u>Westwood One</u>, which continued using NBC identification for some of its programming until 2014. Beginning in 2016, NBC Radio News has been distributed in conjunction with <u>iHeartMedia</u>.

Much of the early network and local programming was musical. Concerts featured live and recorded classical compositions, popular dance music, jazz, and country. Radio drama developed as the complement to the musical programming. Network programming ranged from fortunetellers to gory thrillers. Commercials became more numerous and insistent in their pitch to listeners. Advertisers saw radio as an inexpensive and effective way to reach a national audience.

The network provided a rich variety of classical concert broadcasts including performances by the <u>Metropolitan Opera</u> (1931–40) and the <u>NBC Symphony Orchestra</u> (1937–54) conducted by <u>Arturo</u> Toscanini.

Notable series include the <u>General Motors Concerts</u> (1929–37) and <u>The Eastman School of Music Symphony</u> (1932–42). From 1935 to 1950 it presented numerous live remote broadcasts of popular music from ballrooms, hotels, supper clubs and army camps. Among the band leaders with regular time slots on NBC were <u>Carmen Cavallaro</u>, <u>Nat King Cole</u>, <u>Xavier Cugat</u>, <u>Tommy Dorsey</u>, <u>Eddy Duchin</u>, <u>Benny Goodman</u>, <u>Stan Kenton</u>, <u>Guy Lombardo</u>, <u>Glenn Miller</u>, <u>Leo Reisman</u>, and <u>Paul Whiteman</u>.

NBC radio news included regular broadcasts by journalists and commentators including <u>Morgan</u> Beatty, Alex Dreier, Pauline Frederick, Floyd Gibbons, John Gunther, Richard Harkness, George Hicks, H. V. Kaltenborn, John MacVane, Adela Rogers St. Johns, Dorothy Thompson, Edward Tomlinson, and <u>Hendrik Willem van Loon</u>.

One of NBC's outstanding later contributions was the program *Monitor* which ran weekends and eventually expanded into weekday evenings. (See my previous article on *Monitor*).

Arguably one of the major contributions to American culture were the NBC Chimes used to identify the network at the end of each program. That melody is still incorporated today in the introduction to some programs such as the *NBC Nightly News*.

CBS

The USA's second radio network was launched by a frustrated talent agent in 1927.

Arthur Judson found himself shut-out of placing his clients on NBC. That network was full and not looking for other potential stars or programs. So, radio station WOR's talent agent rented space from the New York City station, lined up some investors and persuaded sixteen stations to sign on to the Columbia Phonograph Broadcasting System.

In the September launch, the network went live with an orchestra broadcast, and then provided 10 hours of arts programming each week, contracting to pay each station \$500 per week. But a few months in, Columbia Phonograph pulled out while salesmen also struggled to sell airtime. In peril,

Judson sold his fledgling radio company to the Levy brothers, who owned the successful WCAU Philadelphia. They brought in additional investors, including Sam Paley, owner of the Congress Cigar Co.

Within a year, his son, William S. Paley, took charge, and changed the name to the Columbia Broadcasting System, while signing dozens of new stations and major advertisers, tripling revenue over a few months. An empire was born. (I'm not really sure when the network changed its self-identification from Columbia to



CBS, but as a kid growing up in the late 1940s and early 1950s, I remember announcers saying "This is the Columbia Broadcasting System.")

He changed the programming emphasis from high-brow music to more mainstream tastes, signing the Paul Whiteman Band and a young singer named Bing Crosby. Vaudeville entertainers and comedians began appearing on the Columbia Network, including Jack Benny, Burns and Allen, and Fred Allen.

In 1935, CBS went public on the New York Stock Exchange, as it continued to rapidly expand—particularly on the news side. As America entered World War II, the nation tuned in to hear the likes of H.V. Kaltenborn, Edward R. Murrow, William L. Shirer, Eric Sevareid and Robert Trout. The network built up a strong and influential news division under the guidance of Murrow and his successors.

During this period, CBS acquired many of its flagship owned and operated stations, including KMOX St. Louis, WBBM Chicago, KNX Los Angeles and KCBS San Francisco. And it bought the Columbia Phonograph Company, which became CBS Records

The presence of stars such as Phil Harris, Fred Allen, Bing Crosby, and Kate Smith on CBS swelled the network's listenership. With the emergence of television during the 1940s, the appearance of performers became as important as their voices, and in 1948 Paley staged a talent raid of rival NBC, signing up stars such as Freeman Gosden and Charles Correll (better known as Amos 'n' Andy), Edgar Bergen, George Burns and Gracie Allen, and Jack Benny, all of whom proved to be as popular on television as they had been on radio.

H.V. Kaltenborn was CBS' foremost news commentator in the 1930s. His knowledge of foreign affairs gave him the ability to analyze and interpret the growing conflict in Europe for audiences. He was fluent in German and French, which allowed him to translate Hitler's speeches for his audience as they were being received via shortwave. During the Munich Crisis of 1938, he stayed in the CBS studios for 18 days, sleeping on a cot between reports.

CBS was a pioneer in international shortwave broadcasting, FM and early television. However, its move into television was slow; as late as 1950 it owned only one station; radio continued to be the backbone of the company. But gradually, as the television network took shape, the big radio stars began to drift to television. The radio soap opera The Guiding Light became the first television soap when it began to air on CBS in 1950. Burns & Allen made the move in 1950; Lucille Ball a year later; Our Miss Brooks in 1952 (though it continued simultaneously on radio for its full television life). The high-rated Jack Benny radio show ended in 1955, and Edgar Bergen's Sunday-night show went off the air in 1957. The last of CBS's daytime serials went off the air November 25, 1960, and prime-time radio ended on September 30, 1962 when a CBS offering, the legendary Suspense, aired for the final time.

After the retirement of talk-show pioneer Arthur Godfrey in 1972, CBS radio programming consisted of hourly news broadcasts, occasional news features, and commentaries, and the nightly CBS Mystery Theater, the lone holdout of old-style programming. The

CBS Radio Network continues to this day, but offers primarily newscasts and news-related features. CBS unveiled its Eye logo on October 17, 1951. Prior to that, from the 1940s through 1951, CBS Television used an oval spotlight on the block letters C-B-S as its logo. The Eye device was designed by William Golden based on a Pennsylvania Dutch hex sign as well as a Shaker drawing. First drawn by graphic artist Kurt Weiss, it made its broadcasting debut on October 20, 1951. The following season, as Golden prepared a new logo, CBS President Frank Stanton insisted on keeping the Eye and using it as much as possible.

The CBS eye is now an American icon. While the symbol's settings have changed, the Eye device itself has not been redesigned in its entire history. It has frequently been copied or borrowed by television networks around the world, a notable example being Associated TeleVision in the United Kingdom.

The logo is alternately known as the "Eyemark," which was also the name of CBS' domestic and international syndication divisions in the mid to late 1990s before the King World acquisition and Viacom merger. And, it is likely no coincidence that the opening segment of the current television program CBS This Morning is called "the eye-opener."

Geomagnetic Data vs. Reception Bill Whitacre

For many years [since at least 2009] I have 'scraped' various webpages to collect, parse, database and then graph geomagnetic data.

The three graphs I use most often are:

1 - the 10-day combo graph of SF, A, K, solar wind and Dst:

2 - the past 120-day stacked look at these indices plus a concurrent, daily reception index for TP and DU reception in Victoria, BC supplied by Nick Hall-Patch:

3 - a stacked bargraph of TP and DU reception in Victoria, BC averaged every 10 days over the past several years: http://tivodxer.com/monthly-ave-rxn-bargraph1-triple.php

Once you have data and know how to visualize it, it's easy to get carried away.

I did that with Nick's TP & DU reception indexes, expanding my original graphs from an average of one month's data to a bi-monthly graph then a tri-monthly and finally a quad-monthly [weekly] graph.

Early on, I had hoped that simply graphing and inspecting geomagnetic data and actual reception might lead to some over-arching conclusions about their correlation. The more I graphed and inspected the more complicated it became.

I have concluded that solar cycle and season of the year have more to do with overall MW reception quality than the daily geomagnetic indices. Sometimes, after-the-fact, it's possible to 'explain' why reception conditions were not good for one geographic region or another. But nearly the same geomagnetic conditions in a different season or different part of the sunspot cycle often lead to very different results.

You would probably not want to turn off the radio and go to bed based on anything I could predict from all this data.

Still, the graphs do provide some reassurance to things most active Northwest DXers know:

- fall is the 'best time' to hear TPs
- late summer/early fall is the best time to hear Dus
- there is often a 'second season' for both TP and DU in the spring

My own selfish interest in these graphs is to tell me when it's best to come visit Grayland to hear things I can't hear at home. So far I've figured out fall and spring are the best times to come. Any more resolution than that results in a 'crap shoot' as to whether 'your week' is a good one or a bad one.

The moral is if you're going to travel for a DXpedetion, it's best to plan on lots of activities — many NOT related to radio.

If you find these graphs useful or interesting, great! If not, ignore them.
