DX Test: KJJR-880 Whitefish MT will test on Saturday morning, **January 8**, from 0201-0400 EST (0001-0200 local MST, and 0701-0900 UTC). Station chief engineer Todd Clark will be performing regular maintenance of the station's audio chain during the test, which will include Code IDs at 10 WPM 800 Hz and 20 WPM 1000 Hz. There will also be sweep tones, telephone offhook indicators, long-duration tones at 1000 Hz, music, jingles, and more. Details about reception reports, verifications, etc. to come. Program NRC/IRCA Courtesy Committee extends its thanks to KJJR ownership, Todd Clark, and Paul Walker for helping to arrange this test.




NRC Antenna Pattern Book 8th Edition

Last week was a tough one in Southern British Columbia, with more rain on the way. Large areas were flooded, knocking at least one transmitter off the air: CBC's LPRT in Merritt, CBUP-860 (see more below).

The CRTC hearing on the Rogers/Shaw merger have wrapped up. "While the hearings at the CRTC focused on the broadcasting aspects [including Cable TV] of the merger, issues such as mobile wireless services and internet providers will be reviewed by the Competition Bureau and by the Ministry of Innovation, Science and Economic Development." (The Canadian Press)

860 **CBUP**

BC Merritt – Off the air during flooding that forced the evacuation of the entire city, and flooded the bottom half of the Transmitter Rack. Ironically, the backup transmitter had been under water, but not the main transmitter, so the station was back on the air within hours of the lifting of the evacuation order, which came after flood waters receded. The station is a 40 Watt CBC LPRT simulcasting CBYK-FM

Kamloops BC.

870 CKIR

BC Invermere – Heard in Edmonton on the evening of November 25th sounding like they were stuck on 1KW day power. Except for a few fades, CKIR dominated a frequency normally owned by KFLD Pasco WA. Several years ago, they ran 1 kW 24/7 for more than a year, so their transmitter problem may have returned. Listen for mentions of "106.3", the frequency of CKGR-FM Golden BC, which CKIR simulcasts. Earlier this year, they switched from EZ Rock soft adult contemporary to Bounce Radio adult hits, but are still playing songs like the 1991 hit "Wicked Game" by Chris Isaak, who harkens back to the late Roy Orbison.

- 972 **SOUTH KOREA** HLCA Dangjin NOV 27 1100 Presumed; carrier observed at s3 level not strong enough to produce audio. Transpacific carriers also observed at 693, 747, 756, 774, 945, 954, 1116, 1188, 1206, 1323 kHz. [Conti-NH]
- 1116 unID DEC 5 1200 Weak carrier observed, another at 1512 kHz, but nothing else. Tim Tromp in the NRC Facebook group reported a number of New Zealand signals received in Michigan this morning. [Conti-NH]

Transatlantic carrier search: NOV 30 0727 – Not in the order tuned: 621, 684, 693, 711, 747(2), 765(2), 774(2), 828, 846(TP?), 855(2), 882(2), 909, 999, 1089, 1107(2), 1125(2), 1215* kHz. *strongest. Note 774, where there are normally two, although mwoffsets shows nothing more than 3 Hz minus from Spain. But at this late/early hour both W Europe and E Asia could be propagating, remnants converging on deep North America; as Walt Salmaniw, BC reported NOV 28 to IRCA: "Happen to be listening to 774, and heard a local ID for JOUB (NHK2 Akita) at 0720 UTC. 1566 HLAZ booming in already, with readily heard co-channel Chinese. All this via my Masset SDR." Mwoffsets shows JOUB is exactly 774.0000 kHz. DEC 1 0202 – Signals beyond W Europe are possible but it seems these are not; 531, 585, 684, 774, 837, 882, 999, 1089, 1098, 1116, 1125, 1152, 1215, 1305 kHz. DEC 4 0407 – 531, 558(2), 576, 612, 639, 657, 684(2), 711, 747, 774(2), 837(2), 882(2), 945, 1098, 1134(2), 1215 kHz. As usual, not much heard higher, partly due to greater adjacent interference level, but I keep going and hear another at 1656+ kHz. If nominal 1656, it's noticeably off-frequency. But there is no official X-band TA. However that area is packed with Euro pirates, hundreds of them logged by Carlos Gonçalves in Portugal, most of them unID, but his latest list shows some on 1655 and 1660, not 1656. So my carrier may be something local or at least not TA. [Hauser-OK]

INTERNATIONAL NEWS

PACIFIC ASIAN LOG: The November 2021 edition of the *Pacific Asian Log* (PAL) is now available. It can be downloaded from the Radio Heritage website www.radioheritage.com, go to the "Radio Guides" drop down menu. As usual, many changes and updates have been incorporated into this latest edition. I've also added a Parallels section listing the frequencies used by various networks throughout the region. It should be helpful for those who check parallel frequencies during their DX sessions. First issued in 2001, The PAL lists medium wave and domestic shortwave broadcasting stations in southern and eastern Asia and the Pacific. It lists nearly 5000 stations in over 50 countries, with frequencies, call signs, locations, power, networks, schedules, languages, formats, networks and other information. <u>Mike Jeziorski – Juriquilla, Querétaro (Mexico)</u>

For those who have not yet had the chance to join in on one of Loyd Van Horn's DX Central YouTube events on Saturday evenings, I encourage you to give it a try. A couple dozen DXers connected on 27 Nov to compare notes on DXing 910 kHz and a few other frequencies, and it was my first experience listening live with others in far-flung geographic locations. We could tip each other off to which station was carrying which programming; it was like having a collection of SDRs who chat. Loyd also has a great setup that puts mine to shame, and I look forward to stealing, er, being inspired by some of his ideas.

A centerpiece of the evening was Loyd's well-conducted interview with Wayne Heinen; it's tough to do better for a first guest. They discussed some of the history of the NRC, the current state of the club, and the most recent edition of the NRC Domestic Log. I confess that I was reluctant to buy a copy of the Log because it is in that old-fashioned format known as "paper"--why isn't it offered in an electronic format that could be easily downloaded, sorted, searched, and updated, keeping clutter to a minimum? During the interview, Wayne mentioned that he had worked in database management for many years, so the mystery deepened. Then he recounted how, many years ago, someone in the club created an electronic form of the log and tried to sell it to the directors. That's when the penny dropped for me. The *Log* represents the intellectual property of the club, and putting it into a downloadable format would make it trivial for anyone to copy and pass around, or worse, attempt to copyright themselves. That also explains why downloads of MWList and the IRCA Mexican AM Log are PDF-only. So the next day I placed my order for the new edition of the Domestic Log. The price tag is steep for a Mexican resident, so I'll need to DX even more to get my money's worth.

The frequency Loyd picked for this week's challenge (27 Nov - 4 Dec) is 1430, and listening to that channel tonight revealed to me another in a series of modern DX problems. So many stations I hear, both Mexican and American, are on regional or larger networks, and often the top-of-hour ID is given for all stations on the network so no individual ID is needed. Usually that's not a problem... until such a network has multiple stations on the same frequency. ESNE Radio (El Sembrador Nueva Evangelización) has either a 14-station network (per website https://esneradio.com/estaciones/) or a 13-station network (per IDs I heard; KRXA-540 was omitted, with KKMC-880 IDed as "Gonzales y Salinas"). Two of the stations, KWST El Centro CA and KMES Ogden UT, are on 1430. Which did I hear? This question has long been a quandary with Cuban stations, and if I hear Radio Rebelde on a given frequency I pick out the closest outlet with the most power or just throw a dart because the island isn't that big. According to current information, ESNE Radio could either be coming from a southern Californian station running 36 watts at night or a 5 kilowatter from the Salt Lake City area. Both would be great catches in central Mexico, yet without clearer info I cannot claim either one. 73, Mike

DX continues to be disappointing with only the commonly received stations showing up across the dial. At this time of year, Canadians and many Cubans usually pop up, often overwhelming everything else, but not so this season.

I took up the DX Central Frequency Challenge for the week of November 28 - Dec 4 and the only stations I logged on 1430 were semi-local pest WNSW, Newark NJ with Relevant Radio programming and often heard CHKT, Toronto. Aside from one instance around 0500 ELT where I actually recorded a complete CHKT ID, that usually powerful signal was weak, with lots of fading. I tried at various times of the day and night with the C.Crane Skywave inductively coupled to an amplified ferrite loop, the Sangean PR-D5 with no external antenna and the RSPDx with 7 different antennas (outdoors a PAR EF, 20 ft. LNV, 15 foot LNV, 2 LoGs oriented in different directions, and indoors, a YouLoop and a 3 foot diameter magnetic loop – all with and without amplifier) I checked IQ recordings and no matter what the setup or time of day, only WNSW and CHKT were heard. Audio

recordings from the C.Crane yielded the same.

75 Years Ago – From the December 14, 1946 issue of *DX News*: A total of 37 members contributed Musings to Musings of the Members, which made up most of the issue. Almost all members responding to a poll were in favor of the NRC remaining a broadcast-band-only club, and against resuming a shortwave column.

50 Years Ago – From the December 18, 1971 issue of *DX News*: Vince Cavaseno of New York City noted that he was beginning his seventh year in the NRC and "the hobby has progressed tremendously in that time." According to an obituary in the Vallejo *Times-Herald*, Ollie Ross, who recently passed away at age 71, was known as the "DX Champ" in the 1930s and 1940s by logging every commercial station on the broadcast band, all 1,374 of them, using a ground-aerial antenna that he had invented. (The *DX News* editors had never heard of him or his invention.)

25 Years Ago – From the December 9, 1996 issue of *DX News*: The NRC was the second-largest club in the Association of North American Radio Clubs (ANARC) with 795 members in 1996; NASWA was the largest.

10 Years Ago – From the December 5, 2011 issue of *DX News*: CKGM-990 Montreal was authorized to move to 690, with new Montreal stations being authorized for 940 and 990 and a new Mississauga station on 960.
