DX Tests

KJJR-880 Whitefish MT will test on Saturday morning, January 8, from 0201-0400 EST (0001-0200 local MST, and 0701-0900 UTC). Station chief engineer Todd Clark will be performing regular maintenance of the station's audio chain during the test, which will include Code IDs at 10 WPM 800 Hz and 20 WPM 1000 Hz. There will also be sweep tones, telephone off-hook indicators, longduration tones at 1000 Hz, music, jingles, and more.

The CPC will issue verifications for the test. Joe Miller has designed the QSL e-card. They are requesting a brief (2 minutes or less) recording in .mp3, .wav, or .mp4 video format, along with the usual identification of the DXer and equipment. Please send reports within 30 days of the test to Les Rayburn at les@highnoonfilm.com.

The NRC/IRCA Courtesy Program Committee extends its thanks to KJJR ownership, Todd Clark, and Paul Walker for helping to arrange this test.

KOKD-1380 Redfield, SD will test on Saturday morning, January 15, from 0101-0300 EST (0001-0200 local CST, and 0601-0800 UTC). Chief engineer and station owner Ron Schacht will conduct a test using 500 Watts day power. The test will include Code IDs and sweep tones at 1000 Hz and other easily identifiable content.

The CPC will issue verifications for the test. They are requesting a brief (2 minutes or less) recording in .mp3, .wav, or .mp4 video format, along with the usual identification of the DXer and equipment. Please send reports within 30 Les Rayburn of the test to <u>les@highnoonfilm.com</u> with the subject line "KQKD 1380 RECEPTION REPORT."

KQKD also conducted an equipment test on December 11 at 0201-0500 EST, but due to a miscommunication this wasn't announced in advance. If you have an overnight recording and wish to submit it for verification, please do.

Al Quaglieri reports WABY-900 Watervliet NY has been running open carrier for weeks and is looking for a buyer.

Miscellaneous: What is the city of license for WAFN-1310 (ex-WKZD), Somerville AL or Priceville AL? At the beginning of 2021, the FCC "AM Query" database said Priceville and the station license (accessible through the FCC web site) to this day says Priceville. In June 2020, the station owners (the Somerville Baptist Church, who purchased the station in 2015), filed an application "solely to change WKZD(AM) from 'commercial' to 'non-commercial'" status; the application was granted in February 2021. On the application, however, the station put "Somerville" as the city of license. Upon the granting of the application, the city of license was flipped to Somerville in the FCC databases, but there was never any formal application to change the CoL (which normally requires a construction permit, even if no "construction" is involved).

This change of CoL based on an erroneous line in an application for non-commercial status has happened on other occasions in recent years. For a while, WRAA-1330 was listed by the FCC as Blacksburg VA rather than the correct Luray VA, for a similar reason. In every case, once the FCC looked into it, the flip of CoL in the FCC databases was reversed. According to FCC records, the transmitter is still located in Priceville (on Marco Drive, ¼ mile north of the intersection with Cave Spring Road), and I can see the tower at that site right now on Google Maps. Somerville is about 7 miles southeast of Priceville. So my vote is that Priceville is still correct, even if the online FCC "AM Query" says Somerville. – DY





--- CANADIAN RADIO BITS, BOBS, AND A HISTORY LESSON ---

Canada has seen major changes in AM Radio listening habits due to COVID-19. Broadcast Ratings in Canada generally rely upon Numeris, a not-for-profit Joint Industry Committee (JIC). They were previously known as BBM, derived from their original name, the Board of Broadcast Measurement. It was a name that made sense in an era (1958-68) when Broadcasting in Canada was regulated by the BBG, the Board of Broadcast Governors. PPMs are used in Major Markets and Diaries in smaller markets.

Hearing multiple transmitters airing the same content, on the same or different frequencies, can be a simulcast, a network or a syndicated program. It is sometimes hard to define which, if any, of these three describes a given situation. Currently, a major trend among corporate owners for overnight is to replace syndicated programming with the corporation's own programming, effectively making all stations with the same brand part of a network. The CRTC licenses some radio networks, most notably the CBC and all the Canadian sports teams' play-by-play networks. Simulcasting with no separate content is issued a single license for all the transmitters. When separate content exists, each station gets a separate license, with a license requirement for a specified weekly amount of local programming, defined as "local news, weather and sports, promote local events, and provide spoken word content that meets the particular needs and interests of the communities it is licensed to serve". Simulcast, network and live syndicated programs are not always synchronized perfectly. Satellite and Internet feeds both create audible delays. Programming can be delayed hours or even days for repeat programming or due to differences in time zones. Voice-tracked simulcasting with local content can also get out of sync if each station's local content varies in length.

570 CKSW SK Swift Current – As well as the station's own content, all CJSN-1490 content is produced at CKSW.

630 CHED AB Edmonton – Heard in Folsom CA on December 18th at 2000 with a strong signal on a car radio. Co-owned CHED and CJOB-680 Winnipeg, Manitoba adjusted their directional patterns several years ago, to take into account stations that are no longer on the air, including CKOV-630 Kelowna, British Columbia, CKRC-630 Winnipeg, Manitoba and CHFA-680 Edmonton, Aalberta, all of which switched to FM.

AB Edmonton – Made a rare appearance as #1 in the overall ratings for the August 30th to November 28th time period. Even a decade ago, when CBC stations were usually number one in other major markets, CKUA's Edmonton audience was enough to rob CBX of the top spot. This time, a 9.0 was just enough to beat three FMs, each with mid-8 shares.

QC Montreal – Montreal Ratings are reported separately for English and French stations (bilingual stations are no longer permitted by the CRTC), with CJAD scoring a 26.8 share in the English ratings, giving them a nine point lead over #2. As might be expected, CJAD has a 0.1 share of the much larger French-speaking Montreal audience, where the top-rated AM station is CKGM-690 with a 0.7 share; English language All Sports CKGM has a 5.0 share in the English ratings.

980 CKNW BC New Westminster – Once known as "The Top Dog in B.C. Radio", more often than not these days, the station loses out on top spot in the Ratings. But, not this time, with a 12.8 share beating second place CBU's 10.6.

MB Winnipeg – Nearly two points ahead of second place CJOB, CBW had a 15.7 share of the Winnipeg market, the latest in a long string of #1 Ratings.

1010 CBR AB Calgary – Over two points ahead of everyone else, the station scored #1 with a 12.2 share of the overall Ratings.

1040 CKST BC Vancouver – Heard in London, Ontario on December 14th @ 2240 with poor signal. CKST is one of those rare stations whose Directional Pattern during the Day impacts its potential listening audience more than its Night Pattern. Both patterns have very tight nulls, toward WHO-

1040 Des Moines, Iowa at night and KBLE-1050 Seattle, Washington during the day; the Night Pattern sends little signal to Victoria BC in order to protect Port Angeles, Washington's reception of KBLE. As a former Daytimer, KBLE is not protected at Night.

1490 CJSN SK Shaunavon – Although their 2016 license renewal includes a requirement for 91.5 hours per week of local programming, one of their engineering staff reports that the

station now totally simulcasts CKSW-570, with the exception of local IDs and commercials.

ommunity Service Radio

115 years ago, during December 1906, Canadian-born Reginald Aubrey Fessenden made Broadcast History at Brant Rock, Massachusetts, though there is some dispute among historians over some of it. On December 21, he demonstrated his newly-invented "high-frequency alternatortransmitter" that broadcast clear audio but lacked the amplification necessary for a strong signal. Speech was heard clearly 11 miles away at Plymouth, Massachusetts, and a successful interconnection was made with the existing nation-wide telephone network. That much is well documented in contemporary editions of Scientific American and The American Telephone Journal. Also well documented is Fessenden's earlier (Autumn 1900) usage of a high-frequency spark transmitter to successfully transmit somewhat distorted speech over a distance of one mile. Fessenden would later (1918) claim that, during the testing before and after the 1906 demonstration, a couple of his transmissions were received in Scotland. But it was not until 1928 and 1932 that accounts were published of his 1906 Christmas Eve broadcast of four selections: a phonograph record followed by Fessenden playing violin, singing and reading a short passage from the Bible. If true, it would represent the first broadcast of music and entertainment to a general audience. If not, that honor would go to Lee de Forest's broadcast of electronic telharmonium music in February 1907. Fessenden also claims to have made a second, shorter, program on New Years Eve 1906. And he goes on to say that both broadcasts were widely publicized and heard as far away as Norfolk, Virginia, and, in the case of the New Years Eve broadcast, the West Indies. It is these DX claims that have generated the greatest skepticism due to the low power of the transmitter. What is known, is that transmitter was built by General Electric and operated on 50 kHz. For comparison, WWVB operates at 60 KHz with 50,000 Watts from Colorado and is heard most nights by millions of clock-based devices in North America.

John muses: "This is not a good frequency for me, since a local station, KGFF at 1450 is located about 1/4 mile from me. USB interference on 1440 is huge! However with a good receiver, LSB comes in fair. Here are some catches:

1440 KEXB TX University Park – **12/22 1400** – Very weak daytime signal under strong interference from KGFF. Religious talk with Relevant Radio ID. Only heard with the ESH3.


1440 WGEM IL Quincy – 12/23 2200 – Sports talk with call ID. I hear this station every day, with a strong signal. There are many other stations closer with similar power, but this one seems to have the strongest signal.

1440 KMAJ KS Topeka – **12/24 0800** – Fair signal with farm news and call ID. Heard mainly in the morning or early evening.

The next frequencies for the **CHALLENGE** are: 860 kHz and 990 kHz. Let's make it a Canadian Clear, of old, challenge. For those of you who only receive the print edition, there are no deadlines. But, be reasonable. So spend some time on 860 and 990 and see what sneaks in under all the noise, clutter, etc. And then REPORT! Suggest a frequency, if you will.

INTERNATIONAL NEWS

CZECHIA: Radio reception on medium wave (MW) and long wave (LW) has been history in many parts of Europe for years. Now, in the Czech Republic, at least the public broadcaster stopped transmitting on MW and LW at the start of the new year. The powerful transmitters on the frequencies 270, 639 and 954 kHz are off. The reason given for the move was the widespread availability of terrestrial digital radio DAB+ and the high costs of broadcasting. Those still listening using medium waves were to be persuaded to switch with a campaign. The radio station Cesky Rozhlas set up a telephone hotline to answer questions. It was not known at first whether the transmitters would be retained or used for other purposes. The antenna of the medium-wave transmitter Liblice B east of Prague is considered the highest structure in the Czech Republic, with a height of 355 metres. R.Cesky Impuls, (981 kHz) the most-listened to private radio station, wants to remain faithful to medium wave for the time being. It broadcasts its second programme, with pop and country music, on analogue transmission. [Deutsche Presse-Agentur GmbH via Mike Terry, NRC Facebook Group] Confirming the closedown of 270 kHz, 954 kHz and 1017 kHz. Still on air: *R.Dechovka* on **792 kHz**. [Nils Düwel, mediumwave.info]

JORDAN: Here is some good news. When other stations are going down, another are reactivating their transmission. Radio of Jordan is reactivated on 612 kHz, from 1st of January, and sounds clear, better than it was in a past. [Alexei Lubich, Israel, mediumwave.info]

MEXICO: The IFT has denied the sale of 1260 XEL to Esne Radio. It is reported that Esne will look for another station to lease in Mexico City, and XEL will revert to La Comadre branding/format, if it hasn't happened already. [Tim Hall, NRC Facebook Group]

- MEXICO XEL Radio La Guadalupana, México, DF OCT 30 0158 Noted often this weekend 1260 with Esne Radio Spanish Catholic programming. Full ID at top of hour included call letters, power (35 kW), and slogans "Radio Católica" and "Radio La Guadalupana-Esne." OCT 31 1200 – They now run what seems to be the full (4:40) children's choral version of the Mexican anthem starting slightly before 6:00 a.m. local time. I caught it in progress at the top of the hour. It ended almost 3½ minutes after the top of the hour, at which time they rejoined the Esne Radio feed parallel 1670 KHPY. 1631 miles. Relog.
- 1300 **MEXICO** XEP R.México Nuestras Noticias, Cd. Juárez, Chih. OCT 31 1203 – Over KVET; older Mexican music, "Radio México Nuestras Noticias" slogan, and fast adult choral version of Mexican anthem followed by full ID. 668 miles. Relog.
- MEXICO XEXX TuDN Deportes, Tijuana, BC OCT 31 1200 Under KTAN and KMOG; long 1420 string of TuDN Deportes promos. 481 miles. Relog.
- **MEXICO** XEEST Ondas de Vida, México, DF OCT 31 0504 On top of channel with children's 1440 choral version of Mexican anthem which ran past the end of my recording (0507 UTC). XEEST is the last surviving Mexican station on 1440 AM. They were

1460 MEXICO XEYC R. Fórmula Juárez, Cd. Juárez, Chih. OCT 31 1157 – R.Fórmula promo's and 970 XERFR ID (unlike many R.Fórmula affiliates, XEYC is usually pretty good about covering the network ID with their own ID) and children's choral version of Mexican anthem. 660 miles. Relog.



- **MEXICO** XERCN, *RCN* 1470, Tijuana, BC OCT 31 1157 Paid religious program, "RCN 1470," and disclaimer about the next paid program. 482 miles. Relog.
- **MEXICO** XEAI *R.Fórmula*, México, DF OCT 31 1157 *R.Fórmula* programming including children's choral version of Mexican anthem (one verse). 1627 miles. Relog.
- **MEXICO** XEDF *R.Fórmula*, México, DF OCT 31 1157 Under KSTP; *R.Fórmula* programming including children's choral version of Mexican anthem (one verse). 1626 miles. Relog.
- **CUBA** *R.Rebelde*, multiple locations OCT 29 0401 Chimes and Cuban anthem parallel 530, 1180, etc. Relog.
- MEXICO XEJPV, *W Radio*, Cd. Juárez, Chih. OCT 31 1200 Appeared suddenly under KNZR and KGOW; fast adult choral version of Mexican anthem and *W Radio* programming. 666 miles. Relog.
- **CUBA** *R.Bayamo*, Bayamo OCT 30 0107 Under Rebelde and KSMH; airing a slow version of the *R.Granma* chimes. I have heard this before on at least one other station in Granma province. Relog.

- **PUERTO RICO** WGIT *Faro de Santidad*, Canóvanas OCT 28 1001 Spanish preaching faded up over KBRE and KQWB. 3197 miles. Relog.
- MEXICO XEPE *Heraldo Radio*, Tecate, BC OCT 31 1200 Still running the children's choral version of the Mexican anthem (at 6:00 a.m. Central time) from the *Heraldo Radio* feed. Slogan "Heraldo radio 98.5 FM." Non-ID gave the frequency and power (100 kW) of the originating FM station in Mexico City. 480 miles. Relog.

- JAPAN JOQG, *NHK1*, Morioka (presumed location) OCT 29 1242 After hearing NHK time pips on some of my top-of-hour recordings (OCT 28 1400 and OCT 29 1000), I finally caught a bit of audio (female announcer) parallel 594 kHz. This was surely the 10 kW outlet in Morioka, right on the main beam of my antenna, as opposed to the much more distant 1 kW outlet on Okinawa. New, Japan #14.
- **unID** OCT 29 1258 Male announcer, probably in Korean, with long 880Hz tone at the top of the hour. This was almost certainly unneeded HLQH, which has been recorded as running a single long 880Hz tone at the top of the hour in recent years.
- JAPAN JOIK, *NHK1*, Sapporo OCT 29 1259 Poor with NHK pips and *NHK1* programming. Not as good as they usually are during these nice TP openings. Relog.
- SOUTH KOREA HLKF, *KBS*, Jeonju (presumed) OCT 28 1357 Female announcer in Asian language, not parallel NHK1 on 594 (which was coming in nicely with a male announcer in Japanese parallel 666 kHz). NHK/KBS 440/880 Hz pips on the hour, which would seem to indicate this was South Korea, still needed here. New, South Korea #7.
- **unID** OCT 29 0959 3 (or more?) + 1 time pips, 440/880 Hz. Probably the 10 kW *NHK1* outlet, still needed here.
- **JAPAN** JOAK, *NHK1*, Tokyo OCT 28 1357 Fair with male announcer in Japanese, NHK pips at top-of-hour. Relog.

- NORTH KOREA KCBS, Pyongyang (tentative) OCT 29 1259 I seemed to have the KCBS station very weak with 3+1 pips, higher pitch (550/1100 Hz) than, and about ½ second ahead of, the NHK/KBS stations. Couldn't find any audio to prove that they were parallel 819 kHz. This would be a new catch if I could positively ID it.
- **SOUTH KOREA** HLKA, *KBS*, Seoul OCT 28 1158 Poor but fairly steady signal with woman in presumed Korean possibly reading news, and *KBS* 3+1 time pips on the hour. Relog.
- 711 **unID** OCT 29 1259 Musical chimes (minor arpeggio) under HLKA time pips.
- NORTH KOREA KCBS, Kanggye OCT 29 1259 Fighting through KFIR; KCBS 3+1 pips (550/1100Hz) parallel 819 kHz. New, North Korea #4.
- 720 **unID** OCT 28 1000 880Hz top-of-hour time tone.
- vnID OCT 28 1158 Chinese or Japanese music briefly in well. No time pips at top of hour. Female talking after top-of-hour. 150 kW station in Jilin, China seems a good possibility, as my antenna is aimed at northeastern China, Japan, and North and South Korea.
- JAPAN JOIB, *NHK*2, Sapporo OCT 28 1240 Fair-good with English lessons parallel 774, 828 and NHK pips at top of hour. Relog.
- JAPAN JOUB, *NHK*2, Akita OCT 28 1259 Good signal with English lessons and NHK pips. Armchair copy at times this morning. The carrier was often as strong as KKOB. Relog.
- NORTH KOREA *KCBS*, Pyongyang OCT 29 1259 Poor with 3+1 pips, 550/1100 Hz (higher pitch than the NHK/KBS stations). The previous morning, they were in for much of the morning with a nice signal running the usual patriotic music. Relog.
- 819 **unID** OCT 29 0959 3+1 time pips, 440/880 Hz, way under KCBS higher-pitch time pips. Probably the 5kW *NHK1* outlet, still needed here.
- JAPAN JOBB, *NHK2*, Osaka OCT 28 1240 Fair-good with English lessons and NHK pips at top of hour. Audio was noted throughout the morning. Relog.
- 846 **unID** OCT 29 1400 Long 880Hz top-of-hour tone.
- unID OCT 28 1059 3+1 time pips, 800/1600Hz. Presumably China CNR/CRI based on the pitches used, but they normally use 5+1 pips. The only 2 Chinese stations listed on 855 are in the western part of the country. Possibly CNR2 in Xinjiang province, NW China.
- 855 **unID** OCT 28 1300 Long 880Hz top-of-hour tone.
- 864 **unID** OCT 28 1359 3+1 time pips, 440/880 Hz. Presumably South Korea, logged here in the past.
- 873 **JAPAN** JOGB, *NHK*2, Kumamoto OCT 28 1159 Poor with NHK pips and NHK2 programming. Weaker than usual this year. Relog.
- **unID** OCT 29 0959 and OCT 29 1259 NHK/KBS 3+1 time pips (440/880 Hz). No audio noted. Most likely the 250 kW *KBS* regional station or the 20 kW *NHK1* station, both still needed.
- 891 **unID** OCT 28 1400 1-second 880Hz pip at top of hour.
- 900 **CHINA** (unknown location) OCT 29 1359 Weak signals with CNR/CRI-style time pips (5+1 800/1600 Hz), two seconds later than the other Chinese stations audible at this hour. Two Chinese stations have already been logged on this channel with these time pips, so I'm guessing this is a relog.
- 909 **JAPAN** JOCB, *NHK*2, Nagoya (location presumed) OCT 29 1359 Poor but steady with NHK time pips. Some audio noted earlier. Relog.
- 945 **CHINA** *CNR1*, Jiaohe, Jilin OCT 29 1359 CNR chimes as heard previously on this frequency. Noted parallel 981 whenever both were coming in. Relog.
- 963 **unID** OCT 28 1159 and OCT 28 1359 Long 880Hz top-of-hour tone noted frequently here during the 2 good TP mornings. Best guess would be the KBS stations. I don't think I hear any 440Hz short pips before the long pip.
- 972 **SOUTH KOREA** HLCA, *KBS*, Dangjin OCT 29 1259 Poor signal with *KBS* 3+1 time pips. Good audio at times. Relog.
- 981 **CHINA** CNR1, Changchun, Jilin OCT 29 1359 Good audio with woman talking in Chinese parallel 945 kHz. CNR/CRI-style time pips (5+1 800/1600 Hz). Relog.
- 1017 **CHINA** *CRI*, Changchun, Jilin OCT 29 1400 *CRI* theme music, also noted on 1323 kHz at this hour. New, China #13.
- 1017 **unID** OCT 29 1000 Top-of-hour long time tone, 880 Hz. Possibly preceded by 440Hz pips.
- 1026 unID OCT 29 1000 Top-of-hour long time tone, 880 Hz, very weak.

- **unID** OCT 29 1259 3+1 NHK/KBS-style (440/880 Hz) time pips getting clobbered by 1070 KNX slop. This was almost certainly the 20 kW *NHK1* station in Hiroshima, still needed here.
- **CHINA** *CNR*2, Harbin, Heilongjiang OCT 29 1259 Finally caught CNR (800/1600 Hz) time pips here after hearing Chinese talk the previous morning. I have almost always had at least a carrier here during good TP openings. New, China #16.
- JAPAN JOQR, Bunka Hoso, Tokyo OCT 28 1159 Female announcer in Japanese, with trademark chimes on top of time pips at the top of the hour. There seemed to be a second station running the same (440/880 Hz) time pips a split second ahead of them, which would likely be the KBS3 station I still need. New, Japan
- unID OCT 29 0957 Poor but faded up with sedate classical piano music, then weak NHK/KBS-style (440/880 Hz) 3+1 time pips at the top of the hour. Probably the KBS3 station, but I could not find a parallel. I almost always have a strong carrier on 1134 when TP conditions are good.
- **unID** OCT 29 1358 Sedate talk by female announcer, and NHK/KBS-style (440/880 Hz) 3+1 time pips at the top of the hour. Again, most likely the KBS3 station, still needed here.
- **SOUTH KOREA** HLSR, *KBS World Radio*, Gimje OCT 29 0956 Fair signal under KTSB; nice audio, 3+1 time pips and theme music at top of hour. Noted several times during the 2 good TP mornings. NNW wire knocked down KLOK very nicely. New, South Korea #6.
- **unID** OCT 29 1000 Carrier appeared suddenly a few seconds before the top of the hour. Male voice was noted very briefly between all the 1180 KOFI slop.
- **unID** OCT 28 1200 Top-of-hour long time tone, 1000 or 1020 Hz.
- **unID** OCT 29 1000 Top-of-hour long time tone, 880 Hz. Possibly preceded by 440Hz pips.
- **unID** OCT 29 1000 Top-of-hour long time tone, 880 Hz.
- 1206 CHINA Yanbian, Jilin (presumed) OCT 28 1400 Chinese or Korean talk and music. Relog.
- **CHINA** *CNR*, Shenyang, Liaoning (presumed location) OCT 28 1359 CNR/CRI-style time pips (5+1 800/1600Hz). The next morning I had some audio of a female announcer possibly parallel 981, 1251 kHz. New, China #15.
- **unID** OCT 29 0959 Top-of-hour long time tone, 880 Hz, almost a second earlier than most other stations.
- unID OCT 28 1300 Top-of-hour long time tone, 880 Hz. This was probably a relog of JOLF, but I'm not sure I can hear the "cuckoo" pips leading up to the top-of-hour tone.
- **CHINA** *CNR1* (unknown location) OCT 28 1359 CNR/CRI-style time pips (5+1 800/1600Hz) followed by male announcer. OCT 29 1358 Female announcer in Chinese parallel 981, so definitely CNR1 as opposed to CRI. New, China #14.
- JAPAN JOHR, *Hokkaido Hoso (HBC)*, Sapporo OCT 28 1159 Top-of-hour long time tone (880 Hz) and fairly high-pitched female announcer in Japanese. Their top-of-hour tone was noted almost every time TP conditions were decent. New, Japan #13.
- **unID** OCT 28 1159 Seemed to be two stations mixing here, one with 880Hz long time tone possibly preceded by a few 440 Hz short tones, and another one slightly out of synch with short pips higher than 440 Hz. The 440/880 pips could by the 10 kW *NHK1* outlet.
- **unID** OCT 29 0959 Top-of-hour long time tone, 880 Hz, about 3 seconds earlier than most other stations.
- CHINA *CRI* (multiple locations surely the 600kW in Huadian, Jilin, or the 200 kW in Shuangyashan, Heilongjiang, as these are the 2 provinces most commonly logged here) OCT 28 1300 Finally caught the CRI interval signal here after having a strong carrier on this channel during just about every previous TP opening. New, China #12.
- unID OCT 28 1159 Seemed to be two stations mixing here, one with short time pips around 440Hz like a Japanese or South Korean station (possibly one of the 10 kW *NHK*2 outlets?) and the other with short time pips around 800Hz like a Chinese station. No long tone noted for either.
- **CHINA** *CNR1* (unknown locations) OCT 28 1159 Two stations with CNR/CRI-style time pips (5+1 800/1600Hz), a split second apart. Must be two of the new *CNR1* "jammer" transmitters that appear to have been launched to block *R.Taiwan* (whose 440/880 Hz pips were barely audible underneath). New, China #17 and #18.
- **TAIWAN** *R.Taiwan International*, Kohou OCT 29 1359 Female announcer, instrumental theme, and 3+1 440/880Hz time pips as heard at home recently. This station suddenly seems to be getting heard by people all over the place. New, Taiwan #1, country #23.
- **SOUTH KOREA** HLAZ, *FEBC*, Jeju OCT 28 1258 FEBC Japanese service, with man talking in Japanese with fair signal, followed by a female announcer after the top of the hour. Relog.

1593 CHINA CNR1, Changzhou, Jiangsu OCT 28 1359 – Bits of audio and very clear strong 5+1 CNR1 time pips (800/1600 Hz). New, China #11.

Radio History Revisited

Historic National Radio Networks—Part Three, ABC

From the organization of the first true radio networks in the late 1920s, broadcasting in the United States was dominated by two companies, CBS and RCA's NBC. Prior to NBC's 1926 formation, RCA had acquired AT&T's New York station WEAF (later WNBC, now WFAN). With WEAF came a loosely organized system feeding programming to other stations in the northeastern U.S. RCA also took control of a second such group, fed by Westinghouse's WJZ in New York. These were the foundations of RCA's two distinct programming services, the NBC "Red" and NBC "Blue" networks. Legend has it that the color designations originated from the color of the push-pins early engineers used to designate affiliates of WEAF (red pins) and WJZ (blue pins).

After years of study, the Federal Communications Commission in 1940 issued a "Report on Chain Broadcasting." Finding that two corporate owners (and the cooperatively owned Mutual Broadcasting System) dominated American broadcasting, this report proposed "divorcement," requiring the sale by RCA of one of its chains. NBC Red was the larger radio network, carrying the leading entertainment and music programs. In addition, many Red affiliates were high-powered, clear-channel stations, heard nationwide. NBC Blue offered most of the company's news and cultural programs, many of them "sustaining," or unsponsored. Among other findings, the FCC claimed RCA used NBC Blue to suppress competition against NBC Red. The FCC issued a ruling that "no license shall be issued to a standard broadcast station affiliated with a network which maintains more than one network." NBC was forced to sell one of its networks, choosing to sell NBC Blue.

RCA found a buyer in Edward Noble, owner of Life Savers candy and the Rexall drugstore chain. The sale closed on October 12, 1943. The new network, known simply as "The Blue Network," was owned by the American Broadcasting System, a company Noble formed for the deal. In mid-1944, Noble renamed his network American Broadcasting Company. This set off a flurry of re-naming; to avoid confusion, CBS changed the call letters of its New York flagship, WABC-AM 880, to WCBS-AM in 1946. In 1953, WJZ in New York took on the abandoned call-letters WABC.

ABC Radio began slowly; with few "hit" shows, it had to build an audience. Noble paid to acquire more stations, among them Detroit's WXYZ; one of the founding stations of the Mutual network. WXYZ was where *The Lone Ranger, Sergeant Preston, Sky King* and other popular daily serials originated. With this purchase, ABC instantly acquired a bloc of established daily shows. Noble also bought KECA (now KABC) in Los Angeles, to give the network a Hollywood production base. Counter-programming became an ABC specialty, for example, placing a raucous quiz-show like *Stop the Music!* against more thoughtful fare on NBC and CBS. Unlike the other networks, ABC prerecorded many programs; advances in tape-recording brought back from conquered Germany meant that the audio quality of tape could not be distinguished from "live" broadcasts. As a result, several high-rated stars who wanted freedom from rigid schedules, among them Bing Crosby, moved to ABC. Though still rated fourth, by the late 1940s ABC had begun to close in on the better-established networks.

By the early 1960s, ABC Radio found its audience continuing to gravitate to television. With a decline in network listenership and far less network programming, ABC's owned local stations (like WABC and WLS) became successful playing popular music. By the mid-1960s, however, hourly newscasts, commentaries, and a few long-running serials were all that remained on the network schedule. Lawrence Welk's musical hour (simulcast from television), and Don McNeill's daily *Breakfast Club* variety show were among the offerings. *Romper Room*, a children's learning show was featured, both in New York and on ABC subsidiaries, with Nancy Terrell as "Miss Nancy."

On January 1, 1968, ABC's radio programming service split into four new "networks," each one with format-specific news and features for pop music-, news-, or talk-oriented stations. The "American" Contemporary, Entertainment, Information, and FM networks were later joined by two others—Direction and Rock.

The sale of ABC Radio

Through the 1980s and 1990s, as radio's music audience continued to drift to FM, many of ABC's heritage AM stations—the powerhouse properties upon which the company was founded, like WABC New York and WLS Chicago—switched from music to talk, syndicating several conservative talk show hosts. In addition to its most popular offering, ABC News Radio, ABC also provides music programming to automated stations, along with weekly countdown and daily urban and Hispanic morning shows.

While many of ABC's radio stations and network programs remain strong revenue producers, growth in the radio industry began to slow dramatically after the dot-com boom of the late 1990s and

the consolidation that followed the Telecommunications Act of 1996. In 2005, Disney CEO Bob Iger sought to sell the ABC Radio division, having declared it a "non-core asset." With the sale of ABC Radio, ABC became the second heritage American television network to sell its original radio properties. NBC dismantled its radio division in the late 1980s. CBS is now the only broadcast television network with its original radio link, though both FOX News and CNN have a significant radio presence.

Historic National Radio Networks—Part Four, Mutual

Those of a younger generation who are familiar with American radio and television networks today may be excused if they draw a blank at the mention of the Mutual Broadcasting System. After all, the three traditional TV networks, NBC, CBS, ABC are well known in their television manifestations and some even continue, in one form or another, on the radio dial.

But, Mutual—what's that?

The Mutual Broadcasting System operated from 1934 until 1999. The network began as a cooperative venture and provided some competition for the more-established national networks.

On September 29, 1934 four AM radio stations—WXYZ in Detroit, WGN in Chicago, WOR in New York, and WLW in Cincinnati—agreed to form a cooperative, program-sharing radio network. WGN and WOR controlled the operation (first dubbed the Quality Group), and the Mutual Broadcasting System was incorporated in Illinois one month later. When WXYZ (which had contributed the popular western program *The Lone Ranger*) withdrew to join the National Broadcasting Company (NBC) network in 1935, Canadian station CKLW in Windsor, Ontario (serving the Detroit market), replaced it. (The *Lone Ranger* remained on Mutual until 1942 under contractual obligation.)



After a year on the air, the new network carried 40 hours of sustaining (non-advertiser-supported) programs and 20 hours of commercial programming per week. The network's first coast-to-coast broadcast came in September 1936, and by 1940 Mutual had 160 affiliates, nearly 20 percent of the stations then on the air. As Mutual's stations in rural areas often had less power than the affiliates of the older national networks, many stations held primary affiliations with the Columbia Broadcasting System (CBS) or NBC and only a secondary relationship with Mutual. Nevertheless, Mutual had more affiliates than any other network—a record it held into the 1980s.

When Mutual won the rights to carry the 1938 and 1939 baseball World Series broadcasts, CBS and NBC would not allow their affiliate stations to contract with Mutual for the popular sportscasts. Mutual's complaints to the FCC led to an investigation of network radio from 1938 to 1941. In 1943 the FCC's new network rules were upheld in a landmark Supreme Court decision, helping to even the playing field for Mutual.

Mutual News

Mutual began to carry more news as the European political crisis worsened in the late 1930s. Listeners heard correspondents via shortwave during the Munich Crisis of 1938, including London representative John Steele and Berlin correspondent Sigrid Schultz (who may have been the first woman to serve as an overseas radio news correspondent). Mutual also picked up reports from various news agency stringers, including Walter Kerr of United Press.

Mutual took advantage of a cost-saving technique in 1938 when WOR began recording Englishlanguage news broadcasts transmitted by European shortwave stations (especially the BBC Empire



Service), and Mutual rebroadcast them unedited, often juxtaposing opposing sides of a story. This technique drew considerable praise from radio critics as a way of allowing listeners to hear all the points of view on the news of the day and enabling them to judge the propaganda for themselves without the commentary offered on CBS and NBC.

Mutual also presented its own very high-quality news analysts, including Raymond Gram Swing and Quincy Howe. Mutual affiliate WOL provided many of Mutual's public affairs and commentary programs, including that of conservative commentator Fulton Lewis, Jr., the public affairs panel *American Forum of the Air*, and

similar offerings. Mutual soon became known for controversial news commentators, including columnist Drew Pearson, Gabriel Heatter (who covered the trial and execution of the kidnapper of the Lindbergh baby in the mid-1930s), and Raymond Clapper.

Local affiliates were expected to feed any major event to the whole network. Mutual was the first on the air with the news of the 1941 bombing of Pearl Harbor by the Japanese, six minutes ahead of CBS and NBC. By 1945 Mutual's newscasts were a 24-hour operation, and Mutual was the first

national network to include FM stations as affiliates after World War II, by which time the network reached nearly 85 percent of the country's homes.

By the mid-1940s Mutual was also offering more sportscasts, including boxing matches, the World Series, and such football contests as the Cotton Bowl. Sports continued to be a Mutual mainstay for decades. By the 1970s Mutual also had radio rights for several golf and tennis tournaments. By the mid-1980s the network was carrying five weekday sportscasts plus nearly 40 weekend reports.

In 1978 interviewer Larry King inherited the nightly Mutual talk-show slot that had been pioneered by Herb Jepko and taken over by "Long John" Nebel until his death. King was on for 90 minutes, and listeners could call in for another 90. The program ran until 1994, airing in the afternoon for its final years.

Mutual ended its cooperative operation in 1952 when the network was purchased by General Tire and set up in New York. In the late 1950s network ownership changed several times, often within months, and none of its owners had sufficient funding to move Mutual into television. On at least two occasions, a shortage of funds threatened to close network operations, and Mutual filed for bankruptcy in 1959. The number of employees dropped to only 50, compared with 350 at its peak in the 1940s. The network faced a scandal when it was discovered that one short-term owner had secretly accepted money from a Caribbean country in return for favorable comment on the air, and Mutual lost 130 of its affiliates.

Ownership changes continued as the network shifted its headquarters from New York to Washington, D.C., in 1971. In 1972 Mutual began special network feeds to African-American and Spanish-programmed stations with news and sportscasts.

Mutual signed a contract with Western Union in 1980 to use its satellite facilities, thus becoming the first radio network to employ satellite distribution. Aided by that, Mutual served 950 affiliates by 1979, but the number slowly declined.

Mutual was purchased by Westwood One in 1985. In its last 15 years Mutual largely produced newscasts. Westwood One closed Mutual on April 18, 1999, but its newscasts continued under the marketing name of CNN Radio.

An interesting and unique feature of Mutual in its later years were its distinctive "Mutualert" network cue tones, or "bee-doops" as they were frequently called. While it seems that they were never intended to become identified with the network, as the NBC Chimes became for that network, they were heard at the beginning and end of Mutual newscasts, programs, between commercials and network identification breaks. The "bee-doops" were retained by Westwood One for several years after it closed Mutual. They can be heard here: https://www.youtube.com/watch?v=FDqr7ruPxM.


NRC Antenna Pattern Book 8th Edition
