DELETED?

710 WEKCt KY Williamsburg – 1/1 1746 – This is deleted? Poor, with C&W, Gospel, Southern Gospel and 'Mountain Music' for 25 minutes (from 1746 -1811.) No IDs, talk, nothing! You can listen via SDR http://scottgs.dynip.com:8073/ where they run ads for local businesses and Legal IDs beginning at :00 (WEKC is DAYTIME ONLY). WOR in null. BEFORE ANYONE SAYS "NO". . . One Might Remember Deleted WCAZ (Carthage, Illinois) Years Ago. (JJR-WI) [FCC says 'Deleted'. But who knows what is going on in Williamsburg? – Ed.]

DELETED!

1480 WGVU MI Kentwood – 1/4 1805 – I listened mostly online during their last few days, but also some on 1480. I listened to the last few hours on 1/7, which included Bob Mason talking to past announcers, many of whom had radio careers going back 50 years, and the last oldies, with a pop music montage. The last song played was Oliver's 'Jean', which was the first song Mason ever played on the radio, on WZZM-FM in September 1969. A final announcement ended the broadcast at 1/7 1405. WGVS-850 also off but not heard at this time. Fun to listen to. (KDF-IL)

PIRATE ACTIVITY??

1590 WHOT FL Palm River-Clair Mel – 1/14 0800 – Man with canned WTPA ID (these are the OLD call letters!) then mostly auto-tuned dance/hybrid soca vocals, frequent live IDs by Caribe-accented announcer as "WZOP" and lots of commercials, including a Miramar, Florida pre-1975 cast iron pipes attorney, a store in the Galleria Mall (Ft. Lauderdale), and Coconutz Fusion Café at 2408 State Road 7 (Miramar). My initial thought was that this is a Southeast Florida pirate fading up as WHOT fades down. But WZOP is actually WZOP-LP, and their YouTube etc. presence and FCC dB confirms 92.7 MHz Ft. Lauderdale at 22 Watts. Their logo also states 96.1 FM, which is WZPP-LP at 48 Watts, and "The Voice of the Caribbean" slogan. See co-branded website at https://wzppradio.com/ WZOP-LP is licensed to "Hollywood Brothers Helping Others, Inc." while WZPP-LP is licensed to "Broward Jewish Alliance, Inc.". I alerted others, including John Santosuosso in Lakeland, FL -- closest contact to Tampa -- who confirms it's WHOT, giving triple WTPA [invalid], WZOP, and WZPP IDs and a "1590 Voice of the Caribbean Tampa" ID. Also heard poorly by Craig Cook in Oviedo, NE of Orlando. There's so many questions and violations here: why is WHOT not properly IDing? Why on earth are they relaying an LPFM, much less from a different MSA 250 miles away? And clearly, WZOP-LP is in blatant LPFM violation themselves by airing commercials, not program sponsored credits. Checking the N02CW Pembroke Pines, Florida KiwiSDR remote, I get a weak 1590 kHz parallel to the signal I have, presumably the daytime power of WHOT at 9800 Watts making it to Southeast Florida. Signal here in Northwest



Florida faded out around **0830** ET. Format has been Haitian Kreyol until now. **(TK-FL)**

The show debuts January 10th, and originated from British Columbia: Ben currently lives in Victoria, but it is unclear if he will move to Vancouver. The following stations air the show: CHED-630 Edmonton, AB; CFMJ-640 Richmond Hill, ON; CJOB-680 Winnipeg, MB; CHQR-770 Calgary, Alberta; CHML-900 Hamilton, Ontario; CKNW-980 New Westminster, British Columbia; and CKPL-980 London, Ontario.

1040 CKST BC Vancouver – Concerning KXPD-1040 Tigard, Oregon: a little research indicates that Vancouver's original 1040, CIOF, was on the air before KXPD, which means that CKST does not have to protect the Oregonian. As previously mentioned, CKST only protects KBLE-1050 Seattle, Washington with its day pattern, as KBLE was originally a Daytimer. At night, CKST's only Null, which is extremely Deep, protects WHO-1040 Des Moines Iowa.

- **1230 CJNL BC Merritt** Moved to FM, and was sold last year to Pattison Media, after the local owner, Elizabeth Laird, was diagnosed with cancer. She passed away on December 31st at the age of 73. Laird purchased the station after learning about it through her son, who was CJNL's Morning Show Host. As the only female independent broadcast owner/operator in British Columbia, Ms. Laird prided herself on giving broadcasters their first working experience.
- **1240 CKMK BC Mackenzie** As "99.3 Rewind Radio", it is licensed as a repeater transmitter of CKDV-FM Prince George, with no local programming. The name has changed from "The Drive", but the music remains Classic Hits from the '80s and '90s, with some '70s and 2000s also included.

INTERNATIONAL NEWS

SLOVAKIA: At the end of the month, medium-wave broadcasting from Rimavská Sobota will be switched off. On 31 January 2022, the Slovak Radio and Television will end the operation of the Rimavská Sobota – Uzovská Panica medium-wave radio transmitter on the frequency of **1521 kHz**.

The transmitter is located in the area of the broadcasting center, from where it has been broadcasting on shortwave since the mid-1950s. The dominant feature not only of the area, but also of its surroundings, are several up to 170 meters high masts from the turn of the '70s and '80s, which serve as beams for the antenna field of a shortwave transmitter. It is no longer in operation, it was shut down in 2011. The mid-wave transmitter is a stand-alone mast that was built in the second half of the 1980s. At that time it was a novelty, the technology was supplied by the company Tesla Hloubětín. "An interesting and European first was the operation of technical equipment (filters), which allowed the connection of all three medium-wave transmitters, transmitting on three different frequencies, to one antenna, which consisted of a 102-meter-high iron lattice mast," said the current operator of the transmitter, Towercom on its official website. While the transmission from Rimavská Sobota on short waves was terminated more than a decade ago, the medium-wave transmitter with a radiated power of 10 kW still works today. In recent years, RTVS has used it to broadcast Radio Patria broadcast for minorities from 6:00 a.m. to 6:00 p.m. and has recently been supplemented by Radio Devín. "The RTVS decision reflects the change in listeners' preferences and allows RTVS to continue modernizing terrestrial radio broadcasting. The funds so far intended for signal propagation via the Rimavská Sobota medium-wave transmitter will be invested in the



development of Slovak Radio digital services, especially in DAB+ broadcasting," said RTVS. Broadcasting on medium waves in Slovakia will thus continue from February on only two transmitters – in Nitra at **1098 kHz** and in Košice at **702 kHz**. RTVS has signed a contract for these two transmitters until the end of 2022. [www.radia.sk via Ron M. Lackovič, mediumwave.info]

Even though it's no longer 50 kW, the station's transmitter is about 12-15 miles from me and stronger here than when in Queens, thus harder to DX around. So it goes in ourDX'ing world.:):)

Pete Taylor mentioned in a recent muse that he wondered where WCAS alum Ben Farnsworth went. I don't know Ben personally, but certainly heard him for many years as an anchor and reporter for WCBS-880, and later for WNBC-TV.

Recently added a radio here that I've wanted for years, the SONY ICF-S5W. Aside from its great sensitivity, I was always mesmerized by radio dials which had call letters on them. While I also have the SONY ICF-EX5 MKII with its great dial and performance, to have call letters on a dial (and in the case of the S5W, a rotatable drum) from early in my DX life was, and is, a big attraction. Also

relatively new to the shack is a Zenith Trans Oceanic D-7000Y from the late 70's. My interest in Trans Oceanics was piqued when getting the John Bryant book on the entire history of the radio. In a very brief and nonscientific comparison of those three radios and my CCrane 2E, the Zenith has the best selectivity (excluding the sync on the EX5 MKII). Sensitivity wise, the Zenith did well on a couple channels but lagged ever so slightly behind the other three. I'd have to give the DX edge to the ICF-S5W – when DX'ing recently on 1240, I was able to dig out a station better than the others with, what I call, the S5W's better "audio clarity." For



program listening, the Zenith clearly get the nod - what a well made radio for its day. To complete my "wanted" collection, I just got the revered Panasonic RF-2200. Quick check has it living up to all the hype. When the weather gets better, I'll do a more thorough comparison of the aforementioned radios. 73!

I've been back in Demarest NJ for the past two weeks. This time I brought my Airspy R2 + Spyverter, the RSPDx and the CCrane Skywave SSB along with a YouLoop and a preamp. Unfortunately my favorite antenna, my 3 foot amplified loop, was too big to bring. Conditions have continued to be less than ideal on the AMBC, but I did log one or two new stations, CKDO 1580 and WTKT 1460, plus three tentative ones on 1580 – WHLY, WGYM and WVZN.

I ran the RSPDx with amplified You Loop overnight with the scheduler set to record at the TOH and around the half-hour for about 13 hours and the CCrane barefoot with the SONY recorder, both set to 1460. Nothing showed up on the RSPDx but WTKT was present from midnight to until about 5 am when WVOX became dominant. Using the same set up, I tried for the KQKD test but local WKAM was the only thing I could hear 1380 all night on both. Onward to 550, the DXCentralonline challenge for the week of January 16!

Unreported Domestic Stations

For the second straight issue, no stations on our unreported list – that is, U.S. and Canadian broadcast stations (100 Watts or more) that have not been reported to DDXD since at least Volume 67 (1999-2000) – appear in DDXD this issue. Our closest was CFAR-590, last reported in Volume 69 Issue 13. So we will hold with 242 stations on the list. The most recent update of the list was in issue 88-18, but an updated copy is available on request from <u>NRCDXNews@gmail.com</u>.
