Radio Ink: Cumulus Shutting Down Arkansas Radio Network

According to a report in Arkansas Business, after more than fifty years of broadcasting news, sports, and farm market reports, the Arkansas Radio Network will be signing off next month. Based at KARN in Little Rock, the network is owned by Cumulus.

PD Toby Howell sent an e-mail to 18 affiliates letting them know that the network will be ending its news and information programming on March 20.

The report says the Howell e-mail thanked the affiliates but gave no reason for ending the network. "We have appreciated the opportunity to serve your news and information needs, and we will continue to do so for the next 30 days so that you may transition to a new service."

The network launched back in 1967 as the Delta Farm Network. In the 1980's the network was heard on nearly 70 Arkansas radio stations. (AM Radio Log Symbol "Ar")

Radio's Very Low Frequency (VLF) band is defined by the International Telecommunication Union as 3-30 KHz. Its widespread use is having a positive impact on some areas of Space near Earth. From 1905-1925, VLF was used for transoceanic telegraph communications. Navigation beacons followed for ships and airplanes. Today, submarines can receive signals under water from 20 kW to 2 Megawatts VLF transmitters. VLF can travel into space where it interacts with charged particles, enhancing the magnetosphere that protects the Earth's atmosphere from the destructive effects of cosmic rays. The Van Allen Belts, where the magnetosphere stores cosmic rays, now begin farther from the Earth due to the wide-spread use of VLF.

A century ago, in March 1922, the City of Vancouver had three major daily newspapers. During that same month, Vancouver went from zero to three radio stations, as those three newspapers scrambled to be the first on the air with daily programming. SUN TO INSTAL WIRELESS SERVICE (spelling theirs) appeared across the bottom of the front page of The Vancouver Sun on March 7, 1922. The Vancouver Daily Province was actually the first on the air, on March 13, 1922, the signal making it over The Rockies to future CFCN owner W. W. Grantin High River, Alberta, despite broadcasting on 2000 meters (150 kHz). "For the first time in the history of the Canadian West, radio 'waves' carried the news of the day to scores of districts, many of them so much beyond the reach of the mailed evening newspaper that news with them by ordinary channels is often three or four days old." It was not until late June 1922 that they moved to 440 meters (about 680 kHz). The Vancouver Sun began broadcasting at 8:00 PM on March 15, 1922 using 200 meters (1500 kHz). And the Vancouver Daily World began regular programming at 2:00 PM on March 23, 1922 at 360 meters (about 830 KHz). That

newspaper was selling a crystal detector receiving set for \$25 that was guaranteed to receive the station at a distance of 50 miles.

- ON Ear Falls The CBC has again applied to move this 40 watt CBC Radio One Low Power Relay Transmitter to 95.5 MHz with 130 Watts non-directional at 41.3 feet Effective Height Above Average Terrain (EHAAT). The station simulcasts CBQT-FM in Thunder Bay, Ontario. A similar application, with different EHAAT and power, was approved in 2018, but expired on February 5, 2022, after being granted a one year extension when the original FM transmitter planned for Ear Falls was used for CBQP-FM Pickle Lake, Ontario, after CBQP's transmitter was destroyed by fire.
- 740 CHCM NL Marystown This 10 kW AM transmitter is no longer on the air, as CHCM-FM's three-month license to simulcast on 740 kHz expired. An exact date is not known but it was definitely off the air before the end of February. CHCM-FM continues to simulcast VOCM-590 St. John's.




NRC Antenna Pattern Book 8th Edition

Unattended IQ recording, a feature of SDR programs, or just recording one frequency over a period of hours, has a lot of positive aspects. It can be a great convenience when I can't be at the receiver during prime DX times. like sunrise and sunset or overnight. And nothing beats the ability to schedule top of the hour or half hour recordings for several hours across the entire BCB. The ability to go back and listen to a recording over and over often yields IDs that were missed the first or even second time around. Finally, having a recording is a good way of validating and recalling receptions, though admittedly not as much fun as getting a QSL. However, there's a few downsides to all this convenience. One drawback is the inability to switch antennas or make other adjustments when you aren't sitting at the receiver. Instead of spending an hour or two at the receiver, I find I'm spending several hours playing back recordings and sometimes several days worth pile up. I sometimes resolve not to make too many lengthy recordings, but I've developed a severe case of FOMO (fear of missing out) and I haven't reached the point of stopping yet.

For those of you who use unattended recording, either IQ recordings or just one frequency at a time, how has that affected your participation in the hobby?

Noise Ingress Testing and Reduction

I've put together some thoughts and techniques that I and others have developed and used over the years to determine where the receiving system needs improvement. I hope that some of these ideas might be helpful as you battle your own noise problems.

Sometimes it is hard to know where to start. I've heard this test suggested many times but it's a good first step. Using a battery-operated radio that can hear the noise you're trying to eliminate or your SDR on a laptop, listen to the noise and then shut off all of the electrical circuit breakers to your residence. If the noise disappears or is reduced, you know you can make an improvement by locating and eliminating the sources that are local to you and that you have control over. Turn on the circuit breakers one at a time to see which circuits power the offending devices. Then, one circuit powered on at a time take your radio and begin to unplug or disconnect devices until you find the noise source. Once you know what the problem is you can research how to clean it up. If the noise does not appreciably change, then you know the main noise source is outside your residence and it's something that you don't have direct control over.

If you don't control the noise source the next easy step to take is to use that battery operated radio and on the medium wave band and walk around. Check the immediate area of your residence to see where the noise is loudest. Rotate the radio to put the end of the ferrite bar antenna towards suspected noise sources and see if the noise level decreases. This isn't going to help you much if the noise frequencies are higher than mediumwave, shortwave for example. If you have a radio that will take an external shortwave antenna, a simple one turn two to three foot diameter loop out of hook-up wire and a 365 pf series tuning capacitor can be coupled to the radio via a much smaller secondary loop and then into coaxial cable to the radio. This loop is tuned to resonate on one of the noise frequencies and you null through the center. The power company will use something similar to this to look for leaking insulators and other faults on the power grid. Remember, should you think it is a power pole issue, tilt the loop to put the null overhead and towards the suspected offending equipment. And of course, it goes without saying, be careful. If you can identify a power grid issue, reporting interference by the power grid to broadcast program reception to the appropriate power company department will get this resolved. If it is something else, then it's down to detective work and social engineering. A neighbor may not know that they have a device failing and have a potential fire hazard unless you mention it to them. In my experience they're grateful to have you help them determine what is possibly failing. But your mileage may vary, and the problem is not always a failing device.

Now, assuming we have done all we can with the noise sources we control, let's talk about testing and tightening up noise ingress on our receiving system.

The first thing you will want to do is to find out where the noise is getting in. Of course, if that's the antenna then we can skip all of the next few suggestions, but if you don't try them, you'll never know if it actually *is* coming in via the antenna. You might want to post to this group's email list and tell us about the antenna you're using and ask for suggestions before doing any of the steps below.

One of the simplest things you can do is to install a common-mode choke effective at the frequencies of interest at the antenna end of the coax to see if that affects anything (more on what constitutes a good choke below). It's possible that the noise will disappear. But, to dig deeper and see just how well your shielding is handling noise ingress, see the steps below.

Here is what I do when I want to test for noise ingress:

First, get yourself a shielded terminating cap. It doesn't have to be 50 ohms. A 75-ohm CATV terminator cap works too, but it should be 100% metal and shielded. You can use a low wattage all-metal dummy load, and these are available for about 20 USD. A larger dummy load you might have or borrow will work too, but it must be 100% shielded. So, the usual open-holed case type dummy load won't work. If you're just doing this for the SDR or a receiver, get a CATV 75-ohm terminating cap and adapters to fit the connectors on your SDR or receiver and the connectors on the ends of your coax. I have some SMA 50 ohm terminating caps I bought cheap on Amazon, and I keep any unused SMA ports on the SDR covered with these caps. Do not make up jumpers for this, you want full metal adapters. I.e., everything fully enclosed 100% in metal.

Next, disconnect all of the antennas from the SDR or receiver. Place the terminating caps on the antenna inputs, and a short jumper from both antenna connections to the ground connection on the green 3-terminal Hi-Z input if you have that too.

Then start the SDR app or tune the receiver and see what the noise floor looks like. It should not have any evidence of the noise interference you were seeing. The spectrum should be nice and flat

and at a very low level. If it isn't there is something wrong with the shielding on the SDR or the receiver or you have something going on with the PC. Your USB cable from the PC to the SDR should have ferrites on each end. And it should be a shielded USB cable. As others on the list will tell you too, ferrites aren't the be-all end-all for common-mode rejection since the core type and turns through them greatly affect this. So, the solution needs to be engineered, and no one design will do it all. But it is a good starting point. I find the USB cables with a ferrite on each end work fine for me here. If this is a laptop, pull the AC adapter and see if the noise goes away. If it does, you have a noisy switching power supply in the power adapter and that noise is leaking through the USB power connections into the SDR. You can't redesign the laptop so your fix there would be to find a clean AC adapter to use (if you need AC power while receiving). If this is a PC then a better power supply may be the next step, or a shielded case if you have the cute windows in the case for gamers that destroy the case shielding. Turn off everything but the PC itself and use headphones to listen to see if this is the PC itself while the SDR app is running. If the noise is still there it's the PC. Now you have to determine if it is the case or the power supply. Some aluminum foil wrapped tight around the PC case (temporarily or you'll overheat it) and cables is a simple test to see if better shielding affects the noise. The foil test works on an SDR too. If the PC case is all metal and has no windows you're probably just fine on the case, but it's a simple step to get the case out of your head as a possible problem. In some of the smaller and "cute" little PC cases you really won't have much choice in alternate power supplies. I have a full size fully shielded PC case and after I tested a few power supplies I wound up with a Corsair AX1500i (the current model is an AX1600i, I think). It's well made, and though I don't need the 1500 watts for my PC, if I'm under 500 watts load it's dead quiet because the fan doesn't need to run. Additionally, it has many separate power rails. I have a 4-port USB PCIe card by StarTech that uses 4 separate Renasys USB chipsets that I connect my SDRs to (it's been absolutely flawless under Windows and Linux). The card has a separate power connector for the USB port power; its a 4-pin CDROM drive type connector, and that I have connected to a separate power rail on the Corsair power supply. So, no power for the SDRs comes from the motherboard card slot and I'm isolated from everything else in the PC. It's quiet and clean noise-wise. Hopefully you will see a clean spectrum when you test the PC and won't need to look further into the PC case or power supply. That's usually the case. Monitors are another thing entirely. Some are dead quiet, and some are terrible. If a monitor has a noisy external power supply, you might be able to replace that. I've been known to haunt my local PC parts store with a portable radio testing to see which monitors are quiet and which aren't. Asking for recommendations from others is a good way to avoid some PC or monitor you have to try to fix.

Now with the above done and testing OK, on and out from the SDR or receiver.

Connect the coax to the antenna to the SDR or receiver antenna port. Then at the antenna end of the coax cable disconnect the antenna and connect the terminating cap to the coax. Look at the spectrum on the SDR app or the receiver again. It should still be nice and flat. If it isn't then you either have something wrong with the coax, bad or cheap coax, or improperly installed connectors, or possibly some combination of the three. Get that fixed before you do anything else. Test any coaxes to antennas one at a time.

Once the coax is ingress tight and anything has been fixed that needed to be, then connect the antenna. See what the spectrum looks like. If it's bad again then we need to determine one other thing. Depending on the antenna in use, the antenna itself may be allowing noise picked up on the coax run and not really there at the antenna to get onto the coax inner shield surface and then into the SDR or the receiver. A common-mode choke at the antenna end will stop this if that's the case. A well-designed commercial antenna should have this handled as a part of the design. A doublet or dipole type antenna directly connected to coax will not stop this common-mode noise ingress. Most baluns won't either because they are built in plastic boxes and nothing but wires inside. A balun in a metal box would generally work well. And a common mode choke designed for the frequency range you are looking at on that antenna installed at the antenna end of the coax will. But not all common-mode chokes are created equal.

So, let's talk about how coax works. There are three surfaces on a coaxial cable as far as RF (radio frequency) is concerned. The outer surface of the center conductor, the inner surface of the shield, and the outer surface of the shield. This is because of the skin-effect. RF does not flow on the entire cross section of a conductor like DC or low frequency AC does, but just on the surface of a conductor. The shield on a coaxial cable actually has two separate surfaces as far as RF is concerned. The energy from the antenna appears as an electric field between the outer surface of the center conductor and the inner surface of the shield. If the coax is well made and the connectors are installed properly, noise on the outer surface of the shield can't make the transition to the inner surface of the shield and get into the SDR or the receiver. The above-described tests check that the inner surface and the outer surface of the coaxial cable shield are isolated from each other.

Now a bit about common-mode chokes and that point at the end of the coaxial cable that connects to the antenna. If you are using a beverage, a flag, a Kaz or Dkaz, or an antenna something like these, then you may possibly have a ground rod at the antenna feedpoint that connects to the coaxial cable's shield. This may give you the isolation that you need. It will also allow for possible ground currents to flow along the coax cable's shield towards or away from the shack end of the cable. The discussion of a ground system is something that can be researched, and I won't dwell on this in any detail here but suffice it to say that you don't want induced currents from lightning or other things flowing on that coax cable's shield. A balun or unun or other type of coax cable isolator might be helpful here to prevent these currents either at the antenna end of the cable or the shack end or both. Usually this is something you will need to test and try as you add or remove things to get where you need to be on ingress isolation and maximum front-to-back ratio on the directional antenna. A common-mode choke would also be a good idea at one end of the cable, and likely best at the antenna end to handle any ingress from direct antenna connections or baluns or other matching devices that do not maintain coaxial cable shield surface integrity, or on both ends of a long cable run. A properly designed common-mode choke must maintain shielding integrity on its output to not allow noise ingress from its input onto the inner surface of the shield of the coaxial cable its output is connected to. It must present a high impedance to currents flowing on the outside of the coax cable shield at the frequencies of interest. For receiving use, I like the common-mode chokes that are built on a piece of low-loss coaxial cable and consist of a series of stacked toroid cores of a sufficient length and core type that are either slid tight right over the cable outer jacket or wrapped securely through the cores several times to provide a large enough impedance to block any appreciable currents from passing them in either direction on the shield of the coax. This type of common-mode choke design presents a mostly resistive impedance to the currents on the outside of the coaxial cable shield.

The above testing is a bit of work, but once you have the necessary stuff at hand it really doesn't take too long to run through. I have used these techniques many times to get things tight and clean.

Once you have the coax cable feedlines ingress tight, another thing you can do is to see if you can find an antenna placement that reduces or largely eliminates the noise. Try a few alternate antenna locations and setups and see if you can improve things. If you can't, you could try a magnetic loop and see if the noise source is at an angle that responds to you nulling it out with the loop. The test loop antenna I described above is something you could try before you spend anything on an expensive preamplified broadband magnetic loop antenna. Lots of people swear by these commercial broadband receiving loop antennas for noise reduction via nulling.

And lastly, these days using an outboard phaser or the diversity capability of an SDR like the SDR play SDR Duo you can phase two antennas together to either create useful patterns for DXing or to reduce noise. If all you're trying to do is reduce noise, a second antenna that gets mostly noise can be used phased against another antenna that gets mostly the desired signal. I have been using these techniques very successfully with the SDR play SDR Duo for the past several years, not only for noise reduction but also on mediumwave to DX on a crowded channel. I can adjust the antenna pattern by phasing two different loop antennas together to separate stations on the channel. So, even if you can't get the local noise level down to a level that would satisfy you, you might still be able to reduce it to a level that still lets you enjoy DXing by phasing.

My hope is that someone else might find some use for any of the above ideas.
