

Aurora conditions 100 or more miles away but not locally, can provide some interesting DX, as it did over the last week. Closer stations disappear completely, leaving more distant stations easy to hear. Easy to be fooled, for example, on 800 KHz when Country music appeared, all alone, knowing that CHAB and CKOR would never consider playing the song. It was KBRV in Soda Springs, Idaho. [See Issue 1 for Jon's report of this!! – **BH**]

It's hard to believe that two hurricanes in a row caused so much damage, including loss of life. First it was Hurricane Fiona, then Hurricane Ian. Nearly a week later, most of Cuba is still without power, though most of its radio stations appear to finally be back on the air.

530 CHLO

ON Brampton – Hurricane Ian's direct hit on Cuba created power blackouts almost everywhere. All three Cuban transmitters on 530 kHz were off the air, with CMBQ first heard in Edmonton early on September 30th. CHLO's 250 Watt night power from their tall tower is worth looking for on any SDR recordings made when CMBQ was off the air. And definitely worth watching for in the future. Especially since the former station on 530 in the Turks and Caicos Islands was being rebuilt, though there is no word on damage from Hurricane Fiona's direct hit on the islands.

- 750 CBGY NL Bonavista Bay Music heard here confused some DXers expecting all talk from this CBC Radio One station, which simulcasts CBG-1400 Gander. With WSB off the air several overnights in a row this past week, CBGY was heard in several Eastern locations, thanks to both of its 10 kW patterns having lobes to the south day and night. The night null is towards the west. CBC Radio One does air a few music programs.
- 750 CKJH SK Melfort Despite the Beach Radio branding, do not expect to hear Carolina Beach Music, which some Eastern DXers were expecting with WSB off the air overnights for tower work. Classic Rock is the official format, focusing on the '80s and '70s, with a touch of '60s, including the requisite large dosage of Canadian Content (CanCon).
- 800 CKOR BC Penticton Play-by-Play: Penticton versus Cranbrook B.C. Hockey League game marks the first report of anything but automated Adult Contemporary oldies, splitters, commercials and local announcements from this station in the last 15 years. Noted September 24 just before 2300 EDT. Top-of-Hour male-voiced splitter at 0100 EDT on September 29 was simply "CKOR Penticton, an i-Heart radio station." Music seems to be a lot "bouncier" since the switch from EZ Rock to Bounce Radio branding. The station, formerly CKOK, is 10 kW during the day but has been only 500 Watts at night since 1950, presumably opting for the lower costs of a single tower.
- 930 CJCA AB Edmonton Reportedly absent overnight for an hour or two lately, presumably Open Carrier as the Edmonton area DXer did not report hearing anything on 930, but did log stations on 920 and 940.
- **1130 CKWX BC Vancouver** Recently heard in Fort Smith, Arkansas, over KWKH. The Amber Alert signal, alternating two sets of three square wave tones, really stuck out.
- **1140 CHRB AB High River** Recently heard in Fort Smith, Arkansas, sometimes dominant, while running "Focus on the Family."
- **1280 CFMB QC Montreal** One of many 1280 stations being heard lately in Seattle, thanks to usually dominant KIT fading out completely for up to several hours at a time. Ethnic format means a variety of programming and languages, including, according to cfmb.ca, instrumental music from 0000-0500 EDT Monday, Wednesday and Thursday mornings.
- 1340 CBLB ON Schreiber CRTC approval for a change in power and tower height of the FM replacement probably indicates that CBLB-1340 is still on the air, especially given the usual three month overlap for AM to FM flips. CBLB-FM is now licensed for 166 watts at 31.2 metres above average terrain, still to be on 90.9 MHz. CBLB is a rebroadcaster of CBQT-FM Thunder Bay, a CBC Radio One station.
- **1400 CBOF-4 ON Rolphton** The CBC has applied to move this CBOF-FM Ottawa LPRT to FM, on 98.5 MHz with a non-directional 129 Watts from 18.2 metres height above average terrain. Part of the Ici Radio-Canada Première network, formerly known as the CBC French AM network.
- 1470 CJVB BC Vancouver This 50 kW station has finally been reported to the NRC as being heard after more than 20 years without a report. The DXer was in Spokane, Washington, where he would be far enough East to miss the deep null, at about 500 Watts equivalent signal, protecting KBSN Moses Lake, Washington. A second deep null protects KELA Centralia-Chehalis, Washington.

The Facebook page 'Canadian Radio News' by **Dan Sys** provides much of the information for this column, with additional tips from **Stan Weisbeck**.

810 KGO CA San Francisco – 10/6 1315 – Without prior notice or warning, 810 KGO San Francisco suddenly ceased their talk radio format and began stunting with selections of contemporary music, whose lyrics have to do with money and gambling, along

with teasers mentioning betting on sports and sports in general. Further they are inviting listeners to tune in to the "New KGO" beginning Monday morning **October 10**. Widespread speculation on the Internet is that a new format based on the BetQL Audio Network, or something similar, is going to happen at that time. **(EC-CA)** As we go to press on the morning of 10/10, "810thespread.com" seems to be the new web site. - DY

- 560 **CUBA** *R.Rebelde*, Ciego de Avila OCT 9 1000 Under WVOC; digital splash attention signals, fast cuckoo stinger, "Rebelde, la Habana, emisora de la revolución," parallel 670 and 1620 kHz. [Conti-NH]
- MEXICO XELRDA Piedras Negras, Coah. OCT 2 0000 Top of the hour ID by female, "Transmite... Coahuila, México, La Rancherita del Aire... XHEMU... FM... La Rancherita del Aire," then males with singing jingle; fair to good signal, relog. [Niven-TX]

Robert Vance speaks: I've been using the diversity mode in the RSPDuo/SDRUno for the last month or so, instead of external phasing. Overall, I am pleased with it but it does make listening a bit different since it's in the software itself. It's easier to eliminate a signal since you're using mouse clicks and drags instead of adjusting pots. The manipulation of the two antenna inputs in the software means that signals will suddenly pop up and often just as quickly vanish. What I haven't tried yet is using the output of an external phaser into one of the SDR inputs and then further processing it in the SDR's diversity mode. I'll try to find the time someday.

TRANS-PACIFIC DX

KIRIBATI *R.Kiribati*, London, Christmas Island SEP 26 0637 – JBA carrier surely from *R.Kiribati*; and a stronger one on 855, probably Spain oppositely. SEP 27 0702 – Cannot detect a JBA carrier, local noise level is higher than usual. But Ron Howard heard and recorded it at 0658 UTC. SEP 28 0650 – No JBA signal. Gary Pence KM5X reports from trying the Hawaii

remote, "846 no show as of 0521 UTC." And Ron Howard reports: "On Sept 21 (Wednesday), I also found 846 was noticeably silent. Yes, off the air again today (Sept 28 – Wed). Regular schedule must be off the air on Wednesday and Sunday, as we have been observing." SEP 29 0656 – JBA carrier, back on after another silent Wed. OCT 1 0642 – JBA carrier, stronger than usual so can almost imagine some modulation. OCT 4 0634 – JBA carrier. Nothing else on 9/kHz splits, any lingering TAs propped out. Gary Pence KM5X at NH6XO Hawaii remote reports, "I checked 846 at 0445, not on yet; checked again 0525, it's on now." OCT 5 0621 – No signal here, but Gary Pence KM5X reports, "I didn't check 846 until 0428 and they were on already." And Ron Howard, "Recently observed while listening at Asilomar State Beach, California, R.Kiribati, anomaly this week? Not on the air Oct 3 (Monday), when they normally would be broadcasting; heard Oct 4 as usual; on Wednesday Oct 5 they were heard on the air from 0600+ UTC, a day that would normally be off the air." So perhaps it go and come on an irregular basis, even within a single night. OCT 6 0632 – JBA carrier presumed R.Kiribati; only other 9/kHz carriers in bottom half are 774 and 684, likely Spain remnants. Simultaneous TA/TP demonstrates what great DX range MW can have. OCT 8 0703 – JBA carrier, no other 9/kHz splits in quick scan of longer MW. OCT 9 0635 - No JBA carrier, as typically silent Sunday nights. [Hauser-OK]

Mike Beu speaks: I've been catching audio on 1611 kHz at my local sunrise – no doubt Australia but have not captured enough audio to ID – will keep working on it.

NRC Antenna Pattern Book 8th Edition



First, to answer Ken MacHarg's question from his "Radio History Revisited – Live Music" feature article in the October 4 *DX News* (DXN 90-01), "Is there any live music that you know of which is broadcast on North American radio regularly?" Yes, I believe 650 WSM still broadcasts the Grand Ole Opry live every Friday and Saturday night, as it has been done for decades. Ken mentioned, "You can write to me at the email address below," but the email address wasn't published, so I'm answering here, while also answering editor Linda Brodsky's challenge for each member to submit at least one musing. Call me the answer man, hi!

Most *DX News* readers will recognize me as the International DX Digest columnist. I wasn't always an international AM broadcast DXer. I got started like so many, first introduced to the DX hobby as a shortwave listener. I never realized that AM DXing was a thing, and never knew that AM radio stations would QSL. I initially learned about AM DXing from magazine articles either in *Popular Electronics* and/or *Elementary Electronics*, where I read about the National Radio Club. I joined the club sometime in the '70s and have been addicted to AM broadcast DX'ing ever since. My primary DX receiver back then was a Heathkit SW-717. Taking the time machine a few years earlier, my father was building a Heathkit color TV, and I was so curious that dad bought me a portable radio kit to build, just to get me out of his hair. Shortly after, I upgraded to the SW-717. Little did he know that it would lead to a high paying job in electronics and the DX bug, although I actually started my professional worklife as a DJ and radio announcer before finally getting serious about engineering, briefly at 1450 WKRI and then 91.7 WRBB while moonlighting as a nightclub and roller disco DJ. At WKRI radio I worked with Jim Roberts, that was his on-air name, who later became investigative reporter Jim Taricani at WJAR-TV.

I remember when 640 KFI Los Angeles could be received coast to coast, although I never QSL'd it. I wrote reception reports typically covering a full hour or more of programming, as it was customary for short wave. KFI reception was never good enough for a full hour of program details, at least not with my random wire antenna connected directly to the receiver without a proper matching transformer and lead-in, a no-no by today's standards. My first QSLs were from relatively easy catches such as 760 WJR, 840 WHAS, and 870 WWL.

Thanks to the numerous get-togethers that once upon a time were held throughout New England, including the legendary Musings editor Ernie Cooper's annual event, I met Mark Connelly and Neil Kazaross who introduced me to the art of international medium wave DXing. Unlike today with the technology of noise-reduced broadband directional antennas, phasing, and the sharp filtering of SDR receivers, it was much more of a skill to be able to tune in those 9 kHz spaced transoceanic signals, requiring one-on-one demonstrations and practice to acquire the skills. In fact, it wasn't until years later when I realized that the BBC signal received at 1088 kHz on the SW-717 wasn't a short wave spur, it was my first transatlantic reception!

Half the fun of DXing is building antennas and, of course, building a collection of receivers. Primary receivers of the past have included the Realistic TRF, Kiwa-upgraded Sony ICF-2010, Lowe HF-225 Europa, and Drake R8B, before becoming an early adopter of SDR receivers with the RF Space SDR-IQ. Now my primary DX receiver is the WiNRADiO Excalibur SDR. My first MW-specific antenna was the Worcester Space Magnet. Early antenna experiments got serious with a Ewe antenna which eventually led to the accidental development of the SuperLoop when the bottoms of the Ewe verticals were connected to try to improve grounding. Still occasionally use an old-school LC-tank phasing unit too, the MWDX-5 designed by Mark Connelly.

So that's my story in brief about how I got started. I still enjoy domestic and international AM broadcast DXing, although now I'm more into hardcore DXing and DXpeditioning, listening more for the catches and less for the programming. I take a break from AM to dabble into FM DXing during the summer, for which the music programming is more enjoyable overall. I miss the good ol' days of Top 40 on AM radio, listening to 550 WGNG and 630 WPRO locally, as well as 660 WNBC and 1520 WKBW among others more distant. AM and FM logbooks are maintained on my BAMLog! website at www.bamlog.com.

In addition to DX'ing, extra-curricular activities include distance running as a member of the Gate City Striders racing team (Pittsburgh NRC Convention host John Malicky was a distance running DXer too), strength training a couple evenings a week at the gym, photography as a juried Associate Colleague member of the New Hampshire Professional Photographers Association, and a Siamese

cat who requires my attention. Believe it or not, there's a Facebook group named "Cats and Radios" where members post photos of, yes, cats and radios. Looking forward to retirement in a couple more years to become a fulltime DXer and cat person. Any more distance running DX'ers out there? 73 and Good DX!

There are lots of articles out there about minimizing RFI from solar panel installations. Here's one of the first ones I found just searching around on the internet: https://palomar-engineers.com/rfi-kits/solar-system-rfi

I would like to hear more about what people on this list have done already in this regard, either at their own house, or know of measures taken a neighboring installation, to keep RFI at a minimum and still be able to DX.

I'm considering trying to move toward being "off grid," and solar looks like the best solution at present. But is it an "either-or" decision? If I'm going to go solar, do I have to give up DX'ing as I know it?

If you've started using solar panels for supplemental or primary power, have you had any success in reducing or eliminating RFI? If so, what type system did you implement, etc. I would love to hear success stories!

Re: Solar Panels and DXing

My neighbor has a professionally installed solar system installed on his roof. I'm guessing it's between 5 and 10 kW. It's the type that feeds back into the grid, as he has 2 power meters. It generates quite a bit of RFI at 50 kHz intervals mainly between 1000 kHz and 1600 kHz. I don't notice *too* much above or below that. All of the wiring is in metal conduit or metal boxes. So I don't think it's as easy as just snapping on a few ferrites here or there. I'm sure it's sealed for safety reasons as well. I have walked around with a portable radio, and the RFI can be easily heard several homes away so it's probably being carried along the mains wiring too. My Wellgood loop (50ft. away) can null it out slightly, but since it's not radiating from a point source, it is wider than the loops null width. I found that noise cancellers such as the popular QRM Eliminator, X-Phase, Quantum Phaser and MFJ Noise Canceller when combined with a properly placed noise pickup antenna work fairly well. I have tried them all BTW.

I think if you are having the system installed, I'd speak with the installer and make sure the system is fairly quiet to begin with, and can be modified up front with extra RF suppression. Maybe find out where they installed a similar installation locally, and have a sniff around with a portable radio before moving forward. Good luck. Tom

Re: Solar Panels and DXing

Solar Panels produce DC. This DC power needs to be converted to 60 Hz before it is either used in the home or sent out on the power grid.

The conversion process, from DC to AC is performed with an inverter. If the inverter produced a pure sine wave there would be no harmonics produced and no RF noise. But most inverters a cheaply made and the resultant "Sine Wave" looks nothing like a pure sine wave. This artificial sine wave is full of square corners and it's the circuits that create this artificial sine wave that generate the RF noise picked up by an AM Radio.

Before anyone purchases solar panels that will produce AC power for either the home or for the grid have the supplier of the inverter show you a graph of the typical output sine wave and have them explain how the wave is produced inside the inverter. My bet is that person would be unwilling to do that for fear that you would not want to purchase that noisy unit.

I think it's safe to say that 99.9% of all commercially available solar systems are going to use some sort of pulse modulated square wave to reconstruct a sine wave. That's the only way to get >95% efficiency. So it really comes down to how well they have filtered the inverter's output. I doubt that even a well-educated salesperson would be able to tell you any engineering details. The best you can hope for is a detailed spec sheet. So if it was me, I'd ask for references, and visit them on a sunny day with a bouquet of flowers and my portable radio. Besides that, you will be able to see the kind of workmanship you can expect on your own installation.

I'd be surprised if there was much – if any – filtration, unless they're subject to some Federal requirement on that. If that's the case it'd be minimal. The concept of any sort of interference to radio reception seems to be no longer a "thing." Especially for MW!

I am 99.9% solar here (not grid tied). The inverter side isn't the issue – I've used backup-style APC UPS for years and finally went to a GroWatt 5000es inverter/charger/PV controller. The Inverter side is fine. The PV charge controller is far from noise free. It takes 450 vdc from multiple panels in series and switches that very efficiently to charge the 48v batteries. These lines go directly out to the panels so they make an effective noise distribution antenna. But two heavy 10 mh chokes/reactors in series with the DC from the panels and a few caps has tamed that to virtually nothing.

Mesa Mike's list I didn't know about. I managed to import that into CSVUB. Not quite as useful because of the number of stations and not being able to sort quite as flexibly. And I did grab a spreadsheet. Your ideas have me rethinking how I'm logging now :) I did know about MWlist.org but not about some of the features you showed us.

I use something that I got from the Medium Wave Circle and usually have it open whenever I am DX'ing. There is a free online version out there but this very inexpensive version has ray tracing so you can pop up a ray from the selected station(s) to your QTH and see where you are exactly on the pattern. Day, critical, night, there are separate screens for that. I don't know if you know about this: https://mwcircle.org/radio-data-mw-rdmw-2022/

I use the NRC Radio Log extensively too as you mentioned you do, and I also use the NRC Pattern Book as that lets you know if something has any possibility of being heard. But the RDMW has the terminator displayed on it, and that changes according to the season, so it's great for thinking about Greyline or sunset/sunrise possibilities.

Re: QRM Noise on LW, MW, and SW – Solved!

I finally found and resolved an interference problem causing QRM from LW, MW and into SW. First noticed several months ago when I heard terrible noise wiping out from around 660 kHz to around 695 kHz.

Here is a screenshot of the noise.

I also noticed noise, though not as severe, in the longwave and shortwave frequencies.

Switched antenna. Same results. First thought, "What has changed recently?" Only thought was a new electrical meter (type remotely read). I contacted the electric company. While waiting for the electric company to call or reply I continued debugging. Since my main receiver is an SDR I need my PC and power for the SDR.

Used a portable, battery powered, receiver inside and outside in an attempt to determine if the noise was in my QTH or in the area. Sometimes the noise was gone and other times I was still hearing the noise. Argh!

Noticed the electric company repairman's truck in the street one day. Went outside and had a pleasant conversation with him. He admitted others complained about "strange problems and interference" from the new meters. He promised to get back in touch with me when he obtained an "old style" meter as he planned to replace the new meter with the older style meter.

Weeks went by and I hadn't heard from the electric company repairman.

We lost power on Monday, September 12, 2022. While waiting for the electricity to return I thought I'd check with a portable, battery powered receiver again. No noise. I'm hearing WFAN, NYC, NY on 660 kHz around 2030 UTC (4:30 PM EDT). I was determined to find the cause of the interference. I turned off all house power except for the circuit including my radio room. Checked 670 kHz. All noise/interference is gone. This is good as I'm able to continue. Here is a screenshot.

Turned on the electrical circuits, one-by-one, until the problem returned. Then turned off the circuit causing the problem and continued turning on the remaining circuits to determine if I had more than 1 cause of QRM. Luckily, no, only 1 circuit was the cause.


On the problem circuit is a power strip, a FIOs box, a TV and a DVD player. Initially thought it was either the power strip or the FIOs power cord brick. No, both are OK. Plug in the TV. Still OK. Plug in the DVD player. Terrible noise returned! The DVD player is a Memorex. It's at least 20 years old. Here is a picture of the problem.

Radio History Revisited The Start of FM Broadcasting

While we have concentrated on AM (medium wave) broadcasting history, since that's where the genre began, it wouldn't hurt to take a quick look at the development of FM radio. (This is not to ignore the once-vibrant niche of shortwave broadcasting. Anyone who knows me would be shocked if I didn't recognize its importance in the broadcasting spectrum. After-all, I worked for almost a decade at one of the world's most prominent international shortwave broadcasting stations, HCJB, The Voice of the Andes in Quito, Ecuador. But, for the purposes of this series we will stick primarily to the AM and, now, FM bands for domestic broadcasting in North America.)

The FM radio band is a technology that many of us take for granted. However, it's also one of the most valuable electromagnetic waves in human discovery. Without FM radio, we wouldn't have the emergency broadcasting services that paramedics and police regularly rely on today. Nor would we have the technology for things like microwaves or baby monitors. And, it was originally FM that allowed the radio industry to broadcast music in high-fidelity, and, more important initially, in stereo.

The history of FM radio began with the search for something that could reduce the static in the radio lines. Finally, in 1933, Edwin Armstrong introduced his revolutionary change to the broadcasting world. FM radio delivered a range of benefits over AM with his experimental station, W2XMN in Alpine, New Jersey.

In 1937 the Yankee Network, looking to eventually establish commercial FM operations, was granted a construction permit for an experimental station, W1XOJ, in Paxton, Massachusetts. The first publicized W2XMN broadcast took place on July 18, 1939, which used a high-quality phone line link to rebroadcast a program from WQXR in New York City.

On July 24, 1939, W1XOJ inaugurated a regular schedule of 16 hours a day (8 a.m. to midnight) from Boston. On January 5, 1940, Armstrong, working with the Yankee Network, demonstrated FM broadcasting in a long-distance relay network, via five stations in five states.

On October 31, 1940, the first 15 commercial FM station Construction Permit authorizations were issued. On March 1, 1941 W47NV (related to WSM) began broadcasting in Nashville, Tennessee, becoming the first fully licensed commercial FM station. There was significant interest in the new FM band by station owners; however, construction restrictions that went into place during World War II limited the growth of the new service.

Following the end of the war, the FCC moved to standardize its frequency allocations. As music came to rule the airwaves, FM radio drew in new listeners because of its high-fidelity sound capabilities. When radio had primarily featured dramas and other talk-oriented formats, sound quality had simply not mattered to many people, and the purchase of an FM receiver did not compete with the purchase of a new television in terms of entertainment value.

As FM receivers decreased in price and stereo recording technology became more popular, however, the high-fidelity trend created a market for FM stations. Mostly affluent consumers began purchasing component stereos with the goal of getting the highest sound quality possible out of their recordings. Although this audience often preferred classical and jazz stations to Top 40 radio, they were tolerant of new music and ideas.

My first contact with FM was in our dentist's office in the late 1940 or early 50s. He had a floor model set in the waiting room tuned to what may have been the only or at least one of the first such outlets in Detroit. The station featured a "beautiful music," all-instrumental format.

Skip from there to my immediate post-college experience of regular FM listening. My wife and I were married in 1965 as we relocated from college to seminary in Louisville. There I discovered not one, not two but (would you believe) three FM stations on the air.

Two were owned by the Louisville Free Public Library, with one carrying a full-time classical music format and the other offering "educational" programs for children in school, similar to what I had heard on the Detroit Public Schools FM station while in elementary school in the 1950s. The third FM station and Louisville's first successful, stand-alone FM outlet was WLRS, which signed on in 1964. The calls stood for Louisville Radio School, and it was intended as a training tool for students of the school. In the late-60s, owner Clarence Henson agreed to sell WLRS to WAKY. However, the deal fell apart when the six-month deadline to complete the transaction wasn't met.

In 1970 WLRS was one of only nine stand-alone FM stations in Kentucky. In 1981 WLRS became the sister station of WAVG (formerly WAVE). (Full disclosure, in the 1980s I worked part-time for Clarence when he and his son owned WXVW where I held the Sunday evening slot for almost a decade).

If the Top 40 AM formula suggested playing no song longer than three minutes, the FM approach was to play an album cut that was ten-minutes long. Rock music, growing from the "flower children" and "make love not war" anti-Vietnam movements, provided much of the content for FM station programming.

The music industry also encouraged the growth of FM radio. The playlists of Top 40 AM stations were tightly controlled, with few opportunities for new songs or new groups to gain on-air exposure. Many FM stations would play virtually anything, so record companies used FM radio to introduce new artists and styles of music. By 1971, nearly half of all radios sold included FM tuners. National FM listener share passed the AM listener share in the fall of 1978; 50.698 percent of the listeners were tuning to FM stations. FM radio subsequently became the de facto standard for most music-radio listeners, which caused many AM stations to shift to talk-radio formats in the 1980s.

Both the high-fidelity market and the growing youth counterculture of the 1960s had similar goals for the FM spectrum. Both groups eschewed AM radio because of the predictable programming, poor sound quality, and over-commercialization. Both groups wanted to treat music as an important experience rather than as just a trendy pastime or a means to make money. Many adherents to the youth counterculture of the 1960s came from affluent, middle-class families, and their tastes came to define a new era of consumer culture. The goals and market potential of both the high-fidelity lovers and the youth counterculture created an atmosphere on the FM dial that had never before occurred.

Between the years 1960 and 1966, the number of households capable of receiving FM transmissions grew from about 6.5 million to some 40 million. The FCC also aided FM by issuing its nonduplication ruling in 1964. Before this regulation, many AM stations had other stations on the FM spectrum that simply duplicated the AM programming. The nonduplication rule forced FM stations to create their own fresh programming, opening up the spectrum for established networks to develop new stations.

The late 1960s saw new disc jockeys taking greater liberties with established practices; these liberties included playing several songs in a row before going to a commercial break or airing album tracks that exceeded 10 minutes in length. University stations and other nonprofit ventures to which the FCC had given frequencies during the late 1940s popularized this format, and, in time, commercial stations tried to duplicate their success by playing fewer commercials and by allowing their disc jockeys to have a say in their playlists. Although this made for popular listening formats, FM stations struggled to make the kinds of profits that the AM spectrum drew.

The Top 40 format helped reposition radio, but it also created a group of similar-sounding stations. AM stations aired similar music and jingles, played loud and lengthy sets of commercials, and generally had poor fidelity (i.e., sound quality). Attention thus shifted to FM radio during the 1960s. Besides the obvious availability of FM channels, operators began to recognize other FM benefits. FM provided day and night service, with uniform power levels and coverage areas. FM channel width meant superior audio, including stereo, and less interference.

In 1971, one of the leading radio groups, ABC, began renaming its FM stations as WABC-FM in New York became WPLJ and KABC-FM in Los Angeles became KLOS. Also during this period, Lee Abrams, a rock radio consultant, began spreading his programming influence across the nation, developing what he coined as "album oriented rock," a streamlined approach to the freeform format that tightened the playlist by rotating tracks from the most popular rock acts.

In 1974, FM radio accounted for one-third of all radio listening but only 14 percent of radio profits. Large network stations and advertisers began to market heavily to the FM audience in an attempt to correct this imbalance. Stations began tightening their playlists and narrowing their formats to please advertisers and to generate greater revenues. By the end of the 1970s, radio stations were beginning to play specific formats, and the progressive radio of the previous decade had become difficult to find.

By the year 2000, approximately 85 percent of all radio listeners were tuning to FM stations. The question, however, now may be whether AM radio and possibly FM radio are simply transitional delivery technologies. Already, broadcasters are investigating (and investing in) digital terrestrial broadcasting that could eventually replace the traditional AM and FM stations. At the same time, companies are streaming audio via the Internet and offering satellite-delivered audio services.

Radio (and some TV) History Revisited "You Bet Your Sweet Bippy"

Each of us has our own expressions that have developed over our lifetime. We use them for humor, we develop them for emphasis and they become somewhat attached to us. I, too have some, several of which come from historic radio and some from historic television. Let me explain.

When someone does something that I don't like or approve of, I am, more often than not likely to respond with "Taint Funny McGee!" That comes from the venerable Fibber McGee and Molly, a 1935–1959 American radio comedy series. The situation comedy was a staple of the NBC Red Network from 1936 on, after originating on NBC Blue in 1935. One of the most popular and enduring radio series of its time, it ran as a stand-alone series from 1935 to 1956, and then continued as a short-form series as part of the weekend Monitor program from 1957 to 1959. The title characters were created and portrayed by Jim and Marian Jordan, a husband-and-wife team that had been working in radio since the 1920s.

Fibber McGee and Molly followed the adventures of a working-class couple, the habitual storyteller Fibber McGee and his sometimes terse but always loving wife Molly, living among their numerous neighbors and acquaintances in the community of Wistful Vista.

They were also expert at their own running gags and catchphrases, many of which entered the American vernacular: "That ain't the way *I* heeard it!"; "'T'ain't funny, McGee!" and "Heavenly days!" were the three best known.

Having been a part of my life for the first seventeen years, there is no wonder that I picked some of them up and still use them today.

Then there is my expression when someone (usually our daughter) asks me what I am doing, I will tell her that I have "places to go, people to meet, things to do." That is a bit ironic in that I am retired and more often than not I don't have a place to go, nor people to meet, nor things to do. It obviously (in my view) comes from the NBC radio network program, *Monitor*, a fascinating magazine program that appeared originally on weekends and eventually went to weeknights too. It quite often used the slogan "going places, doing things." I have written about this program in an earlier article,

(<u>https://revisitingradiohistory.wordpress.com/2022/04/03/youre-on-the-monitor-beacon</u>) but it is an example of how we often pick up vocabulary from the media and integrate it into our conversation.

My third common expression is "You bet your bippy." That comes from the very popular Rowan & Martin Laugh-In show which was a comedy television program that ran for 140 episodes from January 22, 1968, to March 12, 1973, on the NBC television network, hosted by comedians Dan Rowan and Dick Martin.

The show was characterized by a rapid-fire series of gags and sketches, many of which were politically oriented. The co-hosts were the "exasperated" straight man (Rowan) and "dumb guy" (Martin) act which they had established as nightclub comics. The show featured Gary Owens as the on-screen announcer and permanent cast member Ruth Buzzi; longer-tenured cast members included Judy Carne, Henry Gibson, Goldie Hawn, Arte Johnson, Jo Anne Worley, Alan Sues, Lily Tomlin, Johnny Brown, Dennis Allen and Richard Dawson.

It should be noted that numerous other popular expressions came from that program including:

- "Look that up in your Funk and Wagnall's!
- "Ring my chimes!"
- "Beautiful downtown Burbank"
- "One ringy-dingy ... two ringy-dingys ..." (Telephone operator Ernestine's mimicking of the rings while she was waiting for someone to pick up the receiver on the other end of the telephone lines)
- "Have I reached the party to whom I am speaking?
- "Sock it to me!"
- "Blow in my ear and I'll follow you anywhere."

Finally, my common "end of conversation" exclamation to our children when they were young was "that's the way it is!" That was usually sufficient to end any conversation of objection to whatever we as parents decreed. It came from the famous sign-off by renowned CBS news television anchor Walter Cronkite who ended each nightly newscast with that expression which became highly identified with him. I always tried to say it with the same emphasis and rhythm. Our kids didn't hold it with the same esteem however!

Ah, how radio (and television) affect our lives and even our ways of speaking.

The call letter index gives call, frequency, city and state. The city index (listed by state, then city) includes frequency, call and day/night power. The transmitter site index (listed by state, then city) tabulates the latitude and longitude of transmitter sites. Also, in this edition, there is a spread sheet with links to web sites, live broadcasts and Facebook page of many of the Mexican stations. This is an indispensable reference for anyone who hears Mexican radio stations.
