

CKJR-1440 Wetaskiwin, Alberta switched their format to All-Sports September 5 during the daytime, with half of the former CFRN-1260 on-air staff. The remaining staff's on-lineonly All-Sports offering began September 6: Edmonton Sports Talk will have Listen Live and Watch Live buttons on their web site, podcasts and YouTube; Apple and Android apps are promised for the near future. At first glance, these two ventures looked doomed, given that Bell Canada stated that CFRN was not making money as the only All-Sports station in Edmonton. How can two competing "stations" expect to make money? One answer might be the significantly lower costs of "transmission." CKJR's signal into Edmonton is subject to local noise (RFI), especially near 10 kV+ power lines and the city's rapid transit (LRT) overhead lines, but it is not as noisy as the overhead trolley lines in the middle of many major streets for the city's aged fleet of electric buses that ran until May 2, 2009. Additional information can be found later in this column.

Speaking of CFRN, Bell Canada's abrupt shut down of so many AM stations has led to rumors that it has now given other owners of AM stations in major markets the justification they need to shut down many of their stations. Although most of the attention has been focused on the bottom of the ratings, CHQR Calgary may be hinting at another approach for AM stations closer to the top of the ratings: switch an existing FM station to simulcast the AM, then shut down the AM once listeners have made the move to FM.

With the recent 75th anniversary of FM broadcasting in Edmonton, marking the opening of CKUA-FM on June 28, 1948, the competition that followed between the three FM stations in Edmonton bears some similarities to the state of major market commercial AM stations until Bell's move to shut down many AM stations in June 2023: no one wanted to be the first to shut a station down, as opposed to moving it to FM. CJCA-FM and CFRN-FM were both on the air within three years of CKUA-FM's debut, all low-powered, and simulcasting their AM sister stations in monaural. By the mid-1950s, if not earlier, it was clear that FM radio stations would never be viable. Most license owners elsewhere surrendered their FM licenses, but Edmonton's three stations played a game of brinkmanship, with no one wanting to take a chance that FM might be something someday.

Believed to be Canada's oldest living broadcaster, Gordon Skutle just celebrated the 80th anniversary of his first day at CJCA-930 Edmonton, Alberta on August 13, 1943. He became CJCA's Chief Engineer in 1957, and signed many QSL cards when he wasn't building new studios or transmitter sites for CJCA and sister station CIRK-FM (formerly CJCA-FM). Gordon retired in 1986, and will be celebrating his "103.5th" (103-1/2) birthday in September. He still loves to talk about Western Canada broadcast history, and even about the fact that my first paid radio job coincides with his birthday, as the 103.5 MHz frequency of CHQM-FM Vancouver back in 1971 when it was paired with CHQM-1320.

600 CKSP

BC Vancouver – CKSP's license was renewed for seven years, until August 31, 2030, after the station was found in full compliance with radio regulations. The renewal was opposed by an individual who claimed that CKSP's required annual contributions to Canadian Content Development (CCD) were made to a related company, Dishoom Media. The CRTC reviewed the matter and determined there was no connection between CKSP and Dishoom, other than them having once occupied the same office building.

770 CHQR

AB Calgary – Their license would have expired on August 31, but was granted an *Administrative renewal* until December 31, to allow the CRTC more time to consider the station's non-compliance, most notably simulcasting full-time on CFGQ-FM, a violation of both the AM-FM simulcasting rules and the FM Spoken Word rules.

CALGARY 107FM | 770AM

1200 CJRJ

**BC** Vancouver – Their license was renewed for only four years after the station was cited for four areas of non-compliance with radio regulations. A fifth non-compliance issue is technical in nature and is awaiting advice from the Department of Industry to determine future CRTC action. It first came to light when CJRJ filed an interference complaint against CKSP-600, related to 1200 kHz being the Second Harmonic of 600 KHz. In turn, CKSP determined that CJRJ was "operating outside its approved operating parameters." CJRJ admitted that it had failed to determine and make required changes when CKSP, before first signing on, changed power and transmitter location.

**1400 CGOF-4 ON Rolphton** – With the replacement FM transmitter now on the air, this 40 Watt AM CBC LPRT will go off the air in 2-3 months. It will continue as a member of the Ici Radio-Canada Première network, formerly known as CBC's French AM network, and simulcasts CBOF-FM Ottawa.

1410 CJWI

**QC Montréal** – This station has received a short-term license renewal, until August 31 2026, due to long-standing non-compliance issues. The renewal was issued because the CRTC felt that the station was making progress towards full license compliance. Nonetheless, a Broadcasting Mandatory Order was issued to address the major outstanding issue: failure to submit a complete music list for specific recent periods of time whenever requested by the CRTC.

1440 CKJR

AB Wetaskiwin – "Sports 1440" debuted September 5th from 0900-2000 weekdays, replacing the Oldies format with Sports Talk from former CFRN staff. Future plans include syndicated Sports programming during evenings, overnights and weekends, implying that current programming will continue for now, including the third-party South Asian ethnic programming from 2000-2300 week nights. The web site is already available at 'sports1440.ca.' Just days after the press release announcing the format change, the CRTC announced the short-term renewal of the station's license, for five years, and a fine of \$998, for failures to consistently keep track of all musical selections aired, and play the required amount of Canadian Content during the aforementioned brokered ethnic programming each weekday evening.

TX El Paso – 8/23 0100 – Back on the air with CHR/ROK oldies. TOH ID: "KQBU AM, El Paso, 9-20 AM," but no splitter IDs during a very abbreviated listening session. The open frequency was great while it lasted. (RV-TX)

8/25 0719 – Estimated reading, het on what's left of WSM, pointing WSW/ENE. Domestic? Or something Mexico/Central America? (TK-FL)

1050 unID

- 9/7 1948-1949 – Poor, with an ad for a Catholic University. I suspect WVDM in Eau Claire, on day power. (NB-WI)

1090 unID

- 08/18 2155 – Fair, with Spanish language. Sounding like a soccer broadcast, then into recognizable commercials for 'Home Depot' and 'Taco Bell.' Then a male speaks for about thirty seconds and the station appears to go off the air as it isn't heard from again. Went off right at 2200. If it is indeed a daytimer, the most likely target seems like KSOU Sioux Center, Iowa as local sunset was a half hour prior. They do not appear to have post sunset authority though. (MT-WI)

1090 unID

– 8/18 2207-2233 – In KAAY null, with the Mark Levin show. Heard no local IDs. Signal: Fair-to-Good at times. Frustrating. (NB-WI) [I suggest either of these WW1 stations: WCRA in Effingham, Illinois. They are licensed for U1 1000/25, but may have 'cheating' past their 2045 legal bedtime; WKBZ in Muskegon, Michigan could also have 'cheating,' as it's legal sign-off time in August is also 2045. But it would have a fair over-water effect toward your location; and KTGO in Tioga, North Dakota. They are U1 1100/6, and with their 'power-down' time in August being 2200, they may have 'forgot' to power down then. Good Luck! – BH]

1120 unID

-9/6 0317-0322 – Heard what may have been "Coast To Coast" with George Noory. North Korea and San Diego mentioned. Some QRM, but no Call ID. Who carries "C2C" on this channel? (RA-CA2) [KPNW Eugene, Oregon! – BH]

1120 unID

-9/6 0324-0329 – A Country and Western station came up. Reception good, then gone because of QRM. No Call ID. Any clues on this station? (RA -CA2) [No C&W stations here in your listening area. Maybe Mexico? – BH]

1220 unID

 – 8/21 0546 – A few seconds of C&W vocals, then lost to WDYT. Best guess is WFKN, Franklin, Kentucky. (TK-FL)

1239.95 unID

8/18 0744 – Unidentified morning news magazine feed, discussing the hurricane heading for Baja, then California. Briefly in the pileup of co-channel stations. Noted again on 8/20 @ 0445+ – Fading up poorly a couple times with something probably C2C or RER talk. Anyone else? (TK-FL)

1240 unID

- 8/16 0721 - Someone here with unidentified network Sports Talk (WLAG, La Grange, Georgia? But their station stream is "Timeless Oldies" branding with Oldies R&B/Soul). WMSO, Southhaven, Mississippi? (Similar format per streaming but unable to mesh their audio on a fade-in in time). A little while later, someone with a very Urban/Soul cover of "Bridge Over Troubled Water" which might have been the same station. Or not. (TK-FL)

1240 unID

-8/16 0700 - Amongst all the rapidly fading in/out stations here, someone with the CBS News bong on the hour, the only thing from it punching through. WPAX, Thomasville, Georgia and WFOY, St. Augustine, Florida the best contenders, if still CBS. (TK-FL)

1240 unID

-8/20 0451 - Someone with old-time detective radio serial. Strong for a bit, then the prerequisite fade to zero at the top of the hour. Possibly the same station heard at 0508 with 'Real Estate Today,' which, when Googled is a National Association of Realtors brokered program. Their website actually has a list of affiliates though probably not kept updated. ### You have found "Why Do I DX?"

### Response #1:

"I DX because it is one of my hobbies.

All it took was a magazine on a drugstore shelf that caught my eye and thus I was exposed to the concept of being able to hear radio signals as a hobby back in my early teens; and I thought it was the neatest thing in the world.

It was the perfect way to pass the time for someone with my personality. I could do it alone, I didn't need any athletic skills, and it was different. I never outgrew the desire to chase the elusive. The hobby was always there when other priorities (dating, sports, school, work, family, health) were satisfied. I've accepted the increased challenges due to changes that have occurred through the years because it's 'part of the hobby.'

So the 'why' part is simple . . . it is my hobby; the one that I selected from an endless list of my hobby possibilities.

Why do I report my DX for others to see?

Answer #1: Information passing. Look at all of the information provided by resources such as the NRC AM Log, IRCA Mexican Log, IRCA Slogan List, and other lists such as these, and at least a significant percentage of this information can be traced back to a DXer that originally heard it and reported it.

Any time we refer to one of these resources, we are using information that might have been originally sourced by a DX-er, somewhere, who heard it; whether they want to admit it to themselves or not. Reporting our catches gives us a way to continue the passing of information that might prove useful to others.

Personally, I've always gone through each bulletin as I receive it, and use the information to keep track of formats and slogans heard, news networks used by the different stations, silent stations, etc. I've built up a spreadsheet of this information that I can quickly refer to as needed when I'm DXing. It's true that a lot of this information can be found in other resources, but my spreadsheet adds a 'timeliness' component to see changes before they make it to the more established resources.

Answer #2: Building community. Ask yourself – 'Why do people post their personal lives on Facebook?,' or 'Why do people go to club and fraternal organization meetings?'; and that will give you Answer #2."

### Response #2:

"Seeing what other people have heard is immensely important to me, as much now, as in 1966 when my DX suddenly got much better when I first joined a DX Club. I soon learned that a big factor was 'being in the right place (frequency) at the right time,' and realizing it when you are there. Seeing what other people have heard helps me figure out what is possible for me to hear. If I'm in the right place at the right time.

As for why I report: I am more interested in providing Tips for others, than I am in bragging about my latest DX Catch."

#### And behind Door #3:

"I find that when going through the latest loggings, the DXers reporting closer to me are of more interest. For sure.

One thing I do is utilize other loggings to help me ID stations. For example, in this issue, I reported on a logging on 1250 which mentioned "Wabasha." So I went through a few of the recent issues and did a search on "1250." There I found a logging by John Rieger that was the answer to the puzzle of what station I'd picked up.

I think part of the fun of this hobby is seeing what others are logging. You realize you're not the only crazy one who's listening for DX at 2 AM! Plus, you never know what 'tidbit' from DXers hundreds of miles away might help you with a catch.

And for some reason, I enjoy seeing everybody's catches/loggings. It's an encouragement to me."

### Finally, we hear . . .

"I DX because it is fun to see how many long distance stations, I can hear from this one location. It is also a thrill to hear another station either under or beside one of my local stations. It's also interesting to find a 'pest' station off the air due to a technical issue and to find a totally different station that would normally not be heard.

I report my loggings to DDXD-West because it may help someone else with an unidentified station they are hearing with a format and/or slogan that they cannot figure out either because of co-channel interference or fading.

Plus, it lets others in my general area know what can be heard."

**UNITED KINGDOM**: 1548 Gold, London will be turned off at the end of September. The station, which started life as Capital Radio, has been on medium wave in London since it launched in October 1973 – almost 50 years ago. It was originally on 557 kHz before switching to its current frequency. From September, Gold will only have one AM frequency remaining, in Manchester on 1458 kHz, but remains available nationally via DAB digital radio. [https://radiotoday.co.uk/, ARC mv-eko]

VENEZUELA: RCR Radio Caracas Radio has said goodbye to its listeners. Years ago the government closed its transmissions on 750 kHz but the station continued to broadcast online through the internet, but through new conditions, the authorities have now made it largely impossible to continue even via the internet. Radio Caracas Radio 750 AM, the second oldest station in Venezuela, has therefore now closed. [Santiago San Gil G via Cadena DX fb, MWC Medium Wave *News*] One of Venezuela's oldest radio stations has fallen silent for the first time in its 93-year history. Radio Caracas Radio or RCR, broadcast its last show on June 30 with staff saying they could no longer keep the station operating under increasingly difficult circumstances. The station since April 2019 had been broadcasting via YouTube after the telecommunications regulatory agency closed down its signal, without providing a reason. And earlier this year, the state-owned phone company CANTV cut service to all its telephone lines. The power company said the issue was due to a damaged transformer that supplied electricity to the building. But with no power for three months, RCR was unable to keep going. "The telephone line service that allowed us to communicate with the people, to receive complaints, was cut even though we were up to date with our payments. How do you explain that? This is a radio station that was without electricity for 92 days, and dependent on a power generator," said Jaime Nestares, RCR's owner and director. Nestares and one of his show hosts José Domingo Blanco told VOA that the station's board of directors was alerted to possible actions against RCR members. Because of that, they decided to close temporarily to protect the team. "Is it worth the risk? Losing assets, having our assets seized, having people jailed? Is it worth it? I think the time has come to step back, restructure and launch a new alternative that will protect us from all these difficulties," Nestares said. The radio owner said he hopes the closure will be temporary. But added that since CONATEL cut the station's signal in 2019, RCR has struggled to keep working. "Over the last four years, there has been a huge drop in the advertising market and the value of YouTube commerce. We've had difficulties with electricity and the internet. More and more, we're seeing that Venezuelans have fewer and fewer resources to access social networks and audiences have plummeted," he said. VOA's request for comment from Venezuela's Ministry of Communications went unanswered.

Founded in 1930, RCR was known for being critical of the government. It was also one of the few remaining outlets from the Grupo 1BC operation that was still able to work. For more than a decade, the conglomerate has faced pressure from the government which declined to renew the license of Radio Caracas Televisión (RCTV), and also closed Radio Caracas Internacional. The country's economic crisis started taking its toll on RCR about 10 years ago, requiring the station to downsize from 100 employees to about 15 staff, including cleaning and security personnel, and eight program hosts, some of whom work from other countries. Nestares says his small team is looking for a different way to reach audiences to get RCR back up and running. "We have done the best we could to continue. I believe that the difficulties we have force us to reinvent and rebuild ourselves and return with a new alternative." Media watchdog Reporters Without Borders says that under

President Nicolás Maduro "Venezuela is experiencing a prolonged restrictive environment in terms of information, with policies that threaten the full exercise of independent journalism." It ranks 159 out of 180 countries on the World Press Freedom Index. [www.voanews.com]

Project 1 is a detailed bottom to top band scan using the SDR Console recordings I've made since May. This is to clean up my by-frequency list, as it hasn't had an overhaul since I re-joined the hobby. This has yielded many new domestics and a bunch of re-logs to update call letters. But the foreign DX has been nil.

Second project is continued tuning/debugging of the new west-pointed Superloop. One issue eliminated: a problem where the feedline would suddenly degrade. This turned out to be a PL259 connector that had gone bad – the center conductor broke free of the insulation and would lose contact when tension on the feedline reached a certain force. This was very difficult to debug until I tried some advice from Mark Connelly. I ran Teamviewer software on the computer in my shack, then linked to it from the corresponding app on my phone. This allowed me to test each part of the feedline while watching the signal level back at the shack, which did the trick. Problem found and solved. Still having issues with reversing the Superloop, but I think this will also turn out to be a connector or cable issue.

Will soon undertake building the third and last outdoor antenna – another Superloop pointed at 40 degrees for the Maritimes and Europe. Hoping to get that up in September, but still several steps to go before it can be set up.

The NRC AM Radio Log volume 44 just arrived. Thanks Wayne and everyone who works to compile this indispensable resource.

Kp index just hit 6, and the Perseus is recording from the big south Beverage. Some old familiar Cubans are visiting. Let's see if something new rolls in. Good DX, Everyone!

WRTH has it in the fq list for West Indies, page 717: 1300 SXM 1 [kW] PJD2 V. of St Maarten, Phillipsburg but NOT under SAINT [sic] MAARTEN, the very name of which would be a mixture of English and Dutch; where that call is shown only for FM102.7 on page 441. 1300 is weak S5 but fairly steady overwater from one part of Caribbean Netherlands to another, not bad, 862 km = 535 st miles = 465 nmi. 1945 playing "Love, Sweet Love," 1950 hardsell ad in English. 1955 mentions 102.7. Guess what, that website does not lead to a radio station but to a blog in --- Thai!! Except for a Roman name

UFASLOT, about gambling. Stranger and stranger. Here's the correct radio link: <a href="https://pjd2radiosxm.com/">https://pjd2radiosxm.com/</a> Slow loading. "Welcome to the Voice of St Maarten --- We are proud to be providing the Caribbean with the best in broadcast radio for over 35 years. We have two channels 102.7FM and 1300AM. Our listeners are guaranteed to get the latest in news in and around our community. We have the most talented collection of DJs on the island to keep our listeners entertained and updated with the latest music."



I originally joined the NRC in 1942, went to the NRC convention in 1943 at Ray Edge's home in Buffalo, then off to the Navy in 1945, where I learned electronics!

I have just turned 96.5 years old and I continue my radio hobbies on the BCB and the 20-meter and 2-meter ham bands using a Yaesu 991A for both since roofers knocked down my horizontal antenna for my Drake R2B.

I started DXing in 1942 using my mother's old (1927?) RCA Radiola (5-tube TRF). I was forbidden to take the back off the radio, so I made it regenerative by putting an oatmeal box coil shunted with a variable capacitor (stolen from an old inoperative Brandes radio) in series with the Radiola's antenna - like this:



The radio could be made regenerative by adjusting the variable capacitor. This made the RCA Radiola very selective and enormously more sensitive as the condenser was adjusted near the tuned frequency of the radio. I QSL'd over 1,000 stations. Then, off to the Navy! After the Navy, I used a BC-946B army surplus receiver.

### <u>Linda Brodsky, Malverne NY</u> (currently in Golden, CO)

I've been in CO for the past 10 days, 4 of which were spent in Steamboat Springs, where electrical storms virtually obliterated reception on the C.Crane SSB. Back in Golden, during a brief period one evening using the Airspy Discovery and You Loop these "usual" stations from other states on a segment of the BCB showed up: 780 WBBM Chicago; 920 WBAP Ft. Worth; 1020 KCKN Roswell NM; 1030 KTWO Casper WY; 1040 WHO Des Moines, IA; 1070 KNX Los Angeles; 1080 KRLD Dallas; 1110 KFAB Omaha NB; 1120 KMOX St. Louis MO; 1160 KSL Salt Lake City U; 1170 KTSB Tulsa OK; 1200 WOAI San Antonio; 1250 KYYS Kansas City KS; and 1290 KMMM Pratt, KS. 1500 KSTP Minneapolis, MN; and a new one, 1250 KNEU Roosevelt, UT. I've made some overnight TOH IQ recordings which may yield something new. However, I forgot my previous experience and brought the Airspy Discovery from which I can't record the entire MW band at once, instead of the RSPDx which can. I'll try to vary the frequencies recorded each night, a not very satisfying solution, but the only one I can think of.

Hope everyone is ready for the new season and that many of you will share your adventures in this column. 73 and good DX.

## Unreported Domestic Stations

Last issue we printed the full list of stations that have not been reported to DDXD since at least Volume 67 (1999-2000). We inspired several members to look up some of these stations, including on summer vacation travels, and <u>15</u> of them were reported this issue: KDAZ-700, KIMP-960, WCBR-1110, WMGJ-1240, WBIW-1340, WTKY-1370, WEOA-1400, WCYN-1400, WMXF-1400, WXVW-1450, WTCO-1450, KWPM-1450, WASC-1530, WMYJ-1540, and WOCC-1550. That leaves just 189 stations on the list!

Also, some 2,309 different U.S. and Canadian stations were reported to DDXD during Volume 90 alone – that's more than half of the licensed stations. Well done!
