Mon. Apr. 13 W D C R 1340 Hanover, New Hampshire, 250 watts, 1:00 to 5:00 a.m. EST. WDCR will broadcast a special DX program from 1:00 a.m. to 5:00 a.m. on Monday, April 13, 1959. It will consist of wierd music and frequency osculations, writes Mr. Don N. Knapp, Technical Director of WDCR. They want us to publicize this big four-hour DX show via DX NEWS, and they hope to receive much valuable information from reports as to establishing their actual broadcast range. So far, our member Bob Botzum of Reading, Pa. is the furthest to have heard WDCR, so let us see if we can top this on this four-hour marathon DX Test. It might interest you to know that WDCR is unique as commercial stations go in that it is the only full time AM Commercial station in the United States wholly owned by a college and wholly operated by students, and that it operates only during the Dartmouth semester, being silent in the summer time. So we hope you'll listen for this DX, and that you'll send your reports to Mr. Knapp at WDCR, Dartmouth College, Hanover New Hampshire, whom we thank heartily for this big DXcast. HAL WILLIAMS.

Now getting Vermont and New Hampshire will be my Maine problem. 3/24- KFJR-550, KTFI-1270, KTOE-1420, KBOM-1270, KIMA-1460, CJNB-1460. 3/25- WJAK-1460, XEBG-1550. An L-C resonant trap wave trap is the device which I use for my receiver. It consists of a coil and a tuning condensor. I use a 15-365 mmf. condensor with a transistor antenna in parallel for BCB for lower frequencies, such as beacons, You would use a capacitor of higher value according to the formula $f = \frac{1}{2\pi\sqrt{LC}}$ where f = frequency, L = inductance of coil in henries, and C = capacity of condensor, in farads. This is the way which the receiver tunes the signal, as certain frequencies resonate in the circuit as capacitance is varied. See? 73.
