

As we've reported, the 910/1480 call changes above were applied for in May 2023 along with the sale of the two stations to Disruptor Radio, which immediately began operating the stations under a time brokerage agreement. The sale of the stations was finally approved by the FCC on Dec. 21, but the requests for call changes (which were submitted by the previous owners) were dismissed without comment by the FCC on Jan. 8. The WJFA/WJFG calls have been heard on the air by many DXers.

I (David) e-mailed the new owners asking for clarification, but got no response. My guess as to what happened is that the original call change applications filed by the old owners weren't clearly marked as contingent on the station sale (the applications were filed during the LMS switchover that didn't go very smoothly as pertains to call letters) and so the FCC assumed it was the old owners who wanted the new call letters. Now that the old owners don't own the stations anymore, the FCC dismissed their applications. If so, the new owners can straighten this out fairly quickly if they want.



- **1420 WVJS KY Owensboro 1/7 0802 –** Very poor, with Legal ID into ABC News. Once this was so common. In with many others. (JJR-WI)
- **1420 WFNT MI Flint 1/7 0627 –** Poor, with "AM 1420 WFLT" cutting through with Black Gospel music. Not common here. (JJR-WI)
- **1430 WCMY IL Ottawa 1/13 0835** Very poor, though "WCMY" and 'Vincent' by Don McLean was in. With WION. No WXNT. (JJR-WI)
- **1430 KASI** IA Ames 1/5 0917 Very poor, with "WHO (TV) 13" weather and Iowa mentions. Many others in. Rare. (JJR-WI)
- **1430 KBRK SD Brookings 1/3 0923 –** Poor, with time check, then temperatures in South Dakota cities. "And here in Brookings" Nice to hear this; usually CHKT. (JJR-MI)

- 1521 unID JAN 1 2320 JBA carrier het to KOKC; don't usually check for 9/kHz TAs this early, even before LSS today at 2327. Wonder if the 2-megawatt Saudi supposedly to 2230 be on later? Urumqi, East Turkistan, std denunciation, but its sked supposedly only 00-02 and 11-20, on early? LSR at Urumqi today 0144, so its morning broadcast should be quite possible into much of North America. [Hauser-OK]

- 1629 unID JAN 12 2200 Signal fading in/out s3 to s5, occasionally to readable level with music. [Conti-NH]

Transatlantic carrier search: JAN 1 0408 – 684, 711, 774, 891 only, likely Spain, Western Sahara, Spain, Algeria strongest. JAN 2 0435 – 891, 1107; likely Algeria, Spain. JAN 5 0439-0443 – 693(?), 774(2), 891(2), 1107, 1521, 1566. Two carriers beating on 891 is very unusual; normally only 300/100 kW from Algeria. What else could it be? By power, hours and geography, per MWlist, nothing significant in Europe; 2 x 50 kW in Iran; 100 kW in Ethiopia; 100 kW in Turkey would be more likely. The beat timed at 140/minute = 2.33 Hz. MWoffsets show Algeria on 890.9982 as of 3 months ago, so the other would be on 891.0005 or 890.9959. Nothing near the higher one in range. Closest to the lower one would be Ethiopia on 890.9965 as of 2022-02-20. From Mauno Ritola, RealDX io group, "Today at 0200 I got Algeria now on 890.997(1) kHz and Iran on 890.999(8) kHz. Something weaker on 890.999(5) kHz." That would put Alg and Iran 2.7 Hz apart, the third one only 0.4 Hz from Alg. 1566 is surely TWR Benin, 100 kW, as there is nothing else of significant power in Eurafrica or ME. I've detected it before, but not lately tho always alert for it in 9/kHz bandscans around this hour. It's often reported from as far as southwest Canada.

JAN 6 0436 – On the NRD545 with east/west long wire; 891(2) with beat 132/min = 2.2 Hz; 711, 855, 999, 1007, 1044, 1107, 1125, probably mostly Spain; and 1194! Not a broadcast frequency, but sounds like right on 1194.00 so unlikely a spur or image. I switch ASAP to the R75 and scan again 0447-0456. 711, 774(2), 882, 891(2) this time counting 144/min beats = 2.4 Hz; 1044, 1071, 1089(2) with 1 Hz beat; no 1194; 1296, 1413, 1485. This on east/west Wellbrook loop antenna. 1089 has 6 *TalkSport* synchros in UK ranging from 4 watts to 150 kW; strongest are Brooksmans Park 150, Westerglen 125, Moorside Edge 50/100, Washford 80 kW, but mwoffsets shows all within a fraction of 1 Hz on 1089.00000. At 0457 after lots of TA MW carriers, I try LWBC frequencies on the R75 and Wellbrook, detect a couple on 162 and 180 kHz. Always must beware of birdies and images, but these may be legit: 162 France, 800 kW, no longer broadcasts, used only for TDF time signals. But per listings 180 is unoccupied. Such 'even' frequencies are most subject to local MW images. Long ago there were 1200 kW from Turkey and a couple Asiatic Russians on 180.

JAN 7 0407 – 585, 612, 693, 774(2), 837, 855, 882, 891, 909, 999, 1053, 1089, 1098, 1107. Later 10/kHz scan at 0423 adds 711. JAN 8 0437-0442 – On the Wellbrook; 585, 684, 711, 774-2, 855, 891, 1053, 1089, 1107, 1566. JBA means just barely audible, which I think is a very apt description as these cannot be evaluated numerically. JAN 10 0409 – Only 693, 891, 1107, an odd triple. On 693, RNE Spain synchros add up to only 50 kW; UK BBC Radio 5, 342 kW headed by a 150; also 100 kW Iran. 891, Algeria q.v. of course. 1107, R5 Spain synchros add up to 89 kW; also 50 kW Iran. JAN 14 0305 – Not total 9/kHz scan but finds these when sought on the '545; 693, 711, 891. A bit later, at 0444, a full 9/kHz scan on the R75; 909, 1044, 1053 strongest, 1089. [Hauser-OK]

- 570 **CUBA** *R.Reloj*, Santa Clara DEC 28 0023 Poor, RR Morse code every minute; if there was voice associated with the signal could not verify. [Arnold-VA]
- 570 **CUBA** *R.Rebelde*, Pilón JAN 5 0612 Ballad sung by female and flute instrumental, parallel to 560, 570 and 580 kHz. Good signal. [Beu-TX]
- 640 **CUBA** *R.Progreso*, Guanabacoa//Las Tunas JAN 1 0801 Latin music on either side of Spanish talk by female that started with "Buenos dias" and included several Havana mentions. New! 50 kW at 2,185 miles. [Battaglino-CA]
- 660 **MEXICO** XEFZ, *ABC Deportes*, Monterrey, NL JAN 3 0711 Song "Gloria" in English, nice to hear after a long time; ID as "Esto es ABC Deportes," and another song in English, "Can't Help Falling in Love with You", hardly sports in Spanish as branded! Fades down with a 2.5 Hz SAH = 150/minute. 0725 a song in Spanish, may or may not be same station, then "Killing

Me Softly". 0732 fuller ID with AM and FM frequencies but could not copy them. IRCA Mexican Log shows the only 660 by that name is XEFZ, supposedly off the air after 0600, 10/1 kW. MWoffsets shows XEFZ on 659.9981 as of 2019. KSKY and KTNN both on 660.0002 as of 2023, i.e. 2.1 Hz away from XEFZ. By the way there are no XEs at all on 670, 680. This was on a household radio with internal antenna only, positioned to null east/west. From Tim Hall, IRCA Mexican Log editor, the *ABC Deportes* format was 24h on 570, so the 24h schedule probably continued when the format moved to 660 kHz. [Hauser-OK]

- 670 **CUBA** *R.Rebelde*, Arroyo Arenas DEC 30 1800 I miss the 40-50 daytime audible Cuba stations from my former Clearwater, FL location. Here, this is one of the best signals at nearly local (along with 640 Progreso). I'd forgotten about the Noticiero Nacional de Radio 30 minute news feed some networks and provincial stations pick up 1300-1330 Cuba local time. It's still there, with Rebelde dumping out of network programming into the NNdR theme at 1800. National nets R.Progreso, R.Musical Nacional, R.Enciclopedia, R.Taíno, and R.Reloj do not pick up NNdR. On very rare occasions, NNdR has been noted extending to 60 minutes. [Krueger-FL]
- 750 **DOMINICAN REPUBLIC** HIDV *R.Jesús*, Santiago de los Caballeros DEC 31 0300 – Over/under WSB and CBGY; promo's in Spanish including religious keywords la palabra, la vida, el corazón, then "Desde República Dominicana..." and *R.Jesús* jingle. New log. [Conti-NH]



- 799.85 unID DEC 30 1140 Big het on WBAP, pointing roughly SSW/NNE, frequency measurement estimated. The closest thing I find on MWLIST.com Frequency Offsets page is 799.97, *Radio 800* from Managua, Nicaragua, last report update June, 2023. *Radio 800* would very infrequently appear at my former Clearwater, FL home. [Krueger-FL]
- 1000 **CUBA** *R.Artemisa*, Artemisa JAN 14 0900 Under WMVP; signature chimes. [Conti-NH]
- 1060 **MEXICO** XERDO *La Raza*, Matamoros, Tamps. DEC 31 0240 Local level with Mexi and Latin American artists ballads, "La Raza 1060" drops, full ID with calls at 0304 UTC. Listed as 7000/2500 watts, but sounding more like 50 kW. Oddly, listed as silent in the IRCA Mexico Log 26th Edition, though I've noted it often. [Krueger-FL]
- 1160 **ANTIGUA** *Caribbean Radio Lighthouse,* St. John's JAN 6 0816 Choral religious music matching internet stream. Fair signal. [Beu-TX]

It's been a couple months since the last musing – Sorry Linda! With work, holiday prep and other life administration, every available minute of hobby time has been spent listening rather than typing/reporting. It's been a very fun season so far.

One of my favorite aspects of DXing with SDRs is visually looking for locals/pests dropping off for some reason. Spotting a gap in the SDRC Waterfall view is thrilling – what might be hiding in there? Here are the more interesting loggings found in pest gaps:

- 12/4 at 0553z 880-WCBS-NY dropped audio for a minute, long enough for WXBN-FL to ID with the Black Information Network.
- 12/12 Evening 1400-WHGB-PA having amusing digital program feed issues, with stuttering that sounded like Max Headroom after too many Red Bulls.
- 12/13 0500z superlocal 1350-WNLK-CT had open carrier for an hour allowing logging of WGPL-VA pitching Christian-themed holiday gifts.
- 12/24 700-WLW dropped audio after TOH leaving W Radio, Colombia. Sadly, no Argentina.
- 12/26 local 570-WMCA-NY off for less than a minute leaving WSYR-NY, R. Nacional de Colombia //680 and the badly distorted Cuban.
- 12/16 and 12/23 1170-WWVÅ-WV had satellite feed problems on two consecutive Saturday evenings. For over 2 hours each evening they played just a 3-second tone every 6 seconds. Fortunately, the SDR Console audio notch filter quite nicely suppressed the beeps leaving the frequency essentially empty and allowing loggings of WAVS-FL and a cheating WKFL-FL. WAVS must get big sponsorship from Biolife, as both evenings featured a multi-hour infomercial for the products.

The two really big "gap loggings" so far this season were:

- 11/24 0700z 1020-KDKA-PA had a 40-second gap in audio, leaving the faint but unmistakable multi-station ID from Radio Vision Cristiana from KCKN-NM for state #39 from here.
- 12/11 0902z 1210-WPHT-PA had audio problems silence broken by the occasional syllable blurting through leaving KGYN-OK "The Big Talker" for state #40.

International highlights this season include several new Europeans during the openings back in October thanks to the new northeast-pointed Superloop, including 999 R. 

For the last two weeks, the entire LW-HF spectrum at my NY location has been plagued with the worst I've encountered in the 44 years I've been in that house. The problem seems to be coming from one of the electric poles out front. Unfortunately, I don't have the equipment that could pinpoint the source, so even if I can persuade PSEG, the power company, to come out, the chances of them taking the time to do more than a cursory investigation is remote. If the issue isn't obvious and easy to correct, I doubt it will get fixed.

Meanwhile, I'm really enjoying the much more DX friendly conditions in CO. Even the occasional RFI, more prominent during the summer months and I think related to the solar inverters, isn't a problem. Using the Airspy HF Discovery and YouLoop hanging in a North facing window, as well as the C.Crane SSB, I've picked up several new stations which I reported to the DX West column. The Crane is a great little receiver and I often make use of the narrower bandwidths it offers.

Conditions seem to favor Utah and Kansas with an occasional Texan thrown in. I made IQ recordings from the Airspy and also some audio recordings from the Crane. The SONY Digital recorder I use with the Crane produces great audio, but the one thing it lacks is a way to note the frequency. Fumbling around trying to note the frequency on my phone in the middle of the night often yields incomprehensible notes in the daylight :-).


