NRC AM Log Sold Out: We are now sold out of the 44th Edition of the NRC AM Radio Log. Wayne and team will now turn to the preparation of the 45th Edition due out this summer.

From the Publisher: To get this issue down to 24 pages, we have had to hold several non-time-sensitive items for the next issue. As a general rule, we try to have issues of either 24 or 36 pages as these are the most cost-effective sizes for the print edition of *DX News*. So when – as for this issue – we have about 25½ pages of material, we need to either cut/hold a few things or find more content to fill the issue.

We've been asking ourselves how to maintain the print edition of *DX News* as long as it's wanted and supported – the NRC is one of the last radio clubs still publishing a print bulletin – and also take advantage of electronic distribution to avoid holding back or never printing some content for space considerations. The plan is that we'll start distributing bonus issues – call it *DXtra News* – to e-DXN subscribers on an irregular basis.

DXtra News will contain a few kinds of things: (1) industry and station news that is of some interest to members but tends to be cut for space reasons; (2) longer contributions from members that go beyond the usual 30-line limit for Musings; (3) things we plan to eventually publish in DX News but need to delay for space reasons; and (4) more frequently updated reference material (CP/STA lists, etc.). Issues will be distributed as we have material and as I have time to put them together.

From the Archives

90 Years Ago: From the March 7, 1934 issue of *DX News*: News of the March 4 DX test from CP4 La Paz, Bolivia on 1040 kcs arrived a little too late for publication in advance, but a few members

had heard an unID station that morning which they suspect to have been this test.

<u>75 Years Ago</u>: From the March 5, 1949 issue of *DX News*: Bert McAllister, general manager of KRPL-1400 (Moscow ID) noted with surprise that there were no reports from the eastern U.S. for their DX test this year, "probably due to all-nighters on 1400 kcs," and that "some of us old timers in this DX game had better wake up and realize that there are damned few of us left" who know what verifications even are. (Another entry in the "DX isn't what it used to be" series.)

<u>50 Years Ago</u>: From the March 11, 1974 issue of *DX News*: Large logging columns this issue with 20 reporters to DDXD and 17 reporters to IDXD.

25 Years Ago: From the March 1 and March 8, 1999 issues of *DX News*: Longtime NRC member Frank Wheeler died in January. Mark Connelly published the schematics and building instructions for the DXP-1 DXPedition phasing unit.

<u>10 Years Ago</u>: From the March 3, 2014 issue of *DX News*: The NRC Board of Directors proposed adopting a 20-issue-per-year schedule for *DX News*, starting in the fall of 2014.



to overlay directional patterns over maps, modifying the pattern to take ground conductivity into account, fccinfo.com displays the theoretical directional pattern, which generally makes more sense for skywave signals. Further investigation is required but it appears as if the FCC is not getting current information for Canadian stations. As well as likely changes to the night patterns for stations like CJLI-700 Calgary AB (see below), CHED-630 Edmonton AB and CJOB-680 Winnipeg MB, CKJH-750 Melfort SK is still listed as CJVR, call letters that the AM station has not used since 2002, when CJVR-FM first signed on.

700 KALL UT North Salt Lake City – Was off the air all night until 0830 ELT on Sunday morning February 11. CJLI was mostly dominant in areas where KALL normally has a strong signal. In the last few years, they have been heard in more and more areas. As opposed to when CJLI originally signed on in 2015, they could only be heard in Vancouver in narrow windows of time when they were on their day power/pattern and KXLX Airways Heights, Washington was on their night power/ pattern. Clearly, CJLI's night-time directional pattern has changed.

LA Baton Rouge – Just noticed this post on their website today (February 19) when streaming: "KBRH TRANSMITTER UPGRADE We're currently upgrading the 1260 AM KBRH transmitter. Once installed, the new transmitter will restore us to full power and provide reliable service. 1260AM KBRH will be off the air during the installation. However, it's still streaming online at https://wbrh.org/kbrh-listen-live- 2/ Thanks for your support during this exciting upgrade!" (TK-FL)

Fort Walton Beach – [NOT] This remains a killing joke. Per the FCC (via the NRC DXN Volume 91, No. 11) "silent" since February 12, 2024 due to a supposedly lightning strike. Fact is, this station has been silent for at least seven years, pulling the wool over the FCC at every opportunity, they who never visit extreme rural Northwest Florida to discover that this, as well as 1140 kHz WPNS Destin (but really

Niceville) no longer exists, with the transmitter building of WPNS no longer existing! Indeed the weather was poor this night here, a perfect excuse to renew the claim that WFDM of temporary silence. Meanwhile, their W232CF 94.3 MHz translator continues 24/7 illegally with "The Sound Of Freedom 94.3" programming (the branding will tell you what the format is). From Wiki: "WFDM

is currently off the air, their tower and transmitter building have been razed and the studio building (control point) has been vacated as of 3/20/2021. While they are still listed a licensed radio station on 1400 kHz on the FCC AM station query, their listing on the website Radio Locator (www.radio-locator.com) has been removed. Since it is still listed as a licensed station by the FCC it is unclear what the future of the station is. Their translator W232CF on 94.3 MHz remains on the air with a WFDM ID, however the 103.7 MHz translator W259AN is relaying a different station." (TK-FL)

Hi to all. I haven't mused in literally 50+ years, but I thought I'd introduce myself to those in the print pages of *DX News*. I started listening in 1961 from Queens, NY, dropped out of sight in 1972, and only returned to the fold after retiring and spending 18 pandemic months at our Cape house in Mashpee, MA starting in March 2020. The guys from Boston still get a chuckle as I sometimes refer to 680 as WNAC and 850 as WHDH.

Anyway, I've drunk the SDR Kool-Aid and also constructed two terminated 8 ft. x 36 ft. terminated loops, one aimed at 75° and the other at 180°. Where I am is basically a summer community, so there aren't a lot of neighbors around with RFI-causing appliances in February. Our house is just about half a mile to the beach, which offers me nearly a clear water path to transatlantic locations south of Madrid and to most Latin American locations. I report mostly to the CapeDX.io and IRCA.io groups, but since I'm here for a good part of the month of February, I thought I'd drop a few reports to the appropriate sections and a musing to *DX News*. The 75° antenna provided some good results this week with stations from the U.K., Moldova, and Romania, along with the usual Spanish and Algerian stations.

Back in the day the quest was to hear the west coast. Well, that's not happening from this location. Too many things in the way! 73s and good DX to all.

It's been 2 years since moving from CA to FL. This musing goes over some of the differences between the two locations. CA seemed like you could hear DX all year. There were very few thunderstorms so no lightning noise. Where I lived in Orange County most of the frequencies were dominated by a station that you could listen to. And you could get a null on many of them to hear other stations. The graveyards were open some nights to dominant stations from different directions. Here in FL, it seems like distant reception just shuts off in the summer. Thunderstorms and lightning noise are prevalent. Many frequencies sound like graveyards. Most stations fade in and out making it difficult to listen to for more than 5 minutes. I'm getting used to hearing more religious programming including Gospel. The number of non-English languages is less here in FL. GY frequencies don't yield much useful at night. I have 2 locals making it unlikely that I'll hear a large number of GY stations like I did in CA. Cubans are more prevalent than the Mexicans and block many frequencies. I think I'll hear more stations in FL but it will be more difficult to get good reception reports to them. Next muse I'll get back to DX. 73's Martin

I've been back here in CO for the past 10 days where my experience with DX is comparable to Martin Foltz's as described in his latest musing. Listening to overnight IQ recordings, it's not hard to detect different stations popping up over the course of several hours even on frequencies with nearby CO stations. Some nights the Texans dominate and other nights it can be Wyoming, Kansas or Canada. Sunset often brings AZ and NM. Maybe if I were here full time, the novelty would wear off, but right now, the surprises are a lot of fun.

I received the Qodosen SR-286 after a week's delay between the time it cleared U.S. Customs and was delivered here. To my surprise, it came with a fully charged battery. The button combinations are not as intuitive as the C.Crane's, so I downloaded the manual and have to reference it frequently. I have the Crane with me and noted the Qodosen has some features, like an external antenna port, antenna amp and attenuator, that the Crane lacks. On the other hand, it lacks SSB reception which seriously compromises listening to the ham bands which I'm not yet sure it tunes. A quick comparison of the two receivers leaves me wondering why the best features of each couldn't be combined into one without requiring a bigger or more costly unit? More to come as I spend some time tuning around the MW with the two.
