#### From the Archives

90 Years Ago: From the April 25, 1934 issue of DX News: Station XEO-XEFO (940) in Mexico City uses two callsigns, XEFO for commercial broadcasts and XEO for political broadcasts. KYW new transmitter has obtained а site at Whitemarsh, and is expected to move to Philadelphia by the fall. A new 1-million-Watt station, callsign COD, is scheduled to begin

broadcasting from Cuba by November 1. (But I don't believe this station ever came on the air – am I wrong about that? – DY)

75 Years Ago: From the April 30, 1949 issue of DX News: Verifications were finally issued from the WIMS DX test in December; the chief engineer was out for six weeks with diptheria. (See, some things have gotten better over the years.) The accession of Newfoundland to Canada resulted in some call changes; VONF-640 is now CBN St. John's, VOWN-790 becomes CBY Corner Brook, and VORG-1450 is CBG Gander.

50 Years Ago: From the May 13, 1974 issue of From the Publisher: So I promised a DXtra DX News: Tom Sundstrom penned a review of the Autek Research "Q-Box." The mathematics for determining distance along a "Great Circle" path was explained. The publishers wrote an essay on the history of NRC governance (such as it is).

25 Years Ago: From the May 17, 1999 issue of DX News: Lots of news in IDXD on broadcasting from Serbia due to the ongoing conflict there.

10 Years Ago: From the May 12, 2014 issue of DX News: Over many objections, the FCC granted Birach Broadcasting's application to move its new station CP from Terre Haute IN to Peotone IL.


#### NRC Antenna Pattern Book 8th Edition

As well as the CFRN item below, similar requests for license revocation are expected soon for the other Bell Media stations that went off the air last year.

Despite a dismal financial outlook for the next year, Corus is unlikely to follow Bell's example of shutting down money-losing radio and television stations. The book value of these stations is collateral for some Corus financing; shutting down a station could trigger a demand for repayment by the lenders involved. Corus owns major market AM stations including CKNW-980 and CKGO-730 in British Columbia, CHED-630, CHQT-880 and CHQR-770 in Alberta, CJOB-680 in Manitoba, and CFIQ-640 in Ontario. It should be noted that when a station suddenly is no longer listed in Canada's official list of allocated frequencies / stations, it may have already been off the air for several years, which may be the case for CFYI-790 and CHYW-1630, listed below.

- **530 CHLO ON Brampton** Still running hybrid HD (IBOC) with some of their listeners with HD receivers expressing appreciation for the noise-free audio. They are one of only two stations using HD on AM in Canada.
- **580 CHAH AB Edmonton 4/5 0105-0109 –** Open Carrier making it too hard to hear anything else on this quiet channel where KUBC was dominant before CHAH first signed on. Back on the air when next checked at **0633**. CBX-740 shares the same transmitter site but did not suffer any outages. **(JP-AB)**
- **590 CJCW NB Sussex** The CRTC finalized conditions of service for the move to FM on April 8, most notably the implementation of the National Public Alerting System (NPAS) by the time of the FM's launch.
- **600 CFQR QC Montreal** The CRTC has received an application to change the ownership of the station from TTP Media to Phil Richards.

**790 CFYI ON Caledon East** – This 30-Watt Tourist Information station is no longer listed in Canada's official list of allocated frequencies/stations.

**870 CKIR BC Invermere** – Strong signal into Edmonton on two recent nights, likely indicating they are stuck on 1 kW day power. (JP-AB)

- **910 CKDQ AB Drumheller** The CRTC finalized conditions of service for the move to FM on April 8, most notably the implementation of the National Public Alerting System (NPAS) by the time of the FM's launch.
- **940 CFNV QC Montreal** The CRTC has received an application to change the ownership of the station from TTP Media to Phil Richards.
- **1260 CFRN AB Edmonton** Bell Media only requested revocation of the station's license on March 6 but the CRTC revoked the license on April 10. The station has been off the air since last June and the towers were knocked down soon after. Still no word on the other Bell stations that went off the air at the same time, last June.
- **1280 CFMB QC Montreal** Still no hybrid HD (IBOC) yet, and no public comments from owner Evanov, who also runs CHLO-530.
- **1340 CJEV BC Elkford** Slogan changed from Real Country 94.9 to New Country 94.9, to reflect that this is a 50-Watt rebroadcast transmitter of CJPR-FM 94.9 MHz Crowsnest Pass AB.
- **1630 CHYW ON Ottawa –** This 99-Watt Airport Information station is no longer listed in Canada's official list of allocated frequencies/stations.



APR 2 1204 National anthem in progress; 1205:40 ID including call letters, address (Chapultepec 316), power (1000 watts) and slogan; a PSA was followed by a ranchera tune at 1207 UTC. Not strong but no interference for a while. [Wilkins-CO]
- 1070 **CUBA** *R.Guamá*, Guane APR 20 0401 Over/under CHOK; choral national anthem, then signature melodic 4note chimes. [Conti-NH]

*Mike Jeziorski adds*: Two of my Mexican loggings are apparently new to the air, 780 XETMEP and 1250 XEVREP. Both loggings have the vague details "Arre en AcústiK programming." Arre en AcústiK (pronounced ARRay en aCOUStica) is a disastrously managed network of Mexican stations. The only semi-reliable outlet is 1150 XEJP in Mexico City, which had been off the air for over a year. The top-of-the-hour network ID mentions XEJP, 1120 XEUNO Guadalajara (long silent), and 600 XEMN Monterrey (silent, replaced by 630 XEFB, which may be on the air less than 10% of the time), but no other affiliates. About a dozen CPs for the network have been approved around Mexico, all six-letter calls ending with -EP, and maybe 3-4 are on the air relaying dull XEJP programming and constant solicitations for advertisers. Most commercial Mexican stations are currently running constant political ads for the national elections in early June; after that content stream/community obligation ends, who knows how many will go dark.

#### <u> Richard "Rick" Lucas – Rochester NY</u>

Hi there! First time muser, thirty-two-year member, and (almost) seventy-year DXer. As was mentioned in a previous *DX News*, I decided to try a little experiment during our recent total eclipse. Rochester was very near the center line of totality so a small group of friends and I decided to watch from an open softball field at the local Cobbs Hill Park. I took my reliable old CCrane Skywave with me to test the eclipse skip theory. Without better information, I decided to check some mid-band frequencies during totality. Since totality was only a little over three minutes, I preset the tuner to 1100 AM in the hopes of hearing WTAM, Cleveland in the middle of the afternoon (3:20PM EDT). Normally, WTAM at 244 miles is totally absent during the day, so I thought it a good test. Fortunately (unfortunately?) Rochester was completely clouded over, so I didn't need to watch for the corona or wear the debilitating "eclipse glasses". I could fiddle with the tuning knob while being awed by how dark it got.

Long story short...WTAM came up nicely at about 3:17PM and persisted through the eclipse for about 7 or 8 minutes. Not S9+20, but certainly pleasantly listenable. I twisted around a bit and listened to the talkers on KDKA (216 miles) exclaim about the long lines of traffic headed north on I-79 to get to eclipse territory in Erie. Also noted competing audible signals on 1120 and 1160, but there wasn't time to tarry on any one frequency for too long, so no ID's. It was a brief and fun test, and answered a question that I have wondered about for decades!



TOTAL SOLAR ECLIPSE MW DX MONITORING, April 8, 2024 from 1830 past 1900 UT. This is very close to local mean noon here which is always 1832 UT: With city-to-city distances, approx., not site to receiver. Mainly on the altazimuth wrist-mounted DX-398, internal ferrite antenna only, on declining battery power and not especially sensitive. From just outside the house facing south. But first:



1200 at 1832 on the R75 with N/S shortwire, JBA carrier, maybe two of them. WOAI? next closest is 1 kW KYOO in Bolivar MO; big sigs in IL & ND

unlikely. 1200 at 1848 faded up to VG level, 1849 network eclipse coverage from east coast, recorded: <u>https://www.w4uvh.net/Eclipse WOAI 1200 20240408 1849.mp3</u> Got to be 50 kW WOAI San Antonio. Gone by 1905 check. 777 km/485 stmi

1560 at 1833, fringe KEBC, 1 kW Del City = OKC has some CCI. There are several unexpected little stations in KS, MO and TX, but 46 kW KGOW Bellaire [Houston] TX is my prime target, as its Vietnamese will be unmistakable and unique. Despite its patterns, easily heard here at night. Keeps growing past 1837, and by 1843 during totality in SE OK, it's loud and clear in VV, overcoming KEBC, recorded: <u>https://www.w4uvh.net/Eclipse KGOW 1560 20240408 1843.mp3</u> Still in at 1855, another clip with some singing: <u>https://www.w4uvh.net/Eclipse KGOW 1560 20240408 1855.mp3</u> 1901 still dominant but declining. 1908 gone. 777 km/483 stmi

1620 at 1845, talk station mentions Texas; nothing earlier. Got to be 10 kW WTAW College Station. Not often heard here even at night. 658 km/409 stmi

1700 at 1845, SAH between two carriers; 1858 San Antonio ad, AC 210; 1859 fade before ID! Trouble is, neither TX is near San Antonio: Brownsville and Richardson. NRC AM Log shows 5 kW KKLF Metroplex is Spanish, Jalapeño Radio; still? But address in Corpus Christi, so multi-station group? If it's got to be English, that leaves much further KVNS Brownsville, 8.8 kW listed as Fox Sports. Maybe both unless Des Moines snuck in. Richardson: 395 km/246 stmi; Brownsville: 1167 km/725 stmi

1530 at 1846, baseball talk in Spanish. Maybe just KXTD Wagoner/Tulsa OK, but SS in TX are 50 KW KGBT Harlingen. More likely is the only other TX, KZNX Creedmoor, 10 kW Spanish; and despite address way out in El Paso, is really just south of Austin in the Eclipse zone. 701 km/436 stmi. Recorded: <u>https://www.w4uvh.net/Eclipse\_KZNX\_1530\_20240408\_1846.mp3</u>

1480 at 1847, Spanish in mix, overcoming KQAM Wichita. Only SS in TX is 5 kW KLVL Pasadena [Houston]. 785 km/488 stmi

1120 at 1850, religion in English vs Spanish from KETU Catoosa [Tulsa]. Only TX on 1120 is religious 5.6 kW KTXW Manor [Austin], separable. 674 km/419 mi

1110 at 1850, mixture in English. Primary is 50 kW KVTT Mineral Wells [Plano, Metroplex] listed Asian format. Only other TX is 5 kW KTEK Alvin [Houston], religious. 813 km/505 stmi. KFAB Omaha can have remnant daytime signal, doubtful now.

990 at 1851, Spanish religion, surely 7 kW KFCD Farmersville [Dallas]. Not trans- but within Totality; more signal than should be in daytime. 385 km/239 stmi

870 at 1852, SAH of about 7 Hz looping SE. Hoping for WWL! The only TX is 1 kW KFJZ Fort Worth. They fit! MWoffsets in 2023 and 2024 measurements has WWL on 869.9928 and KFJZ on 869.9991, i.e. 6.3 Hz. My count-the-fades-per-second method was a tossup between 6 and 7. Gone by 1905 check. WWL: 1019 km/633 stmi. Recorded: https://www.w4uvh.net/Eclipse WWL KFJZ 870 20240408 1852.mp3

1710 at 1857, steady open carrier, local? Not noticed before, maybe a TIS or Talking House.

1680 at 1900, gospel/CW music loops NW/SE. Got to be 10 kW KRJO Monroe LA. 683 km/424 stmi 1510 at 1902, traffic and WLAC IDs with 98.3, Nashville! Unexpected, way off the angle expected for trans-Eclipse propagation to here. 995 km/618 stmi

1530 at 1903, English ads from ENE, 1905 "ESPN 1530" so WCKY Cincinnati/KY, likewise! 1212 km/753 stmi. These two were also reported during the TSE from east/south of them. Also checked 600 several times, clear frequency locally, for 5 kW KTBB Tyler TX, but no sign of it. Of course highband worx much better. I also looked for KBEL 1240 in Idabel OK where there were loads of visitors in OK's small Totality corner, not really expecting to hear my most distant 240-mile Okie never logged, and did not: just the usual fringemix of Elk City and Wichita.

Since Allan Weiner made such a big deal of the TSE, I thought there might be live coverage on WBCQ. But after 1900, 7490 & 6160 webcasts were ordinary stuff, gospel huxter and music.Meanwhile, visual DX: glimpsed the eclipse several times thru ISO glasses, which sure don't inside, want fit outside spectacles. to or my https://www.w4uvh.net/Eclipse at Enid thru cheap filter 20240408.jpg. There were some fleeting clouds but mostly clear. Not enough leaves on the trees yet for multiple crescent projections; could see some thru pinholes. We witnessed the 2017 TSE in Nebraska, so decided to avoid the trouble, crowds and expense this decade, but enjoy it from home. Also noted local F temps: at 1814, 70.6. At 1840 as max begins, dropped to 65.3. Minimum 63.9 a few minutes later. After 1900 soon back up to 71.

## XHDATA D-608WB Ultralight Portable Tech Report and Loopstick Upgrade Gary DeBock via groups.io via Phil Bytheway

The new XHDATA D-608WB is another innovative portable from the manufacturer of the D-808, R-108, D109 and D-109WB models. For the price of US\$41.50 you get an AM-FM-SW-Weather band



receiver with a 3000 mAh "18650" lithium battery, a built-in emergency flashlight, emergency hand crank and solar panel for charging the battery, an MP3 player with Bluetooth capability and a superb 5 watt-rated speaker (although the audio output power is only 2 watts).

The MW reception of the stock D-608WB portable is fairly good (up to the level of the D-109 and PL-380 on their 3 kHz filters), even though there is no direct frequency input, rotary volume control or selectivity options. But I figured that if I was really using this radio in an

emergency, I would probably want to chase DX with it! For me, that means really digging out weak AM signals with a highly sensitive external loopstick, boosting the AM-DXing capability of this compact portable far past anything the Chinese designers ever dreamed of.

As such, the first "supercharged" D-608WB is now a reality. The stock loopstick is a 265 uH single coil design on a 3 1/8" (79mm) ferrite bar, with fairly accessible circuit board connections. This portable is fairly unique in having almost no plug-in connections between the front and back sections almost everything is hard wired, like you are opening up a book. The DSP chip is probably an Si4734 like that of the D-109, but it is hidden under a well-soldered shield. In any case, the performance is very similar to Si4734 radios (D-109 and PL-380) on their 3 kHz filters, and the 265 uH stock loopstick inductance also is within the Si4734 chip range. For the loopstick transplant job, everything went very smoothly after the 5 cabinet screws were removed from the back panel. These



self-tapping screws are small, tightly installed and obviously not meant to be played with. After using a jeweler's screwdriver to remove all of them, I got the distinct impression that XHDATA would probably want to replace any defective radios rather than repair them.



So how does the "supercharged" D-608WB perform on AM? In combination with the radio's superb deep-bass speaker, you can chase DX with booming, high fidelity audio backing you up. The radio has a very powerful audio amp, so investigating weak signals becomes a real thrill. Marginal signals which hang around the noise level on other models ("supercharged" D-108 and R-108) can pound in with good audio on the souped-up D-608WB. The only "supercharged" Ultralight model that can match it in both audio quality and audio amp power is the new Qodosen SR-286, which has a slight MW sensitivity edge over it (but which is significantly trickier to "supercharge"). The D-608WB has a solar panel installed on the top cabinet surface, but you can still attach the antenna frame and keep the solar panel functional. As a bonus, you can use the same 7.5" upgrade loopstick as described in the Tecsun PL-380 "supercharging" article posted at:

Overall, this model is a real thriller for its total construction cost of about US\$75.

#### **Qodosen SR-286 Hot Rodding with a R40C1 Ferrite**

In 2019, **Gary DeBock** commented on the performance of the R40C1 ferrite rod material versus the more common Amidon 61 rods when used in a XHDATA D-808 transplant.

I recently remembered Gary's positive results in favor of the R40C1 and I decided to give one of these rods a try in on a Qodosen SR-286. For those unfamiliar with the R40C1, it's a ferrite mix in rods from China that are popular with the crystal radio experimenters due to the superior "Q" values achieved with the R40C1. More information is found on the auction page for the R40C1 rods sold by Ebay seller "mkmak222": <u>https://www.ebay.com/itm/151884949745</u> Besides the promise of higher performance, the R40C1 rods are a cost savings over the Amidon 61 rods (\$10.50 vs ~\$25 each).

I was greatly assisted in this project by Steve Ratzlaff, who did initial testing to help determine how many coil turns would be needed on the lower permeability R40C1 rod. The higher than usual

target inductance of 638 uH was a concern for a lower permeability rod. Would you even be able to reach 638 uH within the 200 mm length of the rod?

In the end, 638uH was achieved with about 206 turns of 60/46 Litz wire (also available from Ebay seller mkmak222). The coil was wound over a sliding Kraft paper form, and then centered in the middle of the rod. The coil's length is 4-1/8 inches (105 mm). Winding the coil was about the easiest part of this project, as I put the ferrite rod in the chuck of a variable speed drill and let



the motor do the winding. All I had to do was guide the successive turns as the rod rotated. It took only a couple of minutes to complete, and the coil turned out very neat with no gaps in the winding.

Although I wound the main coil to 638 uH based on Gary's findings, the stock loopstick on my own SR-286 measures 668 uH. Either value works fine in the radio so there's obviously some leeway when the radio's DSP circuit peaks a signal (just like with SiLabs-based DSP models).

I used two turns of the same Litz wire for the "tickler" coil; it measured 4 uH when wound on top of the main coil of the R40C1 rod. The completed rod is suspended in a clear plastic tube by rubber O-rings, which offer some shock protection from bumps. The four coil leads (protected by heat shrink tubing) exit the clear tube from a small hole in the center of its length and enter the SR-286 through a small hole in the radio's case. Trimmed down self-adhesive cable tie mounts hold the assembly to the radio.

The "tickler" coil is indeed essential to the radio's operation on medium wave using the loopstick, and not an inductive coupling coil for the external antenna as I suggested earlier. The correct hookup is essential as Gary has pointed out. I accidentally had the tickler coil's leads reversed at first, and performance was abysmal. I switched the leads, and the radio sprang to life again on MW. I'm very curious what this 2nd small coil provides in a DSP radio like the Qodosen.

Enough of the technicalities! How does the hot rodded SR-286 work? Very well, thank you. Perhaps I'll have the chance to directly compare this R40C1 setup with Gary's Amidon-modded radio the next time I'm in Puyallup. However, I'm seeing an average of 30 dB improvement over the radio's built-in whip antenna (which you'll recall has more sensitivity than the \*stock\* loopstick). Some results are less than 30 dB better, but I've had at least one station that showed a whopping 40+dB increase over the whip! At night virtually every 10 kHz MW channel is filled with stations, something that definitely can't be said for the tiny, stock, internal loopstick of the receiver.

This testing was done indoors near windows in my house, so is only preliminary. I look forward to trying the radio in a quiet area during my DXpedition to Grayland, WA next week. I will also be comparing it to Craig Barnes' stock version SR-286.

Thanks again to Steve for his helpful assistance and to Gary for getting (and keeping!) the SR-286 train rolling!

#### Hot-rodding the CC Skywave SSB – and two pleasant surprises! Hans Ostnell <u>barentsdx@gmail.com</u> via groups.io via Phil Bytheway

Since I added an external antenna jack for Mediumwave on my XHDATA D-808, with a very nice result, I wanted to do the same on my CC Skywave SSB (which is a "version 1", without any external antenna jack at all). Luckily enough, there is a very nice article about this procedure in the Files section here in the group, see "Hot-rodding Skywave.pdf" by Chuck Rippel. The procedure is basically the same as the one I did for the D-808, and it also follows Gary DeBock's <u>article</u> about Supercharging the D-808/PL-380 (and CC Skywave) (T100), with one exception: After removing the "midget" stock loopstick from the receiver, you don't solder the Supercharged 190mm R61-75 Amidon loopstick directly into the stock loopstick's solder pads. Instead you connect the two solder pads to a 3.5 mm female mono jack, via two short lengths of 250/46 Litz wire. Very simple, however a little bit more

tricky on the Skywave, where you have to lift a PCB to access the solder pads. If one works carefully and take time to do a good work, it's a little bit "picky", but not really difficult.

Now, this is what I found out after removing the Skywave SSB stock loopstick and adding an external antenna jack:

1. In the first test, I connected the Skywave SSB to the Supercharged 190mm R61-75 loopstick, which I made for my D-808. I just plugged it into the new external antenna jack. It worked excellent, and I found that the Skywave SSB is just as sensitive as the D-808 on the loopstick. Maybe the D-808 has a tiny edge of



sensibility, but I think that really doesn't matter in practical use. The D-808 has a little bit better audio, but I think that the filters is better in the Skywave SSB. Besides that, the Skywave SSB has a tone control with which you can toggle between "Voice" and "Music". The "Music"-position gives a little bit more fidelity – which makes it possible to use the 1 kHz bandwidth with acceptable (or at least "no-so-muffled") audio. Very nice, indeed.

2. Second test: I hooked up the Skywave SSB to one of my Super-KAZ (huge outdoor loops). Result as expected: excellent, just as the D-808. I found out a very nice thing: The external antenna jack, soldered into the solder pads for the stock loopstick also works on shortwave! Hence, one simple modification solved two problems with the (version 1) Skywave SSB. The Skywave SSB 2 already has an external antenna jack – but that is only affecting Shortwave and FM. I you need an external antenna jack for Mediumwave on your Skywave SSB 2, you need to do exactly the same modification as I did on my version 1.

3. I wanted to make a new "supercharged" loopstick for the Skywave SSB. The problem was that I didn't have any R61-75 ferrite rod available, nor had I any 32mm PVC tubing left (I use a 200mm length this PVC-tubing to make a "housing" and protection for the ferrite loopstick). So what to do? Well, on my shelf I had a Sony ICF-EX5MKII that had been destroyed by leaking batteries (yes, very sloppy of me), and it was beyond any kind of help. I however believed that the internal loopstick in this radio still was OK, so I "rescued" it and cleaned it up from old Litz, glue and wax. I didn't know what kind of material this loopstick is made of, and I also found out that it is 10mm shorter than the 190mm Amidon ferrites that we usually are using for our modifications. Anyway, I took a chance and decided to wind it exactly as in Gary's description of the PL-380 "Supercharged" loopstick. The only difference is that I started winding the 68 turns of 250/46 Litz wire exactly 60 mm from the edge of the ferrite (on the 190mm loopsticks we start 70mm from the edge). I got the Litz coil almost perfectly centered. Now, lacking PVC tubing, I had to find some other kind of protection for my newly fabricated loopstick. Out in the garage I found 1 meter of "foam tube", which we here in Norway are using to isolate hot water tubes - In order to save energy. I cut a 200 mm piece of foam tube, and fit the loopstick inside, before I secured the construction with wire straps. Easy work, and I feel that the loopstick is well protected.

Now, time for testing: I soldered a 3.5 mm mono plug to the two Litz wire sticking out from the loopstick in the foam tube and plugged it in to the external antenna jack in the Skywave SSB. I believed that the difference between the new "unknown material" 180 mm loopstick and the earlier 190 mm R61-75 loopstick wouldn't be that big – but still in favour of the 190 mm. Well, here I got today's second surprise! While testing outdoors, by switching between the 180 and 190 mm loopsticks, I found the "unknown material" 180 mm loopstick to be AT LEAST as sensible as the 190 mm one. Call it luck or whatever – but I'm more than satisfied! This experimental "unknown material" 180 mm loopstick is a keeper. I will try to find out what material it is made of and keep using it for DXing and as a reference.

I'm attaching a picture of the "mystery loopstick" inside it's foam tube. Happy building and modifying! 73 de Hans/LB6GG, Sandnes, Norway

### WCGO-1590 Evanston IL Update

Karl D. Forth, Chicago.

WCGO on 1590 is being heard all over North America and even Africa. It has been reported in Tunisia recently.

I can remember during my DXing days in the 1970s when this was a quiet suburban 1000-watt daytimer, at one time WLTD.

Today, it provides a loud splashy, turned-up-all-the-way signal, listed at 10,000 watts day and 2500 watts night.

Their transmitter site's four towers are wedged into a piece of land in Skokie, between McCormick Blvd., the CTA Yellow Line, and the Northside Metropolitan Water Reclamation plant.

I've read of several requests from DXers for a schedule of the station's varied programs. There are several schedules online, but each one I found was out of date or not accurate.

WCGO's schedule is not carved in stone, and seems to vary a little day by day. I listened during the week in late March, and this is what I heard.

Starting early in the day, it is Korean radio all morning. Then from 1300-1700 EDT it is the Spanishlanguage Ambiente Clasico Radio, with mostly pop songs and kind of a 1970s feel, even playing some English-language oldies.

Next, it's the Russian-language NVC Radio, which comes on at 1700 EDT. At last check, this ran four hours, but I think earlier this was a three-hour program.

I've noticed on some of the other time-brokered stations that a program presenter will buy a shorter time period on the broadcast station, then try to drive listeners to stream a longer program online.

At 2100 EDT, it's back to Spanish-language Ambiente Clasico Radio for the rest of the evening.

At midnight local time (0100 ET) it's into English-language Multiformat Network, and I've heard a variety of recorded programs, from "Talking Pets" (a discussion of pets, not pets speaking) and "Rabbi and the Reverend" just after midnight. I've also heard segments of political talk that were not identified

On one recent Friday night, I heard open carrier for the entire post-midnight period, and during several later checks. The weekends seem more fluid, with a number of shorter programs. They do ID in English, and mention W240EH 95.9 FM Evanston-Chicago.

There are no Tunisian programs currently scheduled.

The county's real-time highway travel advisory radio station, 1620 AM, is disbanding next week after nearly 20 years of broadcasting, officials announced.

The Lake County Division of Transportation's (LCDOT) real-time PASSAGE Highway Travel Advisory Radio Station, WQBR256 operating on 1620 AM, will be decommissioned on Wednesday.

LCDOT operates and maintains five radio towers, which are nearing the end of their service life. The transportation division said an analysis of existing technology and "careful consideration" by the traffic department led to the decision to decommission the existing towers and LCDOT no longer broadcasting on 1620 AM.

1620 AM communicates real-time traffic information directly to Lake County motorists.

Broadcast information includes the location of delays due to crashes, construction and traffic congestion to help motorists plan their commute.

Lake County will save approximately \$400,000 by decommissioning the radio towers in place of constructing new radio towers or updating the existing ones.

"It's a bittersweet moment for us because the radio station was an essential part of Lake County PASSAGE when it opened in 2006," Assistant County Engineer Jon Nelson said.

While the highway advisory radio station is going away, LCDOT said it will maintain its focus on providing up-to-date information on the Lake County PASSAGE website and app.

Lake County PASSAGE, available on Apple and Android devices and at lakecountypassage.com, provides real-time travel information in Lake County.

The public can view snapshots from intersection cameras and snowplows, see road construction zones and closures and sign up for notifications to receive alerts for designated roadways.

LCDOT said usage of Lake County PASSAGE continues to grow, especially during extreme weather events and construction season.

In January, PASSAGE had more than 90,000 website and app sessions and 263,000 email notifications sent.

LCDOT added a new feature to the website and app that allows people to listen to the latest traffic info "radio-style."

The following additional loggings have been found since I submitted my initial report in December.

#### **INTERNATIONAL – PAN-AMERICAN (UTC)**

- **MEXICO** XEPL *La Superestación*, Cuahatémoc, Chih. OCT 28 0400 At 10 p.m. local time, they seemed to run five 800 Hz pips about 18 seconds late, followed by a brief announcement and the Chihuahua state anthem. 841 miles. Relog, but not heard much in recent years.
- **CUBA** *R.Reloj*, Santa Clara, Villa Clara OCT 29 0500 RR pips about 35 seconds after the top of the hour (defective pips were heard on all frequencies: ".-. .-.." so I don't believe I had more than one transmitter). Parallel 790, 860, 950 kHz. Relog.
- **MEXICO** XEPBGJ *Jalisco Radio*, Guadalajara, Jal. OCT 28 0401 Way under usual pests KPLY and KHOW; 6-note chimes (C-E-G, G-C-E). They used to play these chimes at the top of every hour, but now they are hardly ever heard, and not exactly at the top of the hour (these were almost 2 minutes late). The following month this station was re-licensed as a daytimer.
- **COLOMBIA** HJBJ, *RCN* Santa Marta OCT 28 0358 Five note attention signal, Colombia PSAs, and *RCN* 5+1 1000Hz pips parallel 770, 800, 1000 during brief opening on Colombian wire. Coastal site, directly on the beam of my SESE (Colombia) wire. Also found on a recording from the previous night, under KFI and *R.Progreso* with Colombian PSAs. The next night at 0459 UTC I caught their 5-note attention signal parallel 800, with the full *RCN* ID audible on 800 kHz. New, Colombia #23.
- **MEXICO** XELOVE *La Lupe*, Cd. Juárez, Chih. OCT 30 0000 Quick *La Lupe* liner and children's version of the Mexican anthem (which started near the end of my recording). Very odd to hear an anthem at 6 p.m. local time. 660 miles. Relog.
- **MEXICO** XEETCH *La Voz de Los Tres Ríos*, Etchojoa, Son. - **CUBA** *R.Reloj*, Ciego de Ávila OCT 28 0403 Under WBAP and one other station; RR Morse code. Relog but rare.
- **CUBA** *R.Granma*, Media Luna OCT 27 1000 Under KNWN; program of older music and familiar 9-note attention signal about 30 seconds after the top of the hour. Relog.
- **MEXICO** XEQR *R.Centro* 1030, México, CDMX OCT 28 0045 Faded up under KTWO and KBUF; older Mexican vocals and "Radio Centro 1030" liners. 1626 miles. Relog.
- **CUBA** *R.Guamá*, Guane, Pinar del Río OCT 30 0059 Noted familiar 6-note ascending attention signal under KNX. Relog.
- **COLOMBIA** HJBC *Caracol*, Cúcuta OCT 28 0401 Barely audible under KMXA; Caracol "Ultima Hora" news sounder parallel 810, 1170 kHz. New, Colombia #27.
- **COLOMBIA** HJGC, *RCN* Sogamoso OCT 28 0358 Under WOAI; *RCN* 5-note attention signal parallel 640, 770, 800 kHz. New, Colombia #26.

#### DOMESTIC – UNID (ELT)

- **850 unID** 10/30 2304 ESPN programming noted on NENE wire under KOA (probably my worst pest on the entire dial). Given the surprisingly good conditions to northern states, I would love to think this was needed WKNR, but I can't rule out WRUF which has been heard here once or twice before.
- **1370 unID** 10/27 2359 Fox sports programming on this wide-open channel. Only WLOP is listed, but a number of stations in the mountain and plains states run Fox Sports programming on weekends, so I really can't say what this was.
- **1560 unID** 10/26 1958 Under KZQQ on the E/W wire, high school football crowd noise (cheerleaders, etc.). Seemed to disappear shortly after the top of the hour. This may have been needed KHBR. Their Friday night high school football game (Hillsboro Eagles @ Godley Wildcats) got rescheduled to tonight (Thursday) at the last minute, and would have been starting at the top of the hour (pre-game show was scheduled half an hour before the game, which also seems to fit). Unlike the other likely stations on 1560 that carry high school football, KHBR would still be on the air until the top

of the hour. Unfortunately, the archived high school football games on KHBR's web site were gone when I revisited their web site.

- **1560 unID** 10/27 0800 Appeared suddenly on EESE (TX/FL) wire, under KNZR and KEBC with USA news sounder. This was probably needed WSLA, which would be switching from 500 Watt PSRA to 1kW day power at this hour, but it could be unneeded KTUI.
- **1710 unID** 10/27 0547 On the NE wire, traces of a male voice with a possible mention of "National Forest Service." There is a group of new stations in the Bridger-Teton National Forest in Wyoming (one station in Jackson, one in Moran, and one mobile unit) with actor Harrison Ford giving a message about fire safety. Had I known about these stations, I would have aimed an antenna that way (NNE). I'm getting traces of a male voice on my N and NE recordings but so far cannot pick out any solid identifying details.
- **1710 unID** 10/29 2307 On the NE wire, possible partial call sign "WH5" can be clearly heard in a male voice.

- **1610** WPPZ664-WRVK493 CO Loveland 10/27 2110 Faded up over CHHA with nice ID by female announcer: "You are listening to WPPZ664, the City of Loveland information radio system, 16-10 AM." This station was re-licensed as WRVK493 in 2022, but continues to use their originally assigned call letters. 485 miles.
- **1710 TIS NM Bandelier National Monument 10/31 0800 -** Barely audible under lots of noise. "Welcome to historic Bandelier National Monument" phrase by male announcer, as heard in previous years. I never would have noticed this if I hadn't heard them before. 482 miles.

#### **DOMESTIC LOGGINGS )ELT)**

- **540 KNMX NM Las Vegas 10/28 0059 -** Over CBK (on a wire that was aimed much closer to CBK!) with ID by female announcer "You're listening to 5-40 KNMX Las Vegas, and K260DJ Las Vegas 99.9 FM." Listed 25 Watts nights, but *surely running day power much of this weekend*. 543 miles.
- **550 KFRM KS Salina 10/28 1159 -** Way under KFYR with ID by female announcer "the voice of the plains, KFRM Salina" into USA news. Listed 110 Watts night and PSRA power. 875 miles.
- **550 KTRS MO St. Louis 10/27 0359 -** On top of channel (fighting KRAI) with local ad for Robang Properties LLC Mike Robinson 314-283-0867 ("we buy houses for cold hard cash!") followed by very quick ID "KTRS St. Louis." 1282 miles. Relog but fairly rare.
- **570 WWRC MD Bethesda 10/31 0359 -** Barely audible, fading up briefly over WNAX and a few other stations with end of top-of-hour liner in the familiar voice of the Salem announcer: "... Arlington. We ARE the answer." Matched the top-of-hour liner from their web stream. 1954 miles. **New, for Maryland #4**.
- 570 KWML NM Las Cruces 10/28 0052 On top of channel with pregame show for high school football: Las Cruces Bulldawgs @ Las Cruces Centennial Hawks. Heard again on 10/30 @ 1206 Faded up with ID "Kool Oldies 104.5 FM, New Mexico's Greatest Hits." Listed 250 Watts PSRA. This station had been stuck on their day rig 24/7 earlier in the month, but corrected the problem right before my DXpedition. 617 miles.
- **570 KVI WA Seattle 10/28 0156 -** On top of channel with Dana Loesch Show and local ad break including 'Seattle Awnings'. 714 miles.
- **580 KSAZ AZ Marana 10/29 1200 -** Loud signal with usual 'La Estación de la Familia' ID. They actually started the ID for KDYK-1020, but a few seconds later they dubbed the KSAZ ID over it. Listed 390 Watts nights, but they were blasting in on every wire, so *I suspect they left the day rig on all weekend*. 481 miles.
- **580 KUBC CO Montrose 10/26 2358 -** Fair signal with Classic Rock and ID "This is KUBC Montrose, AM 5-80, FM 104.5, The Canyon, a Townsquare Media station." Normally a nightly pest (especially in recent years, when they had their day rig on all night), but hardly noted at all on this year's recordings (possibly not at all when they were on night power), perhaps due to KSAZ covering up almost everything on the channel all weekend. Logged again on 10/28 @ 0005 On top of channel (before sunset) with high school football: Montrose Red-Hawks @ Pueblo West Cyclones, sponsored by Cooper Soils & Landscaping 970-240-0123 and Home Loan State Bank. *They've finally stopped running their day power all night*. 335 miles.

580 CHAH AB Edmonton - 10/29 2258 - Under KMJ, with long ad string by Indian-accented announcer, with phone numbers in the 780 area code. 985 miles.

**590 KRFE TX** Lubbock - 10/28 1159 - Steady signal, fighting WIBW with ID: "You are listening to KRFE Lubbock, AM 5-80, the station that listens to Lubbock, West Texas, and Eastern New Mexico." Listed 390 Watts PSRA. Logged again on 10/30 @ 0459 -Under WIBW (no sign of usual pest KUBC) with same ID. Listed 290 Watts nights. Noted surprisingly often in this year's recordings. *Maybe on day rig?* 779 miles.

MA Boston - 10/30 0304 - Fighting KQNT and KXSP with Eric Metaxas talk program **590 WEZE** (religious/political talk). 2234 miles.

600 WMT Cedar Rapids - 10/29 0359 - Way under KSJB, with top-of-hour ID. The past IA couple years they have been a nightly catch. 1194 miles. Relog.

610 KCSP MO Kansas City - 10/29 0500 - Faded up under KEAR with ID: "KCSP Kansas City, WDAF-HD2 Liberty, always live on the free Audacy app" into Fox sports. 1039 miles.

TX Dallas - 10/27 0959 - Fighting KTAR with ID: "Radio Luz Dallas 6-20 AM KTNO. 620 KTNO Alimiento para miente y corazón. Somos 6-20, radio luz." 1053 miles.

620 CKRM SK Regina - 10/28 1058 - Way over KTNO with Country music & ID: "Country's greatest hits, CKRM," and local ad for Arcola Co-op (fuel) on highway 13 in Arcola. 903 miles.

TX San Antonio - 10/29 2358 - Briefly alone on channel (before they dropped to 680 KKYX night power) with good 90s Country music and ID. 1087 miles.

680 CJOB MB Winnipeg - 10/27 1059 - Blasting away with ID: "6-80 CJOB, Winnipeg's news, today's talk." These guys are a pest on almost every wire. It's widely known that they haven't operated a proper night pattern for years. 1103 miles.

690 KOLT NE Scottsbluff - 10/29 1304 - Under KTSM, with end of Fox News, PSA, and local weather sponsored by Platte Valley Bank. Listed 65 Watts nights (no known PSRA; they have a CP to drop to 7 Watts nights, but I haven't seen any indication that they have implemented it yet). 587 miles. New, for Nebraska #43.

700 KDAZ NM Albuquerque - 10/30 2359 - Way under KALL and an unidentified station running an instrumental version of the Star Spangled Banner with end of top-of-hour ID liner "7 hundred, KDAZ Albuquerque." Listed 65 Watts nights. 491 miles. NEW! New Mexico #65.

730 KWOA MN Worthington - 10/30 0725 - On top of channel with morning show and "AM 7-30 and FM 100.3" slogan. Listed 159 Watts nights (no known PSRA). 1000 miles.

740 KBRT CA Costa Mesa - 10/30 2028 - On top of channel with promo using "K-Bright" slogan, followed by yet another horrible female vocal version of the Star Spangled Banner. (They seem to find the very worst versions available!). Still trying for // KNSN-1240 from here. 412 miles.

ON Toronto - 10/27 0544 - Under KNFL and presumed KVOR/KVFC, with liner 740 CFZM "Zoomer Radio, the original greatest hits" into 70s oldies. Note the song history on the station's web site (https://www.zoomerradio.ca/whatwas-that-song) never seems to match the songs they actually played on the air at the specified times. 1788 miles.

750 KMMJ NE Grand Island - 10/29 1958 - Under KOAL with Spanish contemporary Christian music and ID. This station

consistently signs off 15 minutes later than they should in October, making them a good end-of-October target at this hour. 858 miles.

760 KMTL AR Sherwood - 10/27 0815 - Appeared suddenly under KDFD with regional Mexican music, followed by "la raza" liner which seemed to include the station web site radiolaraza.com. Weak signal for listed 10kW non-directional daytimer. They had been on a 1kW STA but this had not been renewed after 2022. 1236 miles. NEW! Arkansas #11.

770 WABC NY New York - 10/27 0602 - Way under KKOB, with ID and promos for station web site wabcradio.com and "WABC Music on the Weekend" programming. 2100 miles.

KAAM TX Garland - 10/27 1941 - Under KKOB, with EAS alert and flash flood warning 770 from the North Texas Emergency Alert System. 1058 miles.

WJAG NE Norfolk - 10/26 1959 - Faded up under KKOH, with ID and Fox News at the 780 ToH. They should have signed off 15 minutes ago. 890 miles.

790 KWIL OR Albany - 10/28 1030 - Faded up under KSPD, with start of Alistair Begg's "Truth for Life" religious teaching program. 600 miles.

830 KNCO CA Grass Valley - 10/27 2252 - High school football: Shingle Springs Ponderosa Bruins @ Grass Valley Nevada Union Miners. This station is all over my recordings this year. 373 miles.

- **840 CFCW AB Camrose 10/29 2304 -** On top of channel, with Country music and liner "Look anywhere in this great country of ours, and you'll find no station like 8-40 CFCW... Alberta's Country Legend." 961 miles.
- **850 WXJC** AL Birmingham 10/27 0800 Appeared suddenly during a rare half-minute where KOA wasn't pounding bumper music under their news/weather/etc. Brief announcement by a male announcer, then a distinctive two-note ascending chime (which may have been a different station), and an ID: "You're listening to the radio station that cares about you enough to tell you the truth, this is Truth 101.1 WXJC-FM Cullman, WDJC-FM-HD2 Birmingham, and WXJC-AM." (Some of these words were confirmed by listening to the same liner at 0700 Central Time on their web stream. They run a different top-of-hour liner for each hour of the day). 1557 miles. NEW! Alabama #4.
- **850 KFUO MO Clayton 10/29 0815 -** Appeared suddenly under KOA, with "Sacred Music" program hosted by mumbly male announcer. 1272 miles. Relog.
- **860 KKOW KS Pittsburg 10/30 0820 -** Faded up for ID: "Your Number One choice for Classic Country, 8-60 and 97-5 KKOW." Hardly noted at all in this year's recordings. 1056 miles.
- **860** CJBC ON Toronto 10/30 0704 Noted a second French station under CKBF-1 on the NE wire. 1788 miles.
- 870 WKAR MI East Lansing 10/28 0759 Faded up from the slop with promo for WKAR used car donation drive (call 866-WKAR-527), followed by ID including WKAR-FM\_90.5-HD2 and translator W272EM-102.3, both in East Lansing. 1555 miles. NEW! Michigan #6.
- **880 CKLQ MB Brandon 10/27 0804 -** Under KRVN, with traffic report for Highway 18 and local news, followed by promo for 'Q Country Mornings with Ray & Shelly'. These guys are frequently heard on my northern wires, but most of their IDs get trampled by KRVN. 1009 miles.
- **890 KVMX CA Olivehurst 10/30 2104 -** On top of channel, with Las Vegas Raiders football in Spanish. 407 miles.
- **940 KVSH NE Valentine 10/29 2059 -** Under KPSZ, with local weather (this station runs many minutes of weather each hour). Listed 19 Watts nights. 751 miles.
- **950 KJRG KS Newton 10/30 0726 -** Briefly on top of KKSE, with Religious talk and Bott Radio Network promos. Listed 500 Watts PSRA. 901 miles.
- **950 KWAT SD Watertown 10/28 0800 -** ID: "KWAT Watertown, South Dakota" fitting nicely into a few seconds of dead air from KKSE and KJTV. Two mornings later I caught the same ID at this same hour, and found that it also includes a mention of the station web site 'gowatertown.net'. 955 miles.
- **950 CFAM MB Altona 10/27 0704 -** Under presumed KKSE, with local news and weather, mention of station web site 'PembinaValleyOnline', quick ID, and weather sponsored by Rosenort Credit Union. 1050 miles.
- **960 KSRA ID Salmon 10/27 0805 -** Faded up over two or three other stations with jingle ID. Listed 56 Watts nights (no known PSRA). 423 miles.
- **960 KLAD OR Klamath Falls 10/27 2255 -** Way under CFAC, with high school football: Henley Hornets @ North Bend Bulldogs. 452 miles.
- **960 KALE** WA Richland 10/28 1029 Fighting CFAC, with Contemporary Christian songs and "The Bridge" liners. 560 miles.
- **970 KHTY CA Bakersfield 10/27 2119 -** Faded up over KESP, with local traffic report sponsored by 'blindster.com'. Interestingly, they were not exactly // KBFP-800 at this time. Before the traffic report, there was a liner for "Fox Sports Radio AM 9-70." The traffic report on KBFP-800, which covered the same traffic incidents in the same order, was sponsored by an agency of the California State government. Seems rather silly to produce separate traffic reports for two stations in the same market that are essentially (if not actually) simulcasting. This was probably the ideal time to hear this station, as they increase their power at sunset (their October FCC sunset time was four minutes before my logging, and it was already dark in Bakersfield, giving me a complete path of darkness to them). 366 miles. NEW! California #234.
- **970 KHVN TX Fort Worth 10/30 0820 -** Faded up under KJLT and XEJ, with liner: "Dallas' BIN 9-70 and 16-30" // KKGM-1630. Listed 270 Watts nights (no known PSRA). 1029 miles.
- **970 KTTO** WA Spokane 10/28 1030 Under KOFI, with 'Sacred Heart Radio' Catholic programming // KLAY-1180. 614 miles.

- **980 KWSW CA Eureka 10/30 0725 -** Under KFWB, with light Oldies and liner: "Easy 95.5 and AM 9-80." Listed 500 Watts nights. 546 miles.
  - **980 KEYQ CA Fresno 10/27 2359** Audible with quick ID under KMIN's lengthy top-of-hour liner. Listed 48 Watts nights. 354 miles. Relog but rare.
- **980 KFWB CA Los Angeles 10/30 0725 -** On top of channel, with longstanding 'Laboratorios Camacho' program, basically an all-night infomercial program, which once aired on some of the Mexican border-blaster stations. 414 miles.
- **1000 KTOK OK Oklahoma City 10/27 0818 -** Appeared suddenly under cheating KKIM, with 'Oklahoma's First News' program with local news and ID by female announcer, followed by a quick weather update. Seemed like they switched to day pattern about 12 minutes early, but I'm not sure. The same thing seemed to happen three mornings later. 945 miles. Relog but rare.
- **1030 KMAS WA Shelton 10/28 1030 -** Appeared suddenly over KTWO (along with KDUN) as both switched to day power with quick ID. Soon lost to KDUN. 723 miles.
- **1060 KBGN ID Caldwell 10/27 2202 -** On top of channel, with ad for 'Dakan Funeral Chapel' in Caldwell, followed by sedate instrumental hymns and "Grace to You" religious teaching program. This station has a PSSA, but the power levels are not known. 346 miles.
- **1070 WDIA TN Memphis 10/27 0800 -** Appeared suddenly under KNX as they switched to day power, with local ad for 'Washington Brothers Roofing' in Millington 901-486-0609. 1343 miles.
- **1070 WTSO WI Madison 10/30 0727 -** Faded up under KNX and KFTI, with local sports host giving "Fox Sports 10-70" slogan. 1311 miles. **NEW! Wisconsin #5.**
- **1090 KMXA CO Aurora 10/28 0801 -** Appeared suddenly in mid-sentence, with TuDN Deportes programming. They appear to be going to full 50 kW day power at 6 AM local time, instead of using their 500 Watt PSRA. 503 miles.
- **1100 WZFG** MN Dilworth 10/26 2058 Fighting KNZZ and WTAM, with high school football playoffs: Grand Forks Central Knights @ Fargo South Bruins.
- **1100 WZFG MN Dilworth 10/27 0547 -** Under KNZZ. with liner "News, weather, sports and more, subscription-free, am1100theflag.com." Listed 440 Watts nights. 1023 miles.
- **1110 WBT** NC Charlotte 10/30 0730 Appeared under KFAB as they switched to nondirectional day rig with local news and Charlotte traffic. 1835 miles. Relog but rare.
- **1110 KEJL NM Humble City 10/30 0821 -** Under KFAB, with obscure Classic Rock and "Eagle 100.5" liners. This station has no known PSRA, and should not be on the air for another 40 minutes. 741 miles.
- **1130 KLEY KS Wellington 10/30 1958 -** On top of channel, with AC music and full ID about a minute after the top of the hour (they did not seem to reduce power at their October FCC sunset time). They were noted on many of my recordings this year. 911 miles. Relog, but not heard in years.
- **1130 KWKH LA Shreveport 10/27 2045 -** Faded up from the slop, with high school football: Southwood Cowboys @ C.E. Byrd Yellow Jackets. 1206 miles.
- **1140 WQBA FL Miami 10/31 0731 -** Faded up over the slop with female announcer in Spanish giving the station's phone number 833-867-2346. 2143 miles.
- **1170 KJJD CO Windsor 10/31 0700 -** Appeared suddenly over KTSB, blasting away (surely on full day power) with regional Mexican music and "la ley 11-70 AM" liners. They should not be on the air for another hour, and should not be on full power for hour and 15 minutes after that. They have no FM translator, and thus should not be producing any programming at all at this hour, but they were on at this hour every morning. Another long-term cheater that never seems to get caught. 494 miles.
- **1170 KPUG WA Bellingham 10/27 2229 -** Almost alone on channel with ESPN college football. 789 miles. Relog but fairly rare.

**1180 KLAY WALakewood - 10/28 1030 -** Under KOFI with Sacred Heart Radio Catholic programming //KTTO-970. 699 miles.

**1190 KFXR TX Dallas - 10/26 1958 -** Under constant pest KXKS (before cutting power) with "Talk Radio 11-90" promos and liners. 1047 miles.

**1220 WLPO IL La Salle - 10/30 2300 -** Faded up from the slop, with garbled ID: "This is 103-9 WLPO La Salle, a Starved Rock local station" and back to Classic Rock. Listed 500 Watts nights (day power is only 1 kW). 1320 miles. **NEW! Illinois #13.** (Note this station's web stream seems to run about a minute and a half behind the AM signal).

**1220 KDDR ND Oakes - 10/29 2305 -** Very weak, with ID, a slogan that I couldn't copy, and Country music. Listed 327 Watts nights. 944 miles.

- **1230 KBOV CA Bishop 10/27 2119 -** Faded up from the mush, with local ad for 'Black Sheep Coffee' on Highway 395. 264 miles. Relog but rare.
- **1230 KHDN MT Hardin 10/29 2306 -** Faded up very nicely over KDZA, with liner: "We're unfiltered, incorruptible, and unafraid The Vigilante AM 12-30", followed by a male announcer reciting the station's talk show lineup starting with Mike Gallagher at 8 AM. 564 miles. **NEW! Montana #47 and Graveyard #252.**
- **1230 KOTS NM Deming 10/30 2358 -** Briefly on top of channel, with Country music and ID: "The station for hot Country and yesterday's hits . . . AM 12-30 KOTS." 587 miles.
- **1240 KMBY CA Monterey 10/29 0904 -** Fighting perennial pests KRDO and KDGO, with ID: "Broadcasting from historic Cannery Row in Monterey, California . . ." (an instrumental version of the classic "93-KHJ" jingle was spliced in here) ". . . KMBY Monterey-Carmel-Salinas-Gilroy. . .". 460 miles. Relog but very rare.
- **1250 KZOI NE Dakota City 10/29 0904 -** Weak, but on top of channel briefly, with Regional Mexican music, promo including station phone number (255-9810), and slogan: "97.1 FM y 12-50 AM". Listed 500 Watts days (this was 19 minutes after FCC sunrise time and about seven minutes after actual sunrise at the transmitter site). Also found a full legal ID on one of my recordings from the previous evening, about a minute after the top of the hour. 957 miles.
- **1260 KNBL ID Idaho Falls 10/27 0704 -** Briefly on top of channel, over KWYR, with Classic Rock and liner: "Another Cannonball Run on Cannonball 101". 312 miles. Listed 500 Watts PSRA.
- **1260 KKOO ID Weiser 10/27 2202 -** On top of channel with nice oldies format and "101.5 Kool FM" liners. Listed 36 Watts nights. 376 miles.
- **1270 KVMI CA Tulare 10/27 2110 -** Over KGAY's pathetic 90s music and XEAZ's pathetic political speeches, with Soft Classic Hits, app promos, and still calling themselves the "new" My 97.5, many years into the current format. 347 miles.
- **1280 KXEG AZ Phoenix 10/30 0806 -** More or less "stunting", with a Regional Mexican format (same as KNNR-1400), including a Spanish-language morning show. Whereas KNNR is splicing local ads into this program, KXEG was heard with an ad for 'Albor's Collision Center Incorporated' in Addison, Illinois (!) 630-543-7330. Listed 442 Watts PSRA but has a PSRA for 50 Watts days, 49 Watts nights from a longwire. 398 miles.
- **1280 KWSX** CA Stockton 10/27 2117 Faded up under KBNO and KZNS, with Fox Sports and "Fox Sports AM 12-80" liners. 395 miles.
- **1280 KRZE** NM Farmington 10/29 0100 Weak signal, way under WODT, with ID in Spanish including mention of '103.5 FM'. This station has been loud every night in my past sessions, but is missing from almost all of this year's recordings. I strongly suspect they had been running 5 kW day power all night for a few years, and finally fixed it before this year's DXpedition. Listed 95 Watts nights (and finally sounds like it!). 355 miles.
- **1280 KZNS UT Salt Lake City 10/27 0704 -** Already blasting on day rig a few hours before sunrise with sports programming. 166 miles.
- **1280 KZFS WA Spokane 10/28 1029 -** Fighting KIT, with cringy Urban "music" and "Hooptown 101.5" liners. 613 miles.
- **1290 KZSB CA Santa Barbara 10/27 2118 -** Faded up over KAZA, and one or two other stations, with promo for interviews from the KZSB AM/FM News Center. Listed 500 Watts days. 447 miles.

- **1300 KVET TX Austin 10/30 0820 -** Way under KCSF, with promo for sister station "98-1 K-Vet" and the iHeartRadio app. 1101 miles.
- **1300 KKUB TX Brownfield 10/29 0100 -** Under XEP and KCSF with 'Guadalupe Radio' mention, "Radio Católica Mundial" jingle, and very weak ID by a male announcer. Nice to finally catch a legal ID on one of my recordings. Listed 120 Watts nights. 772 miles.
- **1310 KNOX** ND Grand Forks 10/30 0704 Fighting KGLB, and one or two other stations, with local news, time check, ID and five-day weather forecast. Slogan "News Radio 13-10 AM 107-9 103-3 FM." 1043 miles. Relog but rare.

- 34 1310 KNPT OR Newport - 10/28 1030 - Appeared suddenly under KLIX and KEIN, with local ad for 'Szabo's ("Say-Bo's") Steakhouse and Seafood' NE 52nd Street and Highway 101. 639 miles.
- 1310 KTCK TX Dallas - 10/29 2000 - Under KIHP and KYUL, with liner "Sports Radio 96.7 FM
- and 13-10 AM The Ticket." 1042 miles. Relog but hardly noted at all this year. **TX San Antonio 10/27 2047 -** Faded up under KYUL and KZIP, with Adult 1310 KAHL Standards music and ID. Listed 236 Watts nights. 1113 miles.
- 1330 KGAK NM Gallup - 10/31 0731 - Appeared suddenly with male announcer: "Good morning! This is KGAK ...". They signed on a half hour earlier than usual this morning. 379 miles.
- 1330 KOVE WY Lander - 10/28 2058 - Fighting KGAK and KWKW, with local ad break including 'State Farm agent Justus Jacobs', 990 Main Street in Lander (insurewy.com) and 'Baldwin Creek Rental Center', 675 Baldwin Creek Road in Lander, followed by ID. Listed 250 Watts nights. 380 miles.
- SK Rosetown 10/27 2151 On top of channel, with Classic Rock and liner 1330 CJYM "Streaming on the Radio Player Canada app, we're Classic Hits". Haven't heard the // CFYM-1210 the last few years due to KHAT constantly running their 10 kW day rig all night. 904 miles.
- 1340 KDCO CO Denver - 10/27 2101 - 'Esne Radio' Spanish Catholic programming // KHPY-1670. 484 miles.
- 1340 KPRK MT Livingston - 10/28 0859 - ID: "14-50 KMMS Bozeman . . . Where Montana talks". I originally mistook this for KYLT. 540 miles.
- 1340 KSID NE Sidney - 10/30 2258 - Under a Monday Night Football station, with Country music and "Cheyenne County Country" liners. 602 miles. Relog but rare.
- 1360 KHNC CO Johnstown - 10/29 0904 - Promotional announcement for "The Tree Farm" mentioned station phone number 970-587-5003 and website '1360khnc.com'. They should still be on 1 kW night power at this hour, but I don't seem to be finding them on any of my overnight recordings. 494 miles.
- 1360 KBUY NM Ruidoso - 10/27 1941 - Fighting KDJW and two other stations, with local ad string including 'Mountain Top Appliances' in Ruidoso Downs, local weather and ID. 611 miles. Relog but not heard much in recent years.
- 1380 KTKZ CA Sacramento - 10/27 2255 - Surprised to hear them running high school football: Rocklin Thunder @ El Dorado Hills Oak Ridge Trojans. 407 miles.
- 1380 KBWD TX Brownwood - 10/30 0730 - Under KHEY and KLPZ with local news, including a story about an incident at a nearby Walmart which was handled by the local police with help from the Brownwood Fire Department. Listed 500 Watts nights (no known PSRA). 987 miles.
- WA Everett 10/28 1030 Appeared under a couple of other stations with Classic 1380 KRKO Rock, ID: "KRKO, your information station," and slogan "Less talk, more music." Relog.
- 1390 KGNU CO Boulder - 10/26 2000 - Briefly faded up over constant pest KENN, with ad for local realtor 'Julia Mohseni' at 732-859-7064. 484 miles. Relog but rare.
- 1400 KNNR NV Sparks - 10/28 1029 - On top of channel with local ads for 'Avila's Auto & Truck Repair' at 775-324-9090. IDs on this station include KXEG-1280 and their respective translators. 306 miles.
- 1400 KBJM SD Lemmon - 10/31 0659 - Faded up from the mush, with ID: "KBJM Lemmon" (possibly followed by one more word) and USA News. 765 miles. Relog but quite rare.

The full list was last published in Volume 90 Issue 29, although an updated version was included in the first issue of DXtra News for those who received it.
