Tim Hall 2003 DXPedition – Final Update

Loggings from the Border Inn Beverage site, U.S. 6/50 at Nevada/Utah border (39:3:25N, 114:2:53W), Oct 26-31, 2023. The following additional loggings have been found since I submitted my second report in April. (Thanks to Bruce Conti of IDXD for editing the international loggings and Bill Hale of DDXD-West for editing the domestic loggings.)

PAN-AMERICAN DX

- MEXICO XEOA *La Mexicana*, Oaxaca, Oax. OCT 28 0208 On top of channel on SE wire with older Mexican music and female announcer with liner "continua en La Mexicana 570." The frequency was given as 570 (quinientos setenta). 1842 miles. New, Oaxaca #2, México #229.
- 590 unID OCT 28 0500 On the SE (South American) wire, about 48 seconds after the top of the hour, Two downward major arpeggios (G-E-C, G-E-C). Sadly, the Perseus software crashed about 30 seconds before the top of the hour and I couldn't get restart it and start a new recording until 0500:00 UTC, so I likely missed some important information.
- 590 unID OCT 29 1201 On the SSE (Mexican) wire, children's version of the Mexican anthem, ending at the same moment as the anthem on 1410 XEBS. Unfortunately I couldn't find any additional audio on 590 to match the audio from 1410 XEBS. XEPH, which is parallel 1410 XEBS, is still needed here.
- 770 **MEXICO** XEACH *R.Fórmula*, Monterrey, NL OCT 29 1158 Single verse children's choral version of Mexican anthem way under KKOB. They were running about 10 seconds behind the other *R.Fórmula* stations. (This was previously listed as an UNID, but a recheck of the web streams of all 4 surviving Mexican stations on 770 kHz confirms that XEACH is still the only station running this version of the anthem). 1226 miles.
- MEXICO XEANT *La Voz de Los Huastecas*, Tancanhuitz de los Santos, SLP OCT 29 1200 Heard bits of XEANT's distinctive anthem (little children shouting against a piano, perhaps a player piano), followed by a few good segments of the indigenous fiddle theme they play during IDs and other liners. 1499 miles. New, SLP #3, México #231.
- 810 **BAHAMAS** ZNS3 Freeport OCT 30 0358 Under KGO and KLVZ with Bahamas national anthem and "Broadcasting Corporation of the Bahamas" liner. 2211 miles. Relog but very rare since the 2017 hurricanes.

- unID OCT 28 0300 On the SE (South American) wire, about 48 seconds after the top of the hour, a single 1000 Hz pip and liner with slogan ("...Radio") and an upward minor arpeggio, possibly with two additional notes afterward (C-Eb-G-Ab-G). This doesn't sound anything like the CARACOL station. No news was noted.
- PUERTO RICO WABA *La Grande*, Aguadilla OCT 27 1002 Briefly audible under KOA with "Pega'os en la Mañana" morning news block, which is produced by 1320 WSKN "Radio Isla" in San Juan. Between the news stories, the announcer gives a very fast, terse time check: "Radio Isla, Pega'os en la Mañana, seis, uno." (Note the time check was one minute slow, which I also found to be true when listening to their web stream at home). This was half an hour before their October FCC sunrise time, so they should have been on their 1 kW non-directional night power, but I have to wonder if they might have already been on their 5 kW day power. Thanks to Mike Westfall on RealDX for helping me figure out the wording of the time check, leading to the identification of this catch. 3131 miles. New, Puerto Rico #3.
- 870 **ECUADOR** HCLY2 *R.Cristal*, Guayaquil OCT 28 0258 Weak but steady signal, almost missed them under WWL (and LRA1's top-of-hour time pips) with light music and *R.Cristal* liner. My SE wire was aimed right at them. Approximately 3581 miles. New, Ecuador #4.
- unID OCT 27 0500 On the SE (South America) wire, ID in Spanish mostly trampled by KRVN included the phrase "20 mil Watts de potencia," which would seemingly have to be HJGE Caracol Bucaramanga.
- 890 **CUBA** *R.Progreso*, Chambas OCT 30 0359 Tonight's ID included a partial list of frequencies by province: Camagüey 103.1 FM, 650 and 890 AM; Granma 103.1 and 102.3 FM, 1230, 1260, and 920 AM; Las Tunas 101.9 FM and 640 AM. The Camagüey 650 would seemingly be a move from 630, which one site had listed as moving to 890 a few years ago.
- 900 unID OCT 27 0459 On the SE (South American) wire, 6 short 1000Hz pips, about 13 seconds early. Noted at least one other night as well. Maybe Argentina? (870 LRA1 was in at this hour).
- MEXICO XEOY *Stereo Cien*, CDMX OCT 29 1201 Children's choral version of Mexican anthem way under XEFV. The other surviving station on 1000 kHz, XETAC, uses an adult choral anthem parallel 900 XEW. This was an unID in my original report. I eventually realized that XEOY changed their anthem version when they changed format.
- unID OCT 28 0212 Under KCKN and *R.Artemisa* on the SE (South America) wire; a male announcer in Spanish mentioned "la Gente Adventista" ("Adventist people"). There is an AWR affiliate in Bucaramanga, Colombia. Possibly them?
- 1039.615 unID OCT 28 0156 Carrier also noted here on the Colombian wire (the 1039.726 carrier was still present as well). Venezuela has been reported close to this frequency for a long time. No audio noted. Massive slop from Mayabeque wobbler.
- 1039.726 unID OCT 28 0123 Carrier noted between 1039.726 and 1039.731 on most southern wires. On this recording from the SESE (Colombian) wire, I have bits of older Spanish vocals which are consistent with the evening programming of Radio Chiapas. At 0126:48 I can almost hear their slogan "la frecuencia de tu corazón," but there's way too much noise (and slop from the Mayabeque wobbler) to be sure.
- 1050 **MEXICO** XED *La Poderosa*, Mexicali, BC Not a trace of them in this year's recordings, despite the fact that Mexicali stations in general were coming in much better than usual this year. I wonder if they were silent this weekend? (Slogan and format have since changed).
- 1060 **CUBA** *Radio* 26, Jovellanos, Matanzas OCT 29 0358 Under KYW; Cuban anthem in progress.
- 1060 **MEXICO** XECPAE *R.Educación*, CDMX OCT 27 0104 On top of channel with old ID liner using former XEEP calls, mentioning 100 kW.
- MEXICO XEUU *La Mejor*, Colima, Col. OCT 29 1201 Children's choral version of Mexican anthem way under KRLD. TIP: It's very easy to distinguish the two surviving Mexican stations on 1080. XETUL turns on their transmitter at 5:55am local time and immediately plays an adult choral version of the Mexican anthem (2 verses), followed by the México state anthem, before giving an FM/AM ID at 6:00. XEUU plays a children's choral version of the Mexican anthem (1 verse) about a minute after 6:00 a.m. (whenever the previous song ends), followed by an ID. XEUU was recently re-licensed as a 1 kW daytimer. New, Colima #1 (new state), México #230.
- 1130 **COLOMBIA** HJVA *Fuego AM*, Bogotá OCT 29 0358 Faded up under KWKH and KLEY with liner "Fuego AM, transmite en once cientos treinta kilohertz... Colombia..." Note the unusual way of saying the frequency ("11 hundred 30 kHz"). Format moved here from 1160 HJOC (logged here on a few previous DXpeditions) sometime in the past few years. New, Colombia #28.

- 1140 **CUBA** *R.Musical Nacional*, Santa Clara, Villa Clara OCT 29 0358 Only audible for a few seconds on this crowded channel with Cuban anthem parallel 590 kHz.
- MEXICO XERM, PSN, Mexicali, BCN OCT 29 0200 Fighting KEIB, KNRV and XEAD; liner "PSN Canal 45, Primer Sistema de Noticias, La Voz del Pueblo" and promo for 690 XEWW "La gigante." XERM is now parallel 690 XEWW, 1270 XEAZ, 1310 XEC, and 1700 XEPE most of the time. Listed 60 watts nights. (7 p.m. local time seems to be the most common time for Mexican stations to switch to night power, but they might not have actually been switching from day power to night power at this hour. Mexicali stations were unusually strong on this year's recordings). 450 miles.
- unID OCT 28 0358 On the SESE (Colombian) wire, while several Colombian stations were audible, a Spanish station getting trampled by KGYN and KHAT. Partial liner "somos la emisora que inspira..." Perhaps just KUBR?
- 1250 **MEXICO** XEDK, *DK* 1250, Guadalajara, Jal. OCT 29 0200 Under KWSU and others; "En Punto" newscast punctuated by Radiorama news sounder between stories. 1422 miles.
- 1309.676 **COLOMBIA** HJAK *La Voz de la Patria Celestial*, Barranquilla OCT 28 0358 After noting this carrier on my SESE (Colombia) and SE (South America) wires, I finally found some good audio on the Colombian wire, only audible on the lower sideband of 1309.676, with Spanish preaching and prayer. Thankfully, KZIP was running contemporary Christian music and their lengthy multi-station ID during this time, making it easy to distinguish the two stations. New, Colombia #29.
- unID OCT 29 1204 On the SSE (Mexican) wire, under XEHG, a very weak ID sounded like XHXE or XHXN. The second letter definitely seems to be an H, which is odd, as none of the surviving Mexican stations on 1370 have an FM simulcast. Soon lost to XEHG.
- 1370.050 unID OCT 28 0358 On the SESE (Colombian) wire, while several Colombian stations were audible, a carrier was noted here with possible bits of Spanish talk and music. Radio Mundial Bogotá has been reported at this offset.
- 1500.134 **PERU** OBX4I *R.Santa Rosa*, Lima OCT 28 0211 After seeing this off-frequency carrier on many recordings from my southern wires this year, I finally caught an ID liner "Radio Santa Rosa, buenas nuevas en tu vida," exactly as I have heard on their web stream. 4260 miles. New, Perú #3.
- COLOMBIA HJD24 *La Voz de la Unión*, La Unión OCT 27 0200 Appeared briefly under KFNN; announcement by female announcer promoting "El Sacramento de Eucaristia... solo aquí en La Voz de la Unión." This was followed by a male announcer "La Voz de La Unión, 1510 AM" ("Mil quinientos diez AM.") Listening to their web stream, I hear both of these liners at least once, and often twice around the top of most hours. The male announcer also seemed to mention "BTC Digital," and I found several Facebook posts showing the station's new (in 2022) broadcasting equipment from a company called DBTC Digital (this is probably being promoted because the station operates a trade school for careers in broadcasting). This is a 5 kW station about 100 km inland from Colombia's Pacific coast. They are operated by the Catholic Diocese of Río Negro, and their programming is an odd mix of light pop music in Spanish, bits of Catholic theology, and radio personalities, with a few ads for local stores. Approximately 3320 miles. New, Colombia #31.
- 1510 **ECUADOR** HC0034 *R.Monumental/La Gigante de la Capital*, Quito OCT 27 0401 Faded up over WLAC and KOAZ; secondary slogan "La Gigante" and ad for natural/herbal medicines from Francis de Leo El Centro de Salud y Vida Natural in Quito, the station's primary sponsor (and most likely their owner, as their offices are in the same small building in Quito). Approximately 3522 miles. New, Ecuador #3.
- on USB above 1520.071, one of a number of known Colombian offset frequencies that were noted (at least as carriers) on my Colombian wire this evening during a brief early evening opening to Colombia. Steady signal with a female announcer hosting a program of prayer requests. Only about 1 degree off the beam of my Colombian wire. About 3093 miles. New, Colombia #30.
- PERU OCU4J *Bethel Radio*, Lima OCT 28 0500 Fighting XERF; promo including the phrase "Bethel Radio, te esperamos..." and mentioning their new satellite signal, Satélite Amazonas 5, as mentioned on their Facebook page. The station moved to 100.1 FM on February 1, 2024. 4261 miles.
- unID OCT 28 0123 On the SESE (Colombia) wire, I have what appears to be a religious program in Portuguese. There was a good opening to Colombia on this recording, so I wondered if this might be *R.Nove de Julho* in Brasil, which gets out well with 20 kW at night. Although the voice of the man in my recording bears a strong resemblance to the voice of the man whose program airs on that station at this hour, I was eventually able to find a video of

tonight's program on the station's Facebook page, and could not find the specific sentences in my recording within that video. If this was not Brasil, it might have been KGST, which despite being mostly Punjab programming parallel 1490 KWAC, did have an hour of Portuguese programming (2 hours earlier than this recording) in the recent past. Unfortunately KGST has no web stream, and there are no SDRs close enough to hear them (until next winter when it will be dark at this hour?) so I can't eliminate that possibility. I may send a tentative report to the station.

1620 unID OCT 27 0200 – On the SE (South America) wire, under R. Rebelde music program; a man and woman in Spanish praying or reading promotional material, based on the repeated use of the word "gracias." XECSCGU or Argentina?

---AWOL---

1390 (KLGN) UT Logan - Something must have been going on with this station. In all 133 recordings I have only one very weak tentative log of them. On 5 kW non-directional day rig they should be an easy sunrise and sunset catch, but they are conspicuously absent. Perhaps silent much of the weekend, or operating at very low power?

---UNID---

- 10/31 0002 - Faded up over WNAX on EESE (TX/FL) wire with jingle "92.5, 570 unID the latest rock."

- 10/27 0759 – On the EESE (Texas) wire, an instrumental version of the Star Spangled Banner way under KOAL. WNDZ has been known to run an anthem at sunrise, but I could not hear enough details to confirm this was the same version of the anthem that WNDZ uses.

> – 10/28 0831 – On the SESE (West Texas) wire, classic rock music way under KOAL and KXTG. KSEO is a good possibility (they would have just turned on their AM for the day with a full path of darkness to my location) and still needed here. Similar station KSPI-780 (also a 250 Watt daytimer) has been heard here.

- 10/30 0800 - On the NENE (MN/WI/IA) wire, a partial ID "...W, it's eight o'clock." This pretty much has to be WSGW. There are no other stations with call letters ending in W on this channel, and I can almost convince myself I hear "SGW" in the ID. Most of the Eastern time zone is already in daylight at this hour, but a few areas including Michigan are not. Unfortunately I can't hear the distinctive news sounder that WSGW uses between news stories and other items.

– 10/30 2304 – On the NENE (MN/WI/IA) wire, ESPN programming. This may have been needed WKNR, but WRUF has been logged here in the past.

- 10/30 0658 - On the NENE (WI/MN/IA) wire, country music and liner "Real country for all of..." with the remainder crushed by interference. Strongly suspect needed CKNX.

- 10/30 0700 - Appeared suddenly on the NENE (WI/MN/IA) wire with partial top-of-hour liner "The place where the glory(?)..." then trampled by interference. WROL would just be switching to day power at this hour with a full path of darkness to my location, but unneeded KJRG is also possible. Need to monitor web streams to see if I can catch either station using this liner.

– 10/29 2200 – On the terminated E (AL/GA) wire, a garbled ID with one very clear phrase: "News radio business reviews, Birmingham, Alabama."

– 10/27 2017 – Under KSIR, CBR, KIHU, and KCHJ on the unterminated E/W wire, a high school football game with 13 seconds left in the first half (so not the same game as my other UNID on this channel). One player's name was Wylie Eicher, another player's name was Rico.

- 10/27 2028 - On the NE (Dakotas) wire, high school football game in the 4th quarter with two minutes to go. One team was the Bulldogs. Normally I would think this was WJXL, which carries both the Bolles High School Bulldogs and the Georgia Bulldogs, but neither of those teams played tonight (Bolles HS played on Thursday night, Georgia on Saturday).

- 10/29 2200 - On the terminated E (AL/GA) wire, under KTBL, a garbled liner with a very clear mention of 97.3 FM, a pause, and a phrase that included the term "slow jam." This was followed by news read by a Canadian sounding announcer, which may or may not have been the same station. The only 1050/97.3 combo is a country station in Pennsylvania, which definitely doesn't fit this. Maybe someone promoting a sister station?

1150 unID

– **10/29 2200** – On the terminated E (AL/GA) wire, a muffled top-of-hour ID by a deep-voiced male announcer, followed by CBS news. The first letter in the call was a "W." Maybe WGOW?

1240 unID

- **10/29 2000** – On the EESE (TX/FL) wire, a female announcer whose voice sounded just like the announcer for the Bustos and La Estación de la Familia stations seemed to give a slow "K – S – O – X" ID. I have yet to hear a similar-sounding ID when monitoring KSOX on the Brownsville SDR, so I am reluctant to count it.

1240 unID

– 10/30 0800 – Instrumental version of Star Spangled Banner on the NENE (WI/MN/IA) wire. KASL has been known to run an anthem at this hour, but they previously used a Country Gospel vocal version, possibly the Statler Brothers.

1320 unID

- 10/27 0816 – On the EENE (Chicago/New York) wire, liner "Morning with Jethro starts right here... star 10(2?).7, the new..." I'm not sure of the FM frequency; at first it sounded more like 103.7 to me. Internet searches reveal no likely connections between any "Jethro" and any station on 1320 AM, 102.7 or 103.7 FM.

1350 unID

– 10/30 0835 – On the NE (Dakotas) wire, two back-to-back versions of the Star Spangled Banner at this odd hour. The first sounded like a lousy pop star vocal, and the second was a traditional instrumental version.

1370 unID

– 10/30 0721 – Faded up over two other stations (most likely the usual pests KGNO and KXTL) on the EESE (Texas/Florida) wire with morning news program: "WHOE(?), 27 minutes of news talk, I'm Chris Jones…" or something similar. I thought this might be WHEE, possibly going to their 5 kW day power nine minutes early, but their owner tells me they no longer use their PSRA, and sign on at 7:30 am in October. It's possible the "WHOE 27" may refer to a local TV station but I can find no obvious matches.

1370 unID

- 10/30 0832 – On the NENE (MN/WI/IA) wire, a community calendar read by a female announcer; cities mentioned seemed to include Billingsville and Franklin. There are locations with those names near KWRT, but Billingsville is little more than a road junction with a couple homes and a church. KWRT does in fact air a community calendar at this hour, but it is always read by their older male morning show host. Most other possibilities have been eliminated through web stream monitoring. My best guess is WCCN, which would be on 5 kW day power at this hour with a path of darkness to my location. Unfortunately, they have no web stream, and there do not seem to be any public SDRs close enough to catch them. It may also be nothing more than KSOP, which has had a female announcer in my morning recordings.

1400 unID

- 10/30 0707 – Briefly on top on the NE (Dakotas) wire with male DJ "...the heart and soul of your radio. I'm Randy Cox(?)... more news coming up. We'll hear from..." Internet searches yield no reasonable match for the slogan or announcer name. Not sure about the format; I heard some Classic Rock before this, and country afterward, neither of which may have been the same station.

1410 unID

- 10/27 2031 - On the NE (Dakotas) wire, "You're listening to KER country."
 Can't find anything phonetically similar.

1420 unID

– 10/30 2028 – Noted several times this weekend on the NNW (WA) wire, and with the W6LVP Loop aimed roughly N/S and NW/SE. Soft hits / MOR format with liner by a slightly accented female announcer: "The right combination, all day, all night, right here on North(?) 101(?), K-(???)." When heard again a half hour later, the liner sounded more like "Your kind of music, all day, all night, right here on (Your?) 109(?), the (source?)." The "109" is presumably "101..." With all other west coast stations seemingly eliminated, I have to wonder if someone is playing with KIGO, one of many Idaho stations that have been silent for years without telling the FCC.

1430 unID

- 10/27 2100 - On the NE (Dakotas) wire, garbled promo/ID: "...Weekday mornings... WCX...." This appeared to be followed by some kind of network news. No close matches can be found for the call letters I heard. The "W" was definitely the first letter of the call sign; the 4th letter either faded out, or two middle letters ran together (e.g., WDEX).

1440 unID

– 10/27 2032 – On the NE (Dakotas) wire, high school football with 2 slightly twangy-voiced announcers. "Another-nother Elks touchdown!" Best guess is Straford Elks vs. Amarillo Highland Park Hornets on KPUR.

1440 unID

– **10/31 0830** – On the 85-degree E (MO/IL) wire, and on other wires on other mornings at this time, a station appeared suddenly with a loud signal and SRN news. Web stream monitoring has only led to KYCR, which splices SRN news into the bottom-of-hour break in the rather dull "Better Stocks Today" program that they run

during AM drive. Unfortunately, I have yet to hear any of the bumper music from that program, or anything else that could confirm this was KYCR, still needed here.

1450 unID — 10/27 2028 – On the NE (Dakotas) wire, high school football under KGRE. One team name sounded like "Derby." A few minutes later, a second game seemed to fade up with possible mentions of Cardinals and Blackridge.

1470 unID- 10/27 2028 – On the NE (Dakotas) wire, country music with a liner "I'm ____, and this is _____ 98.7." KLTC is country and should be commonly heard on this wire, but despite good conditions to the Dakotas they were hardly heard at all on this year's recordings, and they don't have an FM 98.7.

___TIS AND OTHER___

- 1610 WQNV759 ID Fruitland 10/27 2255 Faded up with ID "WQNV seven hundred fifty-nine Fruitland. This is the Idaho Transportation Department 'Har' station 3-10 broadcasting on 16-10 AM." This group of HAR stations is useful, and they give a distinct ID for each station. Their licenses have all expired, but at least some of them (including this one, based on SDR monitoring in May 2024) are still on the air. They were only about 1 degree of the beam of my NNW wire. 371 miles. New, for Idaho #51
- **1610 unID 10/30 0837** On the NE (Dakotas) wire, a barely audible female voice faded up: "You're listening to WNPS315." Not 100% sure of the call letters.

- 540 KVIP CA Redding 10/26 2059 Weak, but on top of channel, with promo and ID mentioning 98.7 FM. 449 miles.
- **540 KWMT IA Fort Dodge 10/30 0847 –** Faded up under CBK and KNMX with Iowa farm news. 1061 miles. Relog but rare.
- **570 KWML NM Las Cruces 10/27 2052 –** On top of channel with pregame show for high school football: Las Cruces Bulldawgs @ Las Cruces Centennial Hawks. Listed 155 Watts nights. 617 miles.
- 610 KOJM MT Havre 10/27 0900 Appeared suddenly over KVNU, with ID: "KOJM 6-10 AM, 98.3 FM, and 92.5 digital channel 3." The HD simulcast would be KPQX-92.5-HD3 in Havre. 692 miles. Relog but rare.
- **630 KTRW WA Opportunity 10/30 2059 –** Faded up over KPLY and KFXD with ACN promo, ID, and slogan "The Fabulous 6-30 AM." Listed 530 Watts days. 613 miles. Relog, but only heard around sunset and sunrise.
- **640 WOI** IA Ames 10/30 0834 Faded up under KFI with NPR news. 1084 miles. Relog but rare.
- **660 KXOR OR Junction City 10/26 2059** Faded up under KTNN, with top-of-hour ID in Mexican-accented English. Audio quality was very poor. 581 miles. Relog but rare.
- **680 KKGR** MT East Helena 10/27 2028 Briefly on top of channel, with Classic Rock sponsored by East Helena Pit Stop auto mechanics and Top Gun Auto Body. 529 miles. Relog, but fairly rare in recent years since CJOB's night DA has been so far out of whack.

(This is also true for basketball games in the arena, and football games in the stadium). Listed 65 Watts nights. 891 miles.
- 900 KKRT WA Wenatchee 10/29 0859 Barely audible, with multi-station ID (the other station being KWIQ-1020) and ESPN SportsCenter. Listed 72 Watts nights (no known PSRA). 660 miles.

- 980 KDSJ SD Deadwood 10/27 1938 Faded up under KSVC, with end of high school football playoffs: 'Spearfish Spartans @ Pierre Riggs Governors. This was a very early game; it must have started no later than 5:30 pm local time. 648 miles.
- 980 KTCR WA Selah 10/29 0858 Nice signal, briefly over KFWB and CKNW, with liner: "Kruz'n 106.9 KTCR" and Classic Rock. Listed 125 Watts non-directional night STA (no known PSRA), which they renewed in January. 619 miles.
- **1000 WMVP IL Chicago 10/26 2230 –** Faded up from the slop, with promo for local Waddle & Silvy afternoon Sports talk show. 1377 miles. Relog but rare.

- **1150 KNMM NM Albuquerque 10/30 0900 –** Weak signal, faded up under KEIB and KOLJ, with ID: "KNMM 11-50 AM Albuquerque and K271CP Albuquerque 102.1 FM." Listed 105 Watts nights (no known PSRA). 490 miles.
- **TX** Quanah 10/30 0859 Fighting KEIB with ID: "11-50 AM KOLJ Quanah, FM 100.7 and 101.7 FM" City of license is pronounced "Kwannah." Listed 500 Watts days. 855 miles. Relog but quite rare. This was almost three minutes after Quanah sunrise, and almost 15 minutes after KOLJ's October FCC sunrise time.
- 1150 KQQQ WA Pullman 10/26 2100 Faded up with US Bank pregame show for Washington State University Cougars college football, ". . . live from Zeppoz Sports Bar in Pullman." Strangely, they suddenly became audible right around the time they should have dropped to their 27 Watt night power. 555 miles.

The other nights I was here, they seemed to behave themselves. - **KOFO KS Ottawa 10/31 0829 –** Appeared as they switched to 250 Watt day power with 'Brad Howard Early Morning Show,' ID: "KOFO, your source for information and entertainment in East Central Kansas," and local news update beginning with a story about the Ottawa City Commission. They run an ABC News update after the bottom-of-hour local news. 1009 miles. Relog, but only heard once or twice before.

- 1300 KCMY NV Carson City 10/28 1958 Way under KCSF and XEP, with Country music and ID. Very weak signal this year. Normally a pest on every wire (probably running day rig all night in recent years), but hardly noted at all in this year's recordings. 304 miles.

The station normally broadcasts in Spanish, but this ad was in English. They were legally on their 10 kW day rig at this hour, with a full path of darkness to my location. 1618 miles. New, Michigan for #7.
- **1319.96 KCLI OK Clinton 10/27 1953 On top of channel, with high school football: Clinton Red Tornadoes @ Cache Bulldogs. 862 miles.**
- 1330 KJPR CA Shasta Lake City 10/30 2059 Faded up over KWKW, and presumed KCKM, with ID: "The news and information source of Southern Oregon University, KJPR Redding..." (they mentioned several additional stations as the signal faded out). 449 miles. Relog but fairly rare.
- **1330** KCKM TX Monahans 10/27 0714 On top of channel, with Country music and local ads including 'That Cajun Place' on Wildcat Drive in Wink 432-527-3305. 804 miles.
- **1340 KPOK ND Bowman 10/27 0806** Female announcer with KPOK local and North Dakota state news. 731 miles. Relog but rare. Still trying for KXPO.
- 1360 WTAQ WI Green Bay 10/31 0817 Fighting KRKK and KSCJ, with 'Matt Z and Rob Morning News,' reporting on the Wisconsin Dairy Farmers' annual cheese-making competition. I saw a note that they were on a "reduced power STA" until December 12th, but I had not heard of this STA being granted. 1381 miles. New, for Wisconsin #6.
- **1380 KOSS CA Lancaster 10/28 1004** On top of channel, with older Hip-Hop music and liner: "______'s old school jams from back in the day." 376 miles.
- **1380 KRCM TX** Shenandoah 10/30 0749 Fighting KKRX, and presumed KLPZ, with Spanish religious talk including station phone number 281-974-4765. Listed 500 Watts PSRA, but this station has been known to run day power all night in the past. 1195 miles.

- **1430 KWST CA El Centro 10/27 2022** Producing a big echo on KMES, both running Esne Radio Spanish Catholic programming. 439 miles.
- **1440 KRDZ CO Wray 10/27 2144 –** Weak under KMAJ and KPUR, with high school football: Wiggins Tigers @ Wray Eagles. Normally an everyday catch, they were missing from virtually all of my recordings this year. Listed 212 Watts nights. 634 miles.
- **1450 KNOT AZ Prescott 10/27 1927** On top of channel, with automated Oldies and liners for "14-50 AM my fun oldies." 324 miles.
- **1450 KVOW WY Riverton 10/30 0904** Fighting KBFS, with local news, weather and Community Calendar for Lander and Riverton. 404 miles. Relog, but rare.
- 1460 KKOY KS Chanute 10/29 2358 Under XEYC, with Country music and ID (about a minute and 40 seconds after the top of the hour: "KKOY, My Country . . . 14-60 . . . Kansas . . . This is My Country." My other two constant pests this year, KZNT and KION, were both missing, and someone was running a 400 Hz test tone after the top of the hour. Listed 57 Watts nights. 1008 miles. - **1480 KLMS NE Lincoln 10/31 0828** Under KQAM, with Classic Hits and "Mix 103.3" slogans. I think KEJB might have been back on night power (this was Tuesday morning). 930 miles.
- **1480 KNGO TX Dallas 10/30 0900 –** Faded up over KQAM, with ID: "You are listening to Viet Radio KNGO 14-80 AM, Dallas, Texas." 1066 miles.
- **1490 KRKC CA King City 10/28 2301** Fighting with KNAM and one or two other stations, with Top-of-Hour ID (which still begins with a fast Morse code ID, very helpful!) "KRKC-AM, King City." 443 miles.
- **1490 KNDC** ND Hettinger 10/27 2028 On top of channel, with pre-game show for high school football playoffs: South Border "SB" Co-Op (Wishek-Ashley) Mustangs @ Hettinger-Scranton Night Hawks and ID: "KNDC 14-90 AM and 106.7 FM." 750 miles.

- **TX** Littlefield 10/27 2011 On top of channel and over XECJC, with high school football: Idalou Wildcats @ Littlefield Wildcats, sponsored by Rowe Abstract & Title Company, 806-385-4220 and Webb, Webb & Wright CPAs, 823 Littlefield Drive 806-385-5181. "Touchdown Wildcats!" (pretty sure he meant Littlefield). 738 miles.
- **1520** KMSR ND Northwood 10/27 0900 Just barely audible under KVEN, with start of Dan Patrick Show on Fox Sports Radio. 1018 miles.
- **1520 KGDD OR Oregon City 10/30 2058 –** Over KKXA, with Regional Mexican music and liners: "La Gran D, La Mas Mexicana." 623 miles.
- **1530 (KGBT) TX Harlingen Not a trace of them** in this year's recordings. Normally they are a nightly catch.
- **1550 (KDCC) KS Dodge City** Normally a nightly pest (generally running day power all night in recent years), **they were not found at all on this year's recordings**. They turned in their license a few months later. I suspect they were already off the air in October.
- **MO Cape Girardeau 10/28 0817 –** Fighting KZDG, with regional talk show "You're listening to American Healthcare Advocates, broadcasting here on the HIA Radio Network. This is Cary Hall." 1330 miles. Relog but rare.

New, for North Dakota #31.
- 1660 WCNZ FL Marco Island 10/28 0100 Finally caught them with Relevant Radio news // KSMH-1620 including the top-of-hour news sounder (KDMT-1690 was running 30 seconds behind at this time). This should have been one of the easiest stations in Florida to catch from here, but it has taken many tries over several years. 2076 miles. New, for Florida #32.

FCC Construction Permits

Updated to Friday, September 6, 2024

There are no active FCC construction permits (CPs) for new stations, and all applications from the last application window (in 2004) have been processed. A handful of even earlier applications are still listed as "pending" by the FCC:

At this time, the FCC is only accepting applications for "minor modification" CPs from currently licensed stations. This means that the new facilities, when built, would overlap sufficiently with the already-licensed facilities that both could not be authorized simultaneously. This allows for frequency moves of up to 30 kHz (but not more), as well as geographical moves within the coverage overlap area.

The FCC also requires a CP for corrections to a station's geographical coordinates of at least 3 seconds of latitude or longitude, even if no actual "construction" will take place.

With the FCC's transition to the new Licensing and Management System (LMS) for processing station applications, including for CPs as of mid-2023, coordinates are given in the "NAD83" reference system (to the nearest tenth of a second). Older applications and authorizations are in the "NAD27" system (to the nearest second), and the coordinates of any given station in the two systems may vary by a couple of seconds, especially in longitude. Coordinates below in the format "40-00-00.0, 80-00-00.0" are NAD83 and in the format "40-00-00/80-00-00" are NAD27. All latitudes are North and all longitudes are West, unless otherwise specified.

Once the CP is substantially built, the station applies for a "license to cover" (LTC) the CP, containing data about the actual operation of the constructed facilities. In most cases stations that have submitted an LTC application will use the CP facilities on the air under "program test authority." If the station does not file for an LTC within 3 years of the grant of a CP, the CP expires and the station must reapply for a new CP if it wishes to proceed with the project.

332 MCW kHz, Sept 6 at 1450, NDB IC, wIChita KS is JBA. For so nearby and powerful at 400 watts, it's always incredibly weak and hard to reconfirm. And I have yet to hear any sign of QT, 1000 watts from Thunder Bay, in normal winter night conditions stronger than IC. Is it still on air?

341 MCW kHz, Sept 6 at 0259, and still 1450, no signal from EnId's least-known radio station, ND beacon EI, at Woodringn Airport. Had been reliable for many weeks and not logged. Even tho a few km away, it was never a local bigsig, but not even a trace of carrier now. This has happened before, but eventually resumed. Noise level always a LW problem, but I still can at least JB hear 255 SW Stillwater, 515 PN Ponca City and some Kansans.

UNIDENTIFIED. 630.03 approx., Sept 1 at 0645, LAH against 630.00 stations, not the 631 het from Cuba. Nothing in mwoffsets from USA higher than 630.0033.

780, Aug 28 at 0640, WBBM "Newsradio 105.9" with 'Stardate', 2-minute feature from McDonald Observatory, TX. Maybe a regular spot. We normally catch it at 1704 M-F on KANU=KPR webcast, or 1800v on KUCO; or daily 1730v on "QXFM" TX webcast. Many more chances, and lots of stations run it more than once a day: https://stardate.org/radio/affiliates but I'm afraid much of that is outdated or wrong. There is no "KCOU" 91.1 in Enid! This time not shown for WBBM. Better check each station's linked website, but some ignore a mere 2-minute item, if they deign to provide anything

resembling a plain old program schedule. Stardate really pushes people to "subscribe" for a price, but one may read the latest script and then link to some previous ones.

(880), Aug 22 at 1530, WCBS NYC amid a two-sesquihour retrospective before it's deleted Aug 26, via webcast https://www.audacy.com/stations/wcbs880# at one point mentioned that WNYC devoted a semihour yesterday to WCBS. This looks like it, sound and full transcript from Aug 19: https://www.wnyc.org/story/wcbs-newsradio-signs-off-for-good/ It was also mentioned there would be another retrospective on WCBS itself, Saturday at 8 am = Aug 24 at 12; and listen for the final final broadcast Sunday night before midnight EDT = Monday August 26 0345-0400******* (WORLD OF RADIO 2257)

960 & 100.9, Sept 3 at 0334, still 0442, 0521, 0630, KGWA Enid in dead air but translator RDS reassures us it's "KGWA-FM_" -- NOT! Rather K265FL. The real FM side of KGWA is 103.1 KOFM. I see that WTFDA DB now marx 100.9 MONO as per my info. "Cagey Way" is not to be outdone by crosstown rival KCRC/KZLS in the Dead Air Sweepstakes! By nulling 960 on the handheld DX-398 I hear two or three other talkstations mixing, but could not pull an ID by 0400 after one of them weathered. KGWA 960 has come to life by next check 15. Hey, it's been a holiday. Think of all the undernourishedEnidians who could have been fed for the cost of all that wasted AM&FM juice.

1080, Sept 3 at 0655, KRLD Dallas is getting QRM at about equal level. I keep listening and at 0700 there is a multi-station ID, most of them FM translators, but could not copy details in rapid recitation. Only location caught at start is Evansville, so I look it up later in NRC AM Log to find there is no Evansville IN on 1080. Instead, must have been *Edwardsville* IL, which is non-commercial *WRYT, U7 500/20 watts, Heart of Jesus Radio, with CVN/EWTN. NRC Log shows no translators but reverse lookup in WTFDA FMDB shows two which are Relay of WRYT-1080: K216DI 91.1 in Harvey ND!, Covenant Network; and W224DC 92.7 in Caseyville IL with EWTN. On my E/W longwire which unfavors Dallas to the SSE. U7 is an unusual antenna combination, meaning 3 different patterns for daytime, nighttime and critical hours. NRC Pattern Book shows one itty-bitty loop toward the WSW, favorable for us. radio-locator.com shows all three: daytime and CH at 380 watts aim thisaway, while night pattern does not, pulled in to protect KRLD but far from a notch. Anyhow, I strongly suspect WRYT was NOT on night pattern/power. After IDs at 0700, into religious talk show with hostess, repeat of something which occurs on first Monday of each month.

1100, Aug 15 at 0642, dead air which must be usual dominant signal from WTAM Cleveland OH, which normally is // 1110 KFAB with C2CAM. Yet I still have a much weaker C2CAM under the open carrier. But new NRC AM Log does not show any other C2C station on 1100, so really WTAM but undermodulated? I am not about to hunt thru every state in the affil list not by frequency: https://www.coasttocoastam.com/stations/

1110, Aug 29 at 0646, 'Coast to Coast AM' on KFAB Omaha is running 5 seconds behind weaker 1100 WTAM Cleveland. I think the delay be not always thus, so now I have something to compare with later.

1110, Sept 4 at 0654, C2CAM on KFAB Omaha is now running a hefty 27 seconds behind same on 1100 WTAM Cleveland (GlennHauser, OK, WOR)

1110, Sept 6 at 0654, C2CAM on KFAB now running 31 seconds behind same on 1040 WHO; why? 1160, Aug 29 at 0638, take that, LDS, instead of KSL, Christians vs Christians, dominant signal is Spanish preacher reverbing, 0656 ID as R. María, outro program as 'Reflecciones Bíblicas'. Now there is a sesquiHz SAH = 90/minute, probably KSL attempting to regain. Refers to radiomaria.org, lots of info there, HQ in Roma, but no obvious station list! 0700 breaks for ID in English, KCTO with two FM frequencies, 100.5 & 90.3? Am I correct that FCC rules do not require legal IDs to be in English? Radio-locator.com: "KCTO-AM also broadcasts its primary channel from these 2 transmitters K257DZ 99.3 FM Kansas City, MO (99 watts) K263BU 100.5 FM Kansas City, MO(250 watts)" 0702 back to Spanish for "2 de la mañana" timecheck and long list of R. María stations, most/all FM. KCTO is in Cleveland MO, U4 5000/230 watts, yet overcomes U1 50/50 kW KSL. We explored this in great detail when last logged May 27-28; see: https://www.w4uvh.net/ghlogs-2024-0523-0529.txt with a follow-up next week.

1240.2, finally a reconfirmation of the off-frequency het I have been hearing, as first definitely IDed many years ago, still, from Tim Hall's review of his recorded DX-pedition logs last year from the NV/UT Border Inn: "1240.200 KCRT CO, Trinidad. 10/27 1133 – After about a decade of chasing this off-frequency carrier on hundreds of Perseus recordings, I finally caught a nice ID "My 99-3, KCRT." 534 miles, 10 miles short of the current GYDXA record. New, CO #81, GY#254".

1270, Aug 26 at 0638, VG Spanish music, loud & clear, better than some 50/50 kW "clears" such as WOAI 1200. Figured it must be KFLC Benbrook [The Metroplex] TX, U4 50/5 kW, but now listed as TUDN sports -- maybe not in the nightmiddle? Night pattern is E/W, no good for us, nor daypat major lobe east. Then non-ID as "107.9 FM y 1270 AM" so it's really KRXO, Claremore [Tulsa] OK, listed as SS:CHR, address in OKC, 5/1 kW direxional SW but not totally nulled thisaway. Besides ownership, KRXO[AM] has no relation to programming on the original KRXO[FM] 107.7 OKC, silly

sportstalk in English. WTFDA FMDB shows 107.9 is K300CY Broken Arrow [Tulsa], 150 watts, CHR, Lang NOT as Spanish, yet slogan Ritmo 107.9. Another tail wagging an AM dog. A confusing situation; why apply the same calls to AM in Tulsa, and not // FM in OKC? But then I hear "St. Joe's classic rock, KY-102", huh? That's KYSJ, St. Joseph MO, dog wagged by its tail, K273BF, 102.5 per NRC AM Log and supposed to be only 36 watts at night! AOR format. Don't think I had ever heard it, U1 1000/36. Unless it changed to Spanish? Website shows still English: https://www.ky102.net/

UNIDENTIFIED. 1370, Aug 27 at 0637 tuneby in bandscan, "KWIQ" – easiest DX ID ever? No, the real KWIQ is on 1020 in Moses Lake, Washington, with ESPN. Maybe mentioned on that net? But no ESPN correlation on 1370. O well.

1390, Aug 27 at 0638, and still past 0700, local KCRC Enid in dead air again; and so is sibling station 1640 KZLS, but someother talking station is audible underthat, anything but Biloxi.

UNIDENTIFIED. 1390, Sept 1 at 0658, KCRC Enid again providing deadair. This time I try nulling very strong signal on the DX-398, and can hear at least 3 other sigs mixing, talk and music, but can't ID anything as I am falling asleep until 0720. There are 1390s inadja cent states AR, KS, NM, TX, and many more beyond mostly low-powered at night. One still with 5 kW is WGRB Chicago but tightly direxional northwards. Sibling 1640 KZLS also DA again, but always much weaker in town and other 1640 station(s) audible without really trying.

1590, Sept 3 at 0707, "Those Were the Days", classic song in English, 0709 brief Spanish! announcement, another classic song in English, "What a Wonderful World". 0711 I copy "Ambiente Clásico" non-ID and a song in Spanish. So it's WCGO Evanston (think Chicago!) IL, as previously logged, a strange station which is also partly in Russian, e.g. Feb 13, 2024, q.v.

UNIDENTIFIED. 1700 kHz, Aug 18 at 0150, S9+20 open carrier and steady S9+20, a local device? JBA English under, probably Iowa. Most likely KKLF Richardson [The Metroplex] TX, where official sunset for 5 to 1 kW powerdown in August was 0115.

A 10/kHz bandscan in USB audiblizes LAHs – low audible heterodynes on several frequencies due to perpetually off-frequency stations, some of which have been identified before, Aug 28 at 0635-0640. No definite IDs now; no exact measurements here but from [mwoffsets]:

Pro Sports Networks

Here is National Football League (NFL) flagship information for the 2024 season via Internet searches. Some of the network lists are undated, so I do not know if they are for the current season. And I cannot rely on the copyright date at the bottom of each page, as that is probably added globally for the web site, even if the specific web page being viewed has not changed. And some team sites do not list the announcer team, while others have bios that are a few seasons' old, so I do not know if they are current. I found some network list pages that were not linked from the team home page or sub-section "home" page; I assume that there are "orphan" pages that are not current.

Some of the online lists cannot be cut-and-pasted, as they are graphical images. One could download the JPEG image file and then feed it through an OCR scanner, but I find it simpler to hand-compare it to the text file I have saved from last season and create a new text file.

These lists were checked by David Yocis against the official FCC AM and FM databases, so what you see below might differ from what you find at the URLs listed. And, before I sent the column to David, he checked the lists for the Arizona Cardinals, Atlanta Falcons, and Chicago Bears; he found stations that had changed calls letters two times and one that had changed frequencies. I was assuming that the network lists posted by the NFL team would have come from the department that handles the advertising and thus would be up-to-date with respect to call letters and frequency.

And I am not sure that I have all of the Spanish-language stations correct.

The various gotknowhow.com sites claim to have current lists, according to the date "by Doug"; I have no idea from where Doug gets his information. I did compare Doug's list with the official San Francisco 49ers' list, and I found seven stations on Doug's list that were not on the official list. David Yocis says that the gotknowhow lists have "station information that is wildly out-of-date."

I found some of the lists in the "News" section of the team's website under the headline "How to watch the ... pre-season game against ..." I do not know if the pre-season list of stations differs from the list for the regular season. And some of these articles only listed the flagship station(s).

Due to NFL Restrictions, online streaming of games is prohibited by affiliates. You can listen and/or watch games online via NFL.com

The announcer names are found at this URL:

That page seems to have been updated for the 2024 season, but the footnotes on that site point to web page retrievals in 2012.

There is a site http://nflfootballtv.com/onlineradio.html that has Internet online radio - streaming audio and video information on each team. I have no idea if that web site is current.
