So far we've had 1,644 different active stations reported to DDXD this volume, which is now half complete.

CKNW-980 was #1 in Vancouver in December with a 12.1% share of hours tuned among everyone who was at least 12 years old. The upcoming move to 730 kHz will significantly improve the signal into the City of Vancouver thanks to the lower frequency and relative closeness of the transmitter site.

- **ON Owen Sound** DXers are catching this while they still can, before the move to FM. Noted in Ashland, Ohio on **January 19 at 2350.**
- 600 CKSP BC Vancouver Several possibilities exist for the station's continued operation after what will be CKGO-980 (see below) signing off sometime in March. Both 980 and 600 are duplexed on the same transmitter site in the Cloverdale area of Surrey, a suburb of Vancouver. Corus owns both CKGO and CKNW, and currently owns the Cloverdale transmitter site. The most likely scenario appears to be Corus selling the transmitter site to CKSP. They could also follow the precedent of Jim Pattison, who flipped CKBD-600 (ex-CHRX and CJOR) into CKPK-FM, but retained the AM transmitter site. It lay dormant from 2008 until 2014 when CISL-650 moved there, renting the site from Pattison. Similarly, CKSP could continue renting from Corus. A third option would be to move to Pattison's transmitter site, duplexing with CISL.

This would be a perfect fit since the site was designed for 600 kHz. But this would require cutting power to 10 kW and a huge reduction in signal, especially at night, in suburbs like Surrey where the station has a lot of listeners.

630 CHQT AB Edmonton – The CRTC has retroactively revoked the license as of October 31 2024 at the station's request. CHQT-880 and CHED-630 swapped call letters when CHED officially moved to 880. The 630 transmitter was powered off forever a few weeks later. **(Shawn Axelrod)**

730 CKGO BC Vancouver – Swaps call letters with CKNW on February 24 to be branded as 730 CKNW. Other than the branding, there will be no changes in format.

900 CHML ON Hamilton – Despite being off the air since August 14, the station did not request a retroactive license revocation. The CRTC revoked the

license effective January 17, 2025. (Shawn Axelrod)

980 CKNW BC New Westminster – Officially moves to 730 on February 24 and CKGO-980 will broadcast a continuous loop of announcements instructing listeners to change their dial to 730 kHz. Sometime in March, the 980 transmitter will sign off forever. It is very unlikely that

The delay in moving to 730, when compared to CHED Edmonton (which moved from 630 to 880 in October), likely regulted from the time it took to pognitive an agreement with CKSP 600 who



- 1070 KILR IA Estherville 10/25 2129 Under KATQ, with local ad string including 'Cornerstone Insurance Services Nicole Tifft' 712-362-0319. Listed 48 Watts nights, but they appear to have been stuck on 250 Watt day rig for the last year or two. 1040 miles.
- 1070.067 KSKK MN Verndale 10/25 2100 Making a mess of the channel (thankfully only on my northern wires), with Relevant Radio programming. Still off-frequency after several years. Unlike most Relevant Radio stations, which usually ID just before the top of the hour, the legal ID was about 20 seconds after the top of the hour. "Relevant Radio AM 10-70 KSKK Verndale." 1088 miles.
- 1070 KATQ MT Plentywood 10/25 2128 Fair signal, with Friday night high school football playoffs: Bainville Bulldogs @ MonDak Westby-Grenora Thunder, sponsored by 'Grove Furniture' in Plentywood. This station normally carries the Plentywood Wildcats, who played on Saturday afternoon this weekend (their game also ran on KATQ). Listed 49.5 Watts nights, but they were all over this year's recordings, so likely on 5 kW day power all weekend. Additional interference came from KSKK, which has been operating off-frequency for several years. 818 miles.
- **AZ** Green Valley 10/26 2059 Nice "music legends" Oldies/Nostalgia format. Sign-off by male announcer: "KGVY AM 10-80 is required to sign off..." and advising listeners to tune to 101.5 FM. I think their actual FCC sunset time was 15 minutes earlier than this. 521 miles.

- **1080 KSLL UT Price 10/26 0759 –** Appeared suddenly with Country music, "True Country 104.9" slogan and ID, an hour and a half before their FCC sign-on time for October. This station has been cheating to varying degrees (staying on all night or coming on at 6 AM local time in the winter) for at least 25 years. 178 miles.
- **1090 KAAY** AR Little Rock 10/26 0558 Steady signal, under XEPRS, with Singing News Radio Gospel music programming. 1241 miles.
- **MD Baltimore 10/27 0716** Faded up under XEPRS and KAAY, with news about Maryland's governor, multiple IDs, ad for 'Maryland Mortgage Center' 410-653-2600, and Ravens football promo, followed by traffic report. 1979 miles.
- 1090 KBOZ MT Bozeman 10/26 0758 Getting out fairly well on their 1250 Watt STA, under XEPRS, with Classic Country music and "Classic Country 10-90 KBOZ" liners. 477 miles.
- 1100 KAFY CA Bakersfield 10/26 2058 Under KWWN, with Esne Radio Spanish Catholic programming // KENT-1540. Not often heard here. 366 miles.
- 1100 WZFG MN Dilworth 10/25 2132 Fighting through KFAX and a few talk stations, with high school football playoffs: Fargo Davies Eagles @ Fargo Shanley/Oak Grove Lutheran Deacons. Listed 440 Watts nights. 1023 miles.
- 1100 KRKE NM Peralta 10/25 2014 Noted with Classic Rock // web stream. Have been trying for this one (and KEMR-1080) for the last few DXpeditions. 498 miles. NEW, for New Mexico #66.
- 1110 KVTT TX Mineral Wells 10/27 0814 Under KFAB, with South Asian music and "Funasia Radio 104.9" liners. This daytimer with no known PSRA was already on the air 16 minutes before their FCC sunrise time. 1004 miles.
- 1120 KCRN CO Limon 10/24 1959 On top of channel, with incorrect top-of-hour ID liner: "Streaming live on the Catholic Radio Network Gabriel 2, 10-90 AM and 92.9 FM, KEXS Excelsior Springs-Kansas City, this is the Catholic radio Network." 529 miles.
- **MO St. Louis 10/25 2113 –** Fighting KANN and one other station, with University of St. Louis Billikens college basketball. Apparently, a billiken is a mythical good luck figure with roots in Japan and Alaska. 1285 miles.
- 1120 KTXW TX Manor 10/26 0659 On top of channel, with promos and ID: "In hope and encouragement, KTXW Manor-Austin, K266CI Austin, KHSB-FM, Kingsland-Horseshoe Bay, the Bay 104.7, this is 101.1 FM and 11-20 AM, today's Christian talk, the Bridge Austin." Note the city of license is pronounced "Mainer." Listed 155 Watts nights (no known PSRA). 1112 miles.
- 1130 KQNA AZ Prescott Valley 10/26 0559 Under CKWX with PSA, ad for 'Prescott Valley Chamber of Commerce,' and ID. Listed 4 Watts nights. 320 miles.
- 1130 KSDO CA San Diego 10/25 0659 On top of channel, with slogan: "Radio Inspiración, alimiento para el alma" and mostly-Spanish top-of-hour ID, in which only the call letters were in English. Still milking a decade-old STA (2500 Watts non-directional days and nights) that allows them to cover the entire US southwest all night. Their licensed 10 kW night pattern is a very tight lobe aimed out to sea, which doesn't even cover all of San Diego County well. 468 miles.
- **KS** Wellington 10/27 0618 Noted frequently overnight in this year's recordings, with Classic Rock and ID: "104.1 FM and 11-30 AM, KLEY." Hard to believe this is their 1-Watt night power. (Day power is 250 Watts). 911 miles.
- **1130 KWKH LA Shreveport 10/25 2152** Fighting one or two other stations, with high school football: C. E. Byrd Yellow Jackets @ Benton Tigers, sponsored by 'Shreveport Limousine.' 1206 miles.
- **1130 WBBR** NY New York 10/25 0700 Steady signal under KSDO, with ID: "From the financial capital of the world, this is WBBR New York, Bloomberg 11-3-0." 2102 miles.
- 1130 WISN WI Milwaukee 10/25 0800 Appeared as they switched to day power, with promos for 'Milwaukee Philanthropic Show' Sundays at 10 AM and 'Vicki McKenna weekdays 2-3pm,' followed by top-of-hour ID: "Stay informed, all day, every day, on News-Talk 11-30 WISN and WRNW-HD2 Milwaukee, an iHeartRadio station" and local news. 1372 miles. NEW, for Wisconsin #7.
- **1130 CKWX BC Vancouver 10/25 2201** Fighting KWKH's high school footbal, l with lengthy traffic report for Vancouver. 827 miles.
- **1140** KNWQ CA Palm Springs 10/25 2104 Under KGEN with news, local ad for 'Morongo Casino,' and into 'Markley, Van Camp and Robbins Show' // KNWH-1250. 383 miles.

- 1140 KNAB CO Burlington 10/26 0758 About equal with KXRB with an odd mix of nice Oldies/Nostalgia music and lame 90s pop. ID "Music as cool now as it was then, AM 11-40 KNAB." Listed 18 Watts nights but this sounded more like their 1 kW day power. 630 miles.
- **1140 KGEM ID Boise 10/25 2128** Fighting CHRB, with high school football: Bishop Kelly "BK" Knights @ Emmett Huskies, sponsored by local 'Del Taco' locations. 333 miles.
- 1140 KCXL MO Liberty 10/25 0759 Fighting presumed KNAB, with ID including two FM translators. Listed 47 Watts PSRA, but frequently logged here at night in recent years, so probably still stuck on 4 kW day power? 1050 miles.
- 1140 KXRB SD Sioux Falls 10/27 0815 Faded up with promo "Gospel has always been a big part of Country music. This is 100.1 FM and 11-40 AM, KXRB." 949 miles.

- **1150 KNMM NM Albuquerque 10/26 0058** Fighting one or two other stations, with disco hits, top-of-hour ID: "KNMM Albuquerque 11-50 AM and K271CP Albuquerque 102.1 FM, Q-102," and FOX News. Listed 105 Watts nights. 490 miles.
- 1150 KHRO TX El Paso 10/27 2201 Faded up under XEAD, with Mexican Oldies, "Suavecita" liners and jingles, and an ad for 'Household Furniture' in El Paso. Still IDs only as KINT-FM. 662 miles.
- 1150 CKFR BC Kelowna 10/25 0859 On top of channel, with ID by male and female announcer: "CKFR Kelowna ... This is AM 11-50, news, talk, sports." 790 miles.
- **TN Donelson 10/26 0800 –** Appeared suddenly as they switched to 50 kW non-directional day power, with "Turning Point" religious teaching program. 1502 miles. **NEW, for Tennessee #9**.
- 1170 KYET AZ Golden Valley 10/25 0204 On top of the channel (on a wire aimed away from them), with Classic Country, ID, and "Cactus Country" liners. Although I have heard them power down at their FCC sunset time in the past, I have to believe they are running their 6 kW day power (or something more than their 1-Watt(!) night power) all night. 265 miles.
- **1170 KLOK CA San Jose 10/28 0658 Causing substantial interference to KOTV with Punjabi chanting. Methinks their night DA is out of whack again. 440 miles.**
- 1170 KJJD CO Windsor 10/28 0800 Appeared suddenly at 6 am local time, with Regional Mexican music, drowning out KOTV. Allegedly on 500 Watt PSRA at this hour. 494 miles.

- 1180 KOFI MT Kalispell 10/25 2128 On top of channel, with high school football: Ronan Chiefs @ Columbia Falls Wildcats, sponsored by 'Jesse Mann at the Columbia Falls office of Edward Jones,' 'A&W' on Highway 2 in Columbia Falls, and 'NAPA Auto Parts' of Columbia Falls. 631 miles.
- **1180 KZOT** NE Bellevue 10/25 0758 On top of channel, with promo for Creighton Bluejays college basketball on sister station KOZN-1620. 973 miles.
- **1180 KLPF TX Midland 10/27 2159** Fighting the Rebelde mess, with ID read by local priest. Listed 215 Watts nights and actually sounded like it this time. 833 miles.

- 1190 CFSL SK Weyburn 10/25 2134 Fighting presumed KXKS, with ESPN World Series baseball feed from CJCL-590. Commercial break included a Canadian government PSA and a Canadian version of the earworm "Kars 4 Kids" ad. What did Canada do to deserve that? 876 miles.
- **1200 KFNW ND West Fargo 10/25 2130** Under WOAI, with "Insight for Living" Religious Teaching program // KTIS-900. Listed 700 Watts nights. 1008 miles.
- **1200 CJRJ BC Vancouver 10/25 2242 –** Good signal, on top of channel, with Indian music and "Spice Radio" liners, plus local ads including 'Meridian Insurance' in Richmond 604-272-0700 and Port Coquitlam 604-941-8544. This year they were heard more often, and with a stronger signal, than in previous years. 828 miles.
- **1200 CFGO ON Ottawa 10/25 2140** Faded up under KFNW, with Ottawa Redblacks CFL football and liner "Redblack football on TSN 12 hundred." 1985 miles.
- **1210 KPRZ CA San Marcos 10/27 0700** Top-of-hour ID off the back end of the ENE wire. 449 miles.
- **1210 WPHT** PA Philadelphia 10/27 2130 Faded up for ID: "Talk radio 12-10 WPHT Philadelphia, and on the Audacy app." Not heard as often as expected this year, despite KHAT no longer running 10 kW all night. 2064 miles.



- 1210 KUBR TX San Juan 10/25 2159 Under KGYN and KPRZ, with Mexican Contemporary Christian music and promos for events at local churches around the McAllen area. Top-of-Hour ID came almost three minutes after the top of the hour, right as my recording was ending: "Estás escuchando la KUBR, 12-10 AM, en el Valle de Tejas, y KVOZ...." This is a much easier catch now that KHAT finally stopped running day power all night. 1277 miles.
- **1210 KMIA WA Auburn-Federal Way 10/24 2059** Under presumed KHKR, with usual ID by the female announcer who does the IDs for all Bustos and La Estación de la Familia stations. This station had been reported silent last January. 702 miles.

After I contacted them recently to tell them they've been running 10 kW day power 24/7 (when they have both a CP and an STA to operate as a 10 kW daytimer!), they made an attempt to fix the problem but still couldn't get it right. They are no longer running 10 kW all night, but they are signing on way too early. 473 miles.

- **1220 KHTS CA Canyon Country 10/25 0204** Over KSLM, with end of FOX News, a local ad for 'Providence Holy Cross Hospital,' and 'Larry Elder' program. Listed 500 Watts nights. For such a 'small' station, they are a huge pest here, almost single-handedly ruining what would otherwise be a beautifully open channel. 398 miles.
- **1220 KTMZ CA Pomona 10/25 2104 –** Fighting KHTS, with Spanish play-by-play of World Series baseball from TuDN Deportes. // KWKW-1330. 403 miles.
- **1220 KLDC CO Denver 10/25 0601 –** Faded up under KHTS with PSA and ID including the phrase ". . . a Crawford Broadcasting Station," and "Turning Point" Religious Teaching program. Listed 12 Watts nights. 484 miles.
- 1220 CJRB MB Boissevain 10/25 2128 Under KHTS, with religious programming, ID, weather, and promo for 'Discover WestMan app.' CFAM-950 was running almost identical programming about one minute ahead of them. 984 miles.
- **1230** KAAA AZ Kingman 10/26 2058 On top of channel, with local ad for an event at a United Methodist Church in Lake Havasu City followed by multi-station ID (with KZZZ-1490 and related translators). 267 miles.

- **AZ** Phoenix 10/24 2258 On top of channel, with Regional Mexican music. ID about a minute and a half after the top of the hour mentioned iHeartRadio. 403 miles.
- **1230 KINO AZ Winslow 10/27 2158** On top of channel with Country music and liner: "Your Country radio station, Kino" (call letters pronounced as a word). 333 miles.
- **1230 KPRL** CA Paso Robles 10/28 0700 Faded up for nice, clear ID, with mention of translator on 99.3 FM, into FOX News. 440 miles.
- **1230 KEXO CO Grand Junction 10/26 2359 –** Caught a rare top-of-hour ID from this station: "KEXO, Grand Junction, we are Western Colorado's sports leader, AM 12-30 and 96.5 FM" Under perennial pest KFUN. 293 miles.
- 1230 KDZA CO Pueblo 10/25 2159 Fighting presumed KEXO, with nice Oldies format and ID: "From our studios on the beautiful campus at Pueblo Community College, KDZA Pueblo, and 101-9, KDZA." 509 miles.
- **1230 KSTC CO Sterling 10/25 2134** Fighting several other stations, with high school football: Fort Lupton Bluedevils @ Sterling Tigers. 586 miles.
- **1230 KORT ID Grangeville 10/25 0204 –** On top of channel, with obscure Adult Contemporary music and liners: "All the hits, 96.9 KORT." 486 miles.
- **1230 KHDN MT Hardin 10/25 2132** Faded up over two or three stations, with promo: "Weekdays one to three PM on the Vigilante, AM 12-30." 564 miles.
- **MT Lewiston 10/26 0159 –** On top of channel, with nice ID: "Lewistown is KXLO Country, FM 106.9 and AM 12-30, Radio _____," then time check by female announcer: "The current time is 12 o'clock," then an ad for 'Central Lock and Security' 406-535-7276. 600 miles.
- **MT Libby 10/24 2059 –** Faded up nicely for ID: "From the beautiful Kootenai Valley in Northwest Montana, we're KLCB Libby." I've been trying to relog this one to get it off the unreported stations list. 647 miles.
- 1230 KHAS NE Hastings 10/27 0814 Faded up from the slop with promo: "Partyline with Brandon McDermott, weekdays at 9:30 AM on KHAS." Their web site must be slightly out of date, as it says this program airs at 9 AM, but McDermott hosts the shows on either side of it. 835 miles.
- **1230** KLAV NV Las Vegas 10/24 2059 Faded up over KAAA and KWYZ, with promo for Las Vegas Knight Hawks indoor football, and ID. 206 miles.
- **1230** KRSY NM Alamogordo 10/24 2259 Faded up from the slop, with ID and ESPN Sports Center, followed by liner: "Your home for the Alamogordo Tigers is Alamo Sports and Talk 12-30 / 101.9." 620 miles.
- **1230 KYVA NM Gallup 10/25 0059** Faded up from the slop, with ID "Rockin' Oldies Kiva, KYVA Gallup, a Millennium Media station." 381 miles.
- **1230 KFUN** NM Las Vegas 10/24 2359 Fighting KEXO, and a few other stations, with very bland top-of-hour ID: "You're listening to KFUN Las Vegas, New Mexico, K279BW-103.7." 540 miles.
- **1230 KDIX** ND Dickinson 10/25 2130 Fighting KHDN, with high school football: Bismarck St. Mary's Central Saints @ Dickinson Midgets.

- **AZ** Globe 10/25 2159 On top of channel (but getting beat up on both sides by off-frequency XEWG and KCRT) with nice Oldies format and lengthy ID liner by Rollye James. 432 miles.
- 1240 KNSN CA San Diego 10/26 2045 Fighting other stations, with Religious Teaching programming // KBRT-740. This was the last San Diego/Tijuana station I still needed. They are a full-time simulcast of KBRT, and the stations give a joint ID each hour including two or three useless translators. Although this is a local station for me at home, I wanted to wait until I heard it from a distance to report it and get it off the unreported stations list. 471 miles. NEW, for California #235, Graveyard station #256 and #2000 from the Border Inn!

COLOMBIA: 850 kHz now *Radio Red Aleluya Colombia*, ex-*Candela AM* from Bogotá. Relaying online signal <u>iglesiauniversalcolombia.com</u> [*Rafael Rodriguez* to *DXing.info FB group*, mediumwave.info]

CYPRUS: In response to the events in Syria, *BBC World Service* resumed MW broadcasts from Cyprus on 639 and 720 kHz, on the air from 0600-0730 and 1300-1930 UTC in Arabic and English as follows: 0600-0630 Daily Arabic; 0630-0700 Daily English; 0700-0730 Daily Arabic; 1300-1430 Mo-Fr Arabic; 1300-1400 Sa-Su Arabic; 1400-1500 Sa-Su English; 1430-1500 Mo-Fr English; 1500-1530 Daily Arabic; 1530-1700 Daily English; 1700-1730 Daily Arabic; 1730-1800 Daily English; 1800-1930 Mo-Fr Arabic; 1800-1900 Sa-Su Arabic; 1900-1930 Sa-Su English (WRTH schedule). Transmitter power on both frequencies is 250 kW from the Encompass-run relay station at Lady's Mile; the masts are right on the beach within UK Akrotiri military base just south of Limassol. Arabic is mainly BBC Arabic TV sound. BBC WS had for several months been carrying a limited MW service to Gaza on 639 kHz in Arabic at 0600-0630 and 1500-1530 which has presumably been incorporated into the above schedule. 

Lately my antenna of choice at home has been a Loop on the Ground. Like many people I live in an HOA with antenna restrictions which is also responsible for plowing the snow in the winter and

mowing the grass in the summer. I realized this winter that the Loop on the Ground is a great solution for those who live in an HOA in climate in which the grass does not have to be mowed in the winter. I have my loop in my side yard configured in a square with thirty foot sides and using dark wire it is basically invisible from more than five or ten feet away. This will only be temporary since mowing will resume in the spring, but fortunately the time which I will be able to have it out overlaps well with peak MW DX season. I have been very pleased with the results of the LOG in comparison to the wire loop in my attic which I have been using. The strength of signals I receive is much better and the noise level is much lower. I've included an image with the waterfall in which top is the LOG and the bottom is my attic antenna. The LOG has also been useful for my ham activities allowing me to make contacts I otherwise could not hear.

Been an exciting two weeks among 50 kW stations in Western Canada.

In Vancouver, CKNW-980 is moving to 730 to get a better signal into Downtown Vancouver. CKGO-730 is moving to 980 for a few weeks while an endless loop is aired, telling CKNW listeners to switch to 730. After which, the aging 980 equipment will be shut off forever.

The big question then becomes: what happens to CKSP-600? They have been sharing CKNW's 980 transmitter. Will they buy the 980 transmitter site from CKNW, continuing renting it or move? Moving is not generally practical but, in the case of 600 KHz, there is still a transmitter site that used to broadcast on 600 as CJOR and subsequent call letters, until moving to FM from a different transmitter site. After laying unused for a few years, CISL-650 moved there, and continues to rent the site from CJOR's owner. Being custom built for CJOR-600, CKSP could duplex with CISL. But that would require a technical license change, likely reducing power to 10KW day and night, as CJOR was

In Calgary, CKMX-1060, originally CFCN, which dates back to 1922, will return to the airwaves if Bell's sale to Akash is approved by the CRTC several months from now. Because Akash currently owns two ethnic stations (on FM), the CRTC went out of its way to ensure that Akash knows that they can air a maximum of 15% ethnic programming, i.e. – in languages other than English, under CKMX's current license.

In Winnipeg, CFRW-1470, originally CJQM, will also return if Bell is approved to sell to Akash, with the same 15% maximum for ethnic programming as CKMX.

I have a strong personal attachment to CJQM's FM as my first paid job in radio included operating CJQM-FM's IGM automation machine, after CHQM-FM Vancouver shipped it to Vancouver because CJQM's new owner did not want it as part of his plan to change it into CFRW AM & FM. As a Computer Science student at UBC, I was hired by CHQM after the previous Operator never could figure out how to make the IGM automation machine work. International Good Music (IGM) was headquartered at KGMI-790 in Bellingham WA. The GMI in KGMI is a rearrangement of the letters IGM.

Veries: 880 KRVN, new state. I took time off writing reception reports. Three new stations heard in 2025 so far. I was set to listen on Monday Morning 1/27 and my Sony ICF-2010 gave me the ERROR3 message again. I've had trouble with that before. I finally took out the soldering pencil and added some solder to the two pads on the PCB where to three D-cell batteries make contact. The radio works now and I hope it's finally reliable. This radio also had the AA battery issue when I bought it off ebay. Both of these issues are "normal" for the radio.

We've been replacing the light bulbs in our house (about 100 total) with LEDs and I noticed that the chandelier LEDs makes horrendous noise on the radio on one set of fixtures. There are other light fixtures with those bulbs in it so I can test other fixtures. For now I can turn them off. We have a mix of LED, CFL, incandescent, Halogen and fluorescent tubes. Trying to get rid of the CFLs but they're all in closets or hallways so not on much. I'll update next time after I check all the fixtures with the

chandelier LEDs to see if it's the bulb or the fixture. 73s, Martin


