

### --- NOTES FROM CANADA ---

The Stanley Cup championship best of seven games started June 4 at 8:00 PM in Edmonton. The same teams are playing as last year: Edmonton Oilers and Florida Panthers. But this year, the Oilers have home ice advantage, with Games 1, 2, 5 and 7 in Edmonton. CHED-880 will be airing all the games but CKJR-1440 will also be spending most of their local programming time on the Oilers. All times are Eastern Daylight Saving Time.

880 CHED AB Edmonton – Play-by-Play, Pre-Game and Post Game shows for the Edmonton Oilers NHL hockey team repeatedly mention 'Rogers SportsNet,' despite the fact that Rogers is a direct competitor to CHED's owner, Corus. Rogers owns the broadcast rights for all Canadian NHL teams, but uses CHED for the Oilers because they do not have a suitable station of their own in Edmonton.

**920 [CBKG] BC Granisle** – Is off the air permanently, having completed the three month simulcast period with the new CBYG-FM-4.

980 CKGO BC New Westminster – On May 15, the CRTC announced the retroactive revocation of the broadcasting license of CKGO, effective March 11, as requested by station owner, Corus Entertainment. As CKNW, the station was first licensed in 1944 on 1230 with 250 Watts. It subsequently moved to 1320, then 980. The current CKNW-730 is licensed to Vancouver, and was originally licensed in 1955 as CKLG to North Vancouver on 1070.

**1070 CFAX BC Victoria** – The call letters have been pronounced 'Sea Facts' since the station first signed on, before fax machines were commonly available. Long-time owner Mel Cooper passed away in February at the age of 92. He bought the station in 1974 and sold it to CHUM in 2004, after working his way up to General Manager at CKNW.

**AB Wetaskiwin** – Recently expanded their Fox Sports Radio programming while cutting back on local programming to 0900-2000 weekdays and just a few hours on weekends.

**1570 CJLV QC Laval – Was off the air** from May 26 until the evening of May 30.

**AB** Rumsey – Broadcasting from 2009 until the summer of 2020 when the transmitter was destroyed by lightning, there are currently no plans to replace the transmitter since listeners have transitioned to live audio streaming from the rumseyretro.ca web site. Feeding a 55-foot tower from a 100 mW transmitter, they claim that they were regularly heard 35-60 miles away. The transmitter was a Chezradio Procaster. Rumsey is midway between Stettler and Drumheller.

### --- U.S. STATION NEWS ---

**AZ Tucson** – **Receiving this every night lately.** Probably a transmitter/antenna issue? They are licensed U2 50000/1000 with night pattern headed 160°, so not a likely catch for me. **(MR-UT)** [Since thay have no STAs on file, it may be they are failing to switch to their night authorization , or . . . their phasor is out of whack?? – **BH**]

1050 WJSB FL Crestview – 4/26 0809 – Curious if the NRC AM Log entry stating 0700 local sign on is true. Kinda. Abruptly up at 0809, three minutes after local Crestview sunrise this day. The 101.1 translator was on (24/7?) earlier checks, though off pre-sunrise another day. The 1050 kHz transmitter closes at, or about sunset per a couple of previous checks and the translator remains on as that is legal. (TK-FL)

1160 KSL UT Salt Lake City\_ 5/13 0125-rest of night – OFF ALL NIGHT – only signal I got on the channel was an UNKnown with loop facing East. After living in SLC for over 30 years, I've been waiting for KSL to be OFF THE AIR. It Happened! (MR-UT)

1180 KOFI MT Kalispell – 5/24 0534 – One minute ABC News, delayed from 0530 to avoid cutting off an Oldies song, then back into Oldies. Their talk programming ends at 0500 daily, at the end of Coast to Coast AM, then back into their regular format of Oldies music. Still running 1 kW but the new 50 kW transmitter is due to arrive soon. (JP-AB) [KOFI's May 16 STA extension request states that ". . . construction of the new transmitter building is well underway. Further, the 50 kW transmitter was

ordered months ago and is in the process of being built. According to the manufacturer, KOFI may expect delivery of the new transmitter in approximately twelve (12) weeks." So that means an August delivery date, plus a month or so for testing puts them around September or October to return to their **U2** 50000/10000 operation – **BH**]

1320 KNIT UT Salt Lake City – Noted SILENT for a while. Reason unknown. (MR-UT)

1450 WZGX AL Bessemer – 06/01 0835 – Gospel music, which usually is Mexican Radio Estrella Alabama. ID: "Greenville knows Gospel music, that's why they listen to the Big KD." Matched usual // WALQ-1130. The 'Big KD' is WZKD-950, with the same owners. This happened before on 12/29 which also was a Sunday. Clearly not a DX signal, but another feed error, or is this regular on Sundays? Will keep checking. (EB-AL)

1550 KMRI UT West Valley City – After being SILENT, IS BACK ON with Sports Talk programming (ex: Talk). (MR-UT)

**1570 WGLL IN Auburn** – 6/6 0248-0300 – Very weak, with male preacher, then @ 0259, preacher said there'd be another speaker. Then a quick ID sounded like: "Tree Broadcasting Network" with no calls. No live announcer, which fits the 3ABN format per their website. **Tentative.** (**NB-WI**)

1010 UNID – 5/9 0209 – Seemingly syndicated C&W music program with male host, very poor and in only briefly with some WINS co-channel. Pointing about N/S and suspect WORM, Savannah, TN (250/27 watts), but no functioning stream to try to confirm. (TK-FL)

1240 UNID — 4/23 0658 — The mystery Oldies format continues . . . poorly on fade- ups. 'Crazy On You' by Heart at tune-in and other oldie pop/rockers, like Culture -Club's 'Karma Chameleon' on another fade up. 'Capital One' spot, then another with a woman end-tagged ". . . right here in (something)ville?" Not parallel any Oldies stations with functioning streams, pointing pretty much due north/south. (TK-FL)

Based on the large amount of religious programming on KLZ's sister stations in Denver, concluded that this must have been KLZ, despite no listing of any religious programming, based on the direction of the signal and the poor conditions, confirmed by a recording made at the same time by a DXer in Seattle, who also eliminated KPQ as a possibility; KMON was mixing sometimes, eliminating them. Logged again on 5/22 from 0059-0100 – KLZ owner "Crawford Broadcasting"

featured as behind 'Save Our Soldiers' during a 30 second promo. Then at least <u>five</u> mentions of KLZ call letters in less than 20 seconds. Top-of-Hour ID mentioned 560, their FM translator on 100.7, and an HD channel. (**JP-AB**)

**780 WIIN** MS Ridgeland – 05/06 1411 – Very weak Blues music, matching webstream. First daytime log, on 100 ft wire. (EB-AL)

**840 KVJY TX Pharr** – **5/12 0554** – Slow Spanish Christian praise vocals; 'Radio Aleluya' slogan, mention of "840 AM" and something address ". . . "Boulevard." Top-of-Hour Legal ID in Spanish. **(TK-FL)** 

**850 KOA** CO Denver – 5/12 0600 – Good with "KOA, Denver, 850 AM" at tune in, dumping to ABC News. (TK-FL)

910 WBZH WI Hayward – 5/22 0624 – "Northern Wisconsin and Hayward is under a frost advisory." Poor, with WFDF in back. (JJR-MI)

930 WGAD AL Rainbow City – 05/29 1920 – On the air for more than a month now, not just a one-off to keep the license. 'Rocket Man,' slogan: "This is Classic Hits" and sung "WGAD." Fair on caradio. (EB-AL)

930 WMGR GA Bainbridge – 5/20 0126 – Faux C&W vocals, male sweeper "WMGR 99 point 3" and back to fake C&W. Over/under even more painful WFXJ. (TK-FL)

940 KGMS AZ Tucson – 6/3 2325 – 'New Life' Program. Fair, confirmed by internet stream. New for me. (EC-CA)

960 KFLN MT Baker – 5/22 0200 – Nice clear "This is Real Country …" then FOX News musical intro, during CFAC momentary dead air and fade, with antenna E-W for best null of CFAC. Common here whenever KFLN is running their non-directional 5 kW day power at night. (JP-AB)

960 WTCH WI Shawano – 5/20 0634 – Poor, with 'I Fell in Love' by Carlene Carter, calls and time, all with up-tempo host. In-out, with WSBT. (JJR-WI)

**1030 KBUF KS Holcomb** – **5/24 0608** – With calls after 'Queen of Hearts' by Juice Newton. WBZ gone. Poor. (JJR-MI)

**1050 WWIC** AL Scottsboro – 4/24 1952 – Very weak under WJSB, Crestview, Florida, as sunset nears. C&W song followed by male: "104-5 Real Country" slogan. WJSB is scheduled to close down at local sunset (1920 CT this day), but vanished at :14 mark – close enough I suppose – leaving mostly just WFAM thereafter. (TK-FL)

**1050 WJOK WI Kaukauna** – **5/24 0700** – Poor, with Legal ID, into Relavant Radio news. (This was their first network affiliate in 2000). (**JJR-MI**)

1060 WQMV TN Waverly – 5/4 0137 – CCR's 'Suzie Q,' then sweeper with FM, AM and calls. Parallel station stream. XECPAC nulled. Obviously cheating at 1000 vs. 4 Watts. (TK-FL)

1130 CKWX BC Vancouver – 5/23 0623 – News, weather, ads, Business report, etc.; heard several IDs as simply "News Radio" and one as "News Radio Vancouver and Calgary," although all datelines and ads were for Vancouver, with not a single Calgary reference. - **1230 WKWL AL Florala 5/24 1911** Thanks to an **Eike Bierwirth** discovery, this one is reactivated after ages of silence. Tunes by Tom Petty, Mr. Mister, Blood Sweat & Tears, Terry Jacks, Scorpions, and more Oldie Rock hits. ID and weather by many. Just after the top of the hour, young lady with 'Bama accent: ". . . for listening to WKWL, here in beautiful Florala, Alabama." Fair level with the always off-frequency WDWR Pensacola nulled. A 'Blue Bell ice cream spot, so I am guessing this really isn't just a one day annual POP to keep the license active. **(TK-FL)**
- **1230 WHOP KY Hopkinsville 05/20 0713** Just a very fortunate fade-in of an ID: "Newsradio 99.3 WHOP," then gone again. **New! Kentucky #21. (EB-AL)**
- 1230 WBOK LA New Orleans 05/24 0621 Urban Contemporary music, "Thanks for listening to WBOK," WBOK merchandise on WBOK.com, fair in the peaks. (EB-AL)
- **1230 WSOO MI Sault Saint Marie 5/22 0615** "... up-to-date forecast from 1230 WSOO" over anything. Poor. (**JJR-MI**)
- **1230 KGHS** MN International Falls 5/27 0721 "1230 AM and 95.3 FM" into 'Let's Hang On' by the 4 Seasons. Poor, but Alone. (JJR-MI)
- **1230 KTRF MN Thief River Falls 5/22 0729** Mentions of 'Little Falls' and 'Southeast Minnesota,' with calls later on. Poor, with others. (**JJR-MI**)
- **1240 WATT** MI Cadillac 5/26 0734 'Michael Patrick Shields' (A morning talk show's only affiliate.) Poor. (JJR-MI)
- **TN** Fayetteville 05/25 0653 Emerging from the mix, with "Classic Rock right now on 98.5 The Elk" into 'We Will Rock You' and fade out again, replaced by more common WENK. New! Tennessee #54 (and TN #3 on 1240). (EB-AL)
- **1250 WTMA SC Charleston 06/01 0506** ID: "WTMA and WTMA.com," jingle "WTMA," switch to Red Eye Radio. Strong, fighting with a co-channel Radio Maria. **(EB-AL)**

Finding countries and their stations in of recent editions of the World Radio-TV Handbook (WRTH) can be difficult, to the point where several DXers have complained about missing countries. Truth be told, if a Country has a radio station, it is probably there, if you know where to look.

For most NRC members, the best example is probably PJB-800 Bonaire. Page numbers shown below are for WRTH 2025 but they are only for quick reference and are not required to use this method.

The easiest way to begin is to find a known station in the Country, by looking it up by its frequency. WRTH begins with a Table of Contents (page 5). The right sidebar shows sections of the book. Note

the position on the page of Frequency Lists, then look at the page edges where you will see dark grey at the same position near the end of the book.

Go to the first page of that section (page 607) where you will find a similar looking page to the Table of Contents. This time, look on the left side of the page under the heading Section Guide. In PJB's case, in the MW listings group, note the page number (page 655) for Central America, Caribbean & Mexico.

Go to that page and turn pages until you find the correct frequency, 800 (page 656) and read the listing:

800 450 BES Trans World R.Bonaire, Kralendijk

BES is the Country Code for PJB.

Back to the Table of Contents (page 5), note the Reference section is the last listed in the right sidebar. If you look carefully at the page edges, you will see dark grey at the same position right at the end of the book. Go to the first page of the Reference section (page 785) and find Country Codes in the Section Guide and go to the page listed (page 788) entitled GEOGRAPHICAL AREA CODES USED IN WRTH. Look up the Country Code, BES in PJB's case, to find the WRTH Country Name, Caribbean Netherlands.

One page previous is the MAIN COUNTRY INDEX. Look up the Country Name, Caribbean Netherlands, and note the first two page numbers in the columns Nat (page 131) and Int (page 565). This is especially relevant in PJB's case as different pieces of information about the station are listed in each section: Nat is in the NATIONAL RADIO section of WRTH and Int is in the INTERNATIONAL RADIO section.

It is with a heavy heart that I am sending my first Muse in a couple of years because I learned several weeks ago about the passing of my friend Chuck Hutton. Although I haven't seen him in person since the 90's, when he moved from Atlanta to Spain and beyond, we did keep in touch occasionally via email. I met Chuck in the summer of 1975 at a pizza place in Decatur, GA and then from there a long relationship began that included DX, photography, and dining out frequently with our wives. Chuck and I also had a number of DXpeditions during the 80's, mostly to my aunt and uncle's farm in Eastern Alabama, Randolph County. 

## FCC Special Authorizations

Many DX references will tell you the power and antenna pattern information for which stations are licensed ... but as many as 10 percent of U.S. medium wave stations are operating under "special temporary authority." Normally an STA is granted for a period of six months and can be renewed, and some have been going strong for 10 years or more.

The most common type of STA is for reduced power of one kind or another ... due to transmitter issues or other technical problems, stations can be authorized to operate with reduced power. Often, if a station is unable to maintain its directional pattern for some reason, it can be authorized to operate with "parameters at variance" – meaning to broadcast with a non-standard pattern, reducing power as needed to provide the necessary protection to other stations, or with a specified power level. The default is that a station with a directional authorization can broadcast non-directionally at 25% of its authorized power level when necessary, but there are exceptions to the rule.

Increasingly, as land values increase in many locations and the value of AM stations decreases, stations lose their leases on their transmitter sites or just can't afford the market rent increases. Many stations have STAs to operate from alternative sites, often using TIS-style "whip" antennas or old-fashioned longwires or drop-wire antennas from existing towers. And there are a few stations with STAs for higher power, when foreign stations (usually Cuban, but not always) are interfering by operating with higher powers than allowed under international agreements.

Because every STA gets renewed (or not) every 6 months, it gets complicated keeping track of all of them, but here at *DX News* we do our best. Here's our best guess as to the current status (as of Monday, June 9, 2025). But follow AM Switch for the latest updates.
