The Canadian Radio-television and Telecommunications Commission (CRTC) is taking another step forward to implement the modernized Broadcasting Act. The CRTC has released a decision that conditionally approved the Canadian Association



CRTC has released a decision that conditionally approves the Canadian Association of Broadcasters' (CAB) plan to administer a new temporary Commercial Radio News Fund to support local news programming by commercial radio stations outside Canada's largest cities, where the needs are most pressing. Questions about applying for funding can be addressed to the CAB. The CRTC recognizes the important role radio news play in keeping Canadians informed. This decision will help commercial radio stations in smaller communities, where radio is sometimes the only source of local news, continue to deliver timely and fact based information.

- 1460 KENO NV Las Vegas 8/3 0743 Endless promos and programming notes for "Buenos Dias America" program and TuDN network; legal ID at ToH: "KENO Las Vegas 1460 AM Deportes Vegas." Fair and mixing with XEYC, both pretty regular here. (JW-CO)
- 1460 CJOY ON Guelph 7/30 2131 'Gloria' by Laura Branigan. Calls, then would fade out leaving KXNO. Poor. (JJR-MI)

- **1470 KIID CA Sacramento 7/26 0743** Presumed, with Punjabi incantations. Heard often around this time but they never seem to ID, even at ToH. **(JW-CO)**
- 1470 WRGA GA Rome 7/25 1350 Short Fox News at 1350, followed by 'WRGA Local Weather,' ID, and Westwood One talk. Near ToH legal ID: "Newstalk 98.7 FM and AM 14-70 WRGA Rome," then another set of news, this time ABC News! Again, "WRGA Local Weather." Slogan: "Serving Northwest Georgia, this is Newstalk WRGA." Weak but in the clear on 30' wire. (EB-AL)
- **1480 WABF AL Mobile 8/2 0610** Weather forecast by "WABF," swing music. Strong, with no sign of local WMMA today (no worries, WMMA was back later). **(EB-AL)**
- **1480 WIOS** MI Tawas City-East Tawas 8/7 0659 Poor, with 'Michigan Business' PSA, a Hannity promo. Then calls over an unID sign-on! (JJR-MI)
- **1480 KNGO TX Dallas 8/21 0403 –** Talk by Vietnamese lady, joined later by a man, parallel station stream. Fair, on occasional peaks, over a gumbo of others. **(TK-FL)**
- **1490 WCLU KY Glasgow** 8/6 0714 Short and weak, but efficient appearance from the soup: "Good morning at WCLU!" Weather and fade-out. **New, for Kentucky #22.** Heard again on 8/6 @ 2121 with 'You Take My Breath Away,' matching web. (EB-AL)
- **1490 KRTN NM Raton 7/20 0833** Older C&W tunes and frequent "Classic Country 1490 KRTN" IDs. Fair peaks, in partial KCFC null. (**JW-CO**)
- 1490 WCSV TN Crossville 8/8 0758 Someone running for Tennessee governor, 'Mainstreet News.' ID: "Sportsradio 97.7 The Ticket," and ads with 931 area codes. New, for Tennessee #60. (EB-AL)
- **1500 WLQV MI Detroit 8/6 2151** Poor, with REL teaching. Never in much much less at night. KSTP the norm. (**JJR-MI**)
- **1510 KCTE MO Independence 8/6 0800** Legal ID, which also included K233DN 94.5 Raytown, then back to ESPN programming. Fair. (**JW-CO**)
- **1510 KMSD SD Milbank 8/8 0755** "Classic Hits 95.1," playing 'Back in Black' by AC-DC. (That will wake you up, hi!) Poor. **(JJR-MI)**
- **1520 WHOW IL** Clinton 7/29 0806 Town Hall News, followed by weather ". . . for Regional Radio . . . ." "Clinton" heard in ad. Poor. (JJR-WI)
- 1520 WPAY OH Rossford 7/30 2052 Daily Mass being said. Poor, fading in/out with WZBU. (JJR-MI)
- **SD** Sioux Falls 8/1 0759 Poor in fade-up, with 80s songs and 'Sunny 93-3.' Now over WZBU! Logged a week later on 8/8 @ 0735 Poor, playing 'Two Princes' by the Spin Doctors. "Sunny 93.3," then lost to WZBU. (JJR-MI)
- 1520 WZBU WI New Holstein 8/15 2054-2056 Very good with Brewers game. New here. (NB-WI)
- 1540 KBOA MO Kennett 8/2 0630 Ad for 'FM Bank,' "Hits of yesterday," playing Oldies and Country songs. IDs between songs are merely "AM 15-40 and 98.7 FM"; also one "The Great American Playlist." Finally local ads, including an auto dealer in Caruthersville, an area code in Missouri, and a health network in Kennett and Caruthersville. Strong signal from the southern appendix of the state. New, for Missouri #6. (EB-AL)
- 1540 KENT NV Enterprise 7/10 0835 Man with talk in Spanish before an audience not a sermon but religious in nature; 0855 upcoming events calendar, mentions of 'El Sembrador'; parallel to our local Esne Radio affiliate, KDCO-1340. Faded just before ID at ToH. (JW-CO)
- **ON Toronto 7/31 0208** Mostly poor under ZNS1 and one of the Mexi-Texans, with South Asian vocals, parallel station stream. First logging in ages. Supposedly no longer 50/30 kW, and some reports state daytime only. But not. **(TK-FL)**
- **1550 WAMA FL** Tampa 8/2 0124 Proudly cheating at 10 kW day power with Mexi-tunes, "La Ley" slogan. Near local level at times. (TK-FL)
- 1550 KMRI UT West Valley City 7/3 0811 Long half-hour interview with Gary Player on the Sports Byline Radio network. Fair at tune-in, and slightly better at 0815 power-up. Seems regular now had been Silent for ages. (JW-CO)
- 1550 KMRI UT West Valley City 8/2 0156-0158 Several national ads into an unrecognized sports network; the station's 'slcsportsradio.com' web site says they are running the syndicated Sports Byline USA Network. It has been about 10 years since I last heard KMRI here in Edmonton. As KRGO in the late 1960s, they were my best regular reception in Vancouver at High Noon as a 10 kW daytimer. This time, with antenna facing roughly South gave me enough of a null on KRPI's male Punjabi prayer voice to get slightly fluttery audio from KMRI until they faded out completely across the top of the hour.

Conditions were quite good with Ontario signals from CKDO-1580 and CHHA-1610 for the first time in over two years. Had hoped for CHIN-1540, which was recently reported on all night, but KLFE and KXEL were too strong. Suspect KMRI was running their current 188 Watt night power or their signal would have been a lot stronger, without the flutter, and would not have faded out for a while. **(JP-AB)**

- **1570 WKBH WI Holmen 7/29 0800** Legal ID, Relevant Radio news and sounder while chasing others. (**JJR-WI**)
- **1580 CKDO ON Oshawa 7/30 2126 –** Poor, with 'Ballroom Blitz' by the Sweet (twice in 15 minutes!), calls + "HD 95.9" mention. (**JJR-MI**)
- **1590 WGBW WI Denmark 8/1 0739 Format flip from TALK**. "97.9 WGBW" and 50s, 60s, 70s OLDies. (**JJR-MI**)
- 1690 KDMT CO Arvada 8/11 0654 Poor, but alone, with talk of St. Francis. (JJR-MI)
- **MD Lexington Park 8/4 0245** Chicago's '25 or 6 to 4' to Bill Haley & His Comets. Fair under WMLB. Parallel station stream. (**TK-FL**)
- **1690.08 CHTO ON Toronto 8/2 0108 –** Presumed the one, with Greek folk vocals (webstream broken to attempt confirmation) with WMLB mostly nulled. Measurement estimated. I don't recall the 'Cheetos' being off-frequency before. **(TK-FL)**

- 810 **BAHAMAS** ZNS3 Freeport AUG 24 0359 Poor; instrumental national anthem. [Conti-NH]
- 870 **CUBA** *R.Reloj*, multiple locations AUG 16 0712 Whooper or rather squeaker under WWL, and not under 1040 WHO at this time. [Hauser-OK]
- 910 **SAN ANDRES** HJMY San Andrés y Providencia AUG 17 0959 Spanish man and woman alternating news items, net IDs. Fair-good on peaks. [Krueger-FL]
- 920 unID AUG 1040-1100 window sporadically in August, someone pointing roughly Mexico with Mexi-tunes, very poor and only in this rough sunrise line. Not parallel XESTRC *Voces Campeche* or HRSK *R.Catacamas* (the latter which David Crawford, Titusville, FL is hearing). There are other Mexicans on the channel it may be. [Krueger-FL]
- CUBA *R.Progreso*, Pilón JUL 25 2025 0232 Presumed location. Weak carrier, thanks David Crawford tip, who states that he has a rough bearing taken at 0300 UTC using the XHDATA receiver in his driveway away from the wires, and appears to be 150-155 degrees true. 150 puts it on a line through Holguín and Santiago de Cuba. WRTH 2022 listed 920 *R.Progreso* outlet at Pilón, Granma, which would fall close to the 155 line. [Krueger-FL]
- 970 **MEXICO** XERFR *R.Fórmula*, México, CDMX AUG 11 0812 Stevie Wonder 'I Just Called to Say I Love You' parallel station stream. [Krueger-FL]
- 1000 **MEXICO** XEOY *Stereo Cien*, México, CDMX AUG 21 0948 Bonnie Tyler, Mellencamp, Journey. Slogan ID once. Mostly poor and KTOK co-channel. Remember when it was also on shortwave? [Krueger-FL]
- 1020 **CUBA** *R.Artemisa*, Bahía Honda AUG 24 0400 Poor with KDKA cancelled; hourly ID with signature flute music, choral national anthem, then off. [Conti-NH]
- 1040 **CUBA** *R.Mayabeque*, Güines AUG 2 0648 WHO has interference which I would describe now as a 'squeaker' rather than wobbler, or even whooper. Always accused is the only Cuban listed on 1040. Is it ever in normal programming? AUG 14 0643 Whooper under WHO; not now on 870 or anywhere else during MW bandscan. AUG 19 0654 Whooper under WHO and no others at this time, not even 870 under WWL. [Hauser-OK]
- MEXICO XECPAE *R.Educación*, México, CDMX AUG 4 0752 'Sky Pilot' by Eric Burdon to 'White Houses' then 'Don't Bring Me Down' by The Animals. Top of hour ID and into four song set by The Doors. Good, and parallel shortwave 6184.98 kHz. [Krueger-FL]
- 1060 **MEXICO** XERDO *La Raza 1060*, Matamoros, Tamps. AUG 2 0452 Mexi-tunes, "En La Raza 1060" drops. Excellent. [Krueger-FL]
- 1130 **VENEZUELA** YVRL *R.Ideal*, Maiquetía AUG 24 0200 Fair with WBBR cancelled; "La Oración" female religious vocal. [Conti-NH]
- 1141 **CUBA** unID AUG 16 0656 Het upon 1140s, presumed Cuban. [Hauser-OK] AUG 24 0400 Loud het against 1140 WRVA, but nothing from reported 921 and 1431 offset frequencies. [Conti-NH]
- MEXICO XEPZ Cd. Juárez, Chih. AUG 17 0304 Mexican music seems east/west-ish. Maybe KNUV Tolleson AZ, still on 5 kW day power, but it's news/talk. Make that more likely XEPZ, grupera format. AUG 18 0433 "Vacúnase para Chihuahua" PSA, therefore XEPZ as I suspected during previous log. IRCA says 1000/250 watts, "Máxima 99.1, Tu Estilo de Vida." [Hauser-OK]

unID AUG 16 0651 – JBA het upon 1430 signals. Only significant transmitter on 1431 is 600 kW VOA/Sawa Djibouti, but not this late and besides is supposedly turned off. And when it was active, not in daytime between 02 and 16 per mwlist. In Asia/Pacific, nothing more than 10 kW in Australia, China, Japan, New Zealand, Thailand, and besides it's way too early in daytime for any of those. So, more likely yet another Cuban inexplicably transmitting +1 kHz. It's not a modulated tone from some station, since not also on 1429. However, mwlist and WRTH show no Cuban on 1430, let alone 1431. AUG 17 0130 – JBA carrier hetting 1430 again, also at 0300, and 0622; not Cuba nor Djibouti? [Hauser-OK]

1670.03 **MEXICO** XEFCR *Focus Radio*, Reynosa, Tamps. AUG 2 0501 – Tiny kiddies version of untruncated anthem already in progress until 0504, then woman ID, into Spanish ballad. [Krueger-FL]

#### **INTERNATIONAL NEWS**

AUSTRIA: DX tests authorized for a new medium wave station to be licensed. "The assigned frequency will be 1143 kHz. The station will broadcast from the Upper Austria area. The test broadcast has been approved by RTR (the licensing authority in Austria) and is scheduled for 27 August at midnight to 29 August at midnight. The operator is expected to be on air on the frequency from around 8 a.m. on 27 August until midnight. The exact broadcast time for the following two days has not yet been determined. The test will consist of a text loop and an identification signal. At my suggestion, there may also be a special QSL card for the test. As the contact does not want to be made public yet, I am offering to act as an intermediary. Anyone who hears the station can send me their report and I will forward it reliably." – Harald Süss, email: h.suess@aon.net "If a licence is actually granted, the contact will open and announce his contact details. I have also been informed that there will be special nighttime broadcasts with programmes for DXers. The selected frequency is practically empty except for two Spanish 5 kW stations. From Asia, VoTadjik from Dushanbe could appear at best, most likely at the start of transmission at 02 UTC. If the licence application is successful, Austria will then have two licensed MW stations." – Christoph Ratzer. [Thomas Nilsson, ARC] The other licensed radio station is low power (500 watts) Museumradio AM on 1476 kHz.

**COLOMBIA**: *RCN* underwent significant restructuring on August 4, driven by the need to overcome historical financial losses of the Ardila Lülle Group. The Basic RCN Radio Network closed, leaving *La FM* and *Alerta* Bogotá as the main stations. [Rodrigo Torres Villamil] "*RCN* is a large corporation that operates several radio station (program) chains/networks. In the same way that the BBC operates several competing programming chains. The flagship *RCN Basica* network has been shutdown. These are the stations that IDed as *RCN* + name of city (e.g. RCN Cartagena on 1000 kHz). Those are now relaying programming from the (*RCN* owned) "La FM" network stations in their particular cities. While the main ID would be "La FM" I would guess that they might also mention

RCN sometimes as that is the corporate owner. The primarily sports-oriented Antena Dos network is continuing as is. Its IDs have often mentioned RCN and probably will continue to do so as that is the corporate owner. The other large network operated by the RCN company was La Cariñosa. That has been ended but its frequencies are still on the air under the newly-created "Alerta" network name. My guess is that Alerta stations will sometimes mention RCN in their IDs (as did La Cariñosa stations). The RCN company has a couple more small networks on both MW and FM but those are not likely to be heard in North America." [Don Moore, via Mark Connelly, CapeDX]

**NORWAY:** *R.Northern Star* Friday 22 August 2025 commenced broadcasting on new **1575 kHz**. Programmes were parallel 5895 kHz. Noted at 2035 UTC with continuous oldies. [Stig Hartvig Nielsen, *mediumwave.info*]

#### Mike Newland, Morgantown KY

Greetings all, I just renewed my National Radio Club membership for the upcoming fall 2025/winter 2026 DX season. I have enjoyed reading *DX News*, but I need to do a better job of reading the issues when they arrive in the mail, and I also need to do a better job of contributing my loggings. I will make an effort to do both in the upcoming season.

I have had a couple of long wire Beverage antennas up the past several years, one of them pointing NE was terminated making it a true Beverage. I never thought it performed as well as it should. I have about 25 acres surrounding my house but it is heavily wooded and has a steep ravine directly behind my house. In running the wires through the woods, I would find I had to zigzag back and forth from one tree to the next, and sometime the height of the wire would exceed 15 feet, particularly through the ravine. I am not sure if that had any negative effects on the performance. I am planning to have some timber harvested this fall and I am hopeful this may open up things a bit to have a more traditional Beverage wire that can be ran out to about 800 feet. I will let everyone know when I have been able to put up some new wires later in the fall, perhaps by Thanksgiving.

The primary radios I have for medium wave DXing are: ICOM IC-7300, Tecsun PL-330, GE Super Radio III, and a Realistic DX-400. By the way, the Tecsun PL-330 is considered an ultra-light radio and has proven to be very sensitive. This radio has a 3.5 mm external antenna jack that will work on medium wave by long pressing the "3" button when the mode is set to medium wave. It has worked well connected to a G5RV antenna at 35 feet, particularly during the day to receive stations that are more than 100 miles from my QTH. There are several good YouTube videos on this radio that demonstrate its performance and some of the hidden features.

I recently picked up several air core variable capacitors at the Huntsville, AL Hamfest for a terrific price, all 350 pF or more (one measured about 2100 pF). I am planning to use one of these variable capacitors to build an indoor loop antenna, in order to see how those type of antennas perform.

Everyone have a nice remainder of summer and I'll wish everyone 73 and good DX.

#### Jim Weber, Oyster Point PA

Veries: 800 WPLK, 1060 WIXC.

It's been a decent summer for station receptions here in Oyster Point, largely due to a fortuitous absence of a local on 1490. WRKY (Rocky) got its start in 1922 as WGAL, originally owned by the Steinman newspaper family, which included the Intelligencer Journal and the Lancaster New Era. The family expanded into television in 1949 with WGAL-TV, which is still extant. WGAL AM moved to 1490 in 1941 and it was sold to Hall Communications for \$850,000 in March 1976. The call sign changed to WDDL in 1977 and then to WLPA in 1979. During the next 40 years, the station featured several formats, including adult standards and multiple stints as a sports talk station affiliated with ESPN. In July 2021, Forever Media purchased WLPA and its associated WYCR-FM translator from Hall Communications, changed its call sign to WRKY, and began simulcasting the classic rock programming of its sister station; branded as "Rocky 98.5". In late 2024, Forever Media sold WRKY's 92.5 FM translator to a Christian broadcasting company Four Rivers Community Broadcasting. Since the July 2025 the Federal Communications Commission approval of WRKY's application to change its designation from a commercial to a non-commercial educational station, the 1490 station, separately valued at \$15,000, has been off the air; enabling reception of previously unavailable stations. In celebration hereof, I purchased a Qodosen DX-286 which I am still getting familiar with. I'm looking forward to exercising my fleet of portables during the Fall DX season.

#### Linda Brodsky, Malverne NY

I'm writing this from Golden, CO where conditions on the BCB are notably better than at my NY QTH. I brought my Airspy Discovery HF and YouLoop, which is hanging in an east facing .A quick look at several top of the hour overnight IQ recordings show a tolerable noise level and stations heard on almost every frequency. 



Seven stations on the list (KEII-690, WAEC-860, KXPS-1010, KPSF-1200, KRLC-1350, WFIC-1530, and KREA-1540) have been listed as silent for more than a year; if verified, these licenses will be cancelled.

Two more silent notifications (WURL-AL-760 and KCHU-AK-770) were filed with the FCC on Monday, August 25 and aren't yet on the FCC silent list.

There are also many other stations which have been observed as silent for long periods but have not been notified to the FCC.
