THIS IS TO VERIFY YOUR RECEPTION OF KAPB ON THE MORNING OF FEB. 28, 1966. WE WERE ON THE AIR AT THIS TIME, IN ORDER TO BALANCE OUR TRANSMITTER'S LIMITING AMPLIFIER, AND AT THE SAME TIME CONDUCTED A FREQUENCY MEASUREMENT.

KAPB HAS BEEN ON THE AIR SINCE 1954 AND OPERATES WITH A NON-DIRECTIONAL POWER OF 1000 WATTS. OUR TRANSMITTING FACILITIES ARE AS FOLLOWS:

TRANSMITTER: COLLINS RADIO CO... WPM. 20-V2.

ANTENNA: 202 FT. OVERALL HEIGHT, SHUNT EXCITED, UNIFORM CROSS SECTION, GUYED VERTICAL RADIATOR.

KAPB IS OPERATED BY AYOUILLE'S BROADCASTING CORP., MARKSVILLE, LA., WHICH ALSO OPERATES 250 WATT WLBK-1220-DENHAM SPRINGS, LA. AND 1000 WATT KWRC-1500-NEW ROADS, LA. IN ADDITION TO OUR "MIDDLE OF THE ROAD FORMAT", WE FEATURE 2 HOURS OF C&W AND 1 HOUR OF R&R.

FROM THE VERIFICATION REQUESTS RECEIVED TO DATE, OUR SIGNAL WENT COAST TO COAST AND BORDER TO BORDER. I RECEIVED 3 VR'S FROM CANADA.
