WCMX is in all day over here at the Cape Tip, with a listenable signal, but with some background noise and a slight hint of signal from either WHWB in Rutland, or CKBW in Bridgewater, Nova Scotia - it was too faint to tell which it was!

Here is what I heard this late afternoon from WCMX, on 1000 kHz:

5:28 p.m., when I tuned in - Local news from Fitchburg, Gardner, Worcester, Leominster .

- Mentioned Bob Morgan would be along at 5:31 with the sports news.

5:30:15 - Ad for Sears.

5:31:10 - Mentioned still time to register teams for the adult men's softball league; call between 8:30 and 5:30.

5:31:30 - Said the local high school baseball schedule starts Thursday for Leominster, if the field is playable.

- Mentioned that Torrez "will pitch" this afternoon for the Red Sox' home opener. 5:32 (I use quotes because the game was already over!) (I had been listening to it!)

5:32:40 - The weather, now 470. Then mentioned "Country Music Ten, WCMX."

- Two selections in the country style. 5:33

5:39:30 - Mentioned a camping and outdoor show this weekend at Worcester, 701 Lincoln Street, stonsored by Chapter 11 of ----?---.

5:40:10 - Ad for retirement accounts at Leominster Savings Bank.

5:41:10 - Singing station jingle, then a country tune.

5:44:45 - Mutual Sports with Jim Gannon, including some of those "quickie" interviews with "You Know" type interviewees from the Sports world. 5146110xxxxit

5:46:10 - State Farm Insurance ad.

5:46:40 - Rodney Dangerfield for Pilot Pens.

5:49:30 - Ad for Twin Oaks Restaurant in Sterling, phone 422-8414.

5:50:15 - Ad for Guy's Carpeting and Furniture store.

5:50:50 - Ad for Rell Hardware in Leominster.

5:51:05 - Ad for a service station on Route 119 in West Townsend. The announcer's name was ---- Casey.

My receiver is a Hammarlund HQ-180, but I was using a stand-by receiver today, a brand new G.E. Superadio portable. I have been a DX fan from the year 1932 and have 4,233 verifications from that many different standard AM stations. My good friend Stan Morss mentioned receiving a nice letter from you, and suggested I send my report to you.
