
Thank you for your recent "DX'er" listening report.


Mr. Morss;

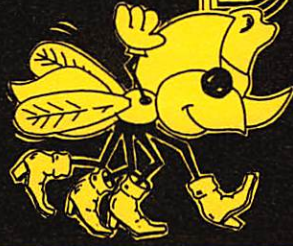





My Dear Listener:

Here's the problem: I grossly under-estimated the time it would take me to become computer literate. I had dreams of customized form letters indistinguishable from hand-crafted missives. The dream still lives, but I thought it was unfair to make you wait for a answer in the meantime. That message hit home when I saw the number of unanswered "I listened to the Super Bowl Instead" cards and reactions to my 1993 Bing tribute. So here's another generic, but at least typed-on-the-computer response.


"The Big Broadcast" began on WFUV-FM in December 1972. I did more than 1000 weekly programs before moving the show WQEW in December 1992. "Big Band Saturday Night" began as "The Big Bandstand" on WFUV in October 1990. I made a lot of friends in my twenty-plus years in Public Radio, and I am grateful to those of you (and I suspect it is almost all of you) who moved with me to the AM dial.

"Where do you get the records?" That's the question I'm asked most frequently. Well, I've been collecting them over the years. I still play mostly LP reissues, but, as I buy them, more and more CDs, and, yes, more 78s. I tape the 78s at home on a DUAL turntable with a Stanton 2.6 mil. truncated elliptical stylus. If you're looking for 78s, try Mort Savada at Records Revisited (34 W33, NYC 10001. 212-695-7155). For reissues, try Footlights (113 E12. 212-533-1572). For equipment to play 78s, contact Kevin A. Barrett (Box 2922 CR, Plainfield, NJ 07062). If you need help in putting your 78s on tape, get in touch with Adrian Cosentini (Box 4772, Bay Terrace Station, Bayside, NY 11360).

Sometimes people send me lists of records they're looking to sell. Well, I'm not a record dealer, but Mort Savada is. However, I'm sure he'd appreciate it if I pointed out that relatively few old records are valuable. Condition and scarcity are the main things. Millions of people bought "White Christmas," and it appears that all of them kept it. 1920s jazz on smaller labels could be worth something, and so could some early 30s jazz, dance band and personality sides. If you want to learn more about the hobby of record collecting, and even get into discographic research, contact Record Research Associates (Box 158, Jericho, NY 11753).

Keep listening and keep writing.
