Radio Station WEAQ:

On Saturday, July 24, 1999, from 8:31 PM to 8:40 PM (Central Daylight Time), it was my pleasure to monitor a portion of the transmissions of WEAQ on 1150 kHz from my location, which is about 10 miles south of Grand Rapids. As proof of this reception, I offer the following listing of items I heard:

- 8:31 Announcement of the previous musical selections, that the "Saturday Night Dance Party was in progress, followed by a brief fade, I believe an announcement concerning Breast Cancer awareness and an announcement concerning the Wisconsin Broadcasters bringing community awareness and service
- 8:33 Ad for Klinger Farm Market, followed by another fade and an announcement that, I think concerned children
- 8:35 Station ID and announcement ("This is Phil Resina, great to be with you, playing unforgettable music on 1150 AM, WEAQ") and song ("Dolores")
- 8:38 Announcement ("WEAQ AM, 1150") and song ("Our Love is Here to Stay")
- 8:40 Your signal faded and did not resurface


I used a Collins UR388 receiver with two foot amplified loop antenna to receive WEAQ. Your signal was quite strong at 8:31, 8:33 and 8:35 but was also subject to very rapid and deep fading. There was considerable interference from WHBY in Kimberly, Wisconsin, and particularly from CKX in Brandon, Manitoba, who took the frequency over after 8:40

On the basis of the above details, I wish to request a brief letter confirming the fact that I indeed received your station's signals. I collect these letters as a hobby and have some 3000 at present. I would greatly appreciate a letter from WEAQ to add to my collection. In fact, a statement, such as

"Mr. Sampson:

This will confirm your reception of WEAQ on July 24, 1999.


