## Radio Station WNDZ:

On Tuesday, November 18, 2008, from 4:21 PM to 4:30 PM (Central Standard Time), it was my pleasure to monitor a portion of the transmissions of WNDZ on 750 kHz from my location, which is about 175 miles north of Minneapolis. As proof of this reception, I offer the following listing of items I heard:

- 4:21 When I tuned in to 750, a song by a man was in progress, this was followed by a brief announcement in a language with which I'm unfamiliar and the song
- 4:22 Announcement in the non-English language; I thought I heard mention of the Venetian Monument Company (on Northwestern Avenue in Chicago, I think), then there seemed to be an announcement about foreclosures, followed by one about the Balkan Cafe
- 4:23 Song by a woman
- 4:27 There were several announcements, the first sounded like something on Thanksgiving, the I heard mention of Sandys Downies, the Balkan Bakery and Taste of Europe; this was followed by a song
- 4:29 Announcement by a man "You have been listening to Radio Tesla, sponsored and hosted by Peter Jevonavich (?)
- 4:30 Announcement by a woman "Views and opinions expressed on our broadcast day are the sole responsibility of paid programming and do not necessarily reflect those of WNDZ management, staff nor WNDZ incorporated. Have a great evening, this is WNDZ, 750, Portage Indiana, Chicago" after which you left the air

I used a Collins UR388 receiver with two foot amplified loop antenna to receive WNDZ. You were very strong. There was slight interference from CKJH in Melfort, Saskatchewan, who took over 750 after you left the air.

On the basis of the above details, I wish to request a brief letter confirming the fact that I indeed received your station's signals. I collect these letters as a hobby and have some 3000 at present. I would greatly appreciate a letter from WNDZ to add to my collection.

A brief statement on the WNDZ letterhead to the effect that I heard WNDZ's transmissions on November 8, 2008, would be ideal for my purposes. For your convenience in replying, I have enclosed a self-addressed, stamped envelope.


